

Lineker row: BBC sport output in chaos

Match of the Day presenter Lineker, England's fourth most prolific goalscorer, sparked an impartiality row by criticising the British government's new policy on tackling illegal immigration. The 62-year-old compared the language used to launch the new policy to that of Nazi-era Germany on Twitter, which the BBC said on Friday was a "breach of our guidelines".

Mass protests against Israeli judicial move

Israelis packed city streets yesterday in nationwide demonstrations now in their 10th week against plans by the hard-right government to curb the Supreme Court's powers, which critics see as a threat to judicial independence. Prime Minister Benjamin Netanyahu, who says his aim is to balance out branches of government, wields a parliamentary majority along with his religiousnationalist coalition allies. As the reforms head toward ratification, the protests have escalated. The shekel has slipped. Some military reservists have threatened not to heed call-up orders. President Isaac Herzog has appealed for the overhaul to be postponed and dialogue held.

Strike to hit German airports today

A 24-hour strike by security staff at four German airports will force the cancellation of 351 flights today, their union announced, an action denounced by the airports association. "One will have to expect longer queueing times as well as cancelled flights," said a statement yesterday from the Verdi union, which is pressing for better pay and conditions. The expected flight cancellations will be at Berlin. Bremen, Hamburg and Hannover airports, hitting around 100,000 passengers, airports association ADV said. Verdi is seeking better pay for night shifts and weekend work, hoping what will be the third stoppage of the year will bolster its

Global Security Forum starts in Doha tomorrow

●PM to open invite-only three-day event

atar will host the fifth Global Security Forum from tomorrow under the central theme of 'Reshaping the Global Order: Conflict, Crises and Co-operation.'

The invite-only event, held under the patronage of HE Sheikh Mohamed bin Abdulrahman bin Jassim al-Thani, Prime Minister and Minister of Foreign Affairs, will run until March 15. It will see heads of government and ministerial leaders join security agency chiefs, senior government policy markets, prominent experts, academics, journalists and private sector leaders from across the US, Europe, the Middle East, Africa, Indian Ocean and Far East, address pressing issues facing global security today.

The forum will be opened by HE Sheikh Mohamed, who is expected to reflect on new world security priorities from a Qatari perspective, according to a press statement from the organisers.

The main business agenda begins with a fire-side chat with Rwanda's President, Paul Kagame, who is expected to provide valuable insights into his country's experiences in post-conflict reconciliation and development, including fostering dynamic socioeconomic progress, and on regional and international security dynamics that shape the nation's diplomacy, development and defence priorities.

Meanwhile, with heightened US-China relations in the global spotlight, Teo Chee Hean, Singapore's Senior Minister and Co-ordinating Minister for National Security, will reflect on the changing dynamics on the global stage from the Lion City's perspective, including the impact of the Russia-Ukraine conflict on China and the Asia-Pacific region, the strategic competition between the US and China, and the importance of international co-operation and co-ordination.

The forum will also include fire-side chats and expert panel sessions. It will witness fire-side chats with Musa Faki Mohamed, Chairman of the African Union Commission; HE Hassan al-Thawadi, Secretary-General of the Supreme Committee for Delivery & Legacv; Dr Joshua Geltzer, Deputy Assistant to the President and Deputy Homeland Security Adviser, US National Security Council; Timmy T Davis, US ambassador to Qatar; Larissa Knapp, Executive Assistant Director, Federal Bureau Carstens, the US's Special Presidential Envoy for Hostage Affairs; Robert C O'Brien, Co-Founder & Chairman, American Global Strategies and former US National Security Adviser; Christopher Miller, author and former US Acting Secretary of Defence; ambassador Bilahari Kausikan, Chairman, Middle East Institute, National University of Singapore and former ambassador-at-Large, Ministry of Foreign Affairs Republic of Singapore; and Major-General Michel Friedling (Retd), former Commander of the French Joint Space Command, France.

The Russia-Ukraine conflict will be a forum highlight, with a dedicated session reflecting on the current state and future prospects following the one-year mark of the war. The session will see Ambassador Nathan Sales, TSC Senior Fellow; Dr Kacper Rekawke, Postdoctoral Fellow, University of Oslo Centre for Research on Extremism; and Dr Biljana Lilly, from Warsaw Security, explore the conflict's traditional military dimensions as well as the role and impact of private military companies. **To Page 12**

Ministry of Labour launches e-service package to process work permits

he Ministry of Labour (MoL) has launched a new package of e-services related to the management of work permits, as part of its strategy to digitally transform services and provide them to the public without the use of paper in order to achieve excellence in performance, streamlining and expediting procedures.

The new services cover six types of requests: for a work permit, for renewing a work permit, for cancelling a work permit, for issuing a labour recruitment approval, for renewing the validity of a labour recruitment approval, and for amending a labour recruitment approval.

In a statement, the ministry explained that the new service of the Work Permits Department provides the opportunity for establishments to submit a work permit application



that allows them to secure a vacancy in the labour market for different categories of individuals – those currently residing in Qatar under the sponsorship of their families; citizens of GCC countries; and per-

manent residence permit holders; or investors.

The service enables establishments to submit a request to renew a work licence and a request to cancel a work licence online, without the need to visit the ministry's head-quarters, external offices or government complexes.

To renew a work permit, a residence permit that is valid not less than three months is required to avail of the service in addition to a certificate of academic qualification, the residence details of the employer, a certificate of good conduct and behaviour, a certificate of practising professions for the professions that one needs (such as engineering, medical, etc), and a letter of approval from the Ministry of Education and Higher Education if the work is related to schools and kindergartens. **To Page 2**

Shura Council attends co-ordination meetings on IPU assembly sidelines

The Shura Council attended the co-ordination meeting of the Islamic parliamentary group, held on the sidelines of the 146th Assembly of the Inter-Parliamentary Union (IPU), which kicked off yesterday in Bahrain and will last for five days.

The Shura Council delegation to the meeting was headed by HE the Shura Council Speaker Hassan bin Abdullah

The meeting saw the Shura Council discuss and submit, on behalf of the Arab parliamentary group, a request to include the criminalisation of contempt of religions, as an emergency item on the assembly's agenda, titled criminalising contempt of religions, violating places of worship and sanctities, spreading ha-

tred among peoples, and instead calling for the promotion of coexistence, tolerance, world peace and security.

Participants stressed the importance of this item, working to add it to the agenda, and uniting their efforts to urge the various parliamentary groups to vote for it, expressing that the item's topic, which was submitted by Qatar, is compatible with the IPU's current session on peaceful coexistence. During the meeting, the items on the 146th session of the IPU Assembly's agenda were reviewed and discussed extensively, stressing the Islamic group's united front in support of it.

In the same context, the Shura Council, headed by HE the Shura Council Speaker Hassan bin Abdullah al-Ghanem, participated in the co-or-

Dr Manal Musallam Othman, director, Patient Education Medicine, HMC said: "Diabetes is a complicated condition that can cause both immediate and life-threatening long-term complications. As a result, education, prevention, and diagnostic services remain at the frontline of the battle against diabetes and related chronic diseases and raising community awareness of healthy lifestyle practices during Ramadan is vital for ensuring safe fasting."

"For people with diabetes, choosing to fast throughout the holy month of Ramadan entails various potential difficulties. Numerous people with diabetes also deal with other associated complications of diabetes, such as high blood pressure, high cholesterol, visual problems, and renal disease. Therefore, healthcare experts advise those with diabetes to exercise regu-



larly and consult their physicians and HCP before fasting. They should have detailed therapy recommendations, dietary modifications, and a medical evaluation specific to their health condition," added Dr Othman.

The campaign features several activities, including a workshop for the home healthcare staff to learn about the essential needs for efficient diabetes management, also, expand their knowledge on fasting-related requirements, including glucose monitoring, physical activity, nutrition, medication dose adjustment, and timing in Ramadan.

The workshop's programme covers all aspects of fasting during Ramadan for people with diabetes, focusing on interactivity and discussion and allowing home healthcare staff to learn from each other and interact with experts in the field to improve the home healthcare patient experience, maximise outcomes, and ultimately improve the quality of life for patients.

MoL launches e-service to process work permits

The service of approving the recruitment of workers provides an opportunity for establishments to submit a request for recruitment approval from the Ministry of Labour, and MoL employees will study the request and decide on it. Once approved in terms of gender, number and profession, the application is automatically transferred to the nationalities selection system. Following approval there, the application information is forwarded to the Ministry of Interior (MoI).

It is also possible, as part of the new service, to submit a request to amend the approval of the recruitment of workers electronically, and then it is decided upon within the procedures followed. To benefit from the amendment service, it is required that the approval belongs to the establishment and the establishment's registration is active and does not have violations of the provisions of the Labour Law. Besides, the approval has to be effective, and not all recruitment approvals should have been used. Also, the number provided in the original approval is not to be exceeded.

The service also enables establishments to submit a request to renew the validity of approval to recruit workers electronically, and it ends with forwarding the request to renew the approval to the MoI through the integrated link, without the need to visit the ministry's headquarters, external

offices or government complexes.

In order to avail of the renewal service, it is required that the approval belongs to the establishment submitting the application, the establishment's registration is effective, it has no violations of the provisions of the Labour Law, all previously approved recruitment approvals have not been used, and that the approval is effective and a week or less remains before the end of

The Ministry of Labour has been working within an integrated strategy for the digital transformation of more than 80 services since the launch of the Digital Transformation Unit, based on the Agile methodology, which allows the ability to launch new services and updates.

Campaign to release falcons launched



Al Gannas Qatari Society launched on Saturday morning its sixth campaign to release falcons and return them back to nature. The campaign, Qatar Falconers 2023, is being conducted at the headquarters of the society at the Culture Village Foundation -Katara. Falconers can donate their falcons and register them from 9am until 12noon. The data of the donated falcons will be registered alongside all related information. until all the donated falcons are collected in preparation for releasing them. The process of receiving donated falcons will continue until March 15.



Over 400,000 workers changed jobs in Qatar under new laws: NHRC chairperson

E the Chairperson of the National Human Rights Committee Maryam bint Abdullah al-Attiyah confirmed that more than 400,000 workers changed their employers since the abolition of the sponsorship system in Qatar.

During a meeting with Secretary-General of Amnesty International Agnes Callamard in London, she underlined that the NHRC's reports and its monitoring of the conditions of workers' rights in Qatar and the follow-up of statistics showed the extent of development in the protection of workers' rights in Qatar, noting that the right to change employers has become a reality for hundreds of thousands of migrant

The NHRC chairperson added that despite this development, from the committee's point of view and through the petitions it received and the monitored statistics, there are some chal-

lenges to solve during the coming period. She expressed the committee's praise for the efforts of the Ministry of Labour to protect wages and the efforts of the labour dispute settlement com-

mittees, as well as the issuance of Law No. 18 of 2018 to establish a fund to support workers, and the significant and important role played by the fund in paying arrears of wages, and providing humanitarian, social, health and food support to vulnerable workers in certain circumstances.

HE al-Attivah indicated that one of the recent procedural developments was the Ministry of Labour's launch of the "one platform for complaints and communications" available to all workers electronically, pointing out that workers can resort to the Labour Department to settle disputes, and the department refers disputes to dispute settlement committees if they are unable to resolve them amicably.

During her meeting with the Secretary-General of Amnesty International, the NHRC chairperson expressed the committee's desire and aspiration for greater co-operation in cases and the exchange of information, including the exchange of reports and comments on them

MoPH, partners celebrate Glaucoma Week

The Ministry of Public Health (MoPH), in collaboration with Hamad Medical Corporation (HMC) poration (PHCC), is celebrating World Glaucoma Week from March 12 to 18 under the theme 'The World is Bright, Protect Your Sight?

Glaucoma is the second largest cause of blindness globally for those aged 50 years or older. Dr Khulood al-Mutaweh, head of the Non-Communicable Diseases Section at the MoPH, said: "Qatar participates in the World Glaucoma Week in March every year to increase public awareness and knowledge regarding this disease and by inviting the targeted group to receive eye checkups by the ophthalmologists.

"This will help in the early detection of this disease, as glaucoma causes a gradual vision loss without any warning signs. Therefore, it is sometimes called the silent thief of sight."

Dr Badria al-Malki, national co-ordinator for blindness prevention and assistant executive director for continuing care and integrated services at PHCC, said glaucoma is one of the leading causes for blindness in the world, with more than 80mn people infected with it.








Conference on political culture in Arab world commences

The three-day Conference on Social and Human Sciences. held by the Arab Centre for Research and Policy Studies, began vesterday based on the theme - 'The conand political cultures in the Arab world?

Dr Azmi Bishara, director-general of the centre and chairman of the Board of Trustees of the Doha Institute for Graduate Studies, delivered the opening lecture.

Then, Dr Abdelwahab El Affendi, president of the Doha Institute for Graduate Studies, presented a paper titled 'Culture as a Weapon: Culture Wars and Cultures of Wars in the United States and Egypt', in which he dealt with the phenomenon known as "culture wars" in the US, a development that drew public attention in the 1990s. It reached its peak in the era of former President Donald Trump.

El Affendi compared it to similar developments in Egypt in the period leading up to the July 2013 events, and it is still raging today. He reviewed the dynamics of this "cultural" conflict, which reveals that the pivotal role of culture is in shaping identity and giving political and social action. The meaning also interacts with the multiplicity and diversity of the possibilities of using it as a tool for conflict and division. He also disagreed with Samuel P Huntington's contention that the difference of cultures delineates the boundaries of conflict between nations.

Dr Abdel-Fattah Madi, a researcher at the Arab Centre for Research and Policy Studies and director of the State and Political Systems Studies Unit, presented a paper titled 'How does tyranny shape the political culture of the masses? An approach from the perspective of civil-military relations? He focused on the policy of indoctrination, which usually has longterm repercussions, because it is related to the political culture of the masses.

The subsequent sessions featured Tunisian researcher in sociology, Dr Asma Lahyoul; Dr Shaker Houki, professor of Public Law at Al-Manar University in Tunis: Dr Ahmed Abu El-Ala. professor of Cultural Anthropology at the National

Centre for Social and Crim-

inology Research in Cairo;

Egyptian academic and architect Dr Ali Abdulraouf; researcher at the Arab Centre for Research and Policy Studies Dr Hani Awad; Dr Ibrahim Morshed and Dr Ibrahim Mansouri, professors of economics at the University of Marrakech, and Dr Hussein Shukrani, professor of public law and political science at the same university; Dr Saeed al-Haji, professor of Contemporary and Current History at Abdelmalek Saadi University in Tetouan (Morocco), and Dr Abd al-Ilah Setti, professor of political science and constitutional law at Ibn Zohr University in Agadir (Morocco).





Build trust with actors and crew, and explore instinctive filmmaking, Qumra **Master Lynne Ramsay tells emerging talent**

Tighly original even when she adapts literary works to cinema, Cannes and BAFTA-award winning director and Qumra Master Lynne Ramsay was effervescent and candid in her Masterclass at Qumra 2023, the Doha Film Institute's annual talent incubator event for Arab and international cinema.

Attended by emerging filmmakers from across the world and moderated by Richard Peaa, professor of Film Studies at Columbia University, the masterclass navigated the cinematic universe of Ramsay, providing glimpses into the genius that makes her works extraordinary and resonate intensely with successive generations of audiences. The takeaway for emerging filmmakers from the session -'Build trust' — with actors and the crew so that together they realise the director's vision.

There was no prescriptive advice from Ramsay for the participants. Instead, they gained insight into a passionate and brilliant filmmaker's mind, enabling them to put themselves in her shoes as directors and bring out the best from their team.

Ramsay says it is important never to be complacent when it comes to directing actors, and to keep exploring together by getting them into the project as early as possible. The next step is to agree how far they can go, and whether their actor impulses match her own vision and then stick to her guns. All the disagreements must be addressed in the first place, to work towards building mutual trust and rapport. "You must

bring your enthusiasm to the film set, and when it's fun, it works." Her own approach to cinema is guided by the exciting prospect of "meeting people from different backgrounds, with different emotions, and understanding what prism they are looking through, and in the process uncover some kind of emotion inside you too. You must be honest and open to seeing the Ramsay says films are like

a crochet of humanity, and filmmaking is an endlessly fascinating job that enables directors to "uncover a person, moment, and time. I always feel like a student - and I always learn from my associations on a film. The key is to find a subject that hits your core." She likes to smash up her themes a bit to challenge herself, which is her way of "uncovering some truth in the subjects" she presents in her films.

Born in Glasgow, Scotland, in a working-class family that loved films, Ramsay attended a film foundation course for young kids, where she stumbled into a dark room to herself, which she calls "the magic room" that enabled her to explore with abandon.

Her original passion was photography, but she went on to graduate in cinematography and directing from the National Film and Television School. She says she hated film school, where she felt she was "thrown into the deep end" as most of her peers were more experienced in film than her.

Her graduation film, Small Deaths, won the 1996 Cannes Prix de Jury, and she continued to work on shorts, such as Gasman (1997), an intense film that too won at Cannes. Ramsay loves making short films for their ability to "speak volumes while saying little". Shorts also enable her to experiment, and she sees it as a "fun form to play with".

Ramsay's first feature film, Ratcatcher, screened in the Un Certain Regard at Cannes in 1999, stood out for its brilliant originality. She worked with non-professional actors for the film, and her cue to young filmmakers is "never to patronise [debutant non-professional actors] and to make the filmset a fun experience".

Her subsequent films, including Morvern Callar (2002), based on a novel by Alan Warner; the intense We Need to Talk About Kevin (2011), based on Lionel Shriver's novel; and the 'neo-noir crime thriller' You Were Never Really Here, based on a novella by Jonathan Ames, all gained international acclaim.

But, in making these films, she again marked a departure from the norm. None of the films were seen by the writers before they were completed, with Ramsay never resorting to a 'straight adaptation but always reinterpreting the characters' in her inimitable way.

Describing her style of filmmaking as "very instinctive", Ramsay says these films are "companion pieces" to the novels. She said she could make another movie altogether on Kevin. She said she likes to review the works by upcoming filmmakers. "I am excited to be here in Qatar after being invited for many years. Qumra is really supportive of emerging filmmakers in a very special way." On final count, here was a masterclass that did not handhold young filmmakers and took them through a preordained path but inspired them to discover the freedom in filmmaking – from ideation to the process to connecting with audiences with a new approach to storytelling.

Bomb attack kills guard, wounds journalists in Afghan north

A bomb blast in the northern Afghan city of Mazar-e-Sharif yesterday killed a security guard and wounded a group of journalists, as well as several children, police and a witness

The blast came two days after a suicide bomber killed the Taliban governor of northern Balkh province in an attack claimed by the Islamic State group.

Yesterday's blast took place during an event honouring Afghanistan's media at a cultural centre in Mazar-e-Sharif. Police said a security guard was killed and that five journalists were among the wounded. - AFP

German aviation stoppage sees more than 350 flights cancelled

A 24-hour strike by security staff at four German airports will force the cancellation of 351 flights tomorrow, their union announced, an action denounced by the airports association "One will have to expect longer queueing times as well as cancelled flights," said a statement yesterday from the Verdi union, which is pressing for better pay and conditions. The expected flight cancellations will be at Berlin, Bremen, Hamburg and Hannover airports, hitting around 100,000 passengers, airports association ADV said.

Verdi is seeking better pay for night shifts and weekend work.

Iraq seizes 3mn captagon pills hidden in apple crates at border

Iraqi authorities said they seized 3mn pills of captagon, an amphetamine-type stimulant that has been sweeping the Middle East for years, near the Syrian border.

The pills had been hidden in apple crates "loaded onto a refrigerator truck" and discovered at the Al-Qaim crossing between Syria's Deir Ezzor province and western Iraq's Anbar desert region, the Iraqi border authority said yesterday. The truck driver had been arrested.

A border authority official told AFP that the shipment from Syria into Iraq contained captagon pills produced by several manufacturers. - AFP

Indian police arrests three after man killed for possessing beef

Police in India have arrested three men in eastern Bihar state in connection with the death of a man who was attacked because he was suspected of carrying beef, a police official said vesterday.

The victim, Naseem Qureshi, 56, died earlier this week after being attacked by a mob on suspicion of carrying beef, the sale and consumption of which is restricted in some parts of the country by local governments.

Ramchandra Tiwari, head of Rasulpur police station in Bihar, where the crime took place, said by phone that three people were arrested. - Reuters

Biden scraps Trump's colour scheme for Air Force One plane

The US Air Force has unveiled a new colour scheme for Air Force One, discarding the palette chosen by Donald Trump for the presidential aircraft.

President Joe Biden is sticking with a classic blue-and-white colour scheme for the jets, which are under construction, retaining a design that dates to John F Kennedy's administration six

A red, white and blue paint scheme for the presidential aircraft, known as Air Force One when the president is on board, was proposed by Trump when he was president, but was scuttled after a study showed it would create too much heat.

Trump's design called for a deep red stripe down the middle of the aircraft and a dark blue underbelly.

The colours presented challenges to engineers, however, and a statement vesterday from the secretary of the Air Force cited possible delays and tests to deal with "the added heat" from the darker shade of blue.

The new Air Force One aircraft will instead closely resemble the ageing current one, although the light blue will be a "more modern tone" than the existing robin's egg blue, and there will be no polished metal on the fuselage "because modern commercial aircraft skin alloys don't allow for it", it said.

The replacement aircraft are projected to be delivered in 2027 and 2028, so the winner of the 2024 elections will be the first to take off in the new jets.

The Boeing aircraft are not like commercial airliners.

The Boeing Co 747-8s are designed to be an airborne White House able to fly in worst-case security scenarios, such as nuclear war, and are modified with military avionics, advanced communications and a self-defence system.

The current Air Force One planes face rising maintenance costs and use parts that are increasingly obsolete, but will have to suffice until the newer aircraft are delivered, the statement said. - AFP/

Skeleton of T-Rex to go on auction

Tyrannosaurus-Rex skeleton dating back 67mn years will be auctioned in Switzerland next month, marking the first such sale in Europe, the auction house said yesterday.

The skeleton dubbed Trinity will go under the hammer in Zurich on April 18, the Koller auction house said.

Towering 3.9m (12.8') in the air, Trinity has been valued at between 6-8mn Swiss francs (\$6.5-8.7mn), according to the auction catalogue.

However, Christian Link, in charge of natural history memorabilia at Koller, told AFP that he believed that was a "very low estimate".

Trinity is "one of the most spectacular T-Rex skeletons in existence, a well-preserved and brilliantly restored fossil", the auction house said.

The sale would mark "the first time in Europe and only the third time worldwide (that) a skeleton of an entire T-Rex dinosaur of exceptional quality will be offered at auction".

The Trinity skeleton is made up of bone material from three T-Rex specimens, excavated between 2008 and 2013 from the US. - **AFP**

Three boats overcrowded with migrants were brought safely to Italian ports yesterday, the coastguard said, as thousands of marchers remembered the

victims of last month's deadly shipwreck off

Calabria's coast. The rescue of more than 1,000 migrants came the same day as the body of the 74th victim of the deadly shipwreck nearly two weeks ago was found - that of a female child between five and six years of age, according

to Italian news agency AGI. The February 26 shipwreck, which occurred just off the shore of Calabria, has drawn sharp criticism of the right-wing government led by Prime Minister Giorgia Meloni for its failure to intervene timely to save the migrants.

Yesterday in Cutro, near the site of the disaster, thousands of marchers carried a cross made of splintered wood from the

shipwreck through the streets. "This cross is a symbol of suffering today," said Domenico "Mimmo" Lucano, a former Calabrian mayor known for his activism on behalf of migrants, as quoted by news agency

Ansa. "During these emergencies, Calabrian

communities are shaken, and what prevails is a spirit of solidarity that the government doesn't show?

More than 1,300 migrants

On Friday, the coastguard began a rescue operation of three boats, one south of the Calabrian city of Crotone and two further south off Roccella Ionica.

Coastguard videos showed a large fishing boat pitching violently back and forth in nighttime rough seas with dozens of people visible on the deck.

Other images showed inflatable rescue boats approaching another fishing vessel packed with people.

Those 487 migrants onboard the first boat were safely brought to the port of Crotone about 0200 GMT yesterday morning, the

coastguard said. Another operation in which 500 migrants were brought to safety aboard a coastguard

ship was wrapping up, it said. Ansa had earlier reported that the ship had docked at the port of Reggio Calabria.

A third boat carrying 379 people was rescued by two coastguard patrol boats and the migrants transferred to a Navy ship headed to the Sicilian port of Augusta, it said.

Italy's defence ministry said it had begun to air transfers of migrants away from the migrant centre on the island of Lampedusa, which it said was now over capacity.

The recent shipwreck has put the government on the defensive.

On Thursday, Meloni held a cabinet meeting at Cutro, near the disaster site, and announced a new decree that included stiffer prison sentences for human traffickers, but no new measures to help save lives.

Late last year, the government cracked down on charity rescue boats, accusing them of acting as a taxi service for migrants.

The charities denied this was the case. Enrico Borghi, a senator with the centreleft Democratic Party, accused the govern-

ment of bungling the crisis. "(It) thinks it can solve such a profound

problem through media posturing, the criminal code and fake efforts at appearing tough," he wrote on Twitter. "The result: landings have tripled with the Meloni government." Meloni herself issued a statement yester-

day, saying that the only solution lay with a joint European effort to strengthen the EU's borders and enhance co-operation with ex-The interior ministry says more than

17,500 people have arrived by sea so far this year - almost three times the number for the same period last year.

Hundreds have also died trying to cross the Mediterranean and reach Europe.

Only 16% of DUP voters back Sunak's Northern **Ireland deal: survey**

nly 16% of Northern Ireland's Democratic Unionist Party (DUP) voters would back British Prime Minister Rishi Sunak's recent deal with the European Union on post-Brexit trade rules if a referendum were held, a poll showed yesterday.

cidTalk for the Belfast Telegraph found just 38% of the region's wider unionist electorate would vote for the Windsor Framework agreement if a referendum were held.

While 73% of DUP voters and 50% of unionist voters would oppose the deal, 67% of all voters in the region were in favour thanks to strong support among nationalists.

Unionists want Northern Ireland to remain part of the UK, while nationalists favour a united Ireland.

The British government is not expected to need the votes of the DUP or the wider Northern Ireland electorate to ratify the agreement, which was announced in February, but Sunak had hoped to use the deal boycott that has frozen the region's devolved government.

In an apparent sign of falling support for the DUP's boycott, the percentage of unionists who said the region's devolved government should not be restored until issues around post-Brexit trade rules are resolved fell to 54% from 66% in a poll six weeks ago.

The online poll questioned 3,409 people on March 3-5. -Reuters

'Pineapple express' storm wallops California

mergency officials in several Califor- nia counties are patrolling levies and ■ swollen rivers as an "atmospheric river" storm drenched the already-sodden state with torrential rains, causing floods that washed out roads and prompted evacu-

The latest deluge from dense streams of Pacific moisture sweeping California's skies soaked some mountain areas still clogged with piles of snow dumped by a recent spate of paralysing blizzards, while bringing even more snow to higher elevations.

The San Bernardino County Sheriff's Department said it is investigating what role, if any, late-February snowstorms may have played in the demise of at least eight people, most of them elderly, found to have died alone while snowbound in their homes over the past two weeks.

Residents in the town of Big Bear and nearby mountain enclaves have said that their communities are ill-prepared for the severity of winter storms that local authorities called unprecedented for Southern California's high country.

The latest blast of heavy showers and gusty winds arrived on Thursday night and peaked early yesterday, sweeping a vast region that is home to 26mn people, including greater Los Angeles, the San Francisco Bay area and metropolitan Sacramento.

Flood watches and advisories extended from San Diego and Mexican border to the Shasta-Cascade region of north California.

The National Weather Service (NWS) reported rainfall totals ranging from 3" to nearly 10" across the region.

US President Joe Biden has declared an emergency in California, ordering federal assistance to help state and local authorities cope with the severe weather.

The move came after a request from California Governor Gavin Newsom.

The storm is the product of what meteorologists call an atmospheric river - known as a "Pineapple express" - a high-altitude current of dense, subtropical moisture streaming into the West Coast from the warm Pacific waters around Hawaii.

Forecasters said the Pineapple Express so-called because it is bringing warm, subtropical moisture from Hawaii - could cause some of that monster snowpack to melt. overwhelming river systems.

It marks the 10th such weather system to hit California since Christmas, adding to an exceptionally wet, snowy winter in a state that in recent years has been plagued far more by drought and wildfires than by severe precipitation.

Among areas hardest hit were riverfront communities in central California where numerous streams engorged by runoff of rain and melting snow from surrounding mountains were transformed into raging torrents.

About 2,000 residents were under evacuation orders and warnings in San Luis Obispo County, as crews there spent the day monitoring levees, creeks and rivers and filling sandbags, said Rachel Monte Dion, the county's emergency services co-ordinator.

Some personnel spent hours in trailers watching for flooding in low-lying areas across the county, which was pummelled by heavy downpours in January, causing a levy to fail and damaging homes.

"Since January, it's been raining steadily here and so our ground is fully saturated and our creeks are full." Dion said, adding that flooding on Friday struck parts of the coastal wine country town of Cambria and the beachfront community of Oceano.

The collapse of one roadway in Paso Robles for the second time since January left a couple hundred residents outside that town cut off again, Dion said. In Santa Cruz County, another road was

washed out by a flooded creek near the town of Soquel, leaving at least 400 homes in adjacent foothill and mountain communities isolated, county spokesperson Jason Hoppin said.

Elsewhere in the county, communities along the swiftly rising San Lorenzo River were ordered evacuated before it reached flood stage, then receded, he said.

Authorities were still keeping their eye on the Pajaro River, which drains a much larger area and thus takes longer to rise and fall, he

Evacuation orders were issued along the Monterey County banks of that river, where "the levee is a little bit lower" than on the Santa Cruz County side, Hoppin said.

On Friday morning, the weather service issued a flash-flood warning for parts of Tulare County, urging residents: "Move to higher ground now! This is an extremely dangerous and life-threatening situation."

The growing frequency and intensity of such storms amid bouts of prolonged drought are symptomatic of human-caused climate change, experts say.

The swing from one extreme to another has increased the difficulty of managing California's precious water supplies while minimising flood and wildfire risks.

Indonesia's Merapi volcano erupts

rndonesia's Mount Merapi, one of the world's most active volcanoes, erupted yesterday, spewing out smoke and ash that blanketed villages near the crater.

There were no immediate reports of casualties, the country's disaster mitigation agency said. Images broadcast on local outlet Kompas TV showed ashcovered houses and roads at a village near the volcano, located on Java Island, near Indonesia's cultural capital Yogyakarta.

The Merapi Volcano Observatory estimated the ash cloud reached 9,600' (3,000m) above the summit.

Authorities established a restricted zone of 7km from the crater after the eruption, which was recorded at 12.12pm (0512

At least eight villages near the

volcano have been affected by volcanic ash, an officer at one of Merapi's observation posts said in a statement. The volcano's last major eruption in 2010 killed more than 300

people and forced the evacuation of some 280,000 residents. It was Merapi's most powerful eruption since 1930, when about

1,300 people were killed. An eruption in 1994 left about 60 people dead. - AFP

Protesters took to the streets in France yesterday on a seventh day of demonstrations against President Emmanuel Macrophysics and Street Stree cron's unpopular pension reform plan, but not in the huge numbers authorities had expected.

reform losing steam

The protests - and rolling strikes that have affected refineries, public transport and garbage collections - aim to pressure the government to withdraw the pension plan, whose key measure is raising the retirement age by two years to 64.

According to figures from the interior ministry, 368,000 demonstrators marched through various cities.

Authorities had expected up to 1mn people to take part. As with the previous protests, yesterday's events were free of

any major scuffles with the police. On Tuesday, 1.28mn people took to the streets, the highest turnout since the start of the protest movement, according to government figures.

The government insists its reform plan is essential to ensure the pension system does not run out of money and has said it will not

The Senate, the upper house of Parliament, continued to review the reform bill during the weekend and may vote on the text tonight, moving it closer to enactment.

In a joint statement, the French unions, maintaining a rare show of unity since the protest movement was launched at the end of January, called on the government to organize a "citizens' consultation" as soon as possible. The unions plan to keep up pressure "and to keep on proving

that the vast majority of the population remains determined to say no to the proposed bill", they said.

Urgent action required to address global crisis on food and nutrition security

Globally, poverty and food insecurity are both on the rise after decades of development gains.

Supply chain disruptions, climate change, Covid-19 pandemic, financial tightening through rising interest rates and the war in Ukraine have caused an unprecedented shock to the global food system, with the most vulnerable hit the hardest.

Food inflation remains high in the world, with dozens of countries experiencing double digit inflation.

According to WFP, nearly 350mn people across some 79 countries are acutely food insecure. The prevalence of undernourishment is also on the rise, following three years of deterioration.

This situation is expected to worsen, with global food supplies projected to drop to a three-year low in 2022/2023.

The need is especially dire in 24 countries that FAO and WFP have identified as hunger hotspots, of which 16 are in Africa. Fertiliser affordability as defined by the ratio between food prices and fertiliser prices is also the lowest since the 2007/2008 food crisis, which is leading to lower food production and impacting smallholder farmers the hardest, worsening the already high local food prices.

For example, the reduction in 2022 of the production of rice, for which Africa is the largest importer in the world, coupled with prospects of lower stocks, is of grave concern.

In response to the inflation of food, fuel and fertiliser prices, countries have spent over \$710bn for social protection measures covering 1bn people, including approximately \$380bn for subsidies.

However, only \$4.3bn has been spent in low-income countries for social protection measures, compared to \$507.6bn in high-income countries, the heads of the Food and Agriculture Organisation, International Monetary Fund, World Bank Group, World Food Programme and World Trade Organisation said in a joint statement.

To prevent a worsening of the food and nutrition

security crisis, further urgent actions are required to rescue hunger hotspots, facilitate trade, improve the functioning of markets, and enhance the role of the private sector, and reform and repurpose harmful subsidies with careful targeting and efficiency.

Meanwhile, one year after Russia's invasion of Ukraine upended agricultural commodity markets, food prices remain elevated even after retreating from their record highs in early 2022, IMF said.

With two of the world's largest exporters of wheat and other crucial crops entering a second year of war, many vulnerable countries still face heightened food insecurity. Fragile and conflict-affected states, home to 1bn people, are at particular risk.

Eleven straight monthly declines have pushed food prices down 19% percent from a peak last March, FAO noted.

Inflation-adjusted prices in February remained above than the average level for recent years, though they are now back in line with levels seen before the war in Ukraine.

The composition of the FAO Food Price Index shows that vegetable oils drove the decline in prices, along with dairy and cereals, while sugar and meat are little changed from early last year.

Obviously, governments and donors must step up support for the most vulnerable, facilitate trade and market functioning, and abandon harmful subsidies.

The great global crack-up

he world is at last waking up to the ways in which economic inter-connectedness amplifies the risks of geopolitical turmoil. But while there is good reason for countries to boost resilience, a wholesale shift from integration to fragmentation, driven by geopolitical hostilities, bodes well for no-one's peace or prosperity.

The global economy is not there yet. While capital flows have declined considerably from their 2007 peak of \$12tn (22% of global GDP) – a trend that began with the 2008 crisis – economic integration remains strong. Total global trade in goods and services exceeds \$40tn – a ten-fold increase since 1990.

But, from 2016 to 2021, trade

restrictions nearly doubled worldwide, owing primarily to tensions between the United States and China. In fact, fragmentation – like globalisation before it – would not be possible without China, whose rise transformed the regional competition for economic, financial, and geopolitical clout into a global one. While some hope to balance rivalry with engagement – the European Union views China as "a partner for co-operation, an economic competitor, and a systemic rival" – the dynamics are obviously complex.

The Covid-19 crisis and Russia's war against Ukraine have also contributed to fragmentation, as they have spurred countries to embrace "onshoring," "near-shoring," and "friend-shoring" with a growing sense of urgency. Yes, the pandemic showed that efficiency and cost-effectiveness do

not necessarily square with economic security. But while adjustments are needed to strengthen supply chain resilience, returning to a world divided into economic (and geopolitical) blocs holds serious risks.

We have been here before. Recall that World War I ended three decades of economic integration, showing that "doing business together" is not a sufficient condition for peace. But it is a necessary one.

The economic costs of fragmentation

are already mounting. For starters, according to the International Monetary Fund, trade fragmentation could reduce global output by between 0.2% and 7%. Moreover, while trade and trade-related transmission channels have dominated discussions about the risks of fragmentation, international financial and monetary integration is also in peril, and the risks are not as slow-moving or moderate as many seem to think.

many seem to think.

Consider sovereign debt. Here, fragmentation is reflected in the heterogeneity of creditors and contracts. In addition, key official creditors are divided along geopolitical lines: China is the largest bilateral creditor for developing countries, having lent them about \$498bn in 2008-21. For comparison, the World Bank lent these countries \$601bn over the same period.

Debt resolution remains the gaping hole in international governance. Countries with unsustainable debt positions lack incentives to address them in a timely way; on the contrary, the fear of losing market access deters such action. But with tighter financial conditions worsening the debt positions of poor countries in

Asia, Africa, and South America – 15% of which are already in debt distress, with another 45% at high risk – an agreement on debt resolution is urgent.

The problem is that fragmentation is hampering negotiations, not least because disunited creditors eschew bailouts and haircuts – the main tools used for debt resolution. This was the case just last month, when – on the fringes of the G20 Finance Ministers' and Central Bank Governors' Meeting in Bengaluru, India – the IMF brought together representatives from the G7, China, India, Saudi Arabia, and the World Bank to strengthen the framework for resolving sovereign debt distress.

At that meeting, the G7's request that sovereign creditors accept haircuts along with private creditors fell on deaf ears. China, the largest external creditor to two of the most urgent cases – holding 35% and 20%, respectively, of the total external debt of Zambia and Sri Lanka – insisted that it was multilateral institutions like the World Bank that needed to accept haircuts, putting an agreement out of reach.

Debt resolution is an important example of the kind of international policy co-operation that is needed to avert global economic fragmentation – co-operation that must include China. But where to begin? A good starting point would be to align China's incentives with those of other bilateral creditors, multilateral institutions, and the private sector.


More broadly, the G20 should attempt to find common ground among global actors, and work to strengthen policy co-operation in areas with the broadest consensus and the least scope for political tension. For example, it

could launch a co-ordinated initiative to build a global digital platform for international remittances, which would enable migrants around the world to send money home securely and without extortionate fees.

Multilateral mechanisms are needed to prevent unilateral action from producing international spillovers and deepening economic fragmentation. As digital currencies and new platforms become available to settle crossborder payments, countries' national security concerns, domestic economic objectives, the need to create buffers against geopolitical shocks, and sheer economic rivalry will encourage them to embrace these new systems as a means of reducing their dependency on the US-dominated financial system. Financial fragmentation will become entrenched, and financial risk management will be significantly weakened. This is not a desirable path.

Over the past three decades, economic integration and co-operation enabled the global economy to triple in size, lifted approximately 1.5 billion people out of extreme poverty, and supported peace and prosperity around the world. To ensure that we do not squander these gains, let alone undermine our ability to confront the challenges of the future (not least climate change), we must find ways to uphold some level of integration and effective co-operation. — Project Syndicate

Call for tree-planting at the Qatar Foundation Earthna Summit 2023

Importance of indigenous knowledge being passed on through generations to protect the environment is driven home as event closes

Bedouin environmental activist from Qatar called on every person across the nation to plant one tree as their contribution to protecting their environment as Qatar Foundation's Earthna Summit 2023 drew

Speaking on the final day of the inaugural Summit in Msheireb Downtown Doha which explored new sustainability pathways for hot and arid climates, and how indigenous knowledge can play its part in tackling the environmental challenges of the present and future - Ali Taleb al-Henzab spoke of how lessons and practices taught by his forefathers instilled in him the importance of "taking only what we need from our environment without harming it".

In a session exploring indigenous approaches to sustainability, he told delegates: "My grandfather had a mobile school which shaped our knowledge of trees, plants, seasons, and this is why I have knowledge of how to preserve the environment that I now look to pass to my children.

"As Bedouins, we move from place to place and take only what we need so we do not drain the environment. We have learned not to cut down trees, and how to use the water we gather when it rains. We did not have any waste because we carried out what is now called recycling. It is about making the best of each and every component of our environment, because if we do not have an environment, we do not have anything."

Al-Henzab - who runs an agricultural initiative and preserves endangered Qatari plants, while also distributing small trees to schools in Qatar - described Islamic values as "a great protection for the environment", and said: "We should go back to our forefathers for at least half-an-hour a day and they should be part and parcel of our schools because they can give us guidance on how to protect the environment.

"All of us are fallible. All of us make mistakes. But what is important is that we incubate ideas and support young people who have initiative, as well as teaching them to plant trees and giving them the opportunity to do this so that it grows in their hearts. We want children to take the initiative in the realm of sustainability.

"I hope that each of us in Qatar will plant one tree, or preserve one. This is the job of every person living in this country. And if you cannot plant, at least deliver the message about the need to plant, and do not cut trees down. Our forefathers were able to develop environmental solutions despite the fact they had limited resources, and this should expand generation that our legacy can be a sustainable one."

Earthna summit spotlighted Yemen experience in sustainability. Former Yemeni minister Abdulrahman al-Eryani highlighted



the importance of native knowledge as main source for sustainable development in a panel discussion at the Earthna Summit 2023 and shed light on Yemen's experience in sustainable development where Abdulrahman al-Eryani, former minister of water and environment of Yemen, spoke about the challenges his country faced to achieve the goals of sustainability.

During a fireside chat - that part of a twoday conference hosted by Qatar Foundation's Earthna Center for a Sustainable Future - moderated by Habes Howail, External Relations Manager, CEO Office, Qatar Foundation (QF), ability are environmental changes that affect seasons - causing an increase in floods and torrential rains, or droughts during some seasons, and hurricanes that lead to coastal erosion and

destruction of marine environment.

He pointed out that to achieve sustainable development, environmental patterns must be preserved, which are fragile systems in hot and dry areas which already pose an additional challenge.

"To achieve a balance between economic and environmental development, there must be a common vision between the political leadership, local community, the private sectors, which would make sustainable development more efficient and less expensive," al-Ervani said.

"A positive experience from Yemen is from lifestyle was followed by the people there to preserve and protect the environment. The island community realised the importance of following the path of sustainable develop-

ment for any growth process that the island is going through, which contributed to achieving great results."

Al-Eryani addressed the issue of water security, saying: "There must be a national agreement that water is a common resource, and preserving it is the responsibility of all community members, and that providing water for humans and animals is a priority."

During this talk, al-Eryani stressed on the importance of native knowledge and local environmental habits which were formed and practised over thousands of years as a main

source for sustainable management. mental legacy, of which soil, water, vegetation and wild animals are part, and the most valuable part is the indigenous local knowledge that helped preserve the environment in the

past, and that should form the basis of our knowledge today.

"This knowledge must be documented in a scientific way and then the basic principles must be extracted from it. And this can be taught to future generations so that it is not limited as oral information only."

Invitation-only Global Security Forum starts in Doha tomorrow

As the world looks back on the 20th year of the post-Iraq conflict, there will be a dedicated session, organised in partnership with the New American Foundation, focusing on the lessons learned from the conflict's impacts and implications for contemporary global security, regional dynamics, emerging threats, and US influence.

The event will focus on the issue of mediation and conflict resolution amid today's security and diplomatic challenges, with framing remarks from HE the Assistant Foreign Minister for Regional Affairs Dr Mohamed bin Abdulaziz bin Saleh al-Khulaifi.

Later, a panel comprising Aaron Nuutinen of the US State Department, former Burkina Faso foreign minister Djibril Bassole, and Dr Monica Juma, National Security Adviser to the Kenyan president, will examine lessons learned and good practices in mitigating conflicts, including through mediation, conflict prevention mechanisms, and defence and diplomatic engagement, with reflections on diverse regional dynamics, including in Africa and the Middle East.

Meanwhile, as many Western nations battle with the energy fallout of recent geopolitical shifts, the forum will examine the means of fostering energy security amidst shifting geopolitical dynamics in a session that will reflect on the global energy crisis and the implications of regional dynamics and the ongoing war in Ukraine for Europe and the Middle East.

The session, which will be moderated by Paul Wallace (of Bloomberg Middle East Energy and Commodities), will unearth the views of former US assistant secretary of state for en-

ergy resources Frank Fannon, assistant dean of the New York University Centre for Global Affairs Dr Carolyn Kissane, Rapidan Energy Group chief executive Scott Modell, and Dr Damilola Olawuyi, professor and Unesco Chair on Environmental Law and Sustainable Development at Hamad Bin Khalifa University's College of Law.

The future of Afghanistan is also high on the forum's agenda, with a session reflecting on the country's future prospects, particularly in relation to security, governance and human rights.

Bloomberg opinion editor Bobby Ghosh will moderate Centre for Conflict and Peace Studies chairman and former Afghanistan deputy foreign minister Hekmat Karzai, Centre for Strategic and International Studies visiting fellow and former Afghan parliament second deputy speaker Fawzia Koofi, and Saad Mohseni, co-founder and chairman of MOBY Media Group, through the complex pathways to

The forum will also investigate global perspectives on the religious militant threat, the roles of cities in fostering resilience and preventing violent extremism and the spectrum of conflict in Africa.

There will also be a special panel examining the practice of hostage-taking by state and non-state actors, with introductory reflections from Roger Carstens, the US's special presidential envoy for hostage affairs, while Christopher O'Leary, the Federal Bureau of Investigation (FBI)'s director of Hostage Recovery Fusion Cell, will number among the panellists.

Technology's emerging influence will come under the forum spotlight in a dedicated session organised in partnership with the UN Security Council Counter-Terrorism Executive Directorate and involving Dina Hussein, Meta (Facebook parent company)'s global head of policy development and expert partnerships, and Amy Larsen, director of strategy and business management at Microsoft.

The session will see international experts scrutinise terrorism and technology in a post-coronavirus (Covid-19) world the potential human rights implications of use and abuse of emerging tech, misinformation/dis-information, conspiracy theories, online abuse and its intersections with gender, and consider future challenges for policymakers, practitioners, and communities.

There will also be dedicated panels exploring countering extremism, hate and disinformation online and international violent far-right movements and the countermeasures of states and global organisations.

Forum findings will be compiled into a key-insights report to provide an overview and strategic assessment of the security matters and policy recommendations to meet the range of 2023 security challenges.

The Global Security Forum 2023, hosted by the Qatar International Academy for Security Studies (QIASS), is being held in co-operation with several high-level agencies and institutions, including the United Nations Counter-Terrorism Committee Executive Directorate (CTED), the New America Foundation, Qatar's Hamad Bin Khalifa University, Defence One, the Centre on National Security at Fordham Law, the Strong Cities Network and the Airey Newy Trust
