### **Amir appoints Shura** secretary-general

His Highness the Amir Sheikh Tamim bin Hamad al-Thani issued yesterday Amiri Decision No. 11 of 2024, appointing Nayef Mohamed Abdullah Zaid al-Mahmoud as Secretary-General of the Shura Council. The decision is effective starting from its date of issue, and is to be published in the official gazette. (ONA)

### **Israel committed** acts of 'genocide'

A UN rights expert said yesterday there were "reasonable grounds" to determine that Israel has committed several acts of "genocide" in its war in Gaza, also evoking "ethnic cleansing". "The overwhelming nature and scale of Israel's assault on Gaza and the destructive conditions of life it has inflicted reveal an intent to physically destroy Palestinians as a group," Francesca Albanese, the United Nations special rapporteur on the rights situation in the Palestinian territories, concluded in a report.

### **Boeing CEO to exit as** safety risks mount

Boeing announced yesterday a leadership shakeup headlined by the departure of CEO Dave Calhoun as the aviation giant faces heavy scrutiny following safety incidents and manufacturing issues. Besides Calhoun, who will stay in his post through the end of 2024, Boeing announced two other major changes. Stan Deal, Boeing's head of commercial airlines since 2019, will exit immediately. while the company's chairm Larry Kellner, will depart after the company's annual meeting this spring.

### Trump gets respite in \$454mn fraud ruling

Donald Trump won a bid yesterday to pause his \$454mn civil fraud judgment if he posts a smaller \$175mn bond within 10 days, in a victory for the former US president that blocks New York state authorities from taking steps to seize his assets. The decision eases an acute cash crunch for Trump, who has said he would be forced to sell assets at "fire sale prices" to post bond in the case. It delays enforcement of a judgment in a case that found he overstated his wealth to dupe investors and lenders.

### **Moscow attack: Putin** refuses to blame IS

Russian President Vladimir Putin is refusing to blame the Islamic State (IS) for the Moscow attack despite a claim by the extremist group, instead insinuating a link to Ukraine in a possible bid to limit the responsibility of the Russian security services. IS claimed the attack Friday that left at least 137 people dead. Putin acknowledged that "radical Islamists" had carried out the attack but made a link with Ukraine.

## **UN Security Council demands Gaza truce**

### • Failure to implement resolution would be unforgivable: Guterres War will not end until the hostages are freed: Israel

Washington

fter more than five months of war, the UN Security Council for the first time yesterday demanded an immediate ceasefire in Gaza after the United States, Israel's ally which vetoed previous drafts, abstained.

Drawing unusual applause in the normally staid Security Council. all 14 other members voted in favour of the resolution which "demands an immediate ceasefire" for the ongoing Islamic holy month of Ramadan.

The resolution calls for the truce to lead to a "lasting, sustainable ceasefire" and demands that Hamas and other militants free hostages seized in their October 7 attack.

"The bloodbath has continued for far too long," said Amar Bendiama, the representative of Algeria, the Arab bloc's current member of the Security Council and a sponsor of the resolution alongside a diverse group that included Slovenia, Switzerland, Japan and South Korea.

"Finally, the Security Council is shouldering its responsibility,"

UN Secretary-General Antonio Guterres demanded that the resolution be implemented. "Failure would be unforgivable," Guterres wrote on X.

Palestiniar sour fought back tears as he said that the resolution should be a "turning point" in ending the war.

The United States had repeatedly blocked Security Council resolutions that put pressure on Israel but has increasingly shown frustration with its ally as the United Nations warns of impending famine in Gaza.

Moments after the United States declined to veto the latest resolution, Netanyahu announced that he would no longer send to Washington a delegation requested by President Joe Biden to discuss Rafah.

The resolution "gives Hamas hope that international pressure will allow them to accept a ceasefire without the release of our abductees," Netanyahu said.

### **Qatar welcomes resolution**

Qatar welcomed the UN Security Council's resolution calling for an immediate ceasefire in Gaza during the blessed month of Ramadan, expressing hope that it represents a step towards a permanent cessation of hostilities in the Strip, particularly given the dire humanitarian situation affecting civilians, including children and women. The Ministry of Foreign Affairs

implementing the resolution, especially the cessation of hostilities, facilitating the urgent and unimpeded entry of humanitarian aid into all areas of the Strip, and engaging positively in the ongoing negotiati stressing in this context the continued mediation of Oatar. in co-operation with partners. to stop the war on Gaza, and addressing its humanitarian repercussions. US ambassador to the United Nations Linda Thomas-Greenfield, who had previously warned that pressure on Israel would ieopardise ongoing talks, said that Hamas must now accept the deal to free hostages.

"A ceasefire can begin immediately with the release of the first Thomas-Greenfield said. "This is the only path to securing a ceasefire."

### **Israel pounds Rafah** despite truce calls

Israel's military carried out new airstrikes in Gaza and laid siege to two hospitals yesterday, despite what the UN chief called a growing international consensus to tell Israel a ceasefire is needed Rafal came under heavy fire in the latest Israeli attacks, witnesses said. Palestinian medics said 30 people had been killed in the previous 24 hours in Rafah.

### US 'perplexed' by scrapped Israeli visit

The White House said yesterday it was "perplexed" and "disappointed" by the cancellation of an Israeli delegation's planned visit to discuss US concerns over a possible offensive in southern Gaza. Israel scrapped the visit after the United States abstained from a UN Security Council vote demanding an "immediate ceasefire" in Gaza.

### **Countries call** for immediate implementation

"We call for a permanent cessation to this criminal war and Israel's immediate withdrawal from the Gaza Strip," he wrote. **United States - Following** the vote, the United States said a ceasefire can "only" be implemented once Hamas begins

releasing hostages it still holds. **EU -** Top European Union officials welcomed the resolution. calling for a ceasefire and the unconditional release of hostages. "Implementation of this resolution is vital for the protection of all civilians," EU President Ursula von der Leyen wrote on X.

France - France's UN representative called for a sustained truce between Israel and Hamas beyond the ongoing month of Ramadan.

**Spain -** Spanish Prime Minister Pedro Sanchez applauded the resolution, saying it was "in line with what Spain has been saving since the start of the conflict. The Netherlands - Outgoing **Dutch Prime Minister Mark Rutte** welcomed the resolution, adding, "What is now needed is to stop the violence, free the hostages, immediately send in vastly more humanitarian aid to Gaza.

## Blockchain tech to help realise Qatar's sustainability efforts

atar's drive for sustainability can be supported through blockchain technology by creating an efficient energy marketplace, a Qatar Foundation (QF) scientist noted.

"Blockchain technology is a decentralised digital ledger that uploads and presents data in a transparent and secure manner, using a network of computers to approve transactions without the need for a central authority," said Dr Amani Boumaiza, a scientist at Qatar Environment and Energy Research Institute (Qeeri), part of Hamad Bin Khalifa University.

"However, it is now being used across a variety of fields - such as healthcare and real estate - and Qeeri is coupling it with Artificial Intelligence to create an efficient energy marketplace. It is aiming to achieve this by encouraging people to shift to renewable resources and reduce reliance on non-renewable energy through energy trading," explained Dr Boumaiza.

According to the scientist, as a secure, transparent, and efficient way to share data,



blockchain has the potential to transform everyday transactions across a variety of

She continued: "Blockchain is important as it is helping to drive sustainability. The technology will offer new, innovative ways to reduce carbon footprint - which is also

one of the main goals of Qatar National Vision 2030."

Dr Boumaiza uses the community housing at Education City as an example, as this is the project's test bed. There are 623 houses and most of these have Solar Photovoltaic installations, allowing sunlight to be converted into electricity.

She highlighted: "In this situation, for example, I produce energy from my roof. Whenever I produce an excess of energy, I can share this energy or sell it to my neighbours, for which I would get tokens as a reward. I could use those tokens, for example, to reduce my energy consumption invoices.

'Trading energy among peers means that if I have an excess of energy, I can sell it to my neighbours at a competitive price, compared to the price on the market." To Page 4



## Qatar Charity constructed 700 mosques in Bangladesh over 5 years

atar Charity (QC), with the support of philanthropists in Qatar, has completed the construction and equipping of 32 mosques in various areas of Bangladesh in less than a year, providing a comfortable and safe environment for over 10,000 worshippers. Additionally, 700 mosques have been constructed across the country in the past five years, benefiting over 200,000 worshippers.

This comes in conjunction with the 'Double Your Ajir' campaign launched by Qatar Charity to run in the second ten days of Ramadan. The campaign aims to provide clean drinking water and housing for needy families, as well as to construct mosques at the lowest possible cost.

The construction of mosques was initiated due to the financial inability of local communities in villages and remote areas, as they had to use bamboo wood and zinc sheets to build their mosques, which did not provide a safe and suitable worship environment.

The construction of these 32 mosques took approximately 8 months, starting in August 2023 and completing in the current month of March. The area of each mosque ranges from 70 to 150 square meters, accommodating between 250 to 400 worshippers. Additionally, each mosque has been wonderfully designed and

equipped, as well as provided with carpets, loudspeakers, ceiling fans, and copies of the Quran before being handed over to local authorities.

Md Bachchu Mia, the president of the Mosque Committee in `Chitrovishram' village of Magura district, expressed gratitude to the benefactors who made it possible to replace their old and dilapidated mosque with a new one.



"We are trying to not go through the main utility grid, and so we are creating a decentralised paradigm. This helps consumers to have greater control over their energy choices and they do not have to rely solely on large companies for energy

Dr Boumaiza noted that the idea of the blockchain is to automate the trade and exchange of energy through AI, as it can gather and analyse data from sensors, identify patterns, make predictions, and optimise energy consumption.

"So, as a household, I will not re about what's going on within the system - everything will be automated. And this automation uses 'smart contracts' which is an AI technology, where everything is coded in a separate file.

And this smart contract is automated; it will orchestrate the trade, determine the price of the energy, and match the best buyers with the best sellers," pointed out the scientist.

Dr Boumaiza added that the Oeeri team is currently trying to encourage people to increase their use of green energy. "One method we are implementing is a system where individuals can trade in their revenue or tokens for incentives, benefiting both themselves and the environ-

These incentives may range from reduced utility bills to vouchers for environmentally friendly products, resulting in a mutually beneficial outcome."







Designed to ensure a safe and comfortable environment for displaced families, the QRCS-constructed model village comprises 30 housing units, with all utilities such as water supply, electricity,


sewage, school, and mosque.

## Qur'an ... The Word of Allah

The Noble Qur'an is the eternal miracle of Prophet Muhammad, sallallaahu 'alaihi wa sallam. Every Prophet was supported with a miracle(s) and upon his death it disappeared, except Prophet Muhammad whose miracle remained, preserved and protected, namely the Book of Allah, His divine revealed Word. Allah Says (what means): "Falsehood cannot approach it from before it or from behind it." [Qur'an 41:42]

Allah clearly stated that the Qur'an is His Word, Saying (what means):

"And if any one of the polytheists seeks your protection, then grant him protection so that he may hear the Words of Allah [i.e. the Qur'an]." [Qur'an 9:6], and in His Saying (which means): "Those who remained behind will say when you set out toward the war booty to take it, 'Let us follow you? They wish to change the Words of Allah." [Qur'an: 48:15] These two verses prove that the Qur'an is the Word of Allah and that He sent it down to Prophet Muhammad, sallallaahu 'alaihi wa sallam.

The Sunnah of the Prophet (his sayings) further proves this fact; Jaabir, may Allah be pleased with him, narrated: "The Prophet used to offer his message to people during the season of Hajj and say: "Is there a man who would take me to his tribe (i.e. to convey the message to them), because the (tribe of) Quraysh have prevented me from conveying the Word of Allah?" [Ahmad & At-Tirmithi]

There are many logical and substantial evidences proving this fact, such as the inability of the polytheists to come up with one single verse, let alone a whole chapter, that is similar to it. This is so, despite their eagerness and ambition to prove the Prophet wrong in what he was calling to, and their strong command of the Arabic language in which the Qur'an was revealed. Undoubtedly, this is evidence that



the Qur'an is not made by or the words of humans.

The Qur'an contains news of past nations and other unseen matters which serve as great proof that it is the Word of Allah. When the Persians defeated the Romans in battle, the Qur'an addressed the issue and informed that the Romans would overcome the Persians in few years to come as Allah Says (what means): "The Romans have been defeated (i.e. By the Persians) in the nearest land. But they, after their defeat, will overcome." [Qur'an 30: 2-3]

Furthermore, the Qur'an consists of scientific miracles by highlighting certain scientific facts which were not discovered except fourteen centuries later, such as the Qur'an proving that there is a barrier between the salty water and fresh water where they meet preventing them from mixing, as Allah Says (what means): "He released the two seas (the two bodies of water: fresh and salt), meeting [side by side]. Between them is a barrier [so] neither of them transgresses. [Qur'an 55: 19-20] Modern science discovered this to be a fact.

The fact that tranquility and assurance can be found upon reading the Qur'an which is not felt when reading any other book, is yet another proof that it is the Word of Allah, as Allah Says (what means): "Those who have believed and whose hearts are assured by the mention of Allah. Unquestionably by the remembrance of Allah hearts are assured." [Qur'an 13: 28]

Furthermore, being cured by virtue of reading the Qur'an over a sick person can be added to the list of evidences proving it to be the Word of Allah. Allah Says (what means): "And We send down of the Qur'an that which is healing and mercy for the believers." [Our'an 17: 82]

Lastly, the evidences proving the Qur'an to be the Word of Allah are too many to numerate in one article, and so we conclude with the saying of Al-Waleed Ibn Al-Mugheerah, one of the leaders of the polytheists who was requested to criticise and censure the Our'an. After hearing parts of it from Prophet Muhammad, sallallaahu 'alaihi wa sallam, he said: "What can I sav? I swear by Allah! There is no man who knows poetry better than me, and it does not sound like anything I ever heard. The only thing I can say is that it has sweetness to it, and it is so appealing. It is so fruitful (to the heart) and abundant (in its benefits). Indeed, nothing rises above it in style, and it surely destroys anything that challenges it." [Al-Haakim & Al-Bayhaqi]

This is the Qur'an, the Word of Allah, which confounds humans' capabilities due to its inimitable style, justice and accuracy. The Qur'an still challenges people and people remain incapable of challenging it, and it remains the clear evidence from Allah against its enemies and opponents. All efforts to deny its authenticity have failed.

## Markets ready for more as Switzerland starts clock on rate cuts

Markets are racing ahead to bet on big central banks lowering borrowing costs after Switzerland last Thursday delivered a surprise rate cut, but analysts cautioned that policymakers elsewhere won't find it as easy to call time on the inflation fight.

The Swiss National Bank (SNB) lowered its key rate to 1.5% from 1.75%, with traders responding by pushing government borrowing costs across Europe lower as the continent's Stoxx 600 share index hit a fresh

Caution remained as to whether the US Federal Reserve would rush rate cuts given that inflation in the world's biggest economy is running

Still, investors viewed the Swiss decision as a landmark and traders laid down strong bets for June cuts by the European Central Bank (ECB) and the Bank of England (BoE).

Some analysts said these rate-setters could even risk a bout of inflationary currency weakness in a strong-dollar environment by moving before the Fed.

"I doubt anyone would think Switzerland is the sun around which everyone else gravitates, but the fact they have crossed this threshold has to matter," said Chris Jeffrey, head of macro strategy at Legal & General Investment Management.

Money markets moved to price a 90% chance of an ECB rate cut by June from less than an 80% chance late on Wednesday. BoE expectations moved to a roughly 70% chance of a June cut, from less than 60% on Wednesday.

Jeffrey tipped both the ECB and the BoE, to lower borrowing costs in June, with the Fed perhaps waiting longer.

The BoE held rates at a 16-year high of 5.25% on Thursday but said the economy was heading in the right direction for cuts.

Unlike in the UK and the eurozone, the headline inflation rate in Switzerland, at 1.2% in February, is within the SNB's 0-2% target range.

Nikolay Markov, senior

economist at Pictet Asset Management and a former SNB staffer, said Switzerland was unique among major central banks in having started to worry about inflation falling too far as its currency had strengthened.

"They were worried that the deflationary impact from a strong Swiss franc will persist, and that was the key trigger for them to start the easing cycle earlier than any other developed market central bank," he said. The Swiss franc, which rose over 6% against the euro last year, fell to nine-month low against the currency on Thursday and dropped over 0.5% against the dollar as the SNB widened the rate gap between Switzerland and its peers.

Elsewhere, after the BoE meeting the yield on the interest ratesensitive British two year gilt was 12 bps lower on the day at 4.23% as the price of the debt rose, heading for its best daily performance in almost a month.

Germany's equivalent bond yield fell 6 bps to just over 2.9%. Bonds tend to get a boost from lower rates, which flatter the real income return from the fixed interest-paying securities.

Salman Ahmed, global head of macro and strategic asset allocation, Fidelity International, cautioned the Fed could wait longer to start easing borrowing costs and that the ECB and the BoE risked currency weakness and more inflation by going first.

The Fed on Wednesday, after hotter than expected US inflation data for February, stuck with its projections for three 25 bps rate cuts in 2024 but also substantially raised its economic growth forecasts. "We have a Fed which wants to cut, it wants the opportunity to start

the cutting cycle but the data is not giving them that entry point,"

"It is the potential FX moves that obviously worry (the ECB)," he said,  $adding\ that\ \bar{}the\ inflationary\ pressures\ from\ a\ weak\ pound\ would\ create$ 

even more of a challenge for the BoE. UK inflation decelerated to 3.4% in February, but was still above the BoE's 2% target.

## 'Wild West' of neuroscience drives new brain privacy laws

S neurologist Sean Pauzauskie used to rely exclusively on expensive and cumbersome hospital kit to capture his patients' brainwayes and analyse problems in their electronic pathways.

But in recent years, the Colorado doctor turned to consumer headbands, commonly sold online to monitor sleep patterns or boost brain function, to capture the brain activity of some patients suffering seizures.

Cheaper and easy to use, the headbands - which can cost just a few hundred dollars - capture similar electronic data as stateof-the-art hospital machines, only with far less fuss.

"In the beginning I w I thought: 'patients can even do all this themselves, at home," he told the Thomson Reuters Foundation.

"But then I thought: 'wait a second, that means all their brain data is going to some private company?"

Advances in brain science have made it easier to capture detailed data flows for the human brain and interpret their meaning. Some recent experiments have also shown the possibility of manipulating thoughts through neurological intervention.

By processing electronic brain images with artificial intelligence (AI) systems, researchers at the University of Texas were even able to accurately predict what words were running through a participant's head.

These kinds of advances have led to big breakthroughs, letting some paralysed patients communicate via brainwaves or helping rewire dormant neural pathways after spinal injuries.

"I am confident that in the next couple of years there will be many devices that can read your thoughts," said Pauzauskie, who is excited to gain this new insight into how minds work.

But he also fears a potential for

So Pauzauskie recently joined a coalition of lawmakers and scientists pushing Colorado to become the first US state to enshrine privacy guarantees for brain data.

Legislation passed the Colorado assembly last month, on a vote of 61-1, and now goes before the

It is part of a trickle of bills under consideration countrywide, united by the common aim of ensuring that what goes on in a brain belongs to its owner can stay private.

Lawmakers in Minnesota introduced their own bill in

California - which often sets the pace for privacy rules - is also preparing a law that could be introduced within weeks.

Experts say the push for 'neural

rights' is a rare attempt to lock consumer protection into an emerging technology before its mass adoption. Some gadgets that capture

brain data — with the potential to resell or share that information are already on sale, and a number of start-ups plan to roll out devices soon. "We want more guidance

from lawmakers," said Adam Molner, co-founder of Neurable, a company developing headphones that can monitor brainwaves. With its first product due to

brain data, and will expressly ask users for consent before its collection. Major companies have not yet rolled out consumer devices that

interact with the brain, though many firms - including SnapChat and Meta – are working on the technology.

Last year, Apple filed a patent for airpods that could monitor electrical activity in the brain. "We have a real patchwork of

laws when it comes to this data." said Sara Pullen Guercio, a lawyer with the privacy group at Alston & Bird who is tracking US neural rights legislation.

While neural data gathered in a medical setting is covered by health data protection laws, she said that same data gathered for commercial purposes was much more loosely regulated.

"What we don't want West for neural data," she said.

The United States has no federal privacy laws, and while 15 states have passed their own versions of legislation, none directly addresses neural data, said Jared Genser, a lawyer and co-founder of the Neurorights Foundation.

The Neurorights Foundation backed the Colorado law, which would insert neural data into the state's existing privacy bill under the category of "sensitive data".

Companies would then need consent before collecting neural data, and would have to give customers options to limit what can be done with it as well as the right to delete it.

"Neural data is really missing from these existing laws in a large part because people were not thinking of it when they were drafting these laws," Genser said.

The Foundation wants to enshrine rights for the brain around the world: last year. Chile issued the first ever ruling demanding that illegally collected brain data be deleted.

Pauzauskie, the Colorado neurologist, approached his state assembly member Cathy Kipp at a recent fundraiser to raise his concerns about unregulated neural data.

"The fact that a company could capture your brainwaves today, and then resell them and then those brain waves could be used for something totally different in five years — that's a problem," she told the Thomson Reuters Foundation.

As the bill moves through the legislature, there's been back and forth with tech industry groups about how to define neural data and the devices that collect it, Kipp said. She wants to make sure the

language remains broad enough to capture future developments in what is a quickly evolving field: neural data that is recorded by a headset today could be gathered by a wristband tomorrow, she reasoned.

David Stauss, a Colorado lawyer who focuses on privacy law, said the Colorado bill is part of a national pattern: states are increasingly tweaking privacy laws to cover sensitive data.

For example, Oregon and Delaware recently amended their bills to add transgender and nonbinary status to their definitions of sensitive data.

In Minnesota, which does not have a state-level privacy law, lawmakers are taking a different tack. They are proposing a law to enshrine "cognitive liberty" and impose penalties for accessing brain data or using neural technology to interfere with thoughts without consent. "Far too often we wait for bad

things to happen, and we respond to a crisis after people have been harmed," said Walter Hudson, a member of the Minnesota state house pushing the bill.

State Senator Josh Becker in California is preparing a draft of a neurorights bill in California to be unveiled this month.

"I am focused on making sure that people own their own neural data," said Becker, who previously spearheaded state legislation to rein in databrokers. It's still not clear exactly how

this patchwork of laws will impact industry, said Rachel Marmor, a privacy law expert at the firm Holland & Knight.

"Until there's a bunch of enforcement actions it's going to be hard to move the needle on how businesses approach this," she explained.

But with any privacy law, there's a risk that compliance comes down to checking countless boxes on a myriad of forms and clicking through long, complex privacy policies, she warned.

"Forcing people to read thousands of privacy disclosures a year is not going to be workable here," she said. — Thomson **Reuters Foundation**

n the pantheon of Pakistani entertainment, few names resonate as

profoundly as Sanam Saeed's. An actress of rare versatility and depth, she has carved a niche for herself in an industry that is both vibrant and competitive. Perhaps best known for her role in the critically acclaimed drama Zindagi Gulzar Hai which made waves both in her native

Pakistan and across the border in India, Sanam has showcased an exceptional ability to bring complex characters to life, earning her a dedicated fan base and critical acclaim both domestically and inter-Beyond reel life, she is a real life hero,

too, lending her time and energy for humanitarian causes. Sanam was in town over the weekend for something similar - raising awareness about cancer - at the annual Ramadan event organised by Friends of Shaukat Khanum Memorial Trust (Qatar) in Doha.

In an exclusive interview with Gulf Times, Sanam spoke at length about the cause she so fervently espouses, her love of Qatar, and, last but not least, her dynamic acting career across television, cinema, theatre, music and now, web se-

Born on February 2, 1985, in London, UK, and raised in Karachi, Pakistan, her journey from a budding theatre artist to a leading television and film actress mirrors the evolving landscape of Pakistani entertainment.

Excerpts from the interview:

Before we venture into your career as an artist, please tell us about how you came to espouse a real life role such as being an ambassador for Shaukat Khanum Memorial Cancer **Hospital (SKMCH)?** 

I knew about SKMCH and the healthcare they were providing to cancer patients and how it was a huge support system for people in need. Personally, I experienced it closer home with my mother diagnosed with breast cancer, and so I could resonate with the cause and was passionate about trying to spread awareness on prevention through early detection.

Television and media are powerful mediums. I was able to learn quickly about the influence and impact our roles on television have on the public, especially

young women, not many of whom are exposed to avenues of information from where they could learn about their fundamental rights.

In fact, I made it my mission to choose roles that would have these empowering messages for women. We made dramas on child abuse, mental health issues, and the like. And so that is how my "social work" is done through my work. Secondly, anything I believe in strongly, I'm happy to contribute as ambassador.

There's Shaukat Khanum, The Citizens Foundation, Kiran Foundation, Hunar Foundation and the like that each cater to different needs whether it's cancer treatment, free education, vocational training centres or improving the community's overall well-being. These organisations just need that extra push and support to spread awareness and raise funds. I'm grateful to have the honour of being their voice where needed.

I think there's more awareness and recognition now, which is all very important given that Pakistan is a country with one of the highest breast cancer rates in the world. With all the work it does, SKMCH has enabled the message to reach across



homes in Pakistan.

Tell us about your Qatar experience. What is it that you like most about the country?

My Qatar experience is serene. It's a beautiful country. I have a very close friend here so it feels like coming home. I was busy at the time of the FIFA World Cup, but I heard about the enriching experience it was. It was lovely see the whole world come to Qatar and respect the local culture and appreciate the hospitality. So there were big takeaways from their trip to Qatar. It is always a pleasure to visit Qatar.

From your initial start in TV with a supporting role in Daam to playing complex characters in serials like Zindagi Gulzar Hai and Diyar-e-Dil, how do you think your acting approach has evolved over the years?

It evolves with every project because every project brings a new director, which brings a new approach, which brings a new aesthetic, a new style. So I'm constantly learning and evolving through my directors, scripts and definitely, through the energy that the cast brings. And then, difficult as it is to watch one's own past work, I've been doing that to learn (from the experience) and see what works and what doesn't. I think it was the greatest way I could teach myself and evolve as an actor.

Your portrayal of Kashaf Murtaza in Zindagi Gulzar Hai received widespread acclaim and numerous awards. What do you think made your character and this serial resonate so strongly with audiences in both Pakistan and India?

Kashaf Murtaza's character was the story of any young girl in the subcontinent who experiences certain biases, whose path is riddled with obstacles, particularly father issues, financial issues, low self-esteem issues. And finally finding a suitable life partner. This is something many young girls experience, which

is why I think people felt very close to the character as they could relate to it.

You've successfully transitioned from TV to film, receiving critical acclaim for your roles in movies like Cake. How do you prepare for these different mediums?

Television is a very 'close-ups' medium; there are lots of close-ups and so your expressions come into play with tighter lens so that the people size up the expressions, emotions and the feelings actors are going through. In contrast, in cinema, you have wider lens, wider shots and open space. And because you have a huge screen, you can show the environment in which the characters perform.

Technically, on the big screen you have to be aware of your movements and body language, given that nothing is hidden in terms of detail from the viewer.

On television, you might still get away with things, but not on the big screen, where the tiniest flaw can stand out like a sore thumb. The theatre background helps a lot with the latter as you learn movements. In terms of preparations, a lot depends on the director: how much they want you to act, emote: do they want it loud, understated, very suttle, or very deadpan.

You had four film releases in 2016. which in itself is a statement. These must have been in the works, but

how did you juggle different roles in that length of time?

These Indie films - or art films as they are sometimes referred to - were shot over several years, but they all happened to come out at the same time, which is interesting. This underpins my love for doing diverse roles.

Finally, what is your take on the current fare on the small screen in Pakistan? Are they substantive in terms of content or suffer from formulaic inertia?

You can't have great content all the time; at any given time, there will be one diamond in the rough, may be two that stand out in the crowd and make an impact. But you have to keep going at it. There's a lot of talent in terms of actors, directors, writers. The channels are there to provide the platform - so we've got a lot of potential. The fact is that, in Pakistan, what has really helped the economy in our field is television, sustaining the media industry.

There is speculation that you're doing web series and something big is coming up. What can you tell us about that?

I have been doing web series more recently only out of my love for diversity; hopefully, the projects will come up before the end of 2024 on several different online streaming platforms.

## Preserving heritage: The spirit behind popular games

opular games are considered an integral part of the patrimony of all nations and have great significance in social upbringing and paid special attention to children by including them in stories, songs, chants, games, popular proverbs, as well as popular and expressive arts, which engage children more with the past in the face of the influence of material values. This prompts the significance of maintaining human heritage as popular games find a place for them in memory.

The popular games are any game people have been practicing since childhood that are inherited throughout generations and adding to them new details. These games are equally practiced by both genders and are commonly related to songs with some sort of kinetic steps and roles distributed by children among them before the start

of the game. They learn these games without guidance or instructions from adults. but only through watching others.

Speaking to Qatar News Agency (QNA), researcher in the heritage Saleh Gharib highlighted that popular games had a profound role in the past, especially in the holy month of Ramadan and its beautiful nights, pointing out that there many mental games that are being played until this day in Qatar, notwithstanding the civilisational evolution in the region, as these games are part and parcel of the daily life of children and they draw on kinetic ac-

Gharib stressed the profound role of these games in the values of the child's socialisation, along with their contribution to the formation of children's personality, which imbue them with the physical strength to overcome fatigue, especially

when the holy month of Ramadan coincides with the hot weather.

Notwithstanding the social change made in the Gulf states after popular games and their prototypes have debuted in the region, they remained constant and did not diminish by virtue of the community that recognises their value and significance, he said.

Since he is a researcher in the popular heritage, Saleh Gharib stressed that he strenuously advocates for the return of the popular games and reduce the children's predilections for the electronic games that have manifestly obscured the activity of the popular games.

He highlighted that there are myriad factors that prompted children to pivot away from popular games and pivot towards electronic games, foremost of which is the venue where they had been

practicing their popular games, whether in sea beaches, open or closed places, emphasising that these places are no longer the same as they were, since electronic games that are practiced on smart phones or tablet screens do not require places or

The popular games offer massive healthy values for children, Gharib emphasised, highlighting that electronic games always grab the children's attention dramatically and drain their physical

Saleh Gharib stressed the importance of promoting the popular games, in addition to designating places for their practice like the games being practiced in Darb Al Saai or other heritage cities nationwide that have been upgraded and renovated, affirming that popular games should dominate all games same as the popular words

and crafts. Speaking to QNA, heritage researcher Abdulaziz al-Bohashem al-Sayed said popular games are a patrimonial repertoire for the people of the State of Qatar, as there were many games practiced by past generations in schools and other places, and most kinetic games are devoted to boys while less kinetic games are dedicated to girls.

The popular games are not solely devoted to achieving entertainment and joy for children, but rather reinforcing social interaction since they collectively practiced and help children communicate with their relatives, al-Sayed outlined, emphasising that popular games perform multiple functions such as promoting the children's skills and building their mental and physical capacities since the games are predominantly kinetic that require intensive concentration and efforts. At the EGM, the shareholders approved the proposed amendments to the Articles of Association of the Bank to comply with the requirements of Qatar Central Bank's Circular No. (2) of 2023 amending certain regulations on corporate governance of banks.

The shareholders authorised the chairman of the board, vicechairman, and/or other board delegate to complete the necessary formalities in respect of the amended AoA subject to necessary regulatory approvals.
