alestinians in Rafah told AFP yesterday they were living in "constant terror" as Israel vows to push ahead with its planned assault on the south Gaza city flooded with displaced civilians. Most of Gaza's population is sheltering in Rafah at the very south of the territory after fleeing Israeli bombardment elsewhere. The Israeli army insists it will carry out a ground assault to eliminate Hamas fighters, despite an international outcry and concern for the roughly 1.5mn Palestinians sheltering in Rafah, many in tents.



# Qatar National Renewable Energy Strategy launched

## •Kahramaa plan aims to increase, diversify utilisation of renewable energy sources

The Qatar General Electricity & Water Corporation (Kahramaa) has launched the Qatar National Renewable Energy Strategy (QNRES). With 22 key energy actors in Qatar, the strategy, according to an official statement, is a step that reflects the efforts of Kahramaa to enhance its work in the field of renewable energy uses.

The aim is to develop policies and strategies related to a more sustainable future to achieve Qatar National Vision 2030 and the Third Qatar National Development Strategy 2024-2030.

"QNRES aims to increase and diversify the utilisation of renewable energy sources, specifically solar energy in Qatar and integrate them into the energy mix while considering the high-quality solar energy resources in the country. The country's global horizontal radiation level is among the highest in the world, with a rating of more than 2,000kWh generated per square meter per year," the statement said.

The ONRES also aims to increase

will enable more localised power generation reducing strain on the centralised grid infrastructure and enhancing energy resilience.

Launching the strategy is considered an ambitious step that will benefit the energy sector in the future in terms of economic advantages, environmental impact and energy security. Reducing CO2 emissions through sustainable policies and trends will enhance environmental sustainability and contribute to improving air quality. In terms of CO2 emissions reduction, the recommended power mix will have a significant impact in reducing 10% of Qatar's total annual CO2 emissions from the power sector. It will reduce the Carbon intensity in Qatar's annual CO2 intensity by 27% for each unit of electricity produced.

In terms of economic advantage, it is expected to reduce the average cost of electricity generation by 15% by 2030 due to the cost-competitive solutions. Diversifying the generation sources promotes energy security, enhancing stability in the energy sector. The QNRES recognises the importance of ensuring that the transition to renewable energy does not compromise the reliability and resilience of the electricity system. **To Page 4**

## 34,388 Palestinians killed so far

At least 34,388 Palestinians have been killed and 77,437 others injured in Israel's military offensive on Gaza since October 7, the Gaza health ministry said in a statement yesterday. Some 32 have been killed and 69 others wounded over the past 24 hours, the ministry said. Mourners react next to the bodies of Palestinians killed in Israeli strikes in Rafah, in the southern Gaza Strip, yesterday. (*Reuters*)

"We live in constant terror and fear of repeated displacement and invasion," said Nidaa Safi, 30, who fled Israeli strikes in the north and came to Rafah with her husband and children.

"We think about it all day long," she said.

Even before Israeli forces begin the expected assault, they have been carrying out devastating air strikes.

An overnight strike on a house in Rafah killed a fourmonth-old baby, her mother, father, and two brothers, relatives and neighbours told AFP. Hospital officials in Rafah said more than a dozen people were

killed during the night. "Every day we hear news about a Rafah invasion and that it's a certain fact, on top of the bombardments we witness and hear," Safi said. "Fear is controlling us,

we don't know how to think anymore." Her family has now decided to leave for Deir al-Balah, in centre of the Gaza Strip. Safi said they hoped to "flee Rafah before they

### US internal memo points to Israeli 'violation' of international law in Gaza

Some senior State Department officials in internal memo told Secretary of State Antony Blinken they do not find "credible or reliable" Israel's assurances that it is using US-supplied weapons in accordance with international humanitarian law, according to an internal State Department memo reviewed by Reuters. A joint submission from four bureaus – Democracy Human Rights & Labour; Population, Refugees and Migration; Global Criminal Justice and International Organisation Affairs – raised "serious concern over non-compliance" with international humanitarian law during Israel's prosecution of the Gaza war.

The assessment from the four bureaus said Israel's assurances were "neither credible nor reliable." It cited eight examples of Israeli military actions that the officials said raise "serious questions" about potential violations of international humanitarian law. **Page 7** 

# HMC in new plan to enhance patient booking system

**H**amad Medical Corporation (HMC) affirmed that it has undertaken an initiative to enhance the entire booking system, covering every aspect from referrals to appointment scheduling, including e-triage and in-calling processes.

This effort reflects the corporation's ongoing commitment to improve patient access to healthcare services, ensuring a more streamlined and effective experience for all.

Led by HMC's Center for Patient Experience and Staff Engagement (CPESE), a set of system changes were implemented following the review to HMC's Referral and Booking Management System (RBMS) with patients now seeing tangible improvements throughout because of the changes, HMC highlighted in a statement vesterday.

ment yesterday. Chief of Patient Experience and Director of Hamad Healthcare Quality Institute Nasser al-Naimi said one of the cornerstones of HMC's success in optimising outpatient care has been the strategic centralisation and decentralisation of its operations, adding that while the Referral and Booking Management System (RBMS) management is centralised, operations were decentralised across various healthcare facilities.

This means that hospitals have more control of booking appointments for their patients and helps to avoid unnecessary delays. This approach ensures that the capacity of clinics matches the demand, effectively reducing waiting times for appointments, he outlined.

He added that the RBMS enhancements have been rolled out across major HMC facilities, including the Ambulatory Care Center, Hamad General Hospital, Al Wakra Hospital, Al Khor Hospital, Qatar Rehabilitation Institute, Aisha bint Hamad Al-Attiyah Hospital, Women's Wellness and Research Center, the Bone and Joint Center, and the Hamad Dental Center.

The project is now concentrating on expanding RBMS services by incorporating Patient Care Assistants. This initiative aims to boost clinic utilisation and streamline the process of booking follow-up appointments directly from the physician's room, thereby enhancing overall patient care and efficiency, al-Naimi pointed out.

Al-Naimi said the changes to



the RMBS have delivered significant improvements and patients are now receiving their appointment dates faster than ever before, following referral to HMC.

"The system changes are making a positive impact on patient care. We have significantly increased the number of patients having their appointment date confirmed within seven days of referral and significantly reduced the number of patients with pending referrals," he said.

He highlighted that a remarkable increase in the number of patients receiving their first appointment within seven days of referral. The figures rose from 3,315 in February 2022 to 10,723 in January 2024, an increase of 224%. An impressive 91% increase in the number of patients seen within two weeks of referral, with numbers rising from 6,815 in February 2022 to 13,005 in January 2024, al-Naimi affirmed.

For her part, Executive Director of Nursing at Hamad General Hospital Khadija al-Shukaili said: "The transformation of the RBMS involved a comprehensive reforming and operationalising our speciality clinics efficiently through direct engagement of services' stakeholders. This initiative was aimed at increasing utilisation of our current capacity and prioritising our patients' needs and care.

"By strategically redirecting referrals in partnership with multiple stakeholders with HMC and PHCC, we have successfully streamlined patient demand and relieved considerable pressure on central Doha hospitals, especially Hamad General Hospital. These multiple initiatives and partnerships have ensured that patients receive the right care at the right service and facility thus reducing the appointment waiting time." she highlighted. ## Labour minister participates in opening of **50th Arab Labour Conference in Baghdad**

E the Minister of Labour and Chairman of the Board of Directors of the Arab Labour Organisation Dr Ali bin Smaikh al-Marri participated in the opening session of the 50th Arab Labour Conference in the Iraqi capital Baghdad, being organised by the Arab Labour Organisation from April 27-May 4.

The opening was attended by Iraqi Prime Minister Mohamed Shi'a al-Sudani, Minister of Labour and Social Affairs of Iraq - Chairman of the Conference Ahmed al-Asadi, Director-General of the Arab Labour Organisation Favez Ali al-Mutairi and representatives of the three production parties in the Arab countries (governments, employers and workers) according to the principle of tripartite representation and a number of relevant Arab and regional organisations.

Addressing the conference opening, HE Dr al-Marri stressed that the convening of the 50th session of the Arab Labour Conference confirms 50 years of a firm and solid relationship between the Arab Labour Organisation and the three production parties of the Arab countries, noting that the relationship is based on mutual understanding, respect, support and assistance to achieve the objectives of the Arab Labour Organisation.

During his speech at the opening of the conference, HE the minister said that the 50th session of the Arab Labour Conference comes under exceptional circumstances that the Arab nation is going through, pointing out that the situation in the Gaza Strip is still burning and the economic crisis continues to cast its shadow on labour markets and employment issues in the Arab countries.

The chairman of the Board of Directors of the Arab Labour Organisation expressed his hope that the conference will come out with decisions and recommendations that contribute to achieving the aspirations of peoples in securing decent work opportunities and achieving a balance between creating more job opportunities, preserving the rights of workers to decent working conditions and reaching more secure, stable and just labour markets.

He explained that during the past year, the Board of Directors of the Arab Labour Organisation discussed many important statutory, financial, administrative and technical issues, in addition to reviewing in its report the situation of workers and the people of Palestine in the occupied territories. where it condemned the crimes committed by the occupation authorities against workers and the people of Palestine as war crimes The 50th session of the Arab Labour Conference addresses vital issues that directly impact labour markets in the Arab region, labour issues in the Arab world, the director-general's report on the future of human resources in light of the technological revolution

and genocide.

The chairperson of the Board of Directors of the Arab Labour Organisation called on the international community and all peace-loving forces to provide the necessary protection for the unarmed Palestinian people, stop this unjust war immediately and hold the perpetrators of these brutal crimes accountable before international courts, stressing the continued support for the Palestinian cause until the Arab people in Palestine obtain their freedom and establish their independent state on their land.

HE the minister pointed out that the Board of Directors reviewed the financial position of the organisation in terms of contributions and arrears to member states and the reports of the Financial and Administrative Supervisory Authority and auditors on the final accounts of the Arab Labour Office in Cairo and the institutes and centres affiliated to the organisation for the fiscal vear ending on 31 December 2023. noting that the Board adopted the ambitious plan presented by the Arab Labour Organization for the

vears (2025-2026), which we hope for your co-operation and support for its implementation.

He noted that the board discussed the report on the activities and achievements of the Arab Labour Organisation, which highlighted the outstanding activities and hard work exerted by the organisation to implement a wide range of activities and events that benefit the three parties of production in the Arab countries.

HE Dr al-Marri, Minister of Labour and Chairman of the Board of Directors of the Arab Labour Organisation, attended the highlevel meeting of representatives of government delegations to the Arab Labour Organisation, where a number of reports on the work of the committees stemming from the Arab Labour Organization were reviewed.

The 50th session of the Arab Labour Conference addresses vital issues that directly impact labour markets in the Arab region, labour issues in the Arab world, the director-general's report on the future of human resources in light of the technological revolution, and the challenges facing human resources in Arab countries in light of technological progress.

The director-general's report reviews how to prepare the workforce of the future, with a focus on training and continuing education to enhance the skills needed to adapt to technological changes, the balance and integration between technology and the human element, and the impact that technology can have on creating new job opportunities and improving working conditions.

The conference will address the development of policies to enhance productivity and sustainability in the Arab labour markets, including the analysis of factors that will contribute to enhancing the work environment and stimulating economic growth, as well as looking at ways to improve and develop policies, and the required roles of the three production parties and the Arab Labour Organisation.

Qatar, represented by HE Dr Ali bin Smaikh al-Marri, Minister of Labour, presides over the Board of Directors of the Arab Labour Organisation following its election last October for a one-year term ending in October 2024.



President of Egypt Abdel Fattah al-Sisi met with HE Speaker of the Shura Council Hassan bin Abdullah al-Ghanem as part of his meeting with the Speakers of Arab councils and parliaments participating in the sixth conference of the Arab Parliament that was hosted by Cairo yesterday. The meeting reviewed a number of topics related to parliamentary efforts aimed at strengthening joint Arab action as well as the most prominent topics on the conference agenda. (QNA)

## Shura Council Speaker highlights Qatar's interest in AI, cybersecurity

E the Speaker of the Shura Council Hassan bin Abdullah al-Ghanem highlighted the importance that Qatar, under the directives of its wise leadership, attaches to artificial intelligence (AI), cybersecurity, and setting legal frameworks to manage their use.

This came during his chairmanship of the Shura Council's delegation to the 6th conference of the Arab Parliament and Speakers of Arab Councils and Parliaments held at the Arab League headquarters in Cairo on Saturday. The conference is held to discuss and issue a draft document for an Arab parliamentary vision for the safe use of AI

HE the Speaker pointed to His Highness the Amir Sheikh Tamim bin Hamad al-Thani's emphasis on and call for the need to hold an international conference to regulate cybersecurity in international law at the 73rd and 74th sessions of the United Nations General Assembly held in 2018 and 2019, respectively.

He underscored Oatar's efforts to solidify national digital infrastructure and ensure the safety of

the state's vital interests by forming the National Cyber Security Agency.

He added that Qatar has supported a United Nations' decision to set a comprehensive international convention to counter cybersecurity crimes, in addition to establishing the Qatar Computing Research Institute in order to meet local needs and enhance Qatar's leading international standing in the field. HE the Speaker said that the state has adopted Qatar's National AI Strategy in accordance with the Qatar National Vision 2030, to ensure the country's economic and strategic future.

HE al-Ghanem stressed the importance of the draft document being worked out, however, pointing to member states' divergence in opinions and positions regarding AI legalisation. HE the Speaker of the Shura Council continued by saying that AI receives international interest due to AI's impressive role in serving humanity and facilitating life. He added that as the case with other forms of knowledge and sciences, AI also poses challenges and risks, particularly with regard to its military misuse which has the potential of threatening world peace and security, something on which specialists are working on understanding and mitigating.

HE al-Ghanem stressed the need for parliamentarians to work with AI experts and specialists on drafting a comprehensive legislation on the safe use of AI in all fields. He said that Arab AI experts and specialists must be benefitted from in conducting research and studies in the field, as well as in preparing a report on the benefits and risks of AI use, and ways for its safe use, to then be presented to the Arab Parliament's general secretariat and distributed among member states to guide their national AI legislations.

He expressed hope that the conference succeeds in making decisions and setting procedures for a unified comprehensive vision on AI. In his speech, HE the Speaker touched on the suffering of the brothers in Palestine because of the brutal aggression that claimed the lives of tens of thousands of people, denouncing the crimes of genocide and forced displacement committed by the occupation forces in the Gaza Strip and the rest of the occupied Palestinian territories.

He denounced the international silence regarding the barbaric crimes committed by the occupation forces, and the inability of

the United Nations agencies concerned with protecting international peace and security and their inability to stop the brutal aggression and hold the occupation accountable for its heinous crimes.

He stressed the need for parliamentarians to act by forming a parliamentary committee or creating a mechanism that brings

together parliamentarians to stop this brutal aggression that disregards all international laws.

Pointing to what the world is witnessing these days in relation to student demonstrations in several universities, which began in the US and extended to a number of countries, he explained that the authorities handling of those demonstrations through repression and arrest reveals the false claim of some countries regarding the protection of freedoms and human rights. He said that he feels pain and bitterness when he sees the failure of 2bn Muslims to influence the UN resolution and the positions of the countries supporting the occupying entity.

### QU opens Fall semester admissions online

The Admission Department at Qatar University (QU) announced yesterday that it will embark on receiving applications for undergraduate admission online for the Fall semester 2024, for students transferring from other universities and second degree students, starting from today (April 28) until May 8.

The QU pointed out that the online application for new students, visitors, and students studying courses will begin on May 13 until July 3.

QU's Director of the Admission Department Lulwa al-Rubaie stated that applicants are required to achieve at least 70% of the secondary certificate average when applying for the faculties of arts, sciences, engineering, management, economics, law, Shariah, Islamic studies, education, health sciences, and nursing; 85% as a minimum for applicants to the faculties of medicine and dentistry; and 80% as a minimum for applicants to the college of pharmacy. She highlighted that online application for scholarships for the Fall semester 2024 will be ened from May 13-July 3 and include excellence grants, grants for children of the GCC states who have a Qatari secondary certificate, distinguished performance grants, and a grant for children of QU staffers New students can apply via the online admission application, while registered students can apply via the self-service system (My Banner), with the need to upload the required documents during the announced application period, pointing out that decisions to accept scholarships will be announced on August 5, said al-Rubaie, and outlined that QU admission depends on the principle of competition between applicants, and that achieving the minimum level in the secondary certificate does not mean that the student will be accepted in the first attempt, but rather admission is made according to the absorptive capacity of each college separately. She indicated that the admission application process is finalised by completing the online application on the university's website and uploading the required documents electronically, on condition that the documents are uploaded before the specified deadline. Al-Rubaie added that students who meet the minimum admission requirements can apply via the QU's website, as it is not required from Qatari public and independent secondary school students who obtained a high school diploma in 2016 or later, to submit their high school diploma to OU. She highlighted that OU will directly receive their results in the public secondary school from the Ministry of Education and Higher Education (MoEHE). For applicants from other universities, al-Rubaie highlighted that they must bring with them a list of the original college study grades attested by the competent authorities, along with copies of them to ensure consistency, and they shall be submitted to QU prior to the end of the submission deadline. She indicated that the admission decisions for students transferred from other universities and second degree undergraduate students will be announced on June 2, and Aug 5 for new students. (QNA)

The clinic, operating for the past 14 years, provided treatment for around 1,260 patients this season.

doctors, nurses, ambulance service and administrators, who participated in securing the camping season.

He also valued the efforts of the ministries concerned for their continued support, particularly in allocating a place for the clinic close to the beachfront as in the past years.

Prof Aftab Mohamed Omar, chief, Emergency Departments at HMC and the medical director of

Sealine Medical Clinic, pointed out that required services were provided to beachgoers and campers in the Sealine area.

The Emergency Department at Al Wakra Hospital and Hamad Medical Corporation were also fully prepared to receive patients and treat urgent and critical cases, he added.

Saleh al-Meqareh al-Marri, assistant executive director for Am-

bulance Services for Emergency and Events Planning at HMC, said two regular ambulances and two off-road ambulances were permanently present during the camping season.

The clinic treated 816 cases of injuries, including accidents, falls, wounds and fractures, alongside 444 medical cases related to respiratory and cardiac problems, as well as minor sunburns. Additionally, 629 emergency cases were transferred to hospitals via ambulances or Life Flight.

Ambulance personnel were deployed according to pre-defined work plans and daily operations outlined in advance by the Emergency and Events Planning Department of the Ambulance Services Management. This was in line with the objectives and medical coverage plans for the Sealine area.

Ambulance services also allocated a fixed site for their vehicles and personnel, in addition to mobile units along the main road.

### Justice ministry 'has embarked on preparing executive regulation, real estate laws'

ssistant Undersecretary for Real Estate Registration and Documentation Affairs at the Ministry of Justice (MoJ) Saeed Abdullah al-Suwaidi has affirmed that the MoI embarks on setting the executive regulation and decisions for the Law No 5 of 2024 regulating the real estate registration to finalise the measures of activating the provisions of the new law.

The official stated that the law has created an array of new provisions in their entirety in real estate registration, which primarily ensure the citizens' rights and ownership of their real estate and property, as well as private investments conducted by citizens and non-citizens.

Al-Suwaidi pointed out that by virtue

of the provisions of the new law, customers will be able to sell and purchase property online via SAK application soon and enforce the real estate registration measures as stipulated in the law electronically, in accordance with the regulations and measures issued by a decision from the Minister of Justice.

This is in addition to providing the feature of notating judicial rulings on the real estate page as soon as they are issued to avoid fraud, giving more transparency to transactions, and informing the parties of all real estate data, which will contribute to reducing real estate disputes.

The law has dedicated a special ruling for the registration measures, authentication of signatures, so that a register is created in the Real Estate Registration Department at the MoJ in which registration applications are recorded with serial numbers according to the order in which they are submitted, and in which requests for obtaining documents and certificates are recorded.

The assistant undersecretary stated that the law also stipulates that the procedures for registration or authentication of signatures are conducted upon request of the concerned parties or their surrogates, according to the forms of documents prepared by the Real Estate Registration Department for this purpose, as per procedures and conditions stipulated in the law

and its later executive regulations.

The new law has been formulated in 55 articles to supersede the law that has been enforced for 60 years, the official said, with overarching and crucial adjustments that will make a paradigm shift in the field of real estate registration, in addition to saving records, documents and indexes related to real estate registration.

The official indicated that the new legislation helps register unregistered properties and the objections submitted regarding them and decide on the ownership rights to unregistered properties expropriated for public benefit, in addition to organising the powers of the Real Estate Registration Committee, and procedures for updating real estate registry data.

Al-Suwaidi said that law regulates the procedures for separating and unifying real estate and the specific penalties for anyone who achieves a registration for a real estate or illegally transfers, alters, or cancels any real right on it. in addition to permitting conciliation in the crimes stipulated before filing the case or during its consideration and prior to deciding on it with a final ruling.

The law also stipulates that the Real Estate Registration Department shall embark on finalising the data pertinent to the description of real estate and its types based on the documents submitted by the concerned parties. - QNA

# Leaked US memo says Israel may be violating international law

ome senior US officials have advised Secretary of State Antony Blinken that they do not find "credible or reliable" Israel's assurances that it is using US-supplied weapons in accordance with international humanitarian law, according to an internal State Department memo reviewed by Reuters.

Other officials upheld support for Israel's representation.

Under a National Security Memorandum (NSM) issued by President Joe Biden in February, Blinken must report to Congress by May 8 whether he finds credible Israel's assurances that its use of US weapons does not violate US or international law.

By March 24, at least seven State Department bureaus had sent in their contributions to an initial "options memo" to Blinken.

Parts of the memo, which has not been previously reported, were classified

The submissions to the memo provide the most extensive picture to date of the divisions inside the State Department over whether Israel might be violating international humanitarian law in Gaza.

"Some components in the department favoured accepting Israel's assurances, some favoured rejecting them and some took no position," a US official said.

A joint submission from four bu-- Democracy Human Rights reaus & Labour; Population, Refugees and Migration; Global Criminal Justice and International Organisation Affairs - raised "serious concern over non-compliance" with international humanitarian law during Israel's prosecution of the Gaza wa

The assessment from the four bureaus said Israel's assurances were "neither credible nor reliable".

It cited eight examples of Israeli military actions that the officials said raise "serious questions" about potential violations of international humanitarian law.

These included repeatedly striking protected sites and civilian infrastructure; "unconscionably high levels of civilian harm to military advantage"; taking little action to investigate violations or to hold to account those responsible for significant civilian harm and "killing humanitarian workers and journalists at an unprecedented rate".

The assessment from the four bureaus also cited 11 instances of Israeli military actions the officials said "arbitrarily restrict humanitarian aid", including rejecting entire trucks of aid due to a single "dual-use" item, "artificial" limitations on inspections as well as repeated attacks on humanitarian sites that should not be hit

Another submission to the memo reviewed by Reuters, from the bureau of Political and Military Affairs, which deals with US military assistance and arms transfers, warned Blinken that suspending US weapons would limit Israel's ability to meet potential threats outside its airspace and require Washington to re-evaluate "all ongoing and future sales to other countries in the region".

Any suspension of US arms sales would invite "provocations" by Iran and aligned militias, the bureau said in its submission, illustrating the pushand-pull inside the department as it prepares to report to Congress.

The submission did not directly address Israel's assurances.

Inputs to the memo from the Office of the Special Envoy to Monitor and Combat Antisemitism and US ambassador to Israel Jack Lew said they assessed Israel's assurances as credible and reliable, a second US official said.

reau, known as the Office of the Legal Adviser, "did not take a substantive position" on the credibility of Israel's assurances, a source familiar with the matter said.

State Department spokesperson Matthew Miller said the agency does not comment on leaked documents.

"On complex issues, the Secretary often hears a diverse range of views from within the Department, and he takes all of those views into consideration," Miller said.

When asked about the memo, an Israeli official said: "Israel is fully committed to its commitments and their implementation, among them the assurances given to the US government." The White House did not respond to

a request for comment.

Biden administration officials repeatedly have said that they have not found Israel in violation of international law.

Blinken has seen all of the bureau assessments about Israel's pledges, the second US official said.

On March 25 Miller said the department received the pledges.

However, the State Department is not expected to render its complete assessment of credibility until the May 8 report to Congress.

Further deliberations between the department's bureaus are underway ahead of the report's deadline, the US official said.

USAID also provided input to the memo

"The killing of nearly 32,000 people, of which the GOI (Government of Israel) itself assesses roughly twothirds are civilian, may well amount to a violation of the international humanitarian law requirement," USAID officials wrote in the submission.

Others are unable to bear the thought of being uprooted again.

Samah Deeb, 32, has decided to wait before leaving. "The thought of displacement again makes me extreme-

ly terrified, because I've fled so many times," she said. Before travelling to Rafah, she had already left home and

taken shelter at the Al-Shifa Hospital in Gaza City. "Just the thought of having to work on another tent and transfer all of our belongings and the new expenses it will cost is unbearable," she said. "There is nowhere else safe, and nowhere else after Rafah to go."

Deeb said she was monitoring the news closely.

"At any moment they tell us to evacuate Rafah, we will leave like the rest of the people but we pray to God they won't invade Rafah and force us to relive the suffering of displacement," she said.

Qasim Abu Nahl, a 40-year-old from Gaza City, said he had already been displaced four times.

"Moving from one place to another has been incredibly hard for us," he said.

"We spent nearly two weeks enduring heavy bombardment, shells, and smoke bombs" at the city's Al-Rantisi Hospital before fleeing to Nuseirat in the centre of Gaza "with nothing but the clothes on our backs," he said.

He said he fled bombing in Nuseirat and went to the southern city Khan Yunis, which "became overcrowded and increasingly dangerous" before he arrived in Rafah.

"We don't know if we'll be safe tomorrow or not," he said. "Every day brings new unsettling news about Rafah."

Resident Noor al-Farah, 56, has been packing clothes, food and firewood with her husband and children in preparation.

"I am mentally exhausted from the worrying news and waiting for the unknown," she said.

She has been unable to find anywhere outside Rafah for her family to stay, and said she was afraid of snakes in displacement camps.

Gazans living in Rafah's camps have also had to contend with unbearable temperatures as a heatwave takes hold.

Intisar Ramadan Ghaban said life inside a hot tent in fear of an Israeli invasion was like a "new death".

The 61-year-old said she had already been displaced from Gaza City and Nuseirat refugee camp before reaching Rafah.

"Invasion of Rafah is what we fear the most," she said. "We fear the day will come when they tell us to get out, but until then we don't know where we'll go.

"Will they give us a warning in advance? Or will we leave urgently without knowing what's going on, carrying only ourselves without anything else? Or will it be under heavy bombardment?"

"We have no idea." she said

### Mali court not 'competent' to rule on political crackdown

Mali's constitutional court has declared itself "incompetent" to examine a case calling for the military junta's suspension of political party activity to be annulled.

In a document seen by AFP yesterday, the court also ruled "inadmissible" a request from associations for magistrates and prosecutors to find that Mali was in a legal and "institutional vacuum" and to set up a roadmap back to elections.

Both court rulings were dated on Thursday. The West African nation has been ruled by juntas since back-to-back coups in 2020 and 2021, with the worsening security situation aggravated by armed religious militant and separatist groups. Juna chief Colonel Assimi Goita this month issued a decree suspending the activities of political parties and banning media coverage of the parties in the name of maintaining public order.

The restrictions were imposed after the regime failed to keep a pledge to hand over to a civilian government by March 26.

Under pressure from regional bloc Ecowas, the junta had promised to organise presidential elections in February. - AFP

### Nigeria landmine blast kills 11

Eleven militia fighters working alongside Nigeria's military to battle religious militants were killed yesterday in the country's northeast when their vehicle hit a landmine on a highway near the border with Cameroon, two militia sources told AFP. Militants in Nigeria are increasingly resorting to planting mines on highways to target military and civilian convoys after they were pushed back from territory they once controlled during the early years of the country's more than 15-year Islamist insurgency

The militia fighters were escorting a civilian convoy from the town of Gamboru in Borno State to the regional capital Maiduguri when around 1230GMT their vehicle drove over a landmine suspected to have been planted by religious militants at Damno village, the two sources said. - AFP

### Kenya flood death toll hits 76

Seventy-six people in Kenya have lost their lives to floods triggered by torrential monsoon downpours since March, the government said vesterday, warning residents "to brace for even heavier rainfall" Flash floods have submerged roads and neighbourhoods, leading to the displacement of more than 130.000 people across 24.000 households, many of them in Nairobi, government spokesman Isaac Mwaura said yesterday. - AFP

# **20 Cambodian soldiers** killed in ammunition base explosion

wenty Cambodian soldiers have been killed in an ammunition explosion at an army base, Prime Minister Hun Manet said yesterday.

The blast at around 2.45pm (0745 GMT) at the army base in Kampong Speu province to the west of the capital also wounded several soldiers, according to the PM, with the army saying that an entire truck of munitions had exploded.

"I am deeply shocked to receive the news of the ammunition explosion incident," Hun Manet said in a statement on Facebook, expressing his "deepest condolences" to the families of those killed.

It was not immediately clear what had caused the explosion. Pictures on social media showed

a destroyed one-storey building reathed in smoke, with resident

## Ireland's asylum-seeker influx shows UK Rwanda plan having impact: Sunak

n influx of asylum seekers into Ireland from the UK is evidence that London's plan to send asylum seekers to Rwanda is acting as a deterrent, Prime Minister Rishi Sunak said. Ireland's Minister of Justice

Helen McEntee told a parliamentary committee this week that she estimates around 80% of those applying for asylum in her country came over the land border with Northern Ireland, which is part of the UK.

Sunak told Sky News, in comments released yesterday but that will air today, that it showed his controversial plan to send asylum seekers to Rwanda was "already having an impact" as a

deterrent. "Illegal migration is a global challenge, which is why you're seeing multiple countries talk about doing third country partnerships," Sunak told Sky News.

"But what it also shows, I think, is that the deterrent is ...

#### already having an impact because people are worried about coming here," he added.

"If people come to our country illegally, but know that they won't be able to stay there, much less likely to come, and that's why the Rwanda scheme is so important." The Rwanda bill cleared its final parliamentary hurdle on Monday, after a marathon tussle between the upper and lower chambers of parliament lasting late into the night.

Sunak hopes the bill will prevent asylum seekers from trying to enter the UK illegally by making small boat crossings of the Channel from northern Europe. Immigration is set to be a key issue in a general election due this year, with Sunak's Tories currently languishing in the polls.

## **UK Conservative lawmaker Poulter** defects to opposition Labour

ritish member of parliament Dan Poulter has defected from the ruling Conservative Party to the opposition Labour Party, in a blow to Prime Minister Rishi Sunak ahead of a set of local elections that could put further pressure on his leadership.

Sunak's Conservatives are trailing Labour by around 20 points in opinion polls ahead of a national election expected this year, and the timing of the defection appeared designed to damage the government further ahead of Thursday's local votes.

Poulter said the government's record on the state-run National Health Service (NHS) - one of Sunak's five priorities for the country

- meant he could no longer represent the Conservatives.

"It is abundantly clear to me that the Labour party alone has the will and the trust to restore and reform the NHS. That's why we need a Labour government," Poulter said in an article in the Observer newspaper, adding he would stand down at the coming election. Labour leader Keir Starmer said it was "fantastic" to welcome Poulter to the party.

"Across the country more and more people are switching to Labour because they know only this changed Labour Party can deliver the change Britain needs," he said in a statement.

Poulter is the second Conservative lawmaker to defect to Labour since the last election. after Christian Wakeford switched in 2022 over former Prime Minister Boris Johnson's conduct around rule-breaking parties during Covid-19 lockdowns.

Sunak has faced a tough time trving to recover Conservative fortunes after the premierships of Johnson and Liz Truss tanked the party's poll ratings, and has blamed strike action by doctors and other health workers for throwing his pledge to cut hospital waiting lists off track.

But Poulter said the government had put ideology ahead of pragmatism in dealing with the industrial disputes, leaving patients to bear the brunt.

A spokesperson for the Conservatives said Poulter's defection would be "disappointing news" for his constituents, adding the government had increased funding for the NHS.

"What Dan says is wrong as Sir Keir Starmer has no plan for our NHS," the spokesperson said.

India's Spices Board, the government's regulator for spice exports, said on Wednesday it had sought data on MDH and Everest exports from authorities in Hong Kong and Singapore, and was working with the companies to find the "root cause" of the quality issues as inspections started at their plants. In 2019 a few batches of MDH's products were recalled in the US for salmonella contamination.

### **Philippines denies** deal with China over disputed shoal

The Philippines yesterday denied a Chinese claim that the two countries had reached an agreement over an escalating maritime dispute in the South China Sea, calling the claim propaganda, Reuters reported from Manila. A spokesperson at China's embassy in Manila said on April 18 that the two had agreed early this year to a "new model" in managing tensions at the Second Thomas Shoal, without elaborating Philippine Defence Secretary Gilberto Teodoro said yesterday his department was "not aware of, nor is it a party to, any internal agreement with China" since President Ferdinand Marcos Jr took office in 2022. Defence department officials have not spoken to any Chinese officials since last year, Teodoro said in a statement. China's embassy in Manila did not immediately respond to a request for comment on Teodoro's comments outside office hours. Beijing and Manila have repeatedly clashed in recent months at the submerged reef, which Philippines says is in its exclusive economic zone but which China also claims. The Philippines had accused China of blocking manoeuvres and firing water cannons at its vessels to disrupt supply missions to Filipino soldiers stationed in a naval ship which Manila deliberately grounded in 1999 to bolster its maritime claims. ### **Five dead in China** after tornado rips through Guangzhou

At least five people were killed and 33 injured after a tornado struck the Chinese city of Guangzhou vesterday, state media reported. China's official Xinhua news agency said that the tornado hit the Guangdong Province capital, in the country's south, around 3pm (0700 GMT). The extreme weather was the latest to hit the country's industrial heartland. Guangdong, China's most populous province, is home to 127 million people and thousands of factories that power the nation's export sector, AFP reported from Beijing. Some 141 factories were damaged, though no houses had collapsed. Xinhua reported. Images published by state media showed dark skies in the middle of the day. Social media images showed damaged cars and uprooted trees. Earlier this week, torrential rains in Guangdong caused serious flooding, leaving four dead. According to state media, it was the worst flooding some parts of the province had seen since the 1950s. Tornados are not unusual in China. In September. 10 people were killed after a tornado struck Sugian, Jiangsu Province, in the country's east. In 2021, two tornadoes struck the country in one day, killing 12, including eight in Wuhan.

# 'Everyone sits out': Yangon parks offer heatwave relief

s the sun sets on another scorching Yangon day, The hot and bothered descend on the Myanmar city's parks, the coolest place to spend an evening during yet another power blackout.

A wave of exceptionally hot weather has blasted Southeast Asia this week, sending the mercury to 45C (113F) and prompting thousands of schools to suspend in-person classes.

Even before the chaos and conflict unleashed by the military's 2021 coup, Myanmar's creaky and outdated electricity grid struggled to keep fans whirling and air conditioners humming during the hot season.

Now, infrastructure attacks and dwindling offshore gas reserves mean those who cannot afford expensive diesel generators must face at least eight hours daily at the mercy of the scorching heat.

For many in the city of some

8mn, relief comes only at night and outdoors with the metropolis' parks offering natural shade and blissful breezes.

"My parents can't stay inside their house in the afternoon," one Yangon resident said, as she visited Inya lake late Friday.

"They have to go outside and sit under the shade of trees." The woman said her parents warn her about going outside in the weather, urging her to cover up, and added: "I feel this year is far hotter than last year." Mya Ave. 62, said she comes to the park every day when the power goes off at 5:00pm. "The weather at home is so hot that neither the children nor the elderly can stay," she said. Across swathes of Myanmar's arid heartland day temperatures on Thursday were 3-4C higher than the April average, according to the country's weather monitor.

In Chauk in Magway region, the temperature reached a blazing 45.9 Celsius on Wednesday. the office said.

Back at the picturesque lake, one man told AFP he and his family had travelled from the northern part of the city as they could not remain at home because of the heat.

"Even if we sit outside, the sun's rays are very hot and we can't sit anywhere," he said.

"After 10:00am in the morning, it's getting hotter and we can't stand it," he said, adding that older people were particularly impacted. "Elderly people are not going outside because of the heat and they just stay inside. After the sun is gone, they come out," he explained.

The frequent power outages only made the situation worse, he said, with homes emptying each evening. "When there is a power blackout everyone sits out on the street until 9:00 or 10:00pm," he said.

Global temperatures hit record highs last year and the UN's World Meteorological Organisation said Asia was warming at a particularly rapid pace, with the impact of heatwaves in the region becoming more severe.

Scientific research has shown climate change is causing heatwaves to be longer, more frequent and more intense

## US paramedic jailed over death of man during arrest

ne of two paramedics who injected a young black man with ketamine as he was put in a chokehold by US police has been sentenced to 14 months in jail with work release and probation, in the final chapter of a case that became a clarion call in the Black Lives Matter movement.

Jeremy Cooper had been convicted in December of criminally negligent homicide over the death of Elijah McClain, an unarmed 23-yearold who died several days after a struggle with police in Colorado.

He had suffered a cardiac arrest in the ambulance in the moments after his forceful arrest.

At a court in Colorado on Friday, Cooper, 49, was given 14 months in jail with work release, and four years' probation, US media reported.

Work-release programmes typically require convicts to spent nights and weekends in jail, though they are free to leave for work during weekdays.

Fellow paramedic Peter Cichuniec was convicted of criminally negligent homicide and assault by drugging.

He was sentence last month to five years in prison, the mandatory minimum for the assault conviction.

Paramedics rarely face charges in such cases. Sheneen McClain, Elijah's mother, walked out of the courtroom when a tearful Cooper rose to say he was directing sorrowful comments to her son.

She later returned to give her own statement before the court and told Cooper to never invoke her son's name.

She said the law enforcement culture that permits young black men to be killed with greater frequency than their white counterparts will not change until deep shifts take place.

"America will never be what it could be because it does not look at all its citizens as one race - the human race," Sheneen McClain said.

She then touched her right hand to her chest and lifted it skyward, choked back tears and concluded: "Long live Elijah McClain, always and forever!"

The episode unfolded in August 2019 when police in the city of Aurora responded to reports of a "suspicious" black male "acting weird" in

the street and wearing a ski mask.

McClain's family later told media that he had been out buying iced tea, and often wore the mask to stay warm because he suffered from anaemia.

One officer said McClain, who was unarmed, had reached for another officer's gun. No evidence was produced to support this claim.

They grappled with him and while they were restraining him Cichuniec and Cooper injected him with ketamine.

During the trial, the paramedics' lawyers argued that their clients had simply followed protocol in administering a drug approved in Colorado for people in an "agitated state".

Prosecutors countered they had ignored their training in handling distressed patients.

McClain's death occurred months before the killing of another black man, George Floyd, in Minneapolis in May 2020, but drew renewed attention soon after as protests against police brutality swelled.

A celebrity-backed campaign led to a special investigation in which three police officers were ultimately indicted, along with the two para-

medics.

Two of the police officers were acquitted,

while the third officer was sentenced in January to 14 months behind bars.

Colorado has undergone significant police reforms since the killing of McClain and the following year's racial justice protests ignited by the killing of Floyd at the hands of police in Minneapolis, Minnesota.

Politicians and experts say more must be done

"It should not be the way that we have to make policy, to do so based on someone being murdered, like Elijah McClain," said Colorado state Representative Leslie Herod. "But when Elijah McClain was murdered, we were able to make a lot of progress in a lot of areas that people wanted to ignore or say did not happen here in Colorado."

Herod said one of the most impactful measures of a sweeping 2020 police reform bill she co-sponsored spelled out that officers have a duty to intervene if they see a colleague committing civil rights violations.

Herod said she is now focusing on providing whistleblower protections for police officers, and said new laws are needed to ensure, for example, that independent bodies investigate allegations against police.

### **Attack in Chile leaves** three police officers dead

hree military police officers were killed in an ambush early yesterday in a restive region of southern Chile, authorities said, in the worst such violence in years.

'This morning we received the grave and painful news of an attack in Arauco province in which three Carabineros were killed," President Gabriel Boric announced on the social media platform X.

He travelled to the area with a large contingent, including top military and congressional officials and the president of the Supreme Court, and later declared three days of national mourning. In Santiago, hundreds of people gathered outside the presidential palace to protest the killings.

The bodies of the three officers were found in a burned-out armoured patrol vehicle on a road near the city of Concepcion, some 500km (300 miles) south of capital Santiago. They appeared to have been shot.

The area had been militarised after a series of arsons, mostly tributed to radical groups of Mapuche. Chile's largest Indig enous group, which has demanded the restitution of ancestral lands.

# **Pasteurised** milk 'safe' from bird flu: officials

ilk sold in US stores is "safe" from the bird flu because pasteurisation effectively kills the disease, American health authorities have said, following spread of the infection among herds of cows.

An outbreak of Highly Pathogenic Avian Influenza (HPAI) has made its way through dairy cattle herds across the country and infected one human, who had mild symptoms.

On Thursday the Food and Drug Administration (FDA) reported that initial results from a nationally representative commercial milk sampling showed about one in five retail milk samples tested positive for viral fragments, with a higher proportion in areas where herds are infected.

The FDA had announced earlier this week that thanks to the pasteurisation process the virus was unlikely to present a health risk via milk.

However, it said additional tests were needed.

Preliminary results indicated "pasteurisation is effective in inactivating HPAI", the FDA said in its press release on Friday.

Bird flu was previously detected in raw milk, which health authorities have long advised against consuming.

Though the H5N1 strain of HPAI has killed millions of poultry during the current wave, affected cows have not fallen severely sick.

According to the FDA's Friday release, information from US health officials continues "to show no uptick of human cases of flu and no cases of H5N1, specifically, beyond the one known case".

There is no evidence of human-to-human bird flu transmission at this time, but scientists fear a mutation in the virus could allow it to pass among people

with exposure to infected animals.

The US Department of Agriculture has confirmed milking cows in Colorado tested positive, following earlier infections Texas, Kansas, Michigan, in Ohio, Idaho, New Mexico, North Carolina and South Dakota.

Congress members' push for a stronger response added pressure on federal agriculture and health authorities still seeking to confirm how the H5N1 virus is spreading and its potential risks to people, one month after the first detection in a Texas dairy herd.

An analysis of US Department of Agriculture data by a University of Arizona scientist offers new evidence that the first known H5N1 outbreak in dairy cattle is more far-reaching than the 34 herds in nine states that have officially tested positive.

"Containing this before it spreads among humans is critical. Given lessons learned from (the coronavirus pandemic), this federal response is insufficient," Republican US Senator Mitt Romney said in a post on X.

Some lawmakers, including Romney, have made a bipartisan push to reauthorise legislation known as the Pandemic and All Hazards Preparedness Act that lapsed last year and is aimed at bolstering the nation's response to pandemics and other public health threats.

The virus in the human case is significantly different from the bird flu virus samples taken from infected cattle that were made public by government officials last weekend, said Dr Michael Worobey, an evolutionary biologist from the University of Arizona.

The difference between the genetic sequences of the worker's virus and the 239 other samples provided indicate that "this was a very longstanding, widespread epidemic", he told Reuters.

The finding, which the WSJ said was based on both classified intelligence and an analysis of public facts, raises new questions about Navalny's death in a remote Arctic prison camp, which led to a new round of sanctions against President Vladimir Putin's Russia.

Among those facts was the timing of the opposition leader's death in mid-February, which overshadowed Putin's re-election a month later.

While the new finding does not question Putin's responsibility for Navalny's death, the Central Intelligence Agency (CIA) and other US intelligence agencies believe that the president probably didn't order it "at that moment", the Journal said, quoting people familiar with the matter.

It said that some European officials, briefed on the US finding, were sceptical that the 47-yearold dissident could have been targeted without Putin's prior knowl-

ary 16 after a walk at the isolated camp. It said attempts to revive him failed.

Navalny had seemed relatively healthy and in good spirits when seen in a video just a day earlier.

A week before that, he reportedly had been the subject of highlevel talks over a potential prisoner swap that could have freed him.

He had earlier survived a poisoning that US and other investigators blamed on the Kremlin. Russian officials have denied culpability in the poisoning or in his death.

### **New York returns 30 pillaged relics worth** a total of \$3mn to Cambodia, Indonesia

New York prosecutors said on Friday that they had returned to Cambodia and Indonesia 30 antiquities that were looted, sold or illegally transferred by networks of American dealers and traffickers.

The antiquities were valued at a total of \$3mn, Manhattan District Attorney Alvin Bragg said.

Bragg said in a statement that he had returned 27 pieces to Phnom Penh and three to Jakarta in two recent repatriation ceremonies, including a bronze of the Hindu deity Shiva ("Shiva Triad") looted from Cambodia and a stone bas-relief of two royal figures from the Majapahit empire (13th-16th century) stolen from Indonesia.

"We are continuing to investigate the wide-ranging trafficking networks that...target Southeast Asian antiquities," Bragg said in the statement. "There is clearly still much more work to do."

During Bragg's tenure, the Antiquities Trafficking Unit has recovered nearly 1,200 items stolen from more than 25 countries and valued at more than \$250mn. - AFP

### Mexican wins \$28 Cartier earrings battle

A Mexican man has claimed a victory over French luxury brand Cartier, saying an error allowed him to buy two pairs of earrings for \$28 that were supposed to cost nearly \$28,000.

After a four-month struggle, doctor Rogelio Villarreal said he had finally received the jewellery, which he accused the company of refusing to deliver after his online purchase in December.

Cartier declined to recognise the purchase and offered Villarreal a refund, as well as a bottle of champagne and a passport holder as compensation, according to a company letter shared by the doctor.

However, Villarreal refused and decided to take the case to Mexico's consumer protection agency, which ruled in favour of the doctor. - AFP

## Scores of tornadoes lash central US plains states

ozens of tornadoes struck the central United States on Friday, razing homes, knocking down power lines and injuring at least three people, authorities said.

More than 70 tornadoes were recorded across the country by the National Weather Service (NWS), most of them around Omaha, a transportation hub in Nebraska.

Images from storm chasers posted on social networks showed immense black twisters sweeping across the sky, turning over earth, dust and materials in their path.

In the Omaha suburb of Elkhorn, the storms razed numerous homes, blew off roofs and stripped trees of leaves.

"Emergency personnel continue to check damaged houses and assist any injured citizens," Omaha police posted on social media platform X.

Further south, near the Nebraska state capital of Lincoln, a tornado struck an industrial shed.

The 70 or so people inside when the roof collapsed were evacuated, but three suffered non-life-threatening injuries, Lancaster County authorities said at a news conference.

To the northeast of Lincoln, near Waverly, powerful storm winds toppled a train from its tracks, the officials said.

About 11,000 households were without power in Nebraska, according to tracking site Poweroutage.com.

The NWS, which issued numerous urgent tornado warnings in several central US states on Friday, warned that powerful storms would continue this weekend in the central plains,

## **Prospects brighten** for global treaty on responsible use of plastics

Plastic pollution is a significant threat to ecosystems worldwide. Plastic debris harms marine life through ingestion and entanglement, disrupts habitats, and leaches harmful chemicals into the environment.



# Risk for some of America's most productive farmland

ave Duttlinger's first thought when he saw a dense band of yellowishbrown dust smearing the sky above his Indiana farm was: I warned them this would happen.

About 445 acres of his fields near Wheatfield, Indiana, are covered in solar panels and related machinery – land that in April 2019 Duttlinger leased to Dunns Bridge Solar LLC, for one of the largest solar  $developments \, in \, the \, Midwest.$ 

On that blustery spring afternoon in 2022, Duttlinger said, his phone rang with questions from frustrated neighbours: Why is dust from your farm inside my truck? Inside my house? Who should I call to clean it up?

said Reuters' findings in the four counties are "concerning."

"It's not the number of acres converting to solar," he said. "It's the quality of the land coming out of production, and what that means for local economies, state economies and the country's future abilities for crop production."

More than a dozen agronomists, as well as renewable energy researchers and other experts consulted by Reuters, said the approach to measuring solar's impact was fair. The news agency also shared its findings with six solar developers and energy firms working in these counties. Three said Reuters' sample size was too small, and the range of findings too wide, to be a fair portrayal of industry siting and construction practices.

By 2050, to meet the Biden Administration's decarbonisation targets, the US will need up to 1,570 gigawatts of electric energy from solar. While the land needed for ground-based solar development to achieve this goal won't be even by state, it is not expected to exceed 5% of any state's land area, except the smallest state of Rhode Island, where it could reach 6.5%, by 2050, according to the Energy Department's Solar Futures Study, published in 2021. Researchers at American Farmland Trust, a non-profit farmland protection organisation which champions what it calls Smart Solar, forecast last year that 83% of new solar energy development in the US will be on farm and ranchland, unless current government policies changed. Nearly half would be on the nation's best land for producing food, fibre, and other crops, they warned. Five renewable developers and solar energy firms interviewed by Reuters counter that the industry's use of farmland is too small to impact domestic food production overall and should be balanced with the need to decarbonise the US energy market in the face of climate change. Doral Renewables, the developer behind the \$1.5bn Mammoth Solar project in Pulaski and Starke counties, does not consider corn or soybean yields in its siting decisions. Instead, the company looks at the land's topography, zoning and closeness to an electrical grid or substation - and tries to avoid wooded areas, ditches and environmentally sensitive areas, said Nick Cohen, Doral's president and CEO. Shifting corn acres for solar? "I don't see it as replacing something that is vital to our society," Cohen said. Solar can make farmland "more productive from an economic perspective," he added. Indiana farmer Norm Welker says he got a better deal leasing 60% of his farmland to Mammoth than he would have growing corn, with prices dipping to three-year lows this vear. "We've got mounds of corn, we're below the cost of production, and right now, if you're renting land to grow corn – you're losing money," Welker said. "This way, my economic circumstances are very good." - Reuters

up to 37mn metric tonnes of plastic pollution could be entering oceans every year by 2040. This is leaving a legacy of environmental impacts for future generations. Negotiators from

176 countries are now gathering in Ottawa, Canada, for the fourth session of the Intergovernmental Negotiating Committee, which

is hosted by United Nations Environment Programme (UNEP) to develop an international legally binding instrument on plastic pollution, including in the marine environment to advance the development a global agreement, by the end of 2024.

Already several countries have clamped domestic ban on harmful single-use plastics, implemented a comprehensive plan to reduce plastic waste and pollution, and moved towards a circular plastics economy.

According to the summit host Canada, plastic pollution costs more than \$2tn every year, a burden that is largely held by local communities. Without new and effective control measures, and increased international cooperation, the global plastic pollution crisis will intensify.

Greenpeace Canada noted the global plastics treaty has the potential to stop the plastic pollution crisis at the source - if governments truly step up and uphold their responsibility to the people, environment, wildlife, and the climate. Ambition needs to be more than just words.

According to UN Secretary-General António Guterres, "Plastics know no border. Every living being and every part of the planet is harmed by plastics and their production. To beat plastic pollution, we need a strong plastics treaty that upholds human rights and addresses the full life cycle of plastics."

Addressing problems because of plastics contamination requires comprehensive strategies that encompass reduction, recycling, innovation in alternative materials, policy interventions, and global co-operation.

Dunns Bridge said it would use "commercially reasonable efforts to minimise any damage to and disturbance of growing crops and crop land caused by its construction activities" outside the project site and "not remove topsoil" from the property itself. Still, subcontractors graded Duttlinger's fields to assist the building of roads and installation of posts and panels, he said, despite his warnings that it could make the land more vulnerable to erosion.

Crews reshaped the landscape. spreading fine sand across large stretches of rich topsoil, Duttlinger said. When Reuters visited his farm last year and this spring, much of the land beneath the panels was covered in yellow-brown sand, where no plants grew.

"I'll never be able to grow anything on that field again," the farmer said. About one-third of his approximately 1,200-acre farm - where his family grows corn, soybeans and alfalfa for cattle - has been leased.

The Dunns Bridge Solar project is a subsidiary of NextEra Energy Resources LLC, the world's largest generator of renewable energy from wind and solar. Duttlinger said when he approached NextEra about the damage to his land, the company said it would review any remedial work needed at the end of its contract in 2073, as per the terms of the agreement.

NextEra declined to comment on the matter or on what future commitments it made to Duttlinger, and Reuters could not independently confirm them. Project developer Orion Renewable Energy Group LLC directed questions to NextEra.

The solar industry is pushing into the US Midwest, drawn by cheaper land rents, access to electric transmission, and a wealth of federal and state incentives. The region also has what solar needs: wide-open fields.

A renewable energy boom risks damaging some of America's richest soils in key farming states like Indiana, according to a Reuters analysis of federal, state and local data; hundreds of pages of court records: and interviews with more than 100 energy and soil scientists, agricultural economists, farmers

(USDA) as the most productive for growing crops, according to a Reuters analysis.

For landowners like Duttlinger, the promise of profits is appealing. Solar leases in Indiana and surrounding states can offer \$900-1,500 an acre per year in land rents, with annual rate increases, according to a Reuters review of solar leases and interviews with four solar project developers. In comparison, farmland rent in top corn and soybean producers Indiana, Illinois and Iowa averaged about \$251 per acre in 2023, USDA data shows.

Farmland Partners Inc., a publicly traded farmland real estate investment trust (REIT) has leased about 9,000 acres nationwide to solar firms. Much of that ground is highly productive, said Executive Chairman Paul Pittman.

"Do I think it's the best use of that land? Probably not. But our investors would kill us if we didn't pursue this," he said.

Some renewable energy developers said not all leases become solar projects. Some are designing their sites to make it possible to grow crops between panels, while others, like Doral Renewables LLC, said they use livestock to graze around the panels as part of their land management. Developers also argue that in the Midwest, where more than one-third of the US corn crop is used for ethanol production, solar energy is key for powering future electric vehicles. Some agricultural economists

and agronomists counter that taking even small amounts of the best cropland out of production for solar development and damaging valuable topsoil impacts future crop potential in the United States.

Common solar farm construction practices, including clearing and grading large sections of land, also can lead to significant erosion and major runoff of sediment into waterways without proper remediation, according to the US Environmental Protection Agency and the Justice Department.

Solar development comes amid increasing competition for land: In 2023, there were 76.2mn - or nearly 8% – fewer acres in farms than in 1997, USDA data shows, as farmland than solar, citing reports from the Department of Energy and agencyfunded research.

No-one knows how much cropland nationwide is currently under solar panels or leased for possible future development. Land deals are typically private transactions. Scientists at the United States Geological Survey and the US Department of Energy's Lawrence Berkeley National Laboratory have been compiling a database of existing solar facilities across the country. While that project is incomplete and ongoing, Reuters found that around 0.02% of all cropland in the continental US intersected in some way with largescale, ground-based solar panel sites they had identified as of 2021.

The total power capacity of the solar operations tracked in the data set represents over 60 gigawatts of electric power capacity. In the following two years, solar capacity has nearly tripled, according to a December 2023 report from the Solar Energy Industries Association (SEIA) and Wood Mackenzie.

To better understand future land-use patterns. Reuters analysed federal government data to identify cropland that USDA classified as prime, unique, or of local or statewide importance. Reuters also reviewed more than 2,000 pages of solar-related documents filed at local county recorders' offices in a small sample of four Midwestern counties – Pulaski, Starke and Jasper counties in Indiana, and Columbia County in Wisconsin.

The counties, representing an area of land slightly bigger than the state of Delaware, are where some of the nation's largest projects are being developed or built. The sample is not necessarily representative of the broader United States but gives an idea of the potential impact of solar projects in farm-heavy counties.

Reuters found the percentage of these counties' most productive cropland secured by solar and energy companies as of end of 2022 was as follows: 12% in Pulaski, 9% in Starke, 4% in Jasper and 5% in Columbia.

## Italy summons Russian envoy over Ariston subsidiary takeover

Ttaly has summoned Russia's ambassador after Moscow announced it was putting a subsidiary of Italian heating firm Ariston under the "temporary management" of state energy giant Gazprom.

"The government requests clarification on the matter of the nationalisation of the Ariston Thermo Group," Foreign Minister Antonio Tajani said on X.

He said he asked the top official in Italy's foreign ministry to summon Russia's ambassador, adding that Rome was "working also with Brussels, in conjunction with Germany", after Bosch was also targeted.

Tajani earlier said he had spoken to Ariston's top managers and Rome "stands alongside businesses, ready to protect them in all international markets".

An EU spokesman condemned the move as "yet another proof of Russia's disregard for international law and rules" and called on Moscow to reverse it.

The move was announced in a Russian decree published on Friday and signed by President Vladimir Putin.

It transfers control over 100% of the shares in Ariston Thermo Rus, owned by Ariston Holding NV, and 100% of shares in BSH Household Appliances, owned by BSH Hausgerate GmbH, to Gazprom Household Systems, a subsidiary of Gazprom.

In a statement, Ariston Group said it had been active in Russia for almost 20 years and had "very correct relations with the local institutions".

It said it was "extremely surprised" by the decree, of which it said it had no advance notice. "While we wait for an explanation on the unexpected action, we are assessing its implications, including from a governance and managerial standpoint," it said.

Since invading Ukraine, Moscow has taken the Russian subsidiaries of a number of Western companies - notably French food giant Danone and Danish brewer Carlsberg - under what it calls "temporary management control".

It cast the moves as a response to Western sanctions on Russian companies.

Western officials and some of the companies have blasted Moscow's "nationalisation" of private property.

Ariston Group has a water heating manufacturing facility located outside St Petersburg, with around 200 direct and indirect employees, producing products for the local market.

The company said there was also "a local product development centre of excellence and a commercial head office in Moscow, co-ordinating around 100 employees also active on local commercial branches" throughout Russia, operating under the Ariston brand.

The group had a turnover of about €100mn in Russia in the 2023 financial year, it said, and held a "significant asset base".

The EU spokesperson said yesterday: "Russia confirms to be an unpredictable actor also in the economic field, and has created a business climate which is arbitrary and hostile towards foreign investors.

"The European Union calls on Russia to reverse these measures and seek acceptable solutions with European companies targeted by them."

BSH Hausgerate told AFP that it is in discussions with Gazprom Household Systems and would not be making any other comments for the time being.

### Finnish MP suspected of firearm offence

A Finnish far-right MP is suspected of shooting a firearm outside a Helsinki nightclub, the populist Finns Party secretary said. "One of our party's MPs was ... implicated in an incident in Helsinki," Harri Vuorenpaa wrote on X, formerly Twitter, on Friday night. "The course of events is currently unclear. Police are investigating and we are waiting for further information," added Vuorenpaa. According to the Seiska newspaper, two members of parliament were on a night out in the capital on Friday when one fired a gun after leaving the Bar Ihku nightclub.

Several media said MP Timo Vornanen had been arrested. Vornanen is a police officer who enjoys hunting during his time off, according to his personal website. - AFP

### AFP Kyiv

Russia launched a "massive" missile strike at Ukraine overnight, damaging four power plants in the latest barrage targeting the country's energy supply, officials in Kyiv said yesterday.

Ukrainian President Volodymyr Zelensky called on Kyiv's Western partners to supply more air defence systems to protect his country's skies, as the air force said it shot down 21 of 34 incoming missiles.

Moscow has launched some of its biggest ever strikes on Ukraine's energy facilities in recent months, knocking out a significant chunk of production, and triggering blackouts and energy rationing across the country.

Ukraine has also said that it targeted two oil refineries and a military air base in southern Russia during its own wave of overnight drone attacks.

"Thirty-four Russian missiles overnight. We managed to shoot down some of them. But the world has every opportunity to help (us) shoot down every missile and every drone," Zelensky said in a post on Telegram. Energy facilities were hit in at least three re-

gions - including Lviv and Ivano-Frankivsk in the west, hundreds of kilometres from the front line - Energy Minister German Galushchenko said in a Facebook post.

One of the missiles landed 15km (nine miles) from the Polish-Ukrainian border, Poland's Prime Minister Donald Tusk said.

Kyiv says Moscow is escalating attacks from the air and on land ahead of nationwide celebrations on May 9, when Russia marks victory in World War II, and while Ukraine awaits the arrival of crucial US weapons.

The DTEK power operator said equipment at four of its thermal power plants was "severely damaged" in the overnight strikes.

State electricity operator Ukrenergo said it had disconnected its main overhead power line in the west of the country as a preventative measure.

Officials urged people and businesses to limit their power usage.

"We ask all consumers to consume electricity sparingly. Industry is asked to maximise electricity imports and use alternative power sources," Ukrenergo said in a statement.

The head of the western Lviv region called on residents not to use kettles, irons, washing machines and microwaves in peak evening hours.

At least two people were killed in separate shelling attacks on the northeastern Kharkiv region and southern Kherson region, Ukrainian officials said.

The spate of missile and artillery attacks also injured more than a dozen.

Russia's defence ministry said yesterday that over the last week it had carried out 35 "group strikes" against Ukrainian energy sites, military factories, railway facilities, air defence systems and other targets.

On Friday the US announced a \$6bn package of military supplies to Kyiv to include key air

defence munitions and artillery rounds.

Ukraine launched its own massive drone attack on Russia's southern Krasnodar region overnight.

A Ukrainian defence source told AFP that it had hit two oil refineries and a military airfield in the region, just east of the annexed Crimean peninsula.

"Ukrainian drones struck the atmospheric distillation columns of the Ilsky and Slovyansky refineries. These are key technological facilities," the source said.

Russian officials in the Krasnodar region reported a fire at an oil refinery in the town of Slavyansk-on-Kuban. The refinery partially suspended operations

as a result, Russian state media reported, citing a company representative.

Videos and photos on social media showed a large fire raging overnight at the site after a series of blasts.

Moscow said Ukraine had launched one of its largest ever attempted drone attacks on the Krasnodar region.

"Air defences destroyed and intercepted 66 Ukrainian drones over the territory of the Krasnodar region and two over the Crimean peninsula," the defence ministry said.

The governor of Russia's Belgorod border region said later that five people were injured when a Ukrainian drone fell on a road a few kilometres from the border.

Kyiv has hit several oil refineries in western Russia in recent months, despite reports of concern in Washington that the strikes could be seen as escalatory and might drive up global oil prices.

Ukraine says targeting Russia's vital energy sector is legitimate as it is a source of fuel and funds for the Russian army.

## Latvians asked to turn their basements into air-raid shelters

uthorities in Latvia called on residents to use yesterday's annual "Big Clean-up Day" to turn basements into air-raid shelters, with many in the Baltic country concerned they could be Russia's next target.

The former Soviet republic, now a member of the North Atlantic Treaty Organisation (Nato) and the European Union, has a 214km (133-mile) border with Russia, and has been one of Ukraine's most reliable supporters since Russia's invasion.

"We call on everyone during the big clean-up, but also afterwards, to ensure that your cellars and your basements can be used as shelters in case of emergencies," said Vilnis Kirsis, mayor of the capital Riga.

Gints Reinsons, head of a Riga civil defence commission, said "the basements of public buildings, schools, retirement homes, hospitals, and town halls will be inspected by the authorities who will prepare them to serve as hiding places in the event of an attack".

He told the TV24 station that the goal was to prepare a hundred anti-bomb shelters a month through the end of the year.

Since 2008, thousands of Latvians have gathered each spring to participate in a national clean-up day, a tradition that has now been followed by Baltic neighbours Lithuania and Estonia. - AFP

## Spanish prime minister's supporters turn out and beg him to stay

housands of supporters of Spanish Prime Minister Pedro Sanchez rallied at the headquarters of his Socialist party imploring him not to step down over a graft investigation against his wife.

The 52-year-old premier, who has been in office since 2018, stunned Spain on Wednesday when he put his resignation on the line after a Madrid court opened a preliminary investigation into suspected influence peddling and corruption against his spouse Begona Gomez.

Sanchez said he would suspend all public duties until he announces his decision tomorrow.

The normally hyperactive premier has since remained out of sight and silent.

According to Madrid city authorities, the crowd rallying yesterday to beg Sanchez to stay on numbered around 12,500.

Supporters held up placards saying "Spain needs you", "Pedro don't abandon us; and shouted slogans such as "Pedro leader".

"I hope that Sanchez will say on Monday that he will stay," said Sara Dominguez, a consultant in her 30's, adding that his government had "taken good steps for women, and the minorities".

Jose María Diez, a 44-year-old

government official who came from Valladolid in northern Spain to express his support, said there is a real possibility that the far-right could take power if Sanchez quit.

"This will mean a step backwards for our rights and liberties," he warned.

"I hope he continues, because Spain has to continue with him. If not, it scares me. We are afraid of what could come," Leonor Romero, 56, a councillor from Huelva, southern Spain, told Reuters.

"He must continue. I think he is not going to resign. He will leave us orphans," Jose Luis Trigo, 74, a pensioner, said.

Inside the party headquarters, there were similar passionate appeals.

"Pedro stay. We are together and together we can ... take the country forward, Spain can't step back,"

said Budget Minister Maria Jesus Montero, the government number two.

"Today all democrats, all progressives, are summoned to Madrid against a pack whose only aim is to overthrow a democratic and legitimate government," said Felix Bolanos, the minister of the presidency, justice and parliamentary relations.

At one point, Socialist leaders

took to the streets to thank those gathered.

"They won't succeed," government spokeswoman Pilar Alegria told the crowd.

The court opened the investigation into Sanchez's wife in response to a complaint from anticorruption pressure group Manos Limpias (Clean Hands), whose leader is linked to the far-right.

The group, which has presented a litany of unsuccessful lawsuits against politicians in the past, said on Wednesday that its complaint was based on media reports and could not vouch for their veracity.

While the court did not give details of the case, online news site El Confidencial said it focused on links Gomez had to Spanish tourism group Globalia when carrier Air Europa was in talks with the government to secure a huge bailout.

The airline sought the bailout after it was badly hit by plunging passenger numbers during the coronavirus (Covid-19) crisis.

At the time, Gomez was running IE Africa Centre, a foundation linked to Madrid's Instituto de Empresa (IE) business school, which had signed a sponsorship agreement with Globalia in 2020.

Spain's public prosecutor's office on Thursday requested the dismissal of the investigation, which Sanchez said was part of a campaign of "harassment" against him and his wife waged by "media heavily influenced by the right and far-right".

If Sanchez decides to remain in office, he could choose to file a confidence motion in parliament to show that he and his minority government are still supported by a majority of lawmakers.

If he resigns, an early election could be called from July - year after the last one - with or without Sanchez at the helm of the Socialist party.

The right-wing opposition has accused the prime minister of being irresponsible for putting the country on hold while he mulls his decision.

"I ask all citizens not to be fooled. Spain does not have a problem, the one who has a judicial problem is Sánchez, his government, his party and his circle. Let them solve it," Alberto Nunez Feijoo, the leader of the opposition conservative People's Party (PP), told a meeting in Tarragona in Catalonia.

A survey, carried out for the PP by the polling company Sigmados, found 54.1% believed Sanchez's period of reflection was a "political strategy" to gain support before the Catalan elections on May 12 and European Parliamentary elections in June.

Some 56.4% of the 1,527 people questioned, said they believe Sanchez will not resign tomorrow while 21.2% said they thought the prime minister will call for a motion of confidence in parliament.

## Mona Lisa could get a room of her own

The Mona Lisa by Leonardo da Vinci, the world's most famous portrait, could get a room of its own in the Louvre, the museum's president said yesterday.

Such a move would give visitors, many of whom visit the Louvre for the iconic painting alone, a better experience, Laurence des Cars told the France Inter broadcaster.

"It's always frustrating when you don't give visitors the best possible reception, and that is the case for the Mona Lisa," she said.

"A better solution seems necessary to me today," des Cars said, adding that the Louvre was in contact with the culture ministry about potential solutions.

The Louvre, the world's most popular museum, welcomed close to 9mn visitors in 2023.

Des Cars said that 80% of them - 20,000 people per day - braved the crowd to catch a glimpse of the Mona Lisa's enigmatic smile, often taking selfies in front of the painting.

The Mona Lisa currently hangs in the Louvre's Salle des Etats (State Room), the museum's biggest, in a protective glass case, but Da Vinci's masterwork is not alone there

It is accompanied by works by 16th-century Venetian masters, and across the room hangs the Louvre's biggest painting, The Wedding at Cana by Paolo Veronese. - AFP
