Israeli fire kills 17 near Gaza aid site

Israeli gunfire killed at least 17 Palestinians and wounded dozens as thousands of displaced people approached an aid distribution site run by a US-backed humanitarian group GHF in central Gaza yesterday. "Day after day, casualties & scores of injured are reported at distribution points manned by Israel & private security companies," Philippe Lazzarini, the chief of the UN Palestinian refugee agency (UNRWA), wrote on X. "This humiliating system continues to force thousands of hungry & desperate people to walk for tens of miles excluding the most vulnerable & those living too far." he said.

10 killed in Austrian school shooting

Qatar to be 'best performing' GCC economy in 2026, 2027: World Bank

atar's economy will clock a real GDP growth of 2.4% this year, 5.4% in 2026 and 7.0% in 2027, the World Bank said in its forecast released yes-

Qatar will outperform the other five GCC countries in real GDP growth in 2026 and 2027, World Bank data reveal.

According to the World Bank forecast, Bahrain's economy will grow 3.5% this year, 3% in 2026 and 2.8% in 2027.

For Kuwait, the World Bank forecasts a real GDP growth of 2.2% this year, and 2.7% in both 2026 and 2027.

Oman, the World Bank forecast says, will grow at 3% this year, 3.7% in 2026 and 4% in 2027.

According to the World Bank forecast, Saudi Arabia's real GDP will grow at 2.8% this year, 4.5% in 2026 and 4.6% in 2027.

UAE, the World Bank forecast says, will grow at 4.6% this year and 4.9% in both 2026 and 2027.

The World Bank said growth in members of the Gulf Co-operation Council (GCC) is forecast to increase to 3.2% in 2025, 4.5% in 2026, and 4.8% in 2027.

The phase-out of oil production cuts is expected to lead to rising oil production, despite projected lower oil prices amid weakening global demand, it said.

Growth is also envisaged to continue to be boosted by expanding non-oil activity. Among the non-GCC oil exporters, activity in several countries is projected to be constrained by lower oil prices and weaker external demand.

In oil importers, growth is projected to pick up to 3.6% in 2025, 3.9% in 2026, and 4.3% in 2027, mostly owing to strengthening private consumption as inflation softens, a recovery in agricultural output, and assumed moderation of geopolitical tensions.

Despite the rise in global trade tensions and heightened uncertainty, activity in the Middle East and North Africa (MNA) has strengthened, in part reflecting increasing oil production, the World Bank noted. **To Page 6**

Qatar slams fabricated Israeli reports

Qatar has slammed recent fabricated reports in the Israeli media, denouncing them as "a deliberate" attempt to sow division between the Gulf state and the US at a critical time of their joint mediation efforts in the

"Fabricated documents are once again circulating in the Israeli media in an attempt to sow tension and division between Qatar and the US at a crucial stage in our efforts to mediate a ceasefire between Israel and Hamas," Qatar's International Media Office (IMO) said in a statement yesterday.

"The timing of their release is

no coincidence. It is a deliberate

distraction, deployed by those who want to deflect attention from negative coverage of their own irresponsible actions in Gaza - including those reported in the news over the past week - at a moment when a breakthrough is within reach," IMO said.

"This tactic has been used previously by those who want diplomacy to fail. They do not want Qatar's work with the Trump administration - on the Gaza file and other regional files - to succeed in bringing peace to the region.

"Similar methods have been used against those who have spoken out against the continuation of the war, or worked diplomatically to bring the hostages home including members of President Trump's administration, in an effort to discredit them and undermine the diplomatic process," the statement said.

IMO stressed that their efforts will not succeed. "No fabricated documents will weaken the bond between Qatar and the US."

Qatar supports international efforts to protect water bodies, ensure sustainability: minister

E the Minister of Environment and Climate Change, Dr Abdullah bin Abdulaziz bin Turki al-Subaie, has affirmed Qatar's commitment to supporting international efforts aimed at protecting water bodies and ensuring the sustainability of their resources. HE the minister highlighted the importance of international cooperation to address the growing challenges threatening the health of

marine ecosystems.

During a speech he delivered at

the third edition of the United Nations Ocean Conference, hosted by the French city of Nice over five days, HE the minister explained that water bodies are the lifeblood of the planet and play a fundamental role in regulating the climate, providing food, and ensuring environmental and economic security. However, they face unprecedented pressures that require an urgent global response.

He noted that the State of Qatar strongly supports the achievement of Sustainable Development Goal 14, which concerns the conservation and sustainable use of oceans, seas, and marine resources, emphasising that the health of these bodies of water represents a fundamental pillar in supporting countries' ability to achieve long-term economic and social development.

In his speech, HE the minister reviewed the most prominent environmental initiatives adopted by the State of Qatar, including treating and recycling 100 percent of wastewater to at least the third level, preventing the discharge of treated wastewater into the sea, and reusing it for irrigation of green spaces, cooling, and industrial purposes.

He also highlighted the launch of the Third National Development

Strategy (2024-2030), which aims to protect 30 percent of marine areas and restore 30 percent of degraded natural habitats by 2030.

He also highlighted the Ministry of Environment and Climate Change's 2024-2030 Strategy, announced last November, which includes ambitious goals, most notably protecting 30 percent of island and coastal areas, ensuring the restoration of degraded habitats, and protecting endemic and endangered species.

He also highlighted the implementation of more than 100 environmental projects that promote green development and the circular economy, enhance the use of recycled resources, and consolidate environmental sustainability practices in the areas of infrastructure, energy, and land use. Concluding his speech, HE Minister of Environment and Climate Change affirmed that the State of Qatar continues to support innovation in combating climate change and is working to develop adaptation measures in cooperation with relevant authorities.

He emphasised that global environmental challenges require concerted international efforts to protect oceans and seas, considering them a shared resource and a collective responsibility.



QRCS Udhiyah campaign benefits over 737,000 people across several nations

atar Red Crescent Society (QRCS) has successfully concluded its 1446 AH En al-Adha Campaign under the theme 'Udhiyah... Is Blessing'. Implemented on behalf of donors from Qatar, the campaign distributed approximately 24,000 sacrificial animals (Udhiyah) in Qatar and 15 countries across Asia and Africa, benefiting nearly 737,000 people.

The project was launched to fulfil the religious duty of Udhiyah during the designated days of Eid while also spreading joy and relief among underprivileged families, displaced individuals, and refugees in need.

This year's campaign was marked by efficient planning and swift execution, thanks to the efforts of QRCS' skilled field teams and reliable local partners. Despite logistical challenges in some areas, the sacrificial rituals were carried out in strict compliance with Islamic guidelines.

Faisal Mohammed al-Emadi, secretary-general of QRCS, said: "The Udhiyah campaign achieved remarkable success in demonstrating the values of solidarity and compassion. We extend our sincere gratitude to all our donors and supporters. The success of this campaign is a result of our collective dedication and the professionalism of our field teams. We promised to deliver your Udhiyah to those in need — and we fulfilled that promise."

In Qatar, QRCS distributed meat from 425 sacrificed sheep to 575 vulnerable families comprising around 3,000 individuals and registered under the Community Care Section. QRCS' campaign extended to 15 countries in Africa and Asia. In Syria 194 sheep were



slaughtered and distributed to 2,900 displaced families (around 14,500 people) in camps in northern Idlib, in cooperation with the Syrian Arab Red Crescent. Yemen: 4,833 displaced and vulnerable families (24,165 beneficiaries) across Aden, Abyan, Haijah, and Al-Bayda received meat from sacrificial animals. Jordan: 712 Syrian refugee and host community families (3,560 people) in Amman, Zarqa, and Mafraq were supported through 11 distribution points in coordination with the Jordan Red Crescent.

Niger: 515 families (34,502 individuals) benefited in Niamey and Tillaberi through local partnerships. Djibouti, Chad, and Tanzania: A total of 3,698 families (22,838 beneficiaries) received meat from cattle and goats in collaboration with national societies and the Chadian Medical Organisation.

Bangladesh: 4,500 families (22,500 people), including refugees, orphans, and vulnerable host community members, received meat in various provinces. Afghanistan: In co-operation with the Afghan Red Crescent, 1,120

impoverished families (7,840 beneficiaries) were reached in Zabul and Nangarhar provinces.

Somalia: In Banadir region, 1,858 animals were sacrificed and distributed to 7,432 displaced and needy families, benefiting 44,592 individuals. Sudan: With the participation of the Minister of Health and Governor of Al-Qadarif, 3,676 families (25,732 people) in refugee shelters across Al-Qadarif state received Udhiyah meat during Eid's first two days.

Mauritania: 350 families (2,100 beneficiaries) in the capital Nouak-chott received meat through coordination with the Mauritanian Red Crescent. Tajikistan and Gambia: A total of 1,190 families received distributed meat in both countries.

In Gaza, a total of 12,810 Udhiyah were allocated, benefitting around 525,000 individuals. The first phase of the operation was carried out in compliance with Islamic rituals: animals were selected, inspected, slaughtered, and then processed into partially cooked canned meat with broth. These food packages will be sent into Gaza as soon as border crossings reopen.

Qatar Charity distributes Udhiyah offering through global outreach

atar Charity (QC) implemented the sacrificial meat distribution project as part of its seasonal campaign adunched for the month of Dhul-Hijjah 1446 AH (2025) under the slogan 'The Greatest Days', thanks to the generous support of donors in Qatar. In a statement, the QC revealed that the project benefited over 850,000 people across 38 countries, including Qatar.

Meat from around 45,300 sheep and cattle was distributed globally, with a focus on crisis-affected countries and regions such as Gaza, Syria, Sudan, Yemen, and Somalia. In Qatar, the sacrificial meat from 4,000 sheep were distributed to around 30,000 individuals. Outside of Qatar, the meat of nearly 41,300 sacrifices were distributed to approximately 826,000 people in 37 countries across Africa. Asia. and Europe.

Udhiyah distribution took place in Albania, Bosnia and Herzegovina, Pakistan, Bangladesh, Kosovo, Nepal, Nigeria, Ghana, The Gambia, Palestine, Syria, Tanzania, Niger, Sri Lanka, Senegal, Ethiopia, Indonesia, India, Lebanon, South Africa, Malaysia, Yemen, Chad, Somalia, Burkina Faso, Turkiye, Tunisia, Kyrgyzstan, Mali, Cote d'Ivoire, Jordan, Egypt, Sudan, Kenya, Djibouti, Mauritania, Togo, Benin, and Burundi. The QC implements the sacrificial Udhiyah project annually, given its importance in embodying the values of solidarity and compassion among Muslims in a practical way. Qatar joins 'Reimagining Education' forum in Chile

n a bid to deepen international dialogue on the future of educa-■tion, the State of Qatar participated in 'Reimagining Education: New Paths for Educational Innovation; a high-level forum hosted by Fundacion Reimagina in Santiago, Chile. The event, held as part of the Qatar-Chile 2025 Year of Culture, brought together educators, policymakers, and innovators to explore new models for educational reform and cross-sector collaboration.

The forum featured contributions from Aurelio Amaral, Director of Programs at the World Innovation Summit for Education (WISE), an initiative of Qatar Foundation, and Hazem Idriss, Deputy Director of Community Development at Qatar Museums. Their presence underscored Qatar's growing role in fostering education and cultural diplomacy as tools for building bridges across continents.

"Innovation in education requires a systems-thinking approach - one that values grassroots



ideas and connects them with global frameworks," said Amaral on the sidelines of the forum. "Events like this are essential for bringing diverse voices together to co-create inclusive, resilient learning ecosys-

Amaral also highlighted WISE's global role in advancing education through research, policy dialogue, and cross-sector partnerships. Since its founding in 2009 by, WISE has become a global platform for educational transformation.

For Idriss, the value of education extended beyond the classroom. He shared lessons from Oatar's international volunteer initiatives,

which pair service-based learning with cultural exchange. Idriss's participation in the forum coincided with a broader visit to Chile and Argentina, where he is conducting site assessments for Qatar Museums' international volunteer programme, an initiative that became an integral part of annual Years of Culture programming during the Qatar-Indonesia 2023.

"Promoting collaboration between organisations, countries and sectors is a core value of Fundacion Reimagina. In order to fulfil our mission of ensuring education that responds to the challenges of 21stcentury society, we require part-

nerships and exchanges that guarantee higher educational quality and the development of key skills, such as creativity, critical thinking and digital proficiency. This requires a profound and practical approach to innovation, which we aim to promote at this meeting with Years of Culture and WISE," said Ana María Raad, Founder of Reimagina and AprendoLAB.

A recent example of this commitment is AprendoLab, a project by Fundacion Reimagina that was named one of the six 2024-25 WISE Prize for Education Finalists. The finalists have been working over the past year to develop solutions for fundamental challenges in education systems, such as accelerating foundational literacies, improving the teaching and learning of Arabic, and addressing emerging challenges of artificial intelligence in education.

Organisers hope that by linking local innovation in Chile with international examples, the forum can spur new partnerships and create momentum for scaling highimpact educational strategies, a powerful legacy of the Qatar-Chile 2025 Year of Culture.



QU continues to accept online admission applications for Fall

atar University (QU) announced that it will continue accepting online applications for new students for the Fall 2025 semester until July 9, noting that admission decisions will be announced on August 4.

In a statement, the university explained that the colleges available for admission according to the percentages and criteria for the Fall 2025 semester are 70% for the Colleges of Arts and Sciences, Engineering, Business and Economics, Law, Sharia and Islamic Studies, Education, Health Sciences, Nursing, and Sports Sciences. The required percentage is 85% for the Colleges of Medicine and Dentistry, and 80% for the College of Pharmacy.

The university emphasised

that admission to the university is based on the principle of competition among applicants, and that meeting the minimum requirements for high school education does not guarantee acceptance based on the student's first preference. Rather, students are admitted based on the capacity of each college. It also noted that it will take the educational track in high school into consideration when applying to the university.

The statement indicated that admission applications must be submitted by completing the electronic form on the university's official website www.qu.edu. qa/apply, urging students wishing to enrol to quickly submit their applications and upload all required documents. (QNA)



uropean powers and the United States submitted a resolution to the UN's nuclear watchdog board yesterday condemning Iran's "non-compliance" with its nuclear obligations, in a bid to up pressure on Tehran, diplomats said.

It is the latest move in a years-long effort to restrict Iran's nuclear activities over fears that it is seeking to develop nuclear weapons, which it denies. The diplomatic manoeuvre comes as the United States and Tehran have held several rounds of talks mediated by Oman, aimed at securing an agreement on limiting Iran's nuclear programme in exchange for sanctions relief.

"The text has been submitted," three diplomatic sources said last night.

Paris, Berlin, London and Washington formally tabled the resolution at this week's board meeting of the Viennabased International Atomic

Energy Agency (IAEA), which come t today evening at the earliest.

The draft resolution obtained by AFP calls on Iran "to urgently remedy its non-compliance" with its commitments under the Non-Proliferation Treaty (NPT).

It also "deeply regrets" that Tehran "despite repeated calls from the Board and many opportunities offered... has failed to co-operate fully with the Agency".

The agency's "inability... to provide assurance that Iran's nuclear programme is exclusively peaceful gives rise to questions that are within the competence of the United Nations Security Council (UNSC)", which can draw up sanctions.

The resolution follows an IAEA report in late May that showed "a general lack of cooperation" by Tehran, diplomats said, including in providing "credible" answers to questions by the agency... as well as the theft of confidential documents and the cleaning up of undeclared sites.

HMC delivers top emergency services during Eid holidays

he Hamad Medical Corpo ration (HMC) continued to serve the public during the Eid al-Adha holidays while handling emergency cases over the first three days.

The Emergency Department of Hamad General Hospital received a total of 2,020 cases during the three days. The first day witnessed 634 cases while the second and third days recorded 683 and 703 cases, respectively.

Dr Aisha al-Sada, emergency specialist at Hamad General Hospital, told local Arabic daily Arrayah that patients suffering from digestive system-related illnesses were treated during the period while traffic accidents were also dealt with at the Emergency Department.

The Paediatric Emergency Centre at Al Sadd and the emergency wings at other PHCCs and hospitals received a total of 5,549 cases during the three days. A total of 1,939 cases were received on the third day. The second and first days recorded 1,946 and 1,664 cases.

Dr Mohamed al-Amri, head of the Paediatric Department and director of Paediatric Emergency at HMC, said most of the cases were mild to moderate with



some patients being admitted to intensive care and put under observation. He added that most cases were of high temperatures, coughs and colds. These were caused by viral infections in addition to intestinal infections, all of which were mild and didn't reach severe levels.

The Ambulance Service at HMC attended to a total of 2,195 cases during the first three days of Eid al-Adha. Ali Darwish, assistant executive director of the Ambulance Service, said these cases included traffic accidents and some were transported by air ambulance. The HMC official

explained that the service covered beaches of Dukhan, Al Khor, Sealine, Al Ghariya, Simaisma, Al Ruwais and Al Wakra while providing special coverage for Katara Cultural Village due to the high turnout it witnessed during the holidays.

He noted that the ambulance service has increased its presence on beaches with ambulances and four-wheel drive vehicles, in addition to distributing bicycles and golf carts in locations such as Katara and Aspire Park to facilitate access to patients in areas crowded with pedestrians.

Besides, industrial activity, particularly in construction, has strengthened in Morocco.

In contrast, activity in West Bank and Gaza has been devastated, with significant destruction of physical capital and massive humanitarian costs in Gaza, as well as heightened tensions in West Bank.

Geopolitical tensions in the Middle East moderated somewhat following ceasefires in late 2024 and early 2025, but violence has resumed in Gaza and Lebanon, and the situation remains highly fragile and uncertain. Tensions have remained high in other countries in fragile and conflict-affected situations (FCS). Outlook: Growth in MNA is expected to pick up to 2.7% in 2025 and strengthen further to 3.7% in 2026 and 4.1% in 2027

"This primarily reflects a gradual expansion of oil production that more than offsets the effects of lower oil prices, and despite the constraints on export activity from rising trade barri-

"Growth forecasts are lower than projected in January, mainly due to the impact of increases in trade restrictions and uncertainty on investment and export activity," the World Bank noted.

Two Palestinians killed as Israeli forces storm West Bank city

ties had been informed by Israel of the deaths of Nidal Amira, 40, and Khaled Amira, 35. It did not specify whether the two were related.

AFPTV footage showed Israeli soldiers standing in one of the old city's narrow streets, next to two dead bodies.

An AFP journalist said dozens of military vehicles entered Nablus' historic centre shortly after midnight (2100 GMT Monday). A curfew had been announced over loudspeakers the day

At a major square outside the old city, young men and boys gathered yesterday to burn tyres and throw stones at the Israeli armoured vehicles.

Suicide 'unlikely in Kenya police custody death'

enyan medical examiners said yesterday that suicide was unlikely in the death of a man while in police custody a case that has sparked protests and widespread anger.

Albert Ojwang, 31, was arrested over posts on social media accusing police deputy inspectorgeneral Eliud Kipkoech Lagat of corruption.

Police initially said he died over the weekend in his cell after hitting his own head against the

But government pathologist Bernard Midia, one of five to examine Ojwang's body, told reporters the injuries were "unlikely to be self-inflicted".

Ojwang was arrested in western Kenya but transferred more than 250 kilometres to Nairobi, "without proper orders from the court", the Law Society of Kenya (LSK) said on Monday.

Kenya was already on edge as it marks a year since massive protests over tax rises and corruption that triggered a police response in which at least 60 were

"The cause of death is very clear; head injury, neck compression and we also have other injuries spread all over the body that are pointing towards assault," said Midia.

His colleague Geoffrey Mutuma said there were "a lot of injuries in the skin, in the back... inflicted with a lot of force".

Ojwang also had "what we call self-defence injuries", he added.

After the postmortem, protesters marched to the deputy inspector-general's office, demanding his immediate resigna-

"The results were coincid-

ing well with our argument that Albert Ojwang was murdered in central police station," activist Geoffrey Mboya said.

The protesters have described the deputy inspector general as 'the main suspect".

"We want Eliud Lagat to resign...so that investigations can be done properly," activist Shakira Wafula said.

Five officers have been removed from active duty to "allow for transparent investigations", police spokesman Michael Muchiri said yesterday.

He said the "suicide theory has been banished" after the postmortem results. "This is a heavy burden for my family," said the victim's father, Meshack Ojwang.

Veteran opposition leader Raila Odinga wrote on X that Ojwang "joins the horrifying long list of young and defenceless Kenyans whose lives have been taken too soon, in brutal and senseless circumstances, at the hands of the police."

Rights groups say dozens were illegally detained in the aftermath of last year's protests, with many still missing, and others have been arrested for mild criticism of the government and President William Ruto.

Odinga, who forged an alliance with Ruto's government this year, said the deaths "seriously erode the authority and credibility of the police and the state".

70 SA white rhinos relocated to Rwanda

wanda said yesterday that 70 white rhinos had been 70 white minos has consuccessfully relocated to the Great Lakes nation after a two-day journey of some 3,000 kilometres from South Africa.

It was the largest ever relocation of rhinos, which can weigh up to two tonnes, Rwandan officials said.

Once abundant across sub-Saharan Africa, rhino numbers have dramatically fallen due to hunting by European colonisers and largescale poaching.

The animals were transported in two loads of 35 - first aboard a Boeing 747, then by road - from South Africa's Munywana Conservancy to Akagera National Park in Rwanda, or about 3,000 kilometres as the crow flies, according to the Rwanda Development Board

(RDB). A "dedicated veterinary team will closely monitor their health and behaviour for several weeks to ensure proper adaptation to their new environment and management of any stress associated with the move", it said in a statement.

The move was part of African Parks' Rhino Rewild Initiative. supported by The Howard G Buffett Foundation, and aims to support population growth and secure a new breeding stronghold in

According to the International Rhino Foundation (IRF), rhino poaching in Africa rose by 4% from 2022 to 2023, with at least 586 rhinos poached in 2023.

The southern white rhino, one of two subspecies, is now listed as "near threatened", with roughly 17,000 individuals remaining, according to the International Union for Conservation of Nature (IUCN).

lack of preparation of certain party officials that led to his elimination. That's why you always have to have several strings to your bow, especially when you're in politics." Ivory Coast law states that candidates must be Ivorian citizens and cannot hold another

Thiam renounced his French citizenship in February in order to meet eligibility conditions for the election.

But a court in Ivory Coast ruled in April that Thiam should be removed from the electoral roll because he was a French national when he registered. Thiam told Reuters after that decision that he planned to fight on and run anyway.

The notion of Ivorian identity was at the heart of past violence in Ivory Coast, and some fear lingering questions over Thiam's nationality in the run-up to the vote risk pushing those tensions back to the surface.

Incumbent President Alassane Ouattara himself was barred from seeking the presidency over what opponents said were his foreign origins before he finally won elec-

Ouattara, 83, has not said whether he will run again this year.

Billon told Reuters that if elected he would endorse a law to lift restrictions on dual nationality.

Nigeria's dog owners hit with surging pet food prices amid cost of living crisis

igeria's two-vear-old cost of living crisis, which has seen the price of grocery staples like rice rise over 100% since 2023, has reached the relatively affluent class of dog owners, who are struggling to feed their pets because of soaring food costs.

Keeping animals as pets is a recent trend in Nigerian society, where traditionally people were more likely to live with chicken or goats reared for food.

Over the past two decades, there was a rise in the number of households in urban areas keeping pet dogs, often for security in a country plagued by violent crime, but also for companionship. No precise data are available on dog ownership, but a 2023 survey by

research agency TGM Statbox indicated that around 42% of Nigerians own pets.

However, in a sign of economic hard times hitting across society, that is an increasingly expensive

One dog owner, Peter Anthony, a student who lives with his parents in the southwestern city of Ibadan, said feeding his German Shepherd, Flora, was never previously a concern for the family.

"Before the whole high cost of living saga, feeding her was so easy," he said, waiting for Flora at a pet hospital where she had been treated for an ear condition.

"But now, by the time you pick out that money from your pocket, you'd know that something has left you," he said.

The family now feeds Flora a smaller daily ration of noodles mixed with fish or eggs, Anthony

said. Flora's owners are among the lucky ones who are still able to keep their dog healthy, even footing vets' bills.

In a crisis that began when gov-

ernment removed a fuel subsidy and devalued the naira currency in May 2023, inflation has been in double digit territory, hitting 34.80% last December, the highest in three decades, before easing to 23.71% in April.

Latest World Bank data shows that 31% of Nigeria's more than 200mn citizens live below the international extreme poverty line of \$2.15 per day.

While pet owners are not among the country's poorest, they are feeling the pinch. Some dog breeders say they are reducing their activity because so many pet owners are struggling.

Sarah Mokelu, who has a business importing dogs from Russia, has reduced the frequency of her trips there to about once every three months, from twice a month previously, because of surging prices and a drop in sales.

she said she would bring between 15 and 20 dogs. Now, during her last trip in May, she brought in six dogs. "Feeding has really humbled a lot of people," said Mokelu, 63, at her home in the Ejigbo neighbourhood of Lagos. "There was a feed we bought about six months ago for 40,000 naira (\$25.70), now we're buying for 70,000 naira." This price, for a 15-kg bag, is the same as the country's minimum monthly wage of 70,000 naira.

During her twice a month trips,

Akindele Olunloyo, CEO of a dog importing company called Pet Lovers Nigeria, said all of his costs - animals, food, transport, permits, airport fees - had risen so much that he had changed his business model.

Olunlovo runs an online platform that helps Nigerians buy and sell pets. He said 90% of the people on the site were interested in buying and selling dogs at a price range of 20,000 to 100,000 naira, well below the price he might charge for an imported dog, which could be in the 300,000-500,000 naira range.

"I now import only for clients who are interested in buying their own food, high net worth Nigerians who place specific orders," he

Several breeders said they had $switched \ from \ imported \ dog \ foods$ to cheaper alternatives, like mixing rice or noodles with fish or eggs. As imported dog food has become unaffordable for many, business has improved for local pet food producers.

"People not being able to afford the foreign kibbles... made people to look in our direction," said Theresa Iwhewhe, who owns a pet hospital and pet food producing company in Ibadan.

UK jobless rate rises to highest since 2021

Pay growth in Britain slowed sharply and unemployment rose to its highest in nearly four years in the three months to April, official data showed yesterday. Wage growth slowed to 5.2%, its weakest since the three months to September and down more than expected from 5.5% in January to March this year. The jobless rate rose to 4.6% from 4.5%, its highest since the three months to May 2021, the Office for National Statistics said. The April data was the first since employers were hit by a £25bn (\$34bn) rise in social security contributions which came into force at the start of the month.

Britain to invest £14.2bn in Sizewell C nuclear project

Britain will invest a further £14.2bn (\$19.25bn) to build the Sizewell C nuclear plant in southeast England, the government said yesterday, as part of its wider spending review which will define its priorities over the next four years. Britain is seeking to build new nuclear plants to replace its ageing fleet to boost its energy security, reach its climate targets and also create new jobs. The funding announced yesterday takes the total amount the government has committed to the project to £17.8bn, with £3.6bn invested prior to the spending review. The Sizewell C plant in Suffolk is expected to create around 10,000 jobs.

Chinese aircraft carriers seen in Pacific, says Japan

Two Chinese aircraft carriers were operating in the Pacific for the first time, according to Japan, whose defence minister said yesterday the move revealed the expansion of Beijing's military activities. Beijing said yesterday the Shandong and Liaoning carriers - its only two currently in operation, with a third undergoing sea trials - were carrying out "routine training". "We believe the Chinese military's purpose is to improve its operational capability and ability to conduct operations in distant areas," a Japanese defence ministry spokesman said. Defence Minister Gen Nakatani told reporters the sightings show that the Chinese military's "activity area is expanding".

Maruti Suzuki cuts near-term EV production amid rare earths crisis

aruti Suzuki has cut nearterm production targets for its maiden electric vehicle e-Vitara by two-thirds because of rare earths shortages, a document showed, in the latest sign of disruption to the auto industry from China's export curbs.

India's top carmaker, which said on Monday it had not seen any impact yet from the supply crisis, now plans to make about 8,200 e-Vitaras between April and September, versus an original goal of 26,500, according to a company document.

It cited "supply constraints" in rare earth materials that are vital in making magnets and other components across a range of hi-tech industries. Maruti still plans to meet its output target of 67,000 EVs for the year ending March 2026 by ramping up production in subsequent months, the document said.

China's curbs on some rare earth exports have rocked the global auto industry, with companies warning of severe supply chain disruptions. While some companies in the US, Europe and Japan are seeing supplies easing as they secure licences from Beijing, India is still waiting for China's approval amid fears of production stoppages.

Launched amid much fanfare at India's car show in January, the e-Vitara is crucial to Maruti's EV push in the country, marking its entry in a segment that Prime Minister Narendra Modi's government wants to grow to 30% of all

However, in the second half of the financial year - between October and March 2026 - Maruti plans to ramp up production to 58,728 e-Vitaras, or about 440 per day at its peak, versus a previous target of 40,437 for those six months under

Two supply chain sources confirmed Maruti's plan to scale back e-Vitara production because of rare earth magnet shortages but were not privy to the exact numbers.

India, US 'near interim trade deal after four-day talks'

Indian and US negotiators made progress in their latest round of talks in New Delhi yesterday on a bilateral trade deal, having focused on market access for industrial and some agricultural goods, tariff cuts and nontariff barriers, Indian government sources said.

"The negotiations held with the US side were productive and helped in making progress towards crafting a mutually beneficial and balanced agreement including through achievement of early wins," one of the sources said.

The US delegation, led by senior officials from the Office of the US Trade Representa-

tive, held closed-door negotiations with Indian trade ministry officials headed by chief negotiator Rajesh Agrawal.

Both sides discussed increasing bilateral digital trade, by improving customs and trade facilitation measures, the sources said, adding that "negotiations will continue" for early conclusion of the initial tranche of the trade pact.

US President Donald Trump and Indian Prime Minister Narendra Modi had agreed in February to conclude a bilateral trade agreement by fall 2025 and to more than double bilateral trade to \$500bn by 2030.

The two sides are expected to sign an interim agreement by the end of the month, before the expiry of Trump's 90-day pause on reciprocal tariffs on major trading partners, including a 26% tariff on India.

Commerce Minister Piyush Goyal, currently in Switzerland for talks with European trade partners, said India is prepared to proceed with the deal by first addressing simpler issues.

The next phase of negotiations could tackle more complex matters, with the goal of signing the first tranche of the bilateral trade pact by September or October, the officials added. India resisted US demands to open its mar-

kets to wheat, dairy and corn imports, while offering lower tariffs on high-value US products such as almonds, pistachios and walnuts, one of the sources said.

India also asked the US to revoke its 10% baseline tariff. However, the US side opposed this, noting that even Britain was subject to this under its recent bilateral trade agreement.

India coastguard battles blaze on container ship

India's coastguard yesterday said it was battling to stop a fierce blaze that has engulfed a Singapore-flagged container ship listing off the southern coast that broke out a day earlier.

The 879-foot container vessel MV Wan Hai 503 carrying 22 crew members caught fire some 78 nautical miles off India's Beypore port on Monday.

Eighteen crew members were rescued by the Indian coastguard and navy, with four still missing.

Indian Coast Guard said yesterday that "fires and explosions persist" on the vessel, which was tilting at around "10-15 degrees".

They issued photographs that showed flames leaping from the

stacked containers, with the ship surrounded by thick plumes of billowing black smoke.

Initial images on Monday showed heavy containers that had seemingly been hurled up by a powerful explosion on board, with the coastguard saying that some were in the water.

Singapore's Maritime and Port Authority had said there were "some injuries" among the crew.

Coastguard vessels alongside the blackened and burning ship poured jets of water onto the flames, according to video footage released.

The MV Wan Hai container ship is the second to run into trouble off India's southern coast within weeks.

A Liberian-flagged container ship with hazardous cargo sank off the coast of Kerala on May 24. The Indian navy rescued all 24 crew members.

Senators send Duterte impeachment case back to House

The Philippine Senate yesterday voted to send the impeachment case against Vice-President Sara Duterte back to the House of Representatives, a decision one senator called a "functional dismissal".

The House impeached Duterte in early February on charges of graft, corruption and an alleged assassination plot against one-time ally and former running mate president Ferdinand Marcos.

A conviction, which requires the support of two-thirds of the senate's 24 members, would mean her removal as vice president and a permanent ban from public of-

Yesterday's 18-5 decision came just hours after senators had taken their oaths as jurors, and followed days of wrangling that had raised fears the trial process was headed for derailment.

Duterte is widely expected to run for president in 2028 if she survives impeachment, a possibility with deep implications for the political futures of the senators tasked with deciding her fate.

Senator Ronald dela Rosa, former national police chief and enforcer of ex-president Rodrigo Duterte's drug war, yesterday introduced a motion to dismiss the impeachment case against the former leader's daughter.

Dela Rosa argued that earlier complaints filed against Duterte in the House, which did not make it past the committee level, had constituted multiple impeachment proceedings within a year, something banned under the Philippine constitution.

The motion was later amended in favour of sending the case back to the House, which must now certify that it did not violate the constitution and that it remains willing to prosecute the case when its new members take their seats on June 30.

Senator Risa Hontiveros, who opposed the motion, warned that

returning the case to the lower body was an abrogation of responsibility that would see it ultimately disappear.

"Remanding is a functional dismissal," she said, later adding the impeachment complaint was "being dismantled brick by brick".

Senate president Francis Escudero, however, insisted there was no such motive behind the body's decision

decision.

"The intention is to give the prosecutors an opportunity to answer certain questions in a manner that does not waste the time

of the court," he said.

Following the vote, Escudero issued a summons for the vice-president, who will have 10 days

from its receipt to answer the impeachment charges.

Yesterday's convening of the impeachment court had already been rescheduled once, with some lawmakers publicly expressing fears the senate might choose to shelve the trial entirely.

Following the vote, the Akbayan party, which had endorsed the impeachment complaint, called the senators "cowards".

"After dribbling for so long, now they're going to pass (the ball). They're not only cowards; they are traitors to their sworn duty," they

said on their Facebook page.

Michael Tiu, assistant professor at the University of the Philippines College of Law, said the

decision to remand had "no constitutional or legal basis".

"The power of the senate is to

try and decide. It cannot second guess a co-equal body's exercise of its exclusive power to initiate an impeachment proceeding," he said.

A slate of candidates loyal to

A slate of candidates loyal to Duterte outperformed expectations in May's mid-term elections, winning five of the 12 open seats and upping her chances for acquittal.

On Monday, Duterte's defence team said in a statement they were "ready to confront the charges and expose the baselessness of the accusations against the vice president".

RFK Jr sacks entire US vaccine panel

ealth Secretary Robert F Kennedy Jr has fired all 17 members of a US Centres for Disease Control and Prevention (CDC) panel of vaccine experts and is in the process of replacing them, his department said on Monday, drawing protest from many vaccine scientists.

The removal of all 17 experts of the Advisory Committee on Immunization Practices (ACIP) was revealed in a Wall Street Journal op-ed and an official press release.

The move is the most farreaching in a series of actions by Kennedy, a long-time vaccine sceptic, to reshape US regulation of vaccines, food and medicine.

Scientists and experts said the changes to the vaccine panel, which recommends how vaccines are used and by whom, would undermine public confidence in health agencies.

Kennedy promised the move would raise public confidence.

"Today we are prioritising the restoration of public trust above any specific pro- or anti-vaccine agenda," Kennedy said in a statement from the Department of Health and Human Services (HHS).

Kennedy has for years sown doubt about the safety and efficacy of vaccines, but he pledged to maintain the country's existing vaccine standards to secure his appointment in President

Donald Trump's administration. The Food and Drug Administration (FDA), which is overseen by Kennedy's department, has approved a number of vaccines during his tenure despite concerns over his stances.

Even so, at least one senior Republican member of Congress expressed doubts about the changes in the panel

Kennedy said the ACIP is rife with conflicts and has never turned down a vaccine, even though the decision to approve

vaccines rests with the US FDA. The CDC panel provides guidance to the CDC on which groups of people would most benefit from an already-approved vaccine.

"That's a tragedy," said former FDA chief scientist Jesse Goodman. "This is a highly professional group of scientists and physicians and others... It's the kind of political meddling that will reduce confidence rather than increase confidence."

The Pharmaceutical Research and Manufacturers of America called Kennedy's action concerning for public health.

"Upending the ACIP membership increases uncertainty and vaccine skepticism, undermining the health gains achieved through vaccination," the industry body said in a statement late on Monday.

Shares of vaccine makers Moderna and US-listed shares of BioNTech fell over 1%, while Pfizer was down marginally in extended trading on Monday.

"Of course, now the fear is that the ACIP will be filled up with people who know nothing about vaccines except suspicion," said Republican US Senator Bill Cassidy in a post on X. I've just spoken with Secretary Kennedy, and I'll continue to talk with him to ensure this is not the case."

Cassidy, a doctor from Louisiana who had expressed wariness about Kennedy's anti-vaccine views before clearing the path for him to become the nation's top health official, said at the time he had received assurances Kennedy would protect existing vaccination programmes.

The CDC panel will convene its next meeting June 25-27 at CDC headquarters in Atlanta, the department said.

Once a celebrated environmental lawyer, Kennedy pivoted from the mid-2000s to public health - chairing a nonprofit that discouraged routine childhood immunisations and amplified false claims, including the long-debunked theory that the Measles, Mumps and Rubella (MMR) vaccine causes autism.

Since taking office, he has curtailed access to coronavirus (Covid-19) shots and continued to raise fears around the MMR vaccine - even as the United States faces its worst measles outbreak in years, with three reported deaths and more than 1,100 confirmed cases.

Trump deploys hundreds of Marines to Los Angeles

undreds of US Marines were expected in Los Angeles after President Donald Trump ordered their deployment in response to protests against immigration arrests and despite objections by state officials.

The 700 elite troops will join around 4,000 National Guard soldiers, amping up the militarisation of the tense situation in the sprawling city, which is home to millions of foreign-born and Latino residents.

The small-scale and largely peaceful demonstrations - marred by sporadic but violent clashes between police and protesters - were entering their fifth day.

In downtown LA's Little Tokyo neighbourhood on Monday night, scores of protesters faced off with security officials in riot gear, some shooting fireworks at officers who fired back volleys of tear gas.

The unrest was sparked by a sudden intensification last week of Trump's signature campaign to find and deport undocumented migrants, who he claims have mounted an "invasion" of the United States.

California officials have stressed the majority of protesters have been peaceful – and that they were capable of maintaining law and order themselves. Democratic Governor Gavin Newsom wrote

on X that US Marines "shouldn't be deployed on American soil facing their own countrymen to fulfil the deranged fantasy of a dictatorial President. This is un-American".

However, Trump has branded the LA protesters "professional agitators and insurrection-

"If I didn't 'SEND IN THE TROOPS' to Los Angeles the last three nights, that once beautiful and great City would be burning to the ground right now," he wrote on Truth Social

Trump has called for Newsom's arrest, while the president's ultra-loyal speaker in the House of Representatives, Republican Mike Johnson, has declared the California governor "ought to be tarred and feathered".

Earlier, demonstrators marching with banners and handmade signs yelled "ICE out of LA"

Trump's use of the military is an "incredibly rare" move for a US president, Rachel Van-Landingham, a professor at Southwestern Law School in Los Angeles and a former lieutenant colonel in the US Air Force, told AFP.

The National Guard - a fully equipped reserve armed forces - is usually controlled by state governors and used typically on US soil in response to natural disasters.

The Guard has not been deployed by a president over the objections of a state governor since 1965, at the height of the civil rights movement.

Deployment of regular troops, such as the Marines, on US soil is even more unusual.

US law largely prevents the use of the military as a policing force - absent an insurrection.

Speculation is growing that Trump could invoke the Insurrection Act giving him a free hand to use regular troops for law enforcement around the country.

Trump "is trying to use emergency declarations to justify bringing in first the National Guard and then mobilising Marines", law professor Frank Bowman, at the University of Missouri, told AFP.

Bowman said the "suspicion" is that Trump is aiming to provoke the kind of all-out crisis which would then justify extreme measures.

Judge rejects class action for Google privacy lawsuit

Deople who accused Google of illegally collecting their personal information, after they chose not to synchronise their Google Chrome browsers with their Google accounts, cannot sue the Alphabet unit as a group in a class action, a US judge

In a decision on Monday, US District Judge Yvonne Gonzalez Rogers in Oakland, California agreed with Google that it was appropriate to address case-bycase whether millions of Chrome users understood and agreed to its data collection policies.

"Inquiries relating to Google's implied consent defence will overwhelm the damages claims for all causes of action," Rogers wrote.

She dismissed the proposed damages class action with prejudice, meaning it cannot be brought again. The judge also said Chrome users cannot seek policy changes as a group.

Umbrella concept of ESG seen falling apart amid backlash

Environmental, social, and governance (ESG) investing accounts for concerns from gender equality to worker rights to new ways to provide funding to charities working in poor countries. ESG envisages an investing principle that prioritises environmental and social issues, and corporate governance.

While institutional asset owners such as pension funds and insurers say they remain committed to sustainable investing, they're less wedded to ESG as an "umbrella concept".

They now widely treat ESG as three separate parts as opposed to a single strategy, according to a survey by Morningstar of 25 asset owners across North America, Europe and the Asia-Pacific region.

Organised efforts at responsible investing can be traced back decades. These approaches, which focused on screening out companies seen as doing specific kinds of harm, later came under the term "socially responsible investing", or SRI.

Over time, more companies adopted "corporate social responsibility" (CSR) policies amid increasing scrutiny of their business practices.

Some investors also advocated what became known as impact investing as they sought to make a positive effect on the world, rather than just avoid the bad stuff.

The biggest change under ESG was that SRI, CSR and impact investing were coming under a single umbrella just as ESG had been embraced by policymakers, regulators, and an ever-bigger number

"Mainly, the sset owners se less concerned about what ESG is called versus how it is implemented across their global portfolios," according to the Morningstar report.

Asset owners also are increasingly

concerned these days about rising geopolitical tensions caused by the Trump administration-led trade war, the Russia-Ukraine conflict and US-China relations. The result is many investors are "waiting for more clarity before

making short-term portfolio moves," according to Morningstar. Investors lack financial incentives to chase sustainable targets, leaving them more exposed to losses once sentiment shifts, according to a study by academics at the University of Cambridge in May.

Despite years devoted to trying to make ESG investing financially appealing, there still aren't enough structures to encourage banks and asset managers to allocate capital in ways that will ultimately protect the planet and its inhabitants, scholars at the Centre for Sustainable Finance at the University of Cambridge Institute for Sustainability Leadership (CISL) wrote in the study. The upshot is markets have failed to provide adequate pricing

signals for the real risks that lie ahead.

ESG, which enjoyed a brief boom during the pandemic, has struggled to right itself as higher interest rates and supply-chain bottlenecks have hampered the progress of capital-intensive green infrastructure. As a result, the theme has rapidly lost investors, with Morningstar noting in April that ESG funds suffered their worst outflows on record in the first quarter.

Corporate America's pivot away from diversity, equity and inclusion (DEI) initiatives accelerated during the first 100 days of President Donald Trump's second White House term.

An area of corporate exchange that has seen a quieting under Trump is shareholder proposals at annual meetings.

Proposals related to ESG topics dropped 34% from the number seen in 2024 as progressive activists dealt with an uncertain voting environment, according to a report released in early April by shareholder advocacy group As You Sow and Proxy Impact.

Global sustainable investments are estimated to range between \$35tn and \$40tn. Amid mounting concern that only a fraction of such assets are bona fide environmental, social, and governance investing, there are calls for tougher regulations to stamp out the false claims by fund managers.



Musk vowed to chainsaw spending but it was a trim

lon Musk once famously wielded a chainsaw on stage in a theatrical demonstration of his effort to drastically cut US federal spending under President Donald Trump. As he leaves government amid bitter acrimony, official data shows he achieved something closer to a trim with scissors.

In the four months since Musk's Department of Government Efficiency began slashing federal spending and staffing, a handful of the agencies he has targeted trimmed their combined spending by about \$19bn compared with the same period last year, according to US Treasury Department summaries reviewed by Reuters.

That is far below M initial goal of \$2tn in savings and amounts to about a half of 1% of total spending by the federal government. Musk said last late last month he is leaving the administration but that its costcutting work will "only strengthen over time." It remains to be seen, however, how enthusiastically Trump's cabinet secretaries will continue to downsize their departments. DOGE says it pulled the plug on more than 26,000 federal grants and contracts that are worth about \$73bn, while more than 260,000 government workers have been bought out, taken early retirement or been fired. But the DOGE tallies have been riddled with errors, according to reviews by numerous budget experts and media outlets, including Reuters. That has made them difficult to verify, and some of the announced cuts are not saving the government any money because judges have reversed or stalled them.

That leaves the Treasury Department's daily reports on how much the government is spending as the clearest window into the scope of the

administration's cost-cutting. The view they offer so far is

modest: The government has spent about \$250bn more during the first months of Trump's administration than it did during the same period of time last year, a 10% increase. And even some parts of the government Trump has cut the most deeply are, for now at least, spending more money than they did last year.

One big factor driving costs is largely outside Trump's immediate control: interest payments on the United States' growing pile of debt, which amount to about \$1 in every \$7 the federal government spends. Debt interest payments are up about 22% from a year ago.

Spending on Social Security, the safety-net programme for the elderly and disabled, totalled about \$500bn since Trump's inauguration, up 10% from a

To be sure, the view offered by the Treasury Department's daily reports is incomplete.

Many of the cuts DOGE has made to the federal workforce, grants and contracting will reduce what the government will spend in the future but do not show up in its checkbook today.

For example, while thousands of workers have taken buyouts, the government will continue to pay their wages until October. So far, the Labour Department has estimated there were only about 26,000 fewer people on federal payrolls in April than were on the books in January, after adjusting the figures for typical seasonal swings.

Tallying savings from future cuts, however, is seldom straightforward.

"It could be that in the future we never replace these workers and we save billions of dollars, or it could be that they come back and it's even more expensive than before," said Martha Gimbel, executive director of the Budget Lab at Yale, a nonpartisan budget analysis organisation at Yale University.

The White House declined to offer an explanation for DOGE's figures. Spokesman Harrison Fields said in a statement that "DOGE is working at record speed to cut waste, fraud, and abuse, producing historic savings for the American people."

Reuters estimated the administration's impact by tallying outlays at agencies that had been targeted for cuts and whose spending had dropped from the same time last year.

Among the agencies hardest hit are the Department of Education, State Department, US Agency for International Development, National Institutes of Health, the Centres for Disease Control and Prevention and other independent agencies.

Rachel Snyderman, an expert on fiscal policy at the Bipartisan Policy Center, said the spending declines at agencies could be reversed if the Trump administration doesn't get congressional approval to cancel outlays from this year's federal budget, as required by law.

The most obvious sign that the Trump administration is making a dent in federal spending is in the Education Department, which Trump has ordered shut down.

The administration cut the department's staff by about half in March. DOGE's website lists 311 Education Department grants and contracts it says it has eliminated for a savings of about \$1.6bn, though it is not clear how it arrived at those figures. Some cuts have not stuck. A federal judge in March ordered the administration to restore some of the grants it had cut, and another judge this month ordered it to rehire 1,400 workers.

Still, the Education Department under Trump has spent close to \$11bn less than it did over the same period last year, the Treasury reports show, far more than what DOGE says it has cut. One reason could be that layoffs have made it harder for the government to process

payments for special education and low-income schools. School districts that have sued over the cuts alleged that states were already experiencing slowdowns in receiving money.

Another factor for the reduced outlays: The department has stopped handing out the \$4.4bn that remains to be distributed from the hundreds of billions of dollars approved in previous years to help schools weather the Covid-19 crisis.

The Education Department did not respond to a request for comment.

Other agencies targeted in Trump's overhaul are also starting to show declines in their spending compared with the same time last

Spending is down about \$350mn at the CDC and about \$1bn at the National Institutes of

The Trump administration has moved to slash spending across those agencies, cancelling grants and ending leases for office space.

The Department of Health and Human Services has reported terminating close to 2,000 grants that planned to disperse more

than \$20bn.

Many of the grants were to boost labs that fight new infectious diseases, or to fund state mental health programmes. Some \$14bn of the grant money had already been spent prior to the termination, with roughly \$7bn effectively frozen, according to a Reuters analysis of the government's tallies.

The administration has effectively dismantled USAID, which handled most US foreign assistance, firing nearly all of the agency's employees and cancelling most of its humanitarian aid and health programmes, though federal courts have forced the government to continue making some payments.

USAID spending is down about 40%, to about \$4.6bn, from last year. Spending at the State Department – where DOGE says it has cut nearly \$1bn in grants and contracts — is also down about 20% from 2024.

Measuring the impact of the administration's actions is difficult because many cuts will not yield savings for months or years even as spending elsewhere increases. Spending on federal employee salaries, for example, is up by more than \$3bn under Trump.

Some of the grants and contracts DOGE cut were due to be paid out over several years, and many remain the subject of lawsuits that will determine whether they can be cut at all.

DOGE says it has saved taxpayers \$175bn, but the details it has posted on its website, where it gives the only public accounting of those changes, add up to less than half of that figure. It says the figure includes workforce cuts, interest savings and other measures it has not itemised.

Ex-student kills 10 in Austria high school shooting

Graz

former student killed 10 people when he opened fire at a high school in southeastern Austria yesterday before taking his own life, authorities said, in an unprecedented case of deadly gun violence that stunned the Alpine country.

Heavily armed police, a heli-copter and paramedics descended on the Dreierschuetzengasse high school in Graz after the 21-yearold lone shooter struck, police

Nine victims were immediately confirmed but a woman died from her wounds in hospital later, an official said.

Seven of the victims were female and three male, authorities said without specifying their ages.

Twelve people suffered severe injuries and police said support was being provided to witnesses and those affected.

The suspect acted alone and took his own life in the school toilet, police said, adding his motive remained unknown.

Austrian Chancellor Christian Stocker declared three days of na-

tional mourning to remember the victims, saying the country had witnessed "an act of unimaginable violence".

According to police, the alleged perpetrator was an Austrian from the Graz region, who used two legally-owned weapons.

He was a former student at the high school, but had not finished his studies, Interior Minister Gerhard Karner told reporters.

Flower bouquets and candles were placed in front of the school, which has around 400 students aged between 14 and 18.

A supermarket and a bank in the vicinity closed for the day.

A resident, who hails from the United States, told AFP that she was "shocked" and "it's a lot to take in" after learning what had occurred nearby an elementary school and kindergarten her two children attend.

"In my home country it happens more often as we know but that it happens here is unheard of," she said, declining to give her

"Graz is a safe city," said Roman Klug, 55, who said he lived close to the school that he said was "known for its openness and diversity".

After arriving in Graz, Stocker described the shooting as "a national tragedy", adding that it was "a dark day" for Austria.

Condolences poured in from across Europe.

French President Emmanuel Macron said that "France extends its deepest sympathy to the victims' families, the Austrian people and Chancellor Stocker during this difficult time."

German Chancellor Friedrich Merz said "our thoughts are with our Austrian friends and neighbours" following the "horrific"

school shooting. Hungarian Prime Minister Viktor Orban offered his "deepest condolences".

European Commission President Ursula von der Leyen said "the news from Graz touches my heart" while Italian Prime Minister Giorgia Meloni expressed her sympathies to the families of the victims following the "tragic

Attacks in public are rare in Austria, which is home to almost 9.2mn people and ranks among the 10 safest countries in the world, according to the Global Peace Index.

While still less common than in the United States, Europe in recent years has been shaken by attacks at schools and universities that were not connected to terrorism.

In France yesterday, a teaching assistant was killed in a knife attack at a school in the eastern town of Nogent.

In January, an 18-year-old man fatally stabbed a high school student and a teacher at a school in northeastern Slovakia.

And in December, a 19-yearold man stabbed a seven-year-old student to death and injured several others at a primary school in

In December 2023, an attack by a student at a university in central Prague left 14 people dead and 25 injured.

A few months earlier, a 13-yearold gunned down nine fellow classmates and a security guard at an elementary school in Belgrade.

Russia strikes Kyiv in one of war's largest air attacks

ussia launched one of its largest air strikes on Kyiv in over three years of war and struck a maternity ward in the southern city of Odesa in attacks that killed at least three people, officials said yesterday.

The overnight strikes followed Russia's biggest drone assault of the war on Ukraine on Monday and were part of intensified bombardments in what Moscow says is retaliation for attacks by Ukrainian forces on Russia.

The Russian attack also aged Saint Sophia Cathedral, a Unesco world heritage site located in the historic centre of Kyiv, Ukrainian Culture Minister Mykola Tochytskyi said.

"The enemy struck at the very heart of our identity again," Tochytskyi wrote on Facebook about the site he called "the soul of all Ukraine".

Loud explosions shook Kyiv and blasts and fires lit up the sky in the early hours of vesterday morning, leaving palls of heavy smoke over the city, Reuters witnesses said. Authorities deployed two firefighting helicopters to douse flames.

One person died in the attack on Kyiv, city authorities said.

At least four people were treated in hospital after seven of the capital's 10 districts were hit, city officials said.

"Today was one of the largest attacks on Kyiv," Ukrainian President Volodymyr Zelensky said. "Russian missile and Shahed (drone) strikes drown out the efforts of the United States and others around the world to force Russia into peace?

In Kyiv, Kateryna Zaitseva, 38, and her 14-year-old son looked at the rubble in their apartment, which received a direct hit by a drone. The explosion destroyed one room, damaged another and blew in the door of the bathroom in which they were hiding.

"We started moving blindly to the entrance door. I heard the voice of the emergency worker ... I shouted that there were two of us, that we were unhurt and he helped us," said Zaitseva, a laboratory technician.

European Union's new Russia sanctions to target energy sector and banks

The European Commission vesterday proposed an 18th package of sanctions against Russia for its invasion of Ukraine, aimed at Moscow's energy revenues, its banks and its military industry.

The new package proposes banning transactions with Russia's Nord Stream gas pipelines, as well as banks that engage in sanctions cir-

"Russia's goal is not peace, it is to impose the rule of might ... strength is the only language that Russia will understand," Commission President Ursula von der Leyen told a press

The Commission proposes adding 22 more Russian banks to its list and broadening restrictions on them beyond a removal from SWIFT, a global financial messaging system, to a full transaction ban. It also proposes expanding the scope to banks from third countries, and lists the Russian Direct Investment Fund (RDIF) as

well as its subsidiaries and wider network.

Kirill Dmitriev, head of the RDIF, said von der Leyen's statements reflected "the EU's desire to prolong the conflict in Ukraine and its strong dissatisfaction with RDIF's efforts to restore relations between Russia and the United

He said in a statement that the RDIF was also actively supporting European companies that have a presence in Russia.

The Commission has also proposed lowering the Group of Seven nations (G7) price cap on Russian crude oil to \$45 a barrel, from \$60 a barrel, in a bid to cut Russia's energy revenues.

Von der Leyen said that the oil price cap will be discussed at a G7 leaders meeting in Canada

"My assumption is that we do that together as the G7. We started that as G7, it was successful as a measure from the G7, and I want to continue this measure as G7," she said.

The proposal also lists more vessels that make up Russia's shadow fleet, taking the total to more than 400 ships, and oil trading companies. The Commission has also proposed a ban on imports of refined products produced from Russian oil.

"In this way, we want to prevent that some of the Russian crude oil reaches the EU market through the back door," von der Leyen said.

ive Qatar-based Indians were killed in a road accident in central Kenya on Monday evening when the bus they were travelling in overturned during a holiday trip.

Several others were seriously injured and under treatment at various hospitals in Kenya, sources said.

The deceased have been identified as Geetha Shoji Isaac (58), Riya Ann (41), and her daughter Tyra Rodrigues (8), Jasna Kuttikkattuchalil (30) and Roohie Mehrin (18 months old) - all natives of various places in Kerala.

Isaac hailed from Thiruvalla in Kerala and was a long time senior teacher at HOPE Oatar Centre for Persons with Disabilities.

The Indian embassy in Qatar confirmed on social media that a group of 28 Indians

from Qatar were involved in the accident. The embassy also stated that they are in touch with Indian Cultural Centre and Indian Community Benevolent Forum and other community organisations to co-ordinate the efforts to provide necessary assistance for those affected.

Sources said that some of the injured are in critical condition and have been receiving treatment at some of the hospitals in the local town while some of them have already been moved to hospitals in Nairobi.

Gulf Times reached out to the tour operator from Qatar who had arranged the trip to Kenva.

They declined to comment.

According to various news agencies, the accident took place in central Kenya as the bus was ferrying the tourists from Nakuru County to Nyahururu Thomson Falls in Laikipia County.

According to local eye witnesses, the driver lost control of the bus which veered off the road and rolled and landed in a ditch
