Saudi cabinet endorses Qatar high-speed rail agreement

Saudi Arabia's cabinet has formally endorsed the landmark agreement to build a high-speed electric railway linking Riyadh and Doha, hailing it as a project that will boost mobility and tourism across the Gulf. The weekly meeting chaired by the Custodian of Two Holy Mosques King Salman bin Abdulaziz al-Saud praised the development, according to *Arab News*. The 785km line, scheduled to begin operations in June 2026, will cut travel time between the two capitals to just two hours, creating new opportunities for economic and cultural exchange. The initiative aligns with Qatar National Vision 2030 and Saudi Arabia's Vision 2030, both of which prioritise sustainable transport and tourism development. By offering a fast, eco-friendly alternative to air and road travel, the railway is expected to reshape regional connectivity while reducing carbon emissions. For tourism, the impact is significant. Easier cross-border travel will encourage multi-destination visits, allowing international and regional tourists to explore both countries more freely. Qatar's luxury and cultural offerings, alongside Saudi Arabia's blend of heritage and modern attractions, will benefit from increased visitor flows. The project is also expected to strengthen partnerships with private sector operators, diversify tourism experiences, and extend visitor stays. Beyond tourism, the railway will enhance economic integration by facilitating the movement of goods, services, and professionals. This efficient transport link is anticipated to attract foreign investment, support trade, and deepen bilateral ties. Regionally, the project sets a precedent for sustainable infrastructure in the Gulf.

14 countries slam Israeli expansion, call for reversal

Fourteen countries, including France, Britain, and Germany, condemned yesterday Israel's recent approval of new Jewish settlements in the occupied West Bank. "We, States of Belgium, Canada, Denmark, France, Germany, Italy, Iceland, Ireland, Japan, Malta, The Netherlands, Norway, Spain and the United Kingdom condemn the approval by the Israeli security cabinet of 19 new settlements in the occupied West Bank," said a joint statement released by the French foreign ministry. "We recall our clear opposition to any form of annexation and to the expansion of settlement policies," it added. The countries urged Israel "to reverse this decision, as well as the expansion of settlements".

Qatar tops Arab world in health services

● **Ranked 18th globally in Numbeo Index, Qatar’s health sector advances with expanded capacity and innovation**

Qatar ranked first in the Arab world and 18th globally in health services, according to the Numbeo Index – an international ranking based on a range of criteria, including the quality of healthcare, ease of access to services, efficiency of infrastructure, and levels of beneficiary satisfaction. Throughout 2025, the Ministry of Public Health (MoPH) has continued to play a pivotal role as the body responsible for formulating national health policies, regulating the health sector, and ensuring the integration of its services in a manner that achieves the highest levels of quality, efficiency, and sustainability. According to MoPH data, there are around 58,000 workers in the public and private

sectors, representing various medical, nursing, technical, and administrative specialties. The number of available hospital beds in health facilities stands at 5,485, which reflects the expansion of the health sector's capacity to keep pace with population growth, urban expansion, and the increasing demand for health services. Further, 2025 has seen a qualitative leap in the progress of Hamad Medical Corporation (HMC), which continued to strengthen its position as the main provider of specialised and secondary healthcare in the country and as one of the leading regional models in quality performance and clinical excellence. HMC's achievements ranged from strategic partnerships and

service development to the introduction of advanced technologies and the realisation of unprecedented medical achievements at the national level. As part of efforts to improve access to health services and reduce waiting times, HMC signed partnership agreements with a number of private hospitals, with the aim of referring Qatari citizens who experience long waiting periods in certain specialties to receive timely care. Similarly, HMC opened a musculoskeletal physiotherapy clinic for seniors at Qatar Rehabilitation Centre, reflecting its commitment to developing specialised health care services that support the independence of older adults and enhance their quality of life. **To Page 6**

Cabinet hails US strategic dialogue, Doha Declaration

HE the Deputy Prime Minister and Minister of State for Defence Affairs Sheikh Saud bin Abdulrahman bin Hassan al-Thani chaired the Cabinet's regular meeting held yesterday morning at the Amiri Diwan. At the outset of the meeting, the Cabinet welcomed the outcomes of the Seventh Strategic Dialogue between Qatar and the United States, co-chaired by HE the Prime Minister and Minister of Foreign Affairs Sheikh Mohammed bin Abdulrahman bin Jasim al-Thani and US Secretary of State Marco Rubio, in Washington on December 17, 2025, with the participation of senior Qatari and American officials. The Cabinet affirmed that the joint statement issued at the conclusion of the dialogue reflected the depth and strength of the relations between the two countries, the solidity of their partnership in various fields, and their shared will to develop and expand their fruitful and constructive co-operation for the benefit of their peoples, and in a way that contributes to maintaining security, peace and stability in the region and around the globe. The Cabinet commended the outcomes of the Doha Declaration 2025, issued at the end of the Eleventh Session of the Conference of the States Parties (COSPII) to the United Nations Convention Against Corruption, which was hosted by Qatar for five days. The session's discussions focused on the opportunities for using ar-

tificial intelligence systems in preventing and combating corruption. The clear message that was conveyed through this session suggested that building the integrity of the future requires harnessing technology responsibly and strengthening international co-operation to confront the growing challenges associated with corruption and transnational financial crimes. Afterwards, the Cabinet considered the topics on its agenda, as it approved a draft law on animal health. Prepared by the Ministry of Municipality, this draft law replaces Law No 1 of 1985 on animal health, as part of updating the law to keep pace with changes in this field. The Cabinet also approved a draft cabinet decision to establish the Medical Committee for the Internal Security Force (Le-khwiya) and define its responsibilities. Prepared by Lekhwiya, the draft decision aims to deal with all cases requiring medical attention, starting from the medical examination stage to recruitment as well as injury cases in need of rapid evaluation according to the requirements of the job nature assigned to the injured force member and other cases. The Cabinet also approved a draft decision of the President of Civil Service and Government Development Bureau regarding training courses and training alternatives scheduled for employees who are candidates for promotion. **To Page 6**

Qatar in first paediatric stem cell transplant

**Brother's stem cells
give young cancer
patient new hope**

Sidra Medicine has announced the successful completion of its first paediatric allogeneic haematopoietic stem cell transplantation (HSCT), marking an important milestone in its mission to deliver advanced, life-saving care for children with complex and high-risk conditions. A first for Qatar, the procedure was performed on a nine-year-old boy diagnosed with relapsed acute lymphoblastic leukaemia, who received stem cells donated by his brother. This transplantation repre-

sents a key milestone in Sidra Medicine's paediatric HSCT programme, and follows the opening of its dedicated HSCT ward in June 2025. Chair of Pediatric Medicine at Sidra Medicine, Dr Ahmed al-Hammadi, said: "Completing our first paediatric allogeneic stem cell transplant is a significant achievement for Sidra Medicine and for paediatric care in Qatar. It reflects our commitment to providing world-class speciality care, strengthening national capabilities in advanced cellular therapies, and ensuring that children have access to highly specialised, life-saving treatment within the country". The patient's treatment journey at Sidra Medicine began in 2019, when he underwent

standard chemotherapy over two years. Following relapses in May 2022 and December 2024, the medical team determined that an allogeneic stem cell transplant offered the best

chance for long-term recovery. Children facing this type of relapse have very limited treatment options without HSCT, highlighting the importance of timely access to this specialised therapy. Acting Chief of Pediatric Hematology, Oncology and HSCT and Director of the Advanced Cell Therapy Core at Sidra Medicine, Dr Chiara Cugno, said: "The continued growth of Sidra Medicine's paediatric HSCT programme reflects the advanced expertise of our haematology and oncology teams. Our services are available to both local and international patients, addressing a critical national need, with more than 50 children in Qatar currently on the transplant waiting list." **(QNA)**



Qatar takes part in child online safety conference in Azerbaijan

Qatar has taken part in an international conference in Azerbaijan on protecting children from harmful content in the digital environment, as concerns grow globally over online risks facing young people.

The conference was held in the capital, Baku, and brought together officials, experts and policymakers from different countries. Qatar's delegation was led by HE Sheikhha Sheikhha bint Jassim bin Ahmed al-Thani, As-

sistant Undersecretary for Family Affairs at the Ministry of Social Development and Family.

Addressing the conference, she said safeguarding children online has become a global priority amid rapid technological advances and the expansion of open digital spaces.

She warned that digital risks extend beyond inappropriate content to include behavioural and psychological effects, such as reduced attention, weakened family communication and exposure to harmful behavioural models. She stressed that tackling these challenges requires

shared responsibility among governments, educational institutions and civil society.

HE Sheikhha Sheikhha outlined Qatar's efforts to enhance child protection online, including the establishment of a cybercrime prevention centre, the strengthening of relevant legislation and the launch of the "Safe Space" initiative aimed at raising awareness among children and adolescents about digital safety.

She also highlighted Qatar's legal framework, including laws on cybercrime and personal data protection, noting that child welfare is a key pillar of the coun-

try's National Vision 2030. This, she said, is reflected in policies related to education, capacity building and healthcare, as well as Qatar's commitment to international child rights agreements.

She pointed to the ministry's national strategy for 2025-2030, which includes digital safety awareness programmes and initiatives to combat cyberbullying in schools and also referenced the creation of several national committees and strategies, including the Child and Youth Digital Safety Committee established in 2025 and the National Cybersecurity Strategy 2024-2030.

Health screenings in Qatar show progress: study

The screening programmes for non-communicable diseases in Qatar have achieved notable results in recent years in terms of participation rates and detection levels, a recent medical study published in *Qatar Journal of Public Health*, issued by Hamad Bin Khalifa University Press, has revealed.

Arabic daily *Arrayah* reported that based on the data presented in the study, the participation rate in the annual health screening for 2023 reached about 12.2% among eligible citizens, while the rate among expatriates reached 13.2%, which is considered an important first step toward strengthening investment in prevention.

The screening results revealed a noticeable prevalence of risk factors associated with non-communicable diseases, such as diabetes, obesity, and hypertension. A total of 1,255 cases of pre-diabetes were recorded, in addition to an obesity rate of about 14.5%, highlighting the need for early intervention and continuous awareness of healthy lifestyle practices.

The study, titled "Insights into Non-Communicable Disease Screening in Adult Primary Care in Qatar", also showed a gradual increase in government-approved screening programmes for breast, colorectal, and cervical cancers. Coverage of breast cancer screening reached 41.8% in the most recent screening round, while participation in colorectal cancer screening rose to 26.7%. Cervical cancer screening, being relatively new, remains limited to opportunistic screening, pending an ongoing evaluation by the Ministry of Public Health to consider the possibility of converting it into a comprehensive national programme.

Regarding mental health, the study indicated that incorporating mental health screenings into the preventive care pathway at the Primary Health Care Corporation was an important strategic step, with psychological screening tools integrated into routine visits, which contributed to raising coverage to 79.5% during 2024.

The study also recorded a significant increase in the number of beneficiaries of psychiatry and psychology services in primary health care facilities, reflecting that integrating mental healthcare into the core system had a direct impact on increasing utilisation and improving service quality.

Further, the study confirmed that Qatar is gradually building a coherent preventive model based on early detection, regular follow-up, and activating the role of primary healthcare as a fundamental component of the national health system. It also emphasised that the annual health screening, which began for citizens in 2017 and was expanded to include expatriates in 2022 at primary health care centres, plays a pivotal role in identifying common risk factors in the community, such as prediabetes, high blood pressure, and obesity.

However, the study noted that cancer screening coverage remains lower than that achieved by some high-income countries. Yet, it highlighted that the performance of mental health screenings in Qatar clearly surpasses that of several advanced countries, including the US and the UK.

Further, the study also identified a number of challenges that screening programmes still face, most notably the need to increase participation rates, improve referral pathways across different levels of care, and overcome communication barriers in a multilingual and multicultural society.

Partnering with Years of Culture for this town hall reflects our shared belief that dialogue across cultures deepens how young people engage with the ideas shaping their societies"

As for students reflecting on the programme's impact, Jamila al-Humaidi from Qatar said the experience was proof that honest conversation is the bridge that connects us. Camila Regueiro, from Argentina, added: "I truly think we all learned so much about each other's culture." Chilean student, Javiera Eugenin Guzmán, noted: "This experience made me feel heard and reminded me of the deep connections that unite us across countries." The expert guests praised the students' engagement, as Akel Ismail Kahera said: "The youth showed maturity and deep understanding of sustainability, urban planning, and global inequities." Guadalupe Granero Realini added: "Their ability to debate fearlessly and challenge experts was impressive."


QRCS project aims to conduct 850 eye surgeries in Gaza

Qatar Red Crescent Society (QRCS), in partnership with the Palestine Red Crescent Society (PRCS), launched a vital project to support Al-Amal Hospital in Khan Yunis amid escalating health and humanitarian challenges in the Gaza Strip. The initiative aims to perform 850 eye surgeries and equip several medical facilities within the hospital to ensure the continuity of healthcare services for the wounded and sick. The project activities include fully equipping two operating rooms at Al-Amal Hospital with all necessary tools and medical supplies for the ENT department, as well as providing surgical instruments and equipment for other departments. Additionally, comprehensive maintenance will be carried out on the two operating rooms to enhance their operational efficiency. Dr Akram Nassar, director of QRCS' office in Gaza, stated: "This new project is a direct response to the urgent need for eye treatment amid a severe shortage of medicines and medical supplies caused by the war and the closure of crossings. It also involves operating two surgical rooms at the hospital to enable medical teams to provide continuous care for patients." Nahid Blata, chairman of the Administrative Committee of PRCS in Gaza and the North, said: "This project represents an extension of the fraternal relationship and ongoing partnership with our



brothers at QRCS. We look forward to sustaining this co-operation to ensure the continuity of medical services for our people inside the homeland, especially given the immense challenges facing the health sector." He noted that the ophthalmology surgical team has already begun performing the first and second batches of eye surgeries despite the current situation on the ground. QRCS noted that these efforts come at

a time when the suffering of eye patients in Gaza is deepening. A recent statistic from the Palestinian Ministry of Health revealed that more than 1,500 people have completely lost their sight since the outbreak of the war on Gaza in October 2023, due to lack of treatment and malnutrition. The QR5.6mn project by QRCS offers a glimmer of hope for thousands of patients awaiting treatment under dire humanitarian condition.

Besides, MoPH has developed a comprehensive five-year national action plan during 2025 aimed at strengthening monitoring and surveillance activities for various additives across all types of locally produced and imported

foods. As such, the ministry obtained renewed international accreditation from the American Accreditation Body for food inspection and sampling in accordance with the international standard ISO/IEC 17020, which enhances public confidence in the food control system.

On the digital transformation efforts, the launch of the LBAIH application has made a qualitative shift in managing the patient experience. The app enables patients to view their medical appointments, reschedule or cancel them, and access their health records, test results, and prescriptions, in addition to receiving alerts and reminders.

Nigeria mosque bombing kills at least seven

An explosion ripped through a mosque in the northeastern Nigerian city of Maiduguri and killed at least seven worshippers yesterday, witnesses and security sources said.

No armed groups immediately claimed responsibility for what anti-militant militia leader Babakura Kolo said was a suspected bombing.

Maiduguri is the capital of Borno state, home to a years-long insurgency by militant groups Boko Haram and an offshoot, Islamic State West Africa Province, though the city itself has not seen a major attack in years.

The bomb went off inside a crowded mosque in the city’s Gamboru market, as Muslim faithful gathered for evening prayers, according to witnesses.

One of the leaders of the mosque, Malam Abuna Yusuf, put

the toll at eight dead, though officials have not yet released a casualty count.

Kolo said that seven were killed. He said it was suspected that the bomb was placed inside the mosque and exploded midway into prayers, while some witnesses described a suicide bombing.

It was not immediately clear how many people were injured, though witness Isa Musa Yusha’u said: “I saw many victims being taken away for medical treatment.”

Videos taken in the aftermath and seen by AFP showed a person covered in blood writhing on the ground, and what appeared to be bodies covered by a sheet.

Nigeria has been battling a militant insurgency since 2009 and the conflict has killed at least 40,000 and displaced around 2mn from their homes in the northeast, according to the UN.

Though the violence has waned since its peak a decade ago, it has split into neighbouring Niger,

Chad and Cameroon. And concerns are growing about a resurgence of violence in parts of the northeast, where insurgent groups remain capable of mounting deadly attacks despite years of sustained military operations.

Maiduguri itself - once the scene of nightly gun battles and bombings - has been calm in recent years, with the last major attack recorded in 2021.

But reminders of the conflict are never far off in the state capital, where major military operations are headquartered.

Military pick-ups lumber through town daily, their beds filled with soldiers whose helmets shield them from the hot afternoon sun.

Evening checkpoints are still in effect, even as markets that once closed in the early afternoon throng into the night.

Meanwhile, in the countryside, the insurgency continues to rage, with analysts warning of an uptick in militant violence this year.

Rights group warns on worsening health of Palestinian prisoners

The health situation of the Palestinians languishing in the Israeli occupation’s custody is deteriorating due to persistent medical negligence, severe shortages of medicines, and lack of medical follow-up, the Commission of Detainees and Ex-Detainees Affairs in Palestine reported in a statement yesterday.

The statement further explained that this situation has engendered numerous morbidities among the prisoners, with the commission’s legal crew documenting an extremely complex humanitarian situation engulfing them in various Israeli dungeons.

Following field visits to these prisons, the statement highlighted that the situation reflected a harsh, dehu-

manised environment at the detention and interrogation sites, with repeated complaints reported about daily repression and intimidation, marked by dehumanised inspections and collective punishment, the statement warned. After the crew huddled with those prisoners, they complained about severe shortages of blankets and clothing, as well as being constantly bereft of familial visits and subjected to sudden relocation between sections in a repeated manner, which is manipulated as a vehicle for psychological pressure.

The Palestinian Prisoners’ Media Office reported that the Israeli occupation has ramped up repression during December, with prison units conducting campaigns throughout the month, marked by beatings and collective dehumanisation against the prisoners. It further noted heightened and harsh solitary confinements amid extreme cold and deprivation of basic life necessities.

Libyans united in grief for army chief killed in crash

People on either side of the divide cutting through Libya grieved yesterday for the head of the country’s armed forces, who was killed when his plane crashed in Turkiye.

General Mohammed al-Haddad and his four aides died on Tuesday after a visit to Ankara, with Turkish officials saying an electrical failure caused their plane to crash less than 15 minutes after takeoff.

“It will be hard to find a man of his calibre,” Nasreddine al-Maghribi told AFP at a cafe in Libyan capital Tripoli.

Haddad “enjoyed great popularity in the east and west of the country, and we had hoped that he would play a key role in the leadership of a united Libyan

army”, said Maghribi, who is in his sixties.

Libya has been divided since a Nato-backed revolt toppled and killed longtime leader Muammar Gaddafi in 2011.

Haddad had been the army’s chief of general staff since August 2020.

In Tripoli, seat of the internationally recognised Government of National Unity (GNU), celebrations to mark Libya’s independence day were cancelled.

Prime Minister Abdulhamid Dbeibah heads the GNU in the west, while commander Khalifa Haftar’s administration runs the east. Both Dbeibah and Haftar have declared a three-day mourning period in the areas they control.

Civil society activist Nouri Ben Othman described Haddad as “an emblematic figure for our nation”.

Renowned Palestinian filmmaker Bakri dies

Actor and filmmaker Mohammed Bakri, a champion of the Palestinian cause, died yesterday aged 72, a hospital spokesperson said.

He was known for his documentary *Jenin, Jenin* and his commitment to the Palestinians, which led to frequent confrontations with Israeli authorities.

“Mohammed Bakri died this Wednesday at the Galilee Medical Center” in the northern Israeli city of Nahariya, hospital spokesperson Gal Zaid told AFP.

He died from heart and

lung problems, according to his family.

Bakri was born in Galilee in 1953 into a Muslim family.

He appeared in leading Israeli films but was also directed by the French-Greek director Costa-Gavras and Italian filmmakers Paolo and Vittorio Taviani.

His role as a Palestinian inmate in an Israeli prison in the 1980s film *Beyond the Walls* earned him critical acclaim in Israel and around the world.

But his international renown grew with the release of 2002’s *Jenin, Jenin*, which denounced alleged Israeli war crimes in the Jenin refugee camp in the occupied West Bank during the Second Intifada.

The Israeli Supreme Court upheld a ban on the film in 2022, deeming it “defamatory”.

The father of six also directed several socially conscious documentaries about the situation of Palestinian citizens of Israel.

Coup leader expected to stay in power in Guinea presidential vote

Guinea coup leader Mamady Doumbouya is expected to coast to victory in a presidential election on Sunday, buoyed by the launch of a long-awaited iron ore megamine and weak competition from a fragmented field of challengers.

Four years ago, Doumbouya, then a special forces commander, ousted President Alpha Conde in one of nine coups that have roiled West and Central Africa since 2020.

He initially vowed not to run for office, but a new constitution approved in September removed language that would have barred him and extended the presidential term from five to seven years.

Conde and longtime opposition leader Cellou Dalein Diallo are in exile and other potential challengers were disqualified for failing to submit required documents. That leaves eight challengers who are unlikely to give Doumbouya much trouble.

“Let’s not kid ourselves: there can be no other opponent who can challenge him,” said Guinean political analyst Bella Bah. “But that’s not the most important thing. (After the election) the president needs to take a step back and realise that he now has to exercise power,” Bah added, urging Doumbouya to engage in dialogue with actors beyond the military.

Political debate has been limited under Doumbouya, and civil society groups accuse his government of banning protests, curbing press freedom and restricting opposition activity.

MINING MILESTONE

Guinea holds the world’s largest reserves of bauxite and the richest untapped iron ore deposit at Simandou, which was officially launched last month.

Production at Simandou, originally scheduled for 1997, had been long delayed. Doumbouya’s junta ordered development to be paused in 2022, saying it wanted to review how national interests would be safeguarded once it came online.

Simandou is central to Doumbouya’s vision for Guinea: the country’s national development strategy is called Simandou 2040.

Annual production at the 75% Chinese-owned project is expected to peak at some 120mn metric tons, and supporters say Doumbouya will ensure Guinea gets its share of the proceeds.

“Dear Guineans, Guinea is no longer for sale,” government spokesperson Ousmane Gaoual Diallo declared at a campaign event this month. “Guinea is no longer up for grabs, Guinea is standing tall.”

Doumbouya’s transitional government also revoked EGA subsidiary Guinea Alumina Corporation’s license after a refinery dispute, transferring its assets to a state-owned firm.

The turn towards resource nationalism — also seen in other countries in the region with military rulers, including Mali, Burkina Faso and Niger — has bolstered Doumbouya’s popularity.

“The way politics was done before and now is different. We no longer have violent campaigns, but there is enthusiasm,” said Conakry resident Mohamed Keita, 65.

“People are out in the field, everyone expresses their opinions without violence.”

WARMING REGIONAL TIES

The campaign has unfolded peacefully, though Doumbouya’s tight grip means it is hardly a level playing field, said Gilles Yabi, founder of West African think tank WATHI.

“This is obviously a context that doesn’t allow for any hope of a free and fair presidential election,” Yabi said.

“The mere fact of holding a presidential election will not change the reality of power, which will remain primarily in the hands of the military.”

Despite such concerns, the West African regional bloc Ecowas is sending observers, a sign of “growing rapprochement” even though Guinea has been formally suspended since the 2021 coup, consultancy Signal Risk said in a note.

About 6.7mn people are registered to vote, with provisional results expected within 48 hours of polls closing.

Sellers under strain in Ivory Coast’s struggling shea industry

With nuts scarce as the shea season draws to a close, buyer Souleymane Sangare’s warehouses in Ivory Coast’s northern city of Korhogo are empty.

In a country where shea production is modest and largely based in the north, sellers made up for the shortfall by sourcing from Mali and Burkina Faso.

But last year, the neighbouring countries — among the world’s top shea crop producers — halted shea nut exports to boost local production.

The shea tree is a symbol of the dry African savannah. Its fruit contains a nut that women collect and sell raw, or process into butter for skincare or the food industry.

“Since they suspended exports, it has been hard to get nuts. And on top of that, this year Ivorian production has not been profitable enough,” said Sangare, a buyer at Korhogo market and vice-president of the Ivorian Shea Network.

Gone are the mountains of nuts in his two warehouses — only a few sacks remain this year.

“I normally have between

3,500 and 4,000 tonnes of nuts per season. This year, I haven’t even managed 500 tonnes, two months after the start of the season” from mid-August to October, he said.

In January, Ivory Coast also suspended exports of its nuts to secure supply for its own industry.

“We can’t criticise other countries for doing the same,” Mamadou Berte, head of the Cotton, Cashew and Shea Council, said.

Korhogo is home to the country’s first modern shea butter processing plant.

“I signed a contract to supply nuts to this plant, but I’m struggling to meet it because I can’t find enough,” Sangare said.

Togo and Nigeria have also frozen raw nut exports. Ghana, for its part, plans a gradual ban starting in 2026.

Those decisions, combined with strong global demand — driven by shea butter’s use as a cheaper alternative to cocoa butter — have left the west African market under strain, according to consultancy N’Kalo.

As a result, prices have soared, while trade has faltered.

In Ivory Coast, the minimum farmgate price of 250 CFA francs (\$0.44) per kilo has climbed to 350 CFA. Factory prices set at 305 CFA per kilo now range between 386 and 400 CFA, N’Kalo noted at the end of November.

US signs health pacts with African nations, warns against failure

The US has signed four new global health memorandums of understanding (MoUs) with Madagascar, Sierra Leone, Botswana, and Ethiopia, which total nearly \$2.3bn in funding, the State Department said.

The Trump administration unveiled its “America First Global Health Strategy” in September, a new approach to overseas aid that seeks to improve target countries’ self-reliance in managing their health sectors.

“Each MoU includes clear benchmarks, strict timelines, and consequences for non-perform-

ance — ensuring US assistance delivers results against priority disease threats and reduces long-term dependence on US assistance,” the State Department said in a statement. “Across the four MoUs, which total nearly \$2.3bn, the United States has committed almost \$1.4bn, with recipient countries co-investing more than \$900mn of their own resources.”

The US embassy in Ivory Coast’s commercial capital Abidjan said a signing of a five-year health cooperation memorandum between the two countries was scheduled for Thursday.

The MoU is aimed at strengthening disease detection and health worker capacity, the embassy said, adding that the State Department

planned to provide up to 273bn CFA francs (\$491mn) in health support, while Ivory Coast commits to increasing its national funding to 252bn CFA francs.

Earlier this month, the US signed a five-year health cooperation agreement with Eswatini to provide up to \$205mn for investments in health data collection, disease monitoring and response and HIV prevention and treatment.

Eswatini, in turn, will increase domestic health spending by \$37mn during the five-year period.

The US has also signed health co-operation agreements with Kenya, Rwanda, Uganda and Lesotho.

Ghana police arrest dozens of Nigerians over online fraud ring

Ghanaian police and security authorities have arrested nearly 50 Nigerians in a sting operation against online scammers, Accra said yesterday.

A nighttime raid on the outskirts of the capital “resulted in the arrest of 48 suspected cyber-crime operatives... believed to be Nigerian nationals”, information minister Sam George said.

Nigeria, home to a bustling fintech sector, also has a reputation

for Internet fraudsters known in local slang as “Yahoo Boys”.

At the same time, Nigeria itself has also become a target for foreign scammers, with a massive raid in Lagos last year leading to the arrest of 792 people, 148 of whom were Chinese nationals.

Those arrested in Ghana — 46 men and two women — are accused of conducting “romance scams, online investment fraud, impersonation schemes and illicit online gold trading,” George said in a post on X.

Ghana has tightened gold trade regulations — including by re-

stricting purchases by foreigners — this year as part of reforms trying to rein in informal mining that has ravaged the environment.

Within Ghana, online scams have become popular among young people who say they have few other economic prospects.

Earlier this year, AFP documented Accra’s tech-savvy teens turning to phishing scams and setting up fake online stores to rack up thousands of cedis in just a few hours.

In the raid, police recovered 54 laptops, 39 mobile phones and a Starlink Internet kit.

Somali migrants in Yemen long to return home

In makeshift homes lacking even the most basic necessities surrounded by piles of rubbish and flanked by dirt roads, thousands of Somalis in Yemen live in poverty in Aden’s “Little Mogadishu”.

Yemen is not a destination in itself for migrants but a way station for those leaving East Africa in the hopes of reaching the Gulf states and working in construction or as domestic staff.

But with security along its borders tight, many struggle to make it out of Yemen.

During the day, the men fan out across the city and line the roads looking for work in the de facto capital of government-controlled Yemen, where more than a decade of war has led to mass unemployment and food insecurity.

To make ends meet, many search for odd jobs or scavenge rubbish heaps, looking for any food that can be salvaged to feed themselves and their families.

“Some days we eat, some days it’s up to God. That’s life,” said Abdullah Omar, a 29-year-old Somali father of four in Aden.

Over a year ago, Omar decided to take his chances, shelling out \$500 to traffickers to board a boat with his family in hopes of escaping Somalia’s instability and finding a better life abroad.

But in Yemen, it has only been

misery. To survive, Omar washed cars, making the equivalent of just a few dollars a day.

After years working in construction in Mogadishu, Omar had hoped to find better conditions and pay in Yemen — where he had passed through as a teenager en route to Saudi Arabia.

But that was before years of civil war killed hundreds of thousands of civilians, destroyed vast amounts of infrastructure and left the country effectively partitioned between the Houthis fighters and Yemen’s internationally recognised government.

“Here I have nothing,” he said, while explaining his decision to enrol in a UN programme that paved the way for his repatriation to Somalia. “There’s no work, no money and no schooling for the children.”

Despite the poor conditions roughly 17,000 Africans arrived in Yemen in October, mostly from nearby Djibouti and Somalia, an increase of 99% from the month prior, according to the UN.

Somalis make up about 63% of the 61,000 registered refugees and asylum seekers in Yemen, UN data shows. Across Aden, where unemployment is already staggeringly high among Yemenis, African migrants are hard-pressed to gain a foothold. Nearly 19.5mn people in Yemen — more than half its population — are in need of humanitarian aid, including 4.8mn internally displaced people, according to early 2025 UN data.

Top court blocks Trump’s National Guard deployment in Chicago

The US Supreme Court dealt a blow to President Donald Trump’s immigration crackdown by blocking his deployment of National Guard troops in Chicago.

The conservative-dominated

court kept in place for now a lower court order barring the deployment of troops on the streets of the city in the midwestern state of Illinois.

“At this preliminary stage, the government has failed to identify a source of authority that would allow the military to execute the laws in Illinois,” the court said in an unsigned order. Three con-

servative justices - Samuel Alito, Clarence Thomas and Neil Gorsuch - dissented.

The Republican president has sent National Guard troops to three Democratic-led cities this year - Los Angeles, Washington and Memphis - but his efforts to deploy soldiers in Portland and Chicago have been tied up in the courts.

White House spokeswoman Abigail Jackson, reacting to the court ruling, said the president “activated the National Guard to protect federal law enforcement officers, and to ensure rioters did not destroy federal buildings and property.” “Nothing in the ruling detracts from that core agenda,” Jackson said. J B Pritzker, the Democratic governor of Illinois,

who strongly opposed the deployment along with the Democratic mayor of Chicago, welcomed the ruling, calling it a “big win for Illinois and American democracy.” After two lower courts blocked Trump from sending troops into Chicago, his administration made an emergency appeal to the Supreme Court.

In his filing with the top court,

solicitor general John Sauer claimed federal agents in Chicago were being “forced to operate under the constant threat of mob violence.”

The court order blocking deployment of the National Guard “improperly impinges on the president’s authority and needlessly endangers federal personnel and property,” Sauer added.

Democrats urge Trump to reverse mass ambassador recalls

Democratic senators yesterday urged President Donald Trump to reverse a recall of nearly 30 career ambassadors, warning the move leaves a dangerous leadership vacuum that allows adversaries like Russia and China to expand their influence.

The Trump administration in recent days has ordered career diplomats serving across Europe, Asia, Africa and Latin America back to Washington to ensure US missions abroad reflect its “America First” priorities.

The state department did not indicate how or when it would replace the ambassadors. A senior department official on Monday said the recalls were “a standard process in any administration.”

But the 10 Democrats on the Senate foreign relations committee who penned the letter to Trump said the abrupt mass recalls were an “unprecedented move” that no other administration has undertaken since Congress established the modern Foreign Service a century ago and that there was no plan to replace the envoys with qualified candidates.

The removals bring the number of empty US ambassadorial posts to well over 100, about half of all such posts worldwide, the senators said in their letter. They said 80 posts had been vacant before the decision.

“As the over 100 US embassies lacking senior leadership await

a new US ambassador, China, Russia and others will maintain regular communications with the foreign leaders that we will have effectively abandoned, allowing our adversaries to expand their reach and influence to limit, and even harm, US interests,” Democrats said in their letter.

The White House referred questions on the letter to the state department. A spokesperson for the department did not address questions on the contents of the letter but accused Democrats of blocking ambassadors’ appointments.

“Senate Democrats engaged in unprecedented obstruction of President Trump’s nominees, including ambassadors and other senior diplomats,” the spokesperson said.

Republicans, who control the Senate, changed the rules in September in response to what they say was Democrats slowing the installation of Trump’s picks to many government positions.

In yesterday’s letter, the Democratic senators, who included Senate foreign relations committee ranking member Jeanne Shaheen as well as Chris Murphy and others, provided examples of how Washington would lack top-level US presence in crucial locations as Beijing and Moscow make inroads.

In regions from the Indo-Pacific to Africa and the Balkans as well as Latin America, Washington would be on the back foot countering China’s expanding economic reach, the senators said. The recall leaves the US without a high-level presence in more than half of the countries

in sub-Saharan Africa. “These ambassadors have demonstrated their commitment to faithfully execute the policies of administrations of both parties for decades,” the senators said. “We urge you to reverse this decision immediately before more damage is done to America’s standing in the world.”

Political appointees leave their posts when a new administration takes office but career diplomats, while serving at the pleasure of the president, are often considered bipartisan and typically serve three to four years in their overseas posts regardless of a change in government.

But Trump has long been suspicious of the bureaucracy and has repeatedly pledged to “clean out the deep state” by firing bureaucrats whom he deems disloyal and placing loyalists in senior roles.

In February, Trump ordered Secretary of State Marco Rubio to revamp the US foreign service to ensure that the Republican president’s foreign policy is faithfully implemented.

In July, the Trump administration fired more than 1,300 state department diplomats and civil servants as Washington grappled with multiple crises on the world stage: Russia’s war in Ukraine, the almost two-year-long Gaza conflict, and the Middle East on edge due to high tension between Israel and Iran.

The department’s workforce reduction in the US totalled roughly 3,000 after deferred resignations and early retirements, accounting for more than 11% of its total foreign and civil service officers.

Two killed, 20 hurt in fire at Pennsylvania nursing home

A pair of explosions and a fire, apparently sparked by leaking gas, ripped through a nursing home near Philadelphia, killing a female employee and a resident, and injuring 20 people, officials said.

All residents and staff of the Silver Lake Nursing Home in Bristol Township, about 33km northeast of Philadelphia, have now been accounted for and the injured taken to local hospitals, police chief Charles Winik said.

Winik said people had been feared missing for a number of hours as flames and blasts gutted

the nursing home. Fire Marshal Kevin Dippolito said numerous patients and staff were initially trapped inside a demolished portion of the building.

Dippolito said the first firefighters arriving on the scene, some from a fire-and-rescue station across the street, encountered “a major structural collapse,” with part of the building’s first floor crumbling into the basement below.

He said numerous victims were extricated from debris, blocked stairwells and stuck elevators, while firefighters ventured into the collapsed basement zone and pulled at least two more people to safety before retreating amid lingering gas fumes.

“We got everyone out that we could, that we could find, that we could see, and we exited the building,” Dippolito said. “Within approximately 15 to 30 seconds of us exiting the building, knowing there was a heavy odour of natural gas around us, there was another explosion and fire.”

The front of the structure appeared to have been blasted away from the inside, but the majority of the facility remained standing, though most of its windows were shattered, according to a Reuters photographer on the scene.

News footage from WPVI-TV, an ABC News affiliate, showed roaring flames and smoke billowing from the crippled building shortly after the first explosion.

Court upholds \$100,000 fee to process US tech visas

A US federal judge has upheld President Donald Trump’s \$100,000 fee to process H-1B visa applications, acknowledging it could “inflict significant harm on American businesses and institutions of higher education.”

In a 56-page opinion, US district judge Beryl Howell wrote that the president has “broad statutory authority” to address “a problem he perceives to be a matter of economic and national security.”

The \$100,000 application fee announced in September gave companies just 36 hours notice before it went into effect, triggering chaos and confusion over how it would work and who would be hit.

The H-1B fee is part of a larger immigration crackdown by Trump, who has unleashed a massive push against migrants

since returning to the White House - though until now it had not targeted the visa on which Silicon Valley relies heavily.

Trump argued that the H-1B visa system was being abused to replace American workers with people willing to work for less money.

The US awards 85,000 H-1B visas per year on a lottery system. India accounts for around three-quarters of the recipients.

Tech entrepreneurs - including Trump’s former ally Elon Musk - have warned against targeting H-1B visas, saying that the US does not have enough homegrown talent to fill important tech sector job vacancies.

The lawsuit was brought by the US Chamber of Commerce, a pro-business lobbying group, and the Association of American Universities, which represents 69 US-based research universities.

Together, the plaintiffs claimed the affected workers “contribute enormously to American productivity, prosperity and innovation.”

Mexico releases water to US



Mexico opened the floodgates of the El Cuchillo Dam to send water through the San Juan River to the US to settle its water debt under the 1944 Water Treaty, which requires delivery of 1.75mn acre-feet of Rio Grande Basin water to the US every five years, in China, Nuevo Leon state, Mexico.

US Coast Guard ‘lacks forces to seize Venezuela-linked tanker for now’

The US Coast Guard is waiting for additional forces to arrive before potentially attempting to board and seize a Venezuela-linked oil tanker it has been pursuing since Sunday, a US official and a source familiar with the matter said.

The ship, which maritime groups have identified as the Bella 1, has refused to be boarded by the Coast Guard. That means that the task will likely fall to one of just two teams of specialists - known as Maritime Security Response Teams

- who can board vessels under these circumstances, including by rappelling from helicopters.

The days-long pursuit highlights the mismatch between the Trump administration’s desire to seize sanctioned oil tankers near Venezuela and the limited resources of the agency that is mainly carrying out operations, the Coast Guard.

Unlike the US Navy, the Coast Guard can carry out law enforcement actions, including boarding and seizing vessels that are under US sanctions.

Trump earlier this month ordered a “blockade” of all sanctioned oil tankers entering and leaving Venezuela, in Washington’s latest move

to increase pressure on Venezuelan President Nicolas Maduro.

The Coast Guard has in recent weeks seized two oil tankers near Venezuela. After the first seizure, on December 10, US attorney general Pam Bondi posted a 45-second video showing two helicopters approaching a vessel and armed individuals in camouflage rappelling onto it.

A Saturday social media post by the department of homeland security, which oversees the Coast Guard, showed what appeared to be Coast Guard officers aboard the Gerald Ford aircraft carrier getting ready to depart and seize the Centuries tanker, the second of the

ships boarded by the US.

A US official, speaking on condition of anonymity, said the Coast Guard officials on the Ford were from a Maritime Security Response Team and at the time too far from Bella 1 to carry out a boarding operation.

“There are limited teams who are trained for these types of boardings,” said Corey Ranslem, chief executive of maritime security group Dryad Global and previously with the US Coast Guard.

The department of homeland security did not immediately respond to a request for comment and Reuters could not determine what, if any other reasons, have led to the

Coast Guard not seizing the vessel yet.

The administration could ultimately choose to not board and seize the vessel.

The White House said that the US was still in “active pursuit of a sanctioned dark fleet vessel that is part of Venezuela’s illegal sanctions evasion.”

The US Coast Guard is a branch of the armed forces but a part of the department of homeland security.

The US has assembled a massive military force in the Caribbean, including an aircraft carrier, fighter jets and other warships. Ospreys and additional MC-130J Commando II aircraft arrived in Aguadilla,

Puerto Rico in recent days, according to a separate source.

The Coast Guard has far fewer resources in place. The service has long said that it lacks the resources to effectively carry out a growing list of missions, including search and rescue operations and drug seizures.

In November, the Coast Guard announced that it had seized about 49,000 pounds of drugs worth more than \$362mn in the eastern Pacific.

“The Coast Guard is in a severe readiness crisis that is decades in the making,” Admiral Kevin Lunaday, who leads the Coast Guard, told lawmakers in June.

India simplifies import checks as it eyes US trade deal

India's government yesterday announced reforms to cut red tape and simplify its import quality checks, addressing a con-

cern raised by the US over what it described as the South Asian country's "burdensome" import-quality requirements. New Delhi and Washington have been working to thrash out a trade agreement, which India hopes will bring relief from a 50%

tariff imposed by President Donald Trump on some of its main exports as punishment for its Russian oil purchases. The reforms on import checks include reduced paperwork, shorter timelines, and fewer inspections for quality approvals, the trade

ministry said in a statement. "The reforms aim to accelerate processes, reduce turnaround times, and leverage technology-driven systems to make quality assurance faster, more transparent, and more accessible for enterprises, institutions, and citizens," said Jaxay

Shah, the chairman of the Quality Council of India. India expects to secure a trade deal with the US before the end of this year as most issues have been resolved, New Delhi's trade secretary said on November 28. Earlier this month, US Presi-

dent Donald Trump said that talks with Indian Prime Minister Narendra Modi had been going well. Trump's administration has pressured India to reduce oil purchases from Russia and to bring down tariffs including across sensitive sectors like agriculture.

Lilly and Novo lock horns in India's obesity drug race

Global pharma giants Eli Lilly and Novo Nordisk are scrambling to cement their lead in India's booming obesity drug market before cheaper generic versions hit shelves in March next year. Novo's strategy emphasises price cuts and accelerated launches, while Lilly's products benefited from hitting the market early. Both companies focused on aggressive outreach to doctors, heavier advertising about obesity, tie-ups with clinics, patient incentives and distribution deals with local drugmakers, according to doctors, analysts, medical representatives, patients and distributors. Lilly has even teamed up in India with well-known Bollywood actors in a social media ad campaign about obesity. India, projected to have the world's second-largest overweight or obese population by 2050 in absolute numbers, is becoming a key battleground for obesity drugs. Analysts expect the global market for such drugs to hit \$150bn a year by the end of this decade. Although the US remains the largest market for obesity drugs, early sales figures in India show rapid uptake, even though most patients in the world's most populous nation pay for the medication out-of-pocket. "We believe that this market can be more than \$1bn within

two years," said Shrikant Akolkar, vice-president at research firm Nuvama Institutional Equities. Data analytics firm Pharmarack said in July that the market was estimated to be worth Rs6.28bn (\$70.23mn) at present, growing fivefold since 2021. US drugmaker Lilly's Mounjaro, approved for diabetes and weight loss in India, became the top-selling therapy by value in October, with sales doubling within months of its March launch, outpacing Danish drugmaker Novo's Wegovy, which entered the Indian market in June. "We realised just after a couple of months that for accessibility, we had to take a price cut," said Vikrant Shrotriya, Novo Nordisk's managing director in India, referring to Wegovy's price cut in November. Shrotriya spoke earlier this month while launching Novo Nordisk's blockbuster diabetes drug, Ozempic, in the country. Ozempic, a once-weekly injection approved by the US drug regulator in 2017 for Type 2 diabetes, became a global bestseller and is widely used off-label for weight loss due to its appetite-suppressing effects. More than 20 Indian drugmakers, including Dr Reddy's, Cipla, Sun Pharma, Zydus and Lupin, plan to launch cheaper versions of Novo's weight-loss drug in India once its patent on semaglutide, the active ingredient in Wegovy and Ozempic, expires in March 2026. Analysts expect generic drugs to cost about 60% less, intensi-

fying the fight - particularly for Novo - for dominance in India's price-sensitive market. Shrotriya played down concerns over looming patent expiries, saying Novo will focus on quality, trust and affordability rather than on patents or competition in India. Lilly's Mounjaro has quickly gained traction in India. A 2.5mg Mounjaro KwikPen costs about Rs13,125 (\$146.79) for a month's usage, with the highest 15mg dose going up to Rs25,781 (\$288.33). In response, Novo cut the price of Wegovy in India by up to 37% in November, pricing its lowest dose of 0.25 mg at Rs10,850 (\$121.34) for a one-month pack. It launched Ozempic last week for a monthly price of Rs8,800 (\$98.42) for 0.25mg. While Wegovy is catching up, Mounjaro's early launch helped it penetrate the market, and the latter drug's claim of offering greater weight loss makes it a popular choice among patients, said five doctors who spoke with Reuters. "Mounjaro clearly has first-strike advantage and continues to have strong demand, but price-sensitive patients are reassessing alternatives," said Dr Anoop Misra, an endocrinologist and executive chairman of Fortis C-DOC Hospital. Mounjaro also differentiates itself by targeting people with severe obesity, said Vishal Manchanda, analyst at Systematix Institutional Equities. He added that Lilly faces no immediate pressure to cut prices, given its strong position.

Bangladesh leader set to return from exile today

The Bangladesh Nationalist Party aims to gather 5mn supporters to welcome its leader Tarique Rahman home from nearly 17 years in exile today, a show of strength as he emerges as a leading contender for prime minister in February elections. Rahman, 60, is the son of ailing former prime minister Khaleda Zia and acting chairman of the party that is widely expected to come out on top in the parlia-

mentary vote set for February 12. His return from London comes as his BNP is on the ascendant following the ouster of its arch foe, long-time prime minister Sheikh Hasina, in a student-led uprising last year. Apart from brief transition administrations, Khaleda Zia and Sheikh Hasina have alternated in power since 1991. A December survey by the US-based International Republican Institute suggests the BNP is on course to win the largest number of parliamentary seats, with the Islamist Jamaat-e-Islami party also in the race. Hasina's Awami

League party, which has been barred from the election, has threatened unrest that some fear could jeopardise the vote. Rahman's decision to return is driven by both political developments and personal circumstances. His mother has been seriously ill for months, prompting what party insiders describe as an urgent trip home. BNP leaders said they are preparing for what they call an "unprecedented" gathering in the capital, aiming to draw more than 5mn supporters along the route from the airport to the reception venue.

India space agency launches its heaviest satellite

India's space agency launched its heaviest ever payload yesterday, with Prime Minister Narendra Modi calling the deployment "a significant stride" for the space sector. The LVM3-M6 rocket launched the US-built AST SpaceMobile communications satellite into low-Earth orbit. The Indian Space Research Organisation (ISRO) said yesterday that the rocket was the "heaviest payload to be launched from Indian soil". The launch is a boost for India's ambitious low-cost space programme, with plans for an uncrewed orbital mission and human spaceflight in the coming years. The satellite, weighing 6,100kgs, was launched on a modified version of a rocket that India plans to use for its future space missions. India is vying for a larger slice of the booming commercial satellite business as phone, internet and other companies seek expanded and more high-end communications.

Modi said the launch marked "a proud milestone in India's space journey". "It strengthens India's heavy-lift launch capability and reinforces our growing role in the global commercial launch market," he said in a statement. Earlier this year, ISRO launched the CMS-03 communication satellite, which weighs about 4,410kgs. For these heavy launches, India has deployed an upgraded version of the rocket it used to send an unmanned craft to the Moon in August 2023. The world's most populous nation has flexed its spacefaring ambitions in the last decade with its space programme growing considerably, and rivalling the achievements of established powers at a much cheaper price tag. It has said it plans to launch an uncrewed orbital mission before its first human spaceflight in 2027. Modi has also announced plans to send an astronaut to the Moon by 2040. — Reuters



Thailand, Cambodia hold talks on resuming ceasefire

Military officials from Thailand and Cambodia yesterday began talks, both countries said, days after the neighbours agreed to discuss resumption of a ceasefire after 16 days of fierce border clashes that have killed at least 86 people. The talks come two days after a special meeting in Kuala Lumpur of Southeast Asian foreign ministers convened to try to salvage a truce first brokered by Asean chair Malaysia and US President Donald Trump after a previous round of clashes in July. Thai defence ministry spokesman Rear Admiral Surasant Kongsiri said yesterday's meeting of the general border committee would last three days and could pave the way for an agreement. The talks were held at a border checkpoint towards the southern

end of their 817km frontier. "If the secretariat meeting goes smoothly and leads to an agreement, then there will be a meeting between the defence ministers of the two countries on December 27," Surasant told reporters. Cambodian defence ministry spokeswoman Maly Socheata said the talks began at 4.30pm local time, led by generals from both sides. The meeting is the most significant step since fighting re-erupted and follows separate, unsuccessful efforts by Malaysia, China and the US to bring the two countries to the table. Cambodia and Thailand have each accused the other of aggression and violations of an enhanced ceasefire reached in October in Malaysia in Trump's presence, during which they committed to demining and withdrawing troops and heavy weapons from areas over which sovereignty has been contested bitterly for decades.

Australian state passes tougher gun, protest law

Australia's most populous state yesterday passed sweeping new gun and anti-terror rules following the mass shooting on Bondi Beach, tightening firearm ownership, banning public display of terror symbols and strengthening police power to curb protests. The New South Wales state parliament passed the Terrorism and Other Legislation Amendment Bill early morning after the

upper house approved the bill by 18 votes to eight during an emergency sitting. Premier Chris Minns said not all residents of New South Wales would support the tough reforms but his government was doing everything possible to keep people safe, in the wake of the December 14 shooting, where 15 people were killed and dozens wounded. "Sydney and New South Wales has changed forever as a result of that terrorist activity," Minns told reporters. The bill passed the lower house

on Tuesday with support from the governing centre-left Labor and the opposition Liberal party. The rural-focused National Party, the Liberal's junior coalition partner, opposed the gun reforms arguing the ownership caps would unfairly disadvantage farmers. The Bondi Beach gun attack, Australia's deadliest in almost three decades, prompted calls for stricter gun laws. Under the new gun laws, which Minns described as the toughest in Australia, individual licences will be capped at four, while

farmers will be permitted to own up to 10 guns. Gun club membership will be mandatory for all firearms licence holders. Police will be granted more powers to impose restrictions on protests for up to three months after a declared terror attack. Public display of flags and symbols of prohibited militant organisations has been outlawed and offenders will be jailed for up to two years or fined A\$22,000 (\$14,742). Minns added that hateful statements used to vilify and in-

timidate people must be banned. Police believe the two alleged gunmen were inspired by the Islamic State. Sajid Akram, 50, was shot dead by police, while his 24-year-old son Naveed has been charged with 59 offences, including murder and terrorism. Activist groups have condemned the law and signalled plans for a constitutional challenge. In a statement, they said it would file a legal challenge against what they described as "draconian anti-protest laws" rushed through the state parliament. "It is clear that the (state)

government is exploiting the horrific Bondi attack to advance a political agenda that suppresses political dissent and curtails democratic freedoms," the groups said. Prime Minister Anthony Albanese has also vowed a crackdown on hate speech, with his centre-left federal government planning to introduce legislation to make it easier to prosecute those promoting hatred and violence, and to cancel or deny visas to people involved in hate speech. Albanese has proposed a gun buyback plan as well.

How German engineers are building future-proof forests

Once visitors who braved the 200 steps of the Lormecke-Turm tower in Germany's Arnsberg forest park would be rewarded with a stunning view across a dense canopy of giant Norwegian spruce.

Now all they see from the 35m viewing tower is a denuded plateau. The trees have gone, struck down after a devastating infestation of bark beetles in 2018.

The "calamity", as experts call it, happened so fast that 60-year-old trees were lost in just weeks here in the forest, a paradise for nature-lovers in North Rhine-Westphalia, along Germany's border with the Netherlands and Belgium.

"It's shocking for me and every forester," said Petra Trompeter, who works for Arnsberg city's forestry department, squinting through the low winter sun from the base of the tower. The foundations for mass dieback were laid over many years as storms and drought created the perfect conditions for the bark beetles to devour row-upon-row of spruce trees.

Foresters know that worse might yet be to come as global warming reaches above 1.5C above the 1850-1900 pre-industrial period, with 2024 confirmed as the first year to breach this level, according to the World Meteorological Organisation.

In a hotter world, climate change-related disasters are expected to increase in frequency and intensity, threatening forests' ability to absorb carbon, as well as thousands of jobs in the tourism and timber sectors.

In May, Germany's independent Expert Council on Climate Issues said the country could miss post-2030 climate targets as forests and wetlands shift from functioning as carbon sinks to become sources of emissions due to forest degradation.

Forest engineers use biodiversity to future-proof forests; Spruce plantations vulnerable to climate change, pests; Financial challenges hinder long-term forest restoration

But these single-species plantations have made North Rhine-Westphalia's forests particularly vulnerable to heat, drought and pests.

"It's high-risk forestry," Siim Kuresoo, a campaigner with Fern, a Dutch forest protection NGO, told the Thomson Reuters Foundation. If everything goes right, there are good returns, but when mass tree losses occur due to extreme weather, they are viewed as "inevitable".

Diversification is seen as a solution, and it is being trialled across Europe.

Under the 20mn-euro SUPERB project, led by the European Forest Institute and funded under the EU's Green Deal, forestry experts have set up 12 demonstration sites from Sweden to Spain, including in Arnsberg, to restore habitats and transform monocultures.

The Arnsberg site covers 34 hectares of public and private land. Forestry experts carefully selected a mix of four species of conifers and broad leaf trees that they believe could adapt to the altitude and climate and withstand the hotter, drier conditions likely in the future.

Trees also play critical role in the economy, supplying 76mn cu m of timber every year, 750,000 jobs in forestry and timber, as well as boosting rural economies through eco-tourism, according the German Agriculture Ministry.

The hilly Sauerland region of North Rhine-Westphalia is a popular destination for hikers, but the mass dieback made the area unrecognisable for some visitors, said Rouven Soyka, press officer for the Sauerland Tourism board.

"Nature tourism is affected in every way. We are a classic outdoor region, it's important to have intact nature."

But many forest owners cannot afford reforestation without state subsidies, which do not cover all costs. At the Jungermann tree nursery, owner Peter Jungermann, says he has to think twice before investing in growing more high-maintenance broad leaf varieties over market-friendly conifers, especially given financial pressure on forest owners.

And it is not clear yet how much money will be allocated to forest restoration in the 2028-2034 EU budget, worth 2tn euros (\$2.35tn). Negotiations will be held over the next two years. Germany's 2026 budget prioritises defence and infrastructure spending as the government attempts to revive the sluggish economy.

"Forests are the basis of life for us humans, for the entire planet," said Trompeter. "Where else should it be spent than to preserve nature and make it climate-resilient?" — Thomson Reuters Foundation

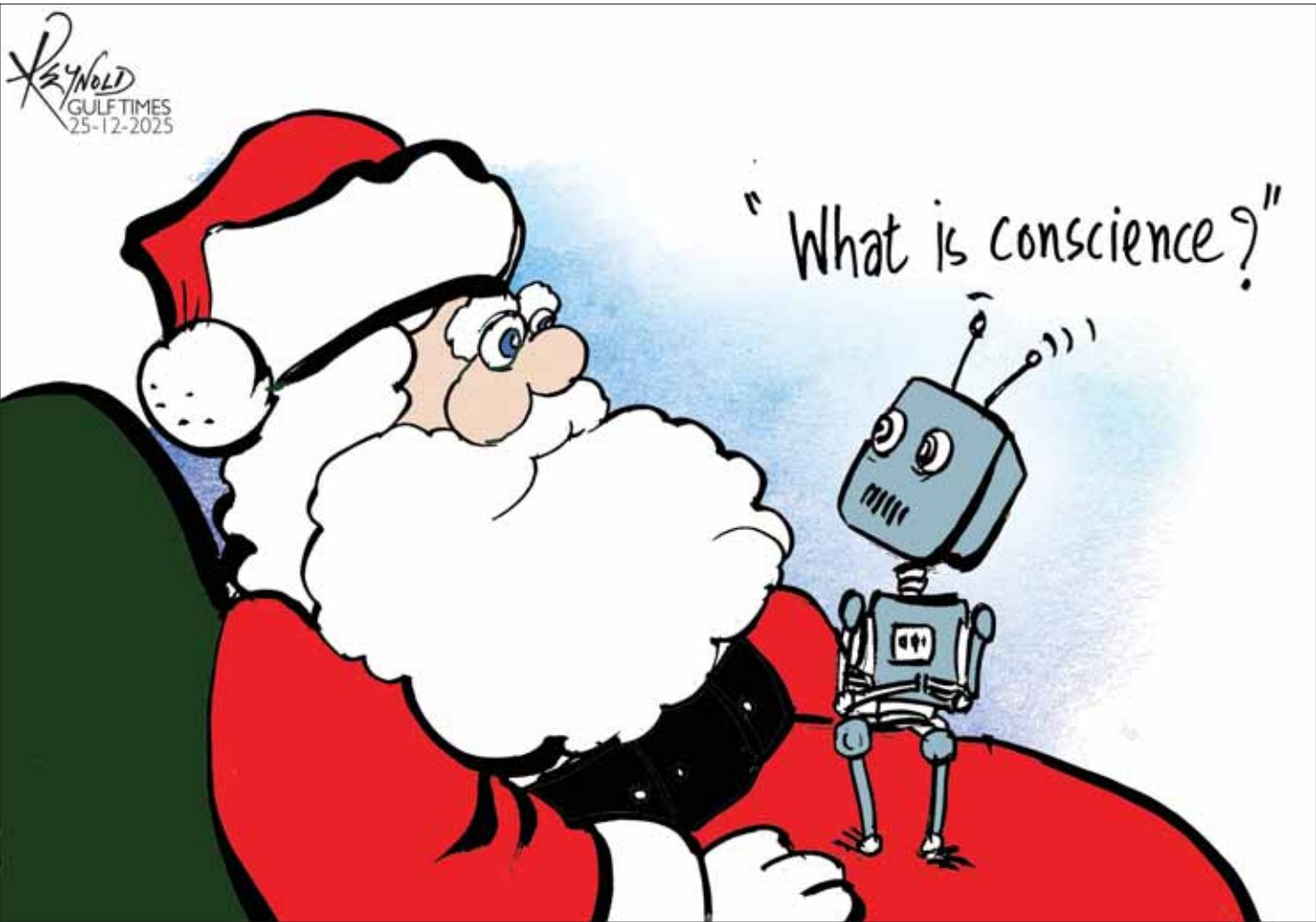

How the Fed became a lender of immediate resort

The greatest threat to the independence of the US Federal Reserve does not come from

President Donald Trump's attacks or a Supreme Court ruling that might expand his authority. It is the Fed's longer-term shift from lender of last resort to lender of immediate resort. Without a clear distinction between temporary liquidity support and protection for insolvent institutions, the Fed's independence turns into cover for ad hoc bailouts, and monetary policy becomes a hostage of weak institutions and authorities' reluctance to admit supervisory failure.

With each successive crisis over the past decade and a half, from 2007-08 to the 2020 Covid-19 shock and the mid-size bank turmoil of 2023, the Fed has steadily expanded the scope and scale of its interventions. What began as emergency liquidity support has become a recurring feature of financial-market management.

When every disruption is said to generate "spillovers" and every balance-sheet wobble prompts intervention, the distinction between containing panics and propping up failing institutions collapses, and with it goes the discipline that keeps moral hazard in check. At that point, independence can no longer enforce restraint; it merely shields open-ended emergency measures.

The benchmark for central-bank restraint was set by Walter Bagehot more than a century ago: lend early and freely, but only to solvent institutions, against good collateral, and at a penalty rate. Under this elegant framework, the

central bank supplies liquidity, the fiscal authority provides capital, and markets impose accountability. Viable institutions are insulated from liquidity panics, while insolvent ones are restructured or shut down.

That framework endured so long as the boundaries between regulated banks and the rest of the financial system were clearly defined, and the line between liquidity and solvency was easier to draw. Modern crises have made it harder to sustain the latter distinction, as sharp asset-price declines can quickly undermine institutions that appear stable.

With non-bank entities increasingly performing bank-like functions without comparable oversight, the Fed extended its reach in 2008 and again in 2020, broadening collateral standards and creating new lending facilities on the fly. By the time the pandemic hit, interventions once considered extraordinary had become routine. While each step may have been defensible in isolation, together they pushed the Fed beyond the limits that preserved its legitimacy.

Whereas illiquidity is a short-term funding problem, insolvency reflects long-term balance-sheet weaknesses that can be addressed only through new equity, mergers, or orderly resolution. The key challenge facing policymakers is to determine whether an institution is solvent yet temporarily illiquid, or insolvent and therefore in need of restructuring. If regulators cannot draw this distinction for banks, despite having granular supervisory data, they certainly cannot do so for non-banks, where visibility is limited.

The turmoil of 2023 underscored the risks created by the Fed's mission creep. My co-authors and I estimated that hundreds of banks

faced large mark-to-market losses on long-duration assets, operated with thin capital buffers, and relied heavily on uninsured deposits. Yet instead of calling for restructuring or new equity, the episode was widely framed as a liquidity crisis. New facilities effectively extended support to roughly \$9tn in uninsured deposits, vastly expanding the safety net.

By acting as a lender of immediate resort, the Fed may have steadied markets, but it also left the underlying incentives unchanged, setting the stage for the next crisis and putting its independence under strain. Higher interest rates, though necessary to rein in inflation, exposed widespread interest-rate risk across the banking system. This left the Fed in a bind: raise rates dramatically and risk breaking the weakest banks, or hold back and allow inflation to run wild. Financial fragility, in effect, became an undeclared ceiling on monetary tightening.

The Fed's dual role as bank supervisor and monetary authority magnifies the conflict. The problem is that admitting supervisory failures or concealed solvency problems is politically costly. That creates a strong incentive for the Fed to characterise balance-sheet weaknesses as liquidity issues, leading to a pro-intervention bias that runs counter to the very purpose of central-bank independence.

The answer is not to abandon Bagehot's framework but to update it. To this end, the Fed should set clear conditions for when emergency facilities can be activated, publish transparent eligibility rules that restrict lending to solvent institutions, impose robust penalty rates and haircuts, and publicly disclose how each facility was used

once it is wound down. Most importantly, the Fed should limit itself to liquidity support and leave solvency issues to markets and fiscal authorities. Without that separation, the Fed will continue to drift toward industrial policy, undermining its legitimacy and independence.

While some may argue that these safeguards already exist, recent interventions have lacked the one constraint capable of limiting moral hazard: automatic mechanisms that force markets to determine whether an institution deserves to survive. Banks that receive liquidity support should be required to raise equity commensurate with that support within a defined window or face restructuring or consolidation. If markets are unwilling to provide capital, the institution is not illiquid – it is insolvent.

Central-bank independence must rest on sound governance, transparency, and accountability. That includes acknowledging supervisory failures when a solvency problem is misjudged as a liquidity one, and explaining how those failures will be addressed rather than masking them through intervention. After all, a central bank that cannot refuse intervention during a crisis cannot be expected to hold its ground when tightening monetary policy.

To protect its credibility, the Fed must resist the temptation to treat every problem as systemic. Otherwise, the financial system will remain fragile by design, and the Fed's credibility will erode every time it rescues another institution that should have been allowed to fail. - Project Syndicate

Flag carrier PIA to be run by new owners from April: Pakistan official

Pakistan International Airlines (PIA) is expected to be run by a new owner from April next year and receive fresh capital under a deal to privatise the flag carrier, the country's privatisation chief said yesterday.

A consortium headed by the Arif Habib Corporation emerged

as the top bidder in a live-televised auction for a 75% stake in PIA on Tuesday, marking a breakthrough for the government's long-delayed privatisation of the carrier.

The Arif Habib consortium offered 135bn rupees (\$482.14mn), surpassing a government reserve price of 100bn rupees, in a sharp turnaround from last year's failed sale attempt.

Muhammad Ali, the privatisation adviser to the prime minister,

said in an online interview that the state expects a new owner to be running the airline by April, subject to approvals.

The process now moves to final approvals by the Privatisation Commission board and the cabinet, expected within days, with contract signing likely within two weeks and financial close after a 90-day period to meet regulatory and legal conditions.

Ali said the government would

receive about 10bn rupees in cash upfront and retain a 25% stake valued at around 45bn rupees.

The deal was structured to inject fresh capital into the airline rather than simply transfer ownership, he said.

"We did not want a situation where the government sells the airline, takes its money and the company still collapses," Ali said.

The winning consortium also comprises fertiliser maker Fa-

tima, private school network City Schools and real estate firm Lake City Holdings Ltd.

Ali said Fauji Fertilizer Company, a military-run conglomerate, did not bid but could still join the winning consortium as a partner, noting the buyer can add up to two partners - including a consortium partner or a foreign airline - if they meet the qualifying criteria.

Allowing partners adds financial strength and could bring glo-

bal aviation expertise, he said.

Ali said safeguards, including retained earnest money and an additional payment on signing, would allow the government to move to the second-highest bidder if the deal fails to close.

On labour, Ali said the buyer must retain all employees for 12 months after the transaction, with contracts unchanged, adding that the PIA workforce has already shrunk in recent years.

Zelensky reveals US-Ukraine plan to end Russian war, key questions remain

Ukraine won some limited concessions in the latest version of a US-led draft plan to end the Russian invasion, President Volodymyr Zelensky has revealed, though key questions remain over territory and whether Moscow could accept the new terms.

The 20-point plan, agreed on by US and Ukrainian negotiators, was being reviewed by Moscow. The Kremlin has previously not shown a willingness to abandon its headline territorial demands for full Ukrainian withdrawal from the east.

Zelensky conceded there were some points in the document that he did not like, but that Kyiv had succeeded in removing immediate requirements for Ukraine to withdraw from the Donetsk region or that land seized by Moscow's army would be recognised as Russian.

Nevertheless, the Ukrainian leader still indicated the proposal would pave the way for Kyiv to pull some troops back, including from the 20% of the Donetsk region that it controls, where demilitarised zones would be established.

It also got rid of demands that Kyiv must legally renounce its bid for Nato membership.

Zelensky presented the plan during a two-hour briefing with jour-

nalists, reading from a highlighted and annotated version.

"In the Donetsk, Lugansk, Zaporizhzhia, and Kherson regions, the line of troop deployment as of the date of this agreement is de facto to be recognised as the line of contact," Zelensky said of the latest version.

"A working group will convene to determine the redeployment of forces necessary to end the conflict, as well as to define the parameters of potential future special economic zones," he added.

This appears to suggest the plan opens the way for, but delays, options that Ukraine was previously reluctant to consider - a withdrawal of troops and the creation of demilitarised zones.

"We are in a situation where the Russians want us to withdraw from the Donetsk region, while the Americans are trying to find a way," Zelensky said.

"They are looking for a demilitarised zone or a free economic zone, meaning a format that could satisfy both sides," he continued.

US President Trump is trying to broker an end to the four-year war, triggered by Russia's 2022 invasion.

Tens of thousands have been killed, eastern Ukraine decimated and millions forced to flee their homes.

Russian troops are advancing on the front and hammering cities and Ukraine's energy grid with nightly missile and drone barrages.

Moscow's defence ministry yesterday said it had captured another Ukrainian settlement in the southern Zaporizhzhia region.

Russia in 2022 claimed to have annexed four Ukrainian regions - Donetsk, Kherson, Lugansk and Zaporizhzhia - in addition to the Crimean peninsula which it seized in 2014.

President Vladimir Putin has shown no willingness to compromise, doubling down on his headline demands for a sweeping Ukrainian withdrawal and a string of political concessions that Kyiv and its European backers have previously cast as capitulation.

Any plan that involves Ukraine pulling back its troops would need to pass a referendum in Ukraine, Zelensky said.

"A free economic zone. If we are discussing this, then we need to go to a referendum," Zelensky said, referring to plans to designate areas Ukraine pulls out from as a demilitarised free trade zone.

On Nato, Zelensky said: "It is the choice of Nato members whether to have Ukraine or not. Our choice has been made. We moved away from the proposed changes to the Constitution of Ukraine that would have prohibited Ukraine from joining Nato."

Nevertheless, the prospects of Ukraine being admitted to the bloc appear slim-to-none, as it has been ruled out by Washington.

Three killed in Moscow bomb blast

Russia plans nuclear power plant on moon within a decade

Russia plans to put a nuclear power plant on the moon in the next decade to supply its lunar space programme and a joint Russian-Chinese research station, as major powers rush to explore the earth's only natural satellite.

Ever since Soviet cosmonaut Yuri Gagarin became the first human to go into space in 1961, Russia has prided itself as a leading power in space exploration, but in recent decades it has fallen behind the US and, increasingly, China.

Russia's ambitions suffered a massive blow in August 2023 when its unmanned Luna-25 mission smashed into the sur-

face of the moon while attempting to land, and Elon Musk has revolutionised the launch of space vehicles - once a Russian speciality.

Russia's state space corporation, Roscosmos, said in a statement that it planned to build a lunar power plant by 2036 and signed a contract with the Lavochkin Association aerospace company to do it.

Roscosmos did not say explicitly that the plant would be nuclear but it said the participants included Russian state nuclear corporation Rosatom and the Kurchatov Institute, Russia's leading nuclear research institute.

Roscosmos said the purpose of the plant was to power Russia's lunar programme, including rovers,

an observatory and the infrastructure of the joint Russian-Chinese International Lunar Research Station.

"The project is an important step towards the creation of a permanently functioning scientific lunar station and the transition from one-time missions to a long-term lunar exploration programme," Roscosmos said.

The head of Roscosmos, Dmitry Bakanov, said in June that one of the corporation's aims was to put a nuclear power plant on the moon and to explore Venus, known as earth's "sister" planet.

Russia is not the only one with such plans. Nasa in August declared its intent to put a nuclear reactor on the moon by the first quarter of fiscal year 2030.

Serbia court drops case against ex-minister for train station disaster

A Serbian court yesterday dropped charges against a former construction minister over the Novi Sad railway station canopy collapse that killed 16 people, citing a lack of evidence.

The case is one of three probes linked to the tragedy in November 2024 that sparked a huge protest movement that has still not abated, with the disaster at the newly renovated station being seen as a symbol of entrenched corruption.

Goran Vesic, 56, who resigned days after the accident, was charged in September along with 12 others with a "serious crime against public safety" by the Novi Sad chief prosecutor.

However, the Novi Sad High Court said there was "insufficient evidence to support reasonable suspicion" that Vesic and five other defendants committed the offences set out in the indictment, while confirming charges against the remaining seven. - AFP

Kosovo, Serbia 'need to normalise' relations

Kosovo and Serbia need to "normalise" their relations, Kosovo's Prime Minister Albin Kurti said yesterday, several days before legislative elections where he is seeking to extend his term with more solid backing.

Kurti has been in office since 2021 and previous accords signed with Serbia - which does not recognise the independence of its former province - have yet to be respected.

"We need to normalise relations with Serbia," said Kurti. "But normalising relations with a neighbouring authoritarian regime that doesn't recognise you, that also doesn't admit to the crimes committed during the war, is quite difficult," he added.

Tensions between the two neighbours are regularly high, and renewed unrest would provide Russia with means of destabilising his country.

"We do have a normalisation agreement," Kurti said, referring to the agreement signed under the auspices of the European Union in 2023.

"We must implement it, which implies mutual recognition between the countries, at least de facto recognition."

But to resume dialogue, Serbia "must hand over Milan Radoicic," a Serb accused of plotting an attack in northern Kosovo in 2023, Kurti asserted, hoping that "the EU, France, and Germany will put pressure" on Belgrade to do so.

Russia's shadow also looms over relations with Serbia, which has never severed ties with Moscow and on which it depends for its energy needs.

European leaders hit out at US visa bans

The European Union, France and Germany yesterday condemned US visa bans on five Europeans combating online hate and disinformation, after President Donald Trump's administration took its latest swipe at long-standing allies across the Atlantic.

Washington imposed visa bans on Tuesday on five European citizens, including French former EU commissioner Thierry Breton. It accuses them of working to censor freedom of speech or unfairly target US tech giants with burdensome regulation.

The bans mark a fresh escalation against Europe, a region Washington argues is fast becoming irrelevant due to its weak defences, inability to tackle immigration, needless red tape and "censorship" of far-right and nationalist voices to keep them from power.

They come just weeks after a US National Security Strategy document warned Europe faced "civilisational erasure" and must course-correct if it is to remain a reliable US ally.

That document - and other comments by senior Trump officials, including a bombshell February speech by Vice-President J D Vance in Munich - have upended postwar

assumptions about Europe's close relationship with its strongest ally, and concentrated minds across European capitals on the urgent need to diversify away from reliance on US technology and defence.

In Brussels, Paris and Berlin, senior officials condemned the US bans, and defended Europe's right to legislate on how foreign companies operate locally. A European Commission spokesperson said it "strongly condemns the US decision", adding: "Freedom of expression is a fundamental right in Europe and a shared core value with the US across the democratic world."

The spokesperson said the EU would seek answers from Washington, but said it could "respond

swiftly and decisively" against the "unjustified measures".

French President Emmanuel Macron, who has been travelling across France to warn about the dangers that disinformation poses to democracy, said he had spoken with Breton and thanked him for his work.

"We will not give up, and we will protect Europe's independence and the freedom of Europeans," Macron said on X.

Breton, a former French finance minister and the European commissioner for the internal market from 2019 to 2024, was one of the architects of the EU's Digital Services Act.

A landmark piece of legislation, the DSA aims to make the internet

safer by compelling tech giants to do more to tackle illegal content, including hate speech and child sexual abuse material.

But the DSA has riled the Trump administration, which accuses the EU of placing "undue" restrictions on freedom of expression in its efforts to combat hateful speech, misinformation and disinformation. It also argues that the DSA unfairly targets US tech giants and US citizens.

Trump officials were particularly upset earlier this month when Brussels sanctioned Elon Musk's X platform, fining it 120mn euros for breaching online content rules.

Musk and Breton have often sparred online over EU tech regulation, with

Musk referring to him as the "tyrant of Europe".

The bans also targeted Imran Ahmed, the British CEO of the US-based Center for Countering Digital Hate; Anna-Lena von Hoderberg and Josephine Ballon of the German non-profit HateAid; and Clare Melford, co-founder of the Global Disinformation Index, according to US Under Secretary for Public Diplomacy Sarah Rogers.

Germany's justice ministry said the two German activists had the government's "support and solidarity" and the visa bans on them were unacceptable, adding that HateAid supported people affected by unlawful digital hate speech.



Municipality ministry holds public cleanliness march to highlight sanitation workers' efforts
