

On the occasion of the 77th Republic Day of India, I extend my warm greetings to all Indians and friends of India in Qatar. I also wish to express my sincere gratitude to His Highness the Amir of the State of Qatar Sheikh Tamim bin Hamad Al Thani, His Highness the Father Amir Sheikh Hamad bin Khalifa Al Thani, the respected Members of the Royal Family, and the Government and people of Qatar for their continued goodwill and support to the members of Indian community in Qatar.

India's journey as a democratic republic has been guided by the values of justice, liberty, equality and fraternity enshrined in our Constitution. As the world's largest democracy, India draws strength from its people and from its institutions to ensure inclusive growth and good governance for all. On Republic Day we remember the sacrifices of the leaders of our freedom struggle, the foresight of the makers of Constitution and contribution of leaders who have made India a strong nation. We also salute our armed forces who keep India safe and secure. Operation Sindoor in 2025 was a resounding success because of their courage and valor.

Over the last year despite facing many challenges India has continued its march towards progress and prosperity. Our economy, supported by timely reforms and investments in manufacturing and infrastructure crossed a historic milestone and became the fourth-largest global economy. We remain the fastest growing large economies in the world with economic growth of 7.4% in FY 2025-26. The people of India continue to distinguish themselves in various fields including business, entrepreneurship, science, technology, innovation, culture and sports. Prime Minister Shri Narendra Modi's vision of Viksit Bharat (Developed India) by 2047 inspires every Indian, especially the youth, to contribute to this goal. The focus on creating digital public infrastructure has helped in ensuring that the fruits of development reach the most disadvantaged sections of society.

Our scientific feats like the visit of Group Captain Shubhanshu Shukla to the International Space Station and successful launch of the BlueBird Block-2 (BlueBird-6) satellite, the heaviest commercial payload ever launched from Indian soil by ISRO's "Bahubali" rocket have drawn global applause. The Sustainable Harnessing and Advancement of Nuclear Energy for Transforming India (SHANTI) Bill, 2025, reflects the government's effort to modernize the laws governing the nuclear sector. This will shape India's long-term journey toward building a secure and sustainable energy future including by allowing private companies to participate in India's nuclear energy sector.

India is experiencing a massive AI-driven data center boom, with billions invested by global tech giants to power India's AI ambitions and digital economy. India is also taking a lead in advocating for equity in AI by engaging with international community. AI Impact Summit is being held in New Delhi in February 2026 which would advocate use of AI for people, planet and progress. India continues to pursue reliable partnerships, guided by its philosophy of Vasudhaiva Kutumbakam - the world is one family. India has worked closely with its partners for addressing shared global challenges while consistently raising the voice of the Global South.

The year 2025 was a landmark year for India-Qatar relations as we had the honour of hosting His Highness the Amir of Qatar on his second State Visit to India in February 2025. Both sides elevated their ties to strategic partnership during the visit and set the foundation for deepening and expanding our relations in different areas. Following the visit, the top leadership of both sides has pursued continuous high-level engagement. In a telephone call in September 2025 PM Modi expressed deep concern over the attacks in Doha and condemned the violation of the sovereignty of the State of Qatar. He also appreciated the role being played by Qatar in promoting regional peace and stability, including its mediation efforts in Gaza.

India's External Affairs Minister Dr S. Jaishankar visited Qatar in November and met His Highness the Amir and H.E. Prime Minister

and Minister of Foreign Affairs Sheikh Mohammed bin Abdulrahman Al Thani. The meetings reviewed progress in bilateral ties and also included exchange of views on regional and global developments. India's Minister of Commerce and Industry Shri Piyush Goyal held the first meeting of the renewed Joint Commission on Economic and Commercial Cooperation with Minister of Commerce and Industry H.E. Sheikh Faisal bin Thani bin Faisal Al Thani in Doha in October 2025. He also met Qatar's Prime Minister and Minister of Foreign Affairs and other dignitaries. The inaugural meeting of India-Qatar Joint Business Council was also held during his visit.

India stays the third largest trading partner of Qatar and mutual investments between both countries have continued to grow. The energy partnership of both countries has also remained solid with new long-term contracts signed for supply of LNG from Qatar to India. During the State Visit of His Highness The Amir to India both sides set ambitious targets of doubling bilateral trade by 2030 and increasing Qatari investments in India to USD 10 billion. Qatar's MOS for Foreign Trade Affairs H.E. Dr Ahmed Al Sayed led a high-level investment delegation to New Delhi in August 2025 and co-chaired a meeting with his counterpart exploring investments in sectors like infrastructure, manufacturing, logistics, healthcare, fintech, semiconductors and start-ups.

The age-old cultural ties between India and Qatar have been manifested through some new initiatives over the past few months. We are delighted that Qatar's Minister of Culture HE Sheikh Abdulrahman bin Hamad bin Jassim bin Hamad Al Thani visited New Delhi in January 2026 for attending the New Delhi World Book Fair in which Qatar was 'Guest of Honour' country. There have also been new linkages established between our museums which should promote greater cultural exchange and understanding. India also hosted a delegation of Qatar Leadership Centre in November 2025. We are glad that Visit Qatar has marked a presence in Mumbai which will promote tourism linkages between both countries.

Both countries have also continued close cooperation in multilateral forums. Our Minister of Labour & Employment and Youth Affairs & Sports Dr. Mansukh Mandaviya visited Qatar in November 2025 for participating in the Second World Summit for Social Development. Qatar's Minister of Culture participated in the UNESCO Intangible Culture Heritage Committee meeting held in New Delhi in December 2025. Our parliamentarians have met during the IPU meetings. There are great opportunities for both sides to work together on technology, innovation and sustainability in accordance with Qatar's Third National Development Strategy and India's vision of Viksit Bharat.

Indian community in Qatar remains an important and strong pillar of our bilateral relationship. The hard work, professionalism and cultural ethos displayed by the community make us proud and strengthen the bonds between our two people. Indians in Qatar can also now avail Unified Payments Interface (UPI) services for making payments at QNB points of sales in Qatar. We in the Embassy remain committed to serve the community through efficient consular services. I also thank Indian community organizations for their services to the Indian community in Qatar and strengthening India-Qatar relations.

As we celebrate the 77th Republic Day of India, let us renew our commitment to the values of our Constitution and build together a future of peace, prosperity and progress. I am confident that the friendship and strategic partnership between India and Qatar will continue to scale newer heights in the years ahead. Jai Hind! Jai Qatar!

Visit of Dr. S. Jaishankar to Qatar (15-17 November 2025)





They reviewed key aspects of the Strategic Partnership including energy, trade, investment and people-to-people ties. Hon'ble Minister of Commerce and Industry, Shri Piyush Goyal, addressed the inaugural meeting of the India-Qatar Joint Business Council, alongside Qatar's Minister of Commerce and Industry, H.E. Sheikh Faisal bin Thani bin Faisal Al Thani. The Minister encouraged businesses on both sides to leverage the strategic partnership and cultural ties to further deepen India-Qatar economic relations, highlighting how the robust economies of both countries offer significant synergies across sectors for shared growth and prosperity.



Hon'ble Minister of Commerce and Industry, Shri Piyush Goyal, met with HE Sheikh Bandar bin Mohammed bin Saud Al Thani, Governor of the Qatar Central Bank and Chairman of the Board of Directors of the Qatar Investment Authority and the Qatar Financial Centre Regulatory Authority. They discussed ways to further enhance trade, investment, and financial cooperation between India and Qatar.



Hon'ble Minister of Commerce and Industry Shri Piyush Goyal launched Bharat's own UPI at Lulu Hypermarket in Doha, Qatar. This move represents a significant step forward in digital connectivity and payment efficiency, reflecting India's commitment to facilitating cross-border trade and leveraging the "Digital India" initiative.

Operating at Qatar National Bank (QNB) points of sale, the platform covers a wide range of the Qatari market and will benefit Indian travelers, boosting trade and tourism between the two countries.



India-Qatar Invest Meet (August 2025)



India's Union Minister for Finance and Corporate Affairs Smt. Nirmala Sitharaman met His Excellency Dr Ahmed bin Mohammed Al-Sayed, Qatar's Minister of State for Foreign Trade Affairs, in New Delhi. FM Smt. Nirmala Sitharaman highlighted the transformative measures India has undertaken over the past decade to attract foreign investment. Both Ministers reaffirmed their commitment to enhancing bilateral trade and investment under the India-Qatar Strategic Partnership. The Qatari delegation noted the significant opportunities for investment in India, given the country's robust economic growth and technological advancements.



India's Union Minister of State for Finance, Shri Pankaj Chaudhary, and Qatar's Minister of State for Foreign Trade Affairs, H.E. Dr. Ahmad bin Mohammed Al Sayed, co-chaired a meeting on investment cooperation between India and Qatar. The discussions focused on enhancing Qatari investments in India, particularly in sectors such as infrastructure, advanced manufacturing, transport, logistics, food processing, health, semiconductors, and finance.

Both sides recalled Qatar's commitment to invest \$10 billion and establish a QIA office in India, announced during the State visit of H.H. the Amir of the State of Qatar to India in February 2025. In this context, they agreed to further promote discussions on investments by QIA and other Qatari entities, focusing on key sectors, specific projects, and companies. The Qatari delegation emphasized the opportunities for investment in India, given the country's robust economic growth and technological advancements.

QIA has already made investments in India across sectors including retail, utilities, media, housing, healthcare, and real estate. Similarly, the Indian community in Qatar has invested, particularly in the SME sector. The visit of this high-level Qatari delegation will help deepen understanding of the available opportunities in India and further strengthen the investment partnership between the two countries.

The programme also included a ceremony honouring the participants, providing direct opportunities to connect and strengthen collaboration with partners in India.

HE Dr. Maryam bint Ali bin Nasser Al Misnad, Minister of State for International Cooperation, received the Shield of Humanity from Shri Pinarayi Vijayan, Chief Minister of Kerala, in recognition of the State of Qatar's ongoing humanitarian efforts and its continued support for the Republic of India and the Kerala community residing in Qatar.



PM Modi hails India's fab power as key to change

Prim Minister Narendra Modi inaugurated Semicon India 2025, underscoring India's resolve to achieve semiconductor self-reliance and emerge as a global leader in the sector.

He stressed that the world now looks to India with confidence to shape the future of semiconductors, while outlining a vision for a holistic ecosystem that goes far beyond manufacturing alone.

PM Modi said that the world now looks to India as a trusted collaborator in building the semiconductor industry's future, suggesting that even the smallest domestically produced chip could spark monumental global transformation.

PM Modi drew a powerful analogy, noting that while oil was the driving force of the 20th century, in the 21st century, it's the compact semiconductor chip—what he referred to as the “digital diamond”—that holds real power and promises to accelerate progress across sectors.

Highlighting India's economic strength, he pointed to the robust 7.8% GDP growth in the April–June quarter, which outstripped all expectations. All sectors, from agriculture and

manufacturing to services and construction, performed exceptionally well.

The event also highlighted international partnership opportunities, especially with Japan, following Modi's visit to a Japanese semiconductor plant. The focus remains on building a resilient, end-to-end semiconductor ecosystem, from design to manufacturing, anchored in India's ambition for technological self-reliance.



According to industry projections, India's semiconductor market, valued at approximately \$38 billion in 2023 and \$45–50 billion in 2024–25, is projected to more than double, reaching \$100–110 billion by 2030.

Digital gold transactions surge 377% as UPI drives shift in investment

Investing in gold is undergoing a transformation, with more consumers opting for digital gold even as prices of the yellow metal climb steeply. Data from the National Payments Corporation of India (NPCI) shows that the volume of digital gold purchases through UPI rose 377% in just 16 months, hitting 99.77 million transactions in August, compared with 20.92 million in April 2024. The value of transactions more than doubled during the same period, to INR 1,184 crore from INR 550 crore.



Experts say the surge is driven by expectations of further price increases and the convenience of digital purchases. The price of 24-carat

gold rose 44% year-on-year in August to INR 11,021 per gram, up from INR 7,633 a year earlier. Analysts note that digital platforms enable buyers to purchase even small quantities, making gold more accessible to households with varying budgets.

Consumers are using service providers such as PayTM, Google Pay and PhonePe to invest in digital gold, which is primarily offered by MMTC PAMP and Augmont Goldtech. Jewellers, including Tanishq and Senco, have also entered the space. Digital gold is certified 24-carat, backed by custodians, and buyers receive digital certificates that can be redeemed for either cash or physical gold at designated outlets.

The category has emerged as one of the fastest-growing for UPI transactions, joining the NPCI's top 10 medium-volume merchant categories in April 2024 and climbing steadily since. UPI remains most heavily used for groceries, which accounted for transactions worth INR 68,116 crore last month.

India's chief economic advisor V. Anantha Nageswaran recently said consumer buying patterns are shifting structurally, with digital channels gaining traction. He added that disposable incomes are set to rise further with recent GST and income tax cuts, which will likely boost digital gold purchases even more.

From 5G to 6G: IMC 2025 signals India's next telecom leap

The India Mobile Congress (IMC) 2025 opened on October 8, with a keynote by Union Minister Jyotiraditya Scindia, who laid out India's ambitious telecom roadmap beyond 5G. Scindia highlighted the transformative impact of 5G rollout across sectors such as agriculture, healthcare, and education, and stressed the need to now focus on 6G research, satellite communications, and AI-driven networks. He called for deeper collaboration between government, industry, and academia to build a robust digital ecosystem that supports emerging technologies.

The minister also underscored India's growing stature as a global telecom manufacturing hub, citing the success of the Production Linked Incentive (PLI) scheme and rising exports of telecom equipment. He urged stakeholders to invest in semiconductor fabrication, quantum communication, and green telecom infrastructure to future-proof the sector.

IMC 2025, held in New Delhi, brought together global tech leaders, telecom operators, startups, and policymakers to showcase innovations



and discuss regulatory frameworks. The event featured exhibitions on 5G use cases, smart cities, cybersecurity, and digital inclusion.

Scindia's roadmap reflects India's strategic vision to become a net exporter of telecom technology, reduce dependency on imports, and ensure universal digital access. With over 1.2 billion mobile users and a rapidly expanding digital economy, India's telecom sector is set to play a pivotal role in shaping the future of connectivity.

The IMC platform is expected to catalyze partnerships, investments, and policy reforms that will drive India's transition from a 5G-enabled nation to a global leader in next-generation telecom innovation.

India's renewable energy push signals a new era for global investors

India is rapidly emerging as one of the world's most compelling clean energy investment destinations, driven by unmatched scale, surging demand, and a stable, forward-looking policy framework that is turning ambition into execution

In the renewable energy sector, smart capital is driven by three key factors: scale, long-term demand, and a stable policy environment. Few countries globally offer this powerful combination at the scale India does today. That is precisely why India is starting to feature prominently on the radar of global green energy players.

This shift has little to do with headline-grabbing announcements and everything to do with the implementation of transformative government green energy schemes across India. The country has rapidly expanded its renewable capacity, reinforced its policy framework, and unlocked opportunities for large-scale, sustainable investments. India recently achieved a new milestone with its total renewable energy capacity, including large hydro and nuclear power, reaching 256 GW, further demonstrating the effectiveness of the country's renewable efforts.

From massive solar parks in Gujarat to an ambitious green hydrogen mission along the coasts, India's momentum in the green energy is visible. It isn't a question of whether global companies are paying attention — many already are. The real question for investors is whether they are positioned to seize this growth at the right moment. Let's explore the reasons why India is among the most attractive destinations for clean energy investment and where investors should consider aligning their portfolios with sustainable growth.

India's perfect positioning for green energy investments

India combines the key ingredients that global investors seek — scale, demand, and clear policy direction. As one of the world's fastest-growing energy markets, India's renewable energy investments are driven not only by environmental goals but also by the fundamental need to meet rising energy demand sustainably.



The government has laid out an ambitious clean energy roadmap, targeting 500 GW of non-fossil fuel capacity by 2030. To support this, several initiatives are already in place:

- The National Green Hydrogen Mission, launched in 2023, aims to make India a global hub for hydrogen production. It targets an annual production of 5 MMT of green hydrogen by 2030. The mission has an outlay of over ₹ 19,744 crore to facilitate the production, distribution, utilisation and export of hydrogen globally. It positions India to achieve a \$8 billion green hydrogen market by 2030 and \$340 billion by 2050. The SIGHT program (Strategic Interventions for Green Hydrogen Transition) offers financial incentives for manufacturing electrolyzers and producing green hydrogen.
- The Production Linked Incentive (PLI) scheme has been launched to promote the manufacturing of solar modules and batteries. Under the scheme, the government launched the National Programme on High Efficiency Solar PV Modules to promote solar PV manufacturing in India with an outlay of over ₹4,500 crore. Under the scheme, 11 companies have been allocated the total domestic solar PV module manufacturing capacity of 39,600 MW.
- To further promote green energy-related manufacturing initiatives, the government is allowing 100% FDI in renewable energy within India under the automatic route, further helping global investors and enterprises. Thanks to a liberalised FDI regime, foreign investment in non-conventional energy sources has been increasing year-on-year, reaching \$12.67 Bn as on March 31, 2025.
- India is strengthening its position through key international collaborations, which began with the launch of the International Solar Alliance, in partnership with France. The European Union (EU) remains one of India's closest partners in this space. The third phase of the India-EU Clean Energy and Climate Partnership is already underway, focusing on enhancing green hydrogen production — a critical component of the clean energy transition. Through the India-Australia Renewable Energy Partnership, the

countries will collaborate on a range of renewable energy-related areas, including green hydrogen, solar photovoltaics, capacity building, and more. India is also a founding member of the Global Biofuel Alliance with the US, UAE and Brazil.

This policy stability, combined with a growing domestic energy market and export opportunities, is transforming India into a dependable destination for long-term green energy investment.

Presence of large-scale green energy projects

India's renewable energy ambitions are transforming into substantial, large-scale projects that are already drawing global attention. These initiatives showcase the country's capacity to execute projects at scale, develop long-term infrastructure, and open up investment opportunities across diverse regions and technologies. Some of the most notable initiatives currently underway include:

Rajasthan and Gujarat's solar parks

The two western Indian states continue to lead India's solar

expansion initiatives. Through projects like the Bhadla solar park with a capacity of over 2,000 MW, India continues to demonstrate its dedication to renewable energy initiatives. The upcoming Khadva Solar Park, being developed in collaboration with Adani Power, is already operational and expected to be the world's largest solar energy project after completion. Projects like these not only increase renewable generation but also present clear investment opportunities in associated infrastructure and services.

are already attracting major domestic and international energy players. Ports like Kandla are also developing electrolyzers for hydrogen to ensure they produce green hydrogen ready!

Public-sector partnerships

Public-private partnerships are a consistent feature across these initiatives, with India's private sector playing an active role as both a participant and investor in renewable energy generation and distribution. These large Indian

- Battery Storage and Grid Modernisation, with recent government tenders for 4,000 MWh of battery storage capacity, is a key step towards renewable grid stability

This momentum is already visible in the actions of global investors. Brookfield Renewable has announced plans to invest up to \$1 billion in Avaada Group for the manufacturing of Green Hydrogen, solar PV modules and the growth of a Renewable Energy platform. British International Investment has marked its foray into India's solar manufacturing industry through an investment of over \$100 million into ReNew Power. India's Oil and Natural Gas Corporation Limited (ONGC), in conjunction with National Thermal Power Corporation (NTPC), acquired a 100% stake in Ayana Renewables for \$2.3 billion,

marking a significant shift in the growth trajectory for these energy companies.

Commitments such as these demonstrate increasing confidence in the market's long-term prospects.

India offers the ideal conditions for investors committed to sustainable growth, thanks to its large-scale demand, clear policy guidance, and visible project pipelines. It will require \$400 billion in financing to realise its 500 GW target of renewable energy by 2030. This is the right time to make a move in India's renewable energy sector.

The fundamentals are solid and supported by real, verifiable progress on the ground rather than mere promises on paper. With expanding global partnerships and set domestic targets, India's renewable energy sector is steadily creating the kind of long-term opportunities that align with both financial and environmental goals of becoming a net-zero economy by 2070.

The region's ambitious solar and transmission projects aim to supply clean power across the northern grid, supported by investments from central and state governments.

Green Hydrogen initiatives across key states


The coastal states of India are poised to gain the most from India's green hydrogen corridors, and their efforts reflect this. They have active policy incentives, abundant land resources, and well-developed port infrastructure essential for producing, utilising, and exporting hydrogen. These states

conglomerates are collaborating with global energy firms and government agencies to drive the next generation of clean energy investments and their subsequent infrastructure. For instance, the India H2 Alliance (IH2A) is one such example. It is building India's hydrogen value chain to reduce carbon emissions and promote green hydrogen. For investors, these projects offer entry points into new segments backed by long-term policy support and visible project pipelines.

How investors can benefit from India's green energy push

India's clean energy sector has moved beyond early-stage growth and is now firmly positioned as a major investment destination. The country offers scalable opportunities across:

FIVE WAYS INDIA IS MODERNISING ITS RURAL ECONOMY

India is an agricultural superpower. For as long as most of us can remember, agriculture has been an integral part of India's identity. It is especially prevalent in rural India, where 45.8% of the workforce relies on agriculture as their primary means of income. Tech like apps, AI, and automation has also impacted agriculture.

The past few years have brought a new ally to the field: technology. Not the tech we associate with Silicon Valley, but technology addressing immediate problems on the ground. It is emerging from every angle and is equally sustainably sourced, from startups and local entrepreneurs to government subsidy schemes, offering a multitude of options and entrepreneurial opportunities.

The result is a significant difference between how rural India farms and how it earns its income. Preconditions that would traditionally take a decade to implement have been achieved in just a few years. Execution at

scale will determine outcomes, but early pilots are promising. In the past three years, the AgriTech sector has experienced historic 10x growth, driven by four key factors: increasing digital penetration across India, supply chain disruptions caused by COVID-19, growing consumer preferences for quality produce, and increased interest from private equity and venture capital.

As of December 2023, India had over 2,800 DPIIT-recognised agritech startups. These startups are often referred to as "a ray of hope" and are innovating and transforming the way agricultural work has traditionally been carried out in India. Here are several ways in which AgriTech startups are changing the landscape.


1. Precision farming: Making every drop and seed count

One of the leading areas in which AgriTech startups are making a major contribution is



precision farming. Precision farming enables the more accurate application of resources such as water, fertilisers, and pesticides, thereby increasing efficiency and reducing environmental impacts. This not only has the potential to improve crop yields by up to 30% but also promotes a sustainable form of farming, which is especially important with the onset of climate change. According to





industry estimates, precision farming can improve yields by a20–30% and reduce input costs by 15–20%, especially in high-value crops like fruits and vegetables. For example, Fasal Tech uses real-time data and science to help farmers make informed decisions in their fields. To provide farmers with accurate, practical guidance on five key areas - irrigation, disease management, pest control, fertiliser use, and climate risk management - they have developed a clever mix of IoT, AI, and agronomy. Their IoT device, Fasal Sense, collects data directly from the field and is at the centre of it. A central system then processes this data alongside inputs from radar and satellites, analysing and interpreting it to provide farmers with valuable information guidance.



2. Drone technology: Aerial solutions for ground-level issues

Drones are rapidly becoming one of the most innovative technologies in India's agricultural sector. From monitoring and imaging crops to spraying pesticides and estimating yields, drones are enhancing efficiency and safety.

To achieve fast-tracked adoption of agricultural practices, the government has launched initiatives such as "Namo Drone Didi," which aims to train 15,000 women-led SHGs in rural areas to become licensed drone operators.

Research has shown that drone spraying technology can cut the use of crop protection chemicals by up to 30%, while also reducing farmers' exposure to pesticides during spraying. It can also cover larger areas of growing environments in a fraction of the time.

3. Climate-resilient crops: Adapting to a changing future

Extreme weather events now pose a greater threat to crop security as droughts, floods,

and heatwaves become more frequent. Consequently, both public and private organisations are investing resources into developing climate-resilient seed varieties capable of withstanding stress without sacrificing yield.

Under the Indian Council of Agricultural Research (ICAR), the National Agricultural Research System (NARS), which comprises ICAR Institutes and State/Central Agricultural Universities (CAU/SAU), has developed 2,900 location-specific improved field crop varieties/hybrids between 2014 and 2024. These include 1,380 cereals, 412 oilseeds, 437 pulses, 376 fibre crops, 178 forage crops, 88 sugarcane, and 29 other crops. The Government of India is implementing the Seed Village Programme component of the Sub-Mission on Seed and Planting Material (SMSP) under the National Food Security and Nutrition Mission to make seeds of climate-resilient, biofortified, and high-yielding varieties available to farmers at the village level.



Aside from that, many scientists are currently working to develop more intelligent methods of crop improvement that will help them better withstand the effects of climate change. To produce crops that can endure heat, drought, and pests, they are using cutting-edge techniques. Meanwhile, farmers are making better decisions in the field thanks to technologies like artificial intelligence (AI) and satellite data, which assist them in maximising the potential of these climate-resilient crops. There are also startups such as Farmtheory that focus on reducing agricultural waste, helping farmers earn more while addressing climate change.



4. Agri-logistics: Bridging the last-mile gap

With an average of 55 kg of food waste generated per capita annually by households, the total food waste generated in India is about 78 million tonnes. The estimated cost of India's food waste is up to ₹92,000 crores every year.

New logistics models are complementing traditional supply chains and raising service

benchmarks. Agri-tech startups now focus on the logistics of agriculture, including cold chains, micro-warehouses, and efficient farm-to-market links. Companies like Arya.ag and DeHaat are developing systems that enable farmers to securely store their produce, access loans based on their warehouses, and reduce distress selling.



5. AgriStack & Digital Agriculture Mission: Building the data backbone

At a systems level, India is advancing its digital infrastructure for agriculture through initiatives like the AgriStack and Digital Agriculture Mission.

By establishing the user's agricultural identification and linking it with land records, cropping patterns, and soil health, a user-centric framework has the potential to provide targeted subsidies, credit, insurance, and advisories, eliminating manual paperwork in future.

With 19 states having signed MoUs with the Ministry of Agriculture, the central and state governments are collaborating to advance the implementation of AgriStack. To test the development of Farmer IDs and the Digital Crop Survey, pilot projects have been conducted in six states, including Uttar Pradesh, Gujarat, and Maharashtra.

With e-NAM already connecting over 1,522 mandis across 23 states and four union territories, the digital plan is helping to make India's agriculture more transparent, inclusive, and sustainable, regardless of phase or form of activity.

An Innovative Future

In India, integrating technology with agriculture not only increases output but also supports millions of people whodepend on it to achieve sustainability, opportunity, and dignity. Platforms like AgroStar (inputs/advisory) and DeHaat (inputs + market linkages) help farmers buy quality inputs and access advisory, and connect produce to institutional buyers.

Agri-tech can build a more resilient and dynamic rural economy by transforming farmers into entrepreneurs, helping themadapt quickly, and ultimately boosting resilience for their collective benefit. As startups, policies, and communities continue to expand, it is clear that the vision of a Digital Bharat rooted in its fields but prepared for the future is no longer just a hope. It is already taking shape.

FIRSTS, FAREWELLS AND FUTURE STARS

Indian Sport's Remarkable 2025

From historic World Cup wins in cricket and squash to breakthrough performances by young stars in shooting and boxing, Indian sports in 2025 offered great promise for the LA 2028 Olympics.

It was a year defined by landmark firsts, iconic individual feats and the rise of a new generation across Olympic, Paralympic and indigenous sports.

The headline moments came at home. After heartbreaks in the 2005 and 2017 finals, the Indian cricket team finally lifted its maiden ICC Women's ODI World Cup.

On the squash front, India bagged their first-ever Mixed Team World Cup title in Chennai.

In athletics, Neeraj Chopra shattered the long-pursued 90-metre barrier in javelin throw, while youngsters announced themselves as world champions in shooting and boxing.

Beyond medals and trophies, 2025 also marked a transition year for Indian sports.

Rohit Sharma and Virat Kohli bid farewell to Test cricket, drawing the curtain on a defining era even as fresh faces stepped forward. Among them was Vaibhav Suryavanshi, whose performances across age groups and senior cricket saw him top Google's most-searched list in India.

Women's ODI World Cup 2025: India's long wait ends

India's long wait for a Women's ODI World Cup title ended in November as Harmanpreet Kaur's side lifted the trophy on home soil. Co-hosting the tournament with Sri Lanka, India's campaign was marked by resilience and fightback.

Early wins over Sri Lanka and Pakistan were followed by three consecutive defeats that left India on the brink of bowing out. A clutch victory over New Zealand in a potentially must-win encounter proved decisive, pushing the hosts into the semi-finals.

There, India produced possibly the great World Cup chases, hunting down a record 338 against seven-time champions Australia, powered by a sublime century from Jemimah Rodrigues.

In the final against South Africa, Shafali Verma composed 87, setting up a match-winning total of 298/7, before Deepti Sharma, the Player of the Tournament and World Cup's leading wicket-taker with 22 scalps, sealed the title with a five-wicket haul.

Squash World Cup 2025: India breaks new ground

In squash - a sport set to make its Olympic



debut at LA 2028 - India claimed its maiden World Cup title in Chennai, defeating top seeds Hong Kong China in the final to create history in December.

Seeded second, the Indian team, which included the quartet of Anahat Singh, Joshna Chinappa, Abhay Singh and Velavan Senthilkumar, went unbeaten through the tournament without dropping a single match across ties.

The triumph made India only the fourth nation to win the Squash World Cup.

World Boxing Championships 2025: A double-gold breakthrough for India

Despite Olympic medallist Lovlina Borgohain and Nikhat Zareen missing the podium at the World Boxing Championships 2025 in Liverpool, India enjoyed a breakthrough campaign, courtesy of gold medals from Jaismine Lamboria and Minakshi Hooda.

Jaismine stunned by Paris 2024 Olympics medallist Julia Szeremeta of Poland in the 57kg final while Minakshi edged Kazakhstan's Nazym Kyzaibay to clinch the 48kg crown. Their titles made them India's first champions under the new World Boxing governing body.

With a silver from Nupur Sheoran and a bronze from Olympian Pooja Rani, Indian boxers wrapped up their campaign in Liverpool with four medals.

ISSF World Championships 2025: Samrat Rana's golden upset in shooting

Samrat Rana produced one of the year's standout performances by winning gold in the men's 10m air pistol at the ISSF World Championships 2025 in Cairo. The 20-year-old defeated world No. 1 Hu Kai in a tense final, becoming the first Indian to win a senior individual world title in an Olympic pistol shooting event.



Rana topped the qualification, then held his nerve through a dramatic final. His campaign also featured a team gold alongside Varun Tomar and Sharvan Kumar.

ICC Champions Trophy 2025: India's third crown

India marked the return of the ICC Champions Trophy after an eight-year gap by lifting the title for a record third time in the UAE in March.

Virat Kohli's century against Pakistan lit up the group stage, while Rohit Sharma anchored the final with a composed 76 off 83 balls as India chased down 252 to beat New Zealand by four wickets.

Both Rohit and Virat announced their retirement from Test cricket in May, closing a glittering chapter in Indian cricket during a year of transition.

Neeraj Chopra breaches 90m barrier

Neeraj Chopra's performance at the Doha Diamond League 2025 delivered a moment Indian athletics had long yearned for - watching its golden boy shatter the elusive 90m barrier to enter the elite club in men's javelin throw.

At the Qatar Sports Club, the Tokyo 2020 Olympic champion breached the milestone with a 90.23m attempt.

Neeraj Chopra began the meet with what was then a world-leading mark of 88.44m. The former world champion fouled on his second attempt but followed it up with the 90.23m throw to reset the Indian national record.

His previous personal best was 89.94m, achieved at the Stockholm Diamond League 2023. In fact, the Indian ace had recorded six throws in the 89m range.

Neeraj became the 25th man in history to surpass the 90m mark in the javelin throw.

However, it was Germany's Julian Weber who toppled Neeraj off the perch in the Doha standings with a personal best of 91.06m with his final throw of the evening.



World Archery Championships 2025: Gold and silver for India

India's Rishabh Yadav, Aman Saini and Prathamesh Fuge clinched a historic gold at the World Archery Championships 2025 in Gwangju, marking India's maiden top podium finish in the men's compound archery team event at the global showpiece.

The second-seeded Indian men's team showed

remarkable grit to overturn a first-set deficit of 59-57 and beat the fifth-seeded French team of Nicolas Girard, Jean Philippe Boulch and François Dubois 235-233 in the final.

The victory capped a remarkable run in which the Indian men's team came from behind in all four archery matches.

Meanwhile, Rishabh Yadav paired up with Jyothi Surekha Vennam to bag a silver in the compound mixed team event. Though not a gold, it was perhaps as significant a feat as the men's triumph considering the event will mark an Olympic debut at LA 2028.

World Para Athletics Championships 2025: India's best-ever finish

Hosting the World Para Athletics Championships 2025 in New Delhi from September 27 to October 5, India delivered their best-ever performance, finishing 10th with 22 medals- six gold, nine silver and seven bronze.

Sumit Antil (men's javelin throw F64), Sandip Singh Sargar (men's javelin throw F44), Shailesh Kumar (men's high jump T63), Rinku Hooda (men's javelin throw F46), Nishad Kumar (men's high jump T47) and Simran Sharma (women's 100m T12) won gold medals.

The 73-member contingent of Indian para-athletes featured 54 men and 19 women.

Furthermore, Indians set three championship records, seven Asian records and registered more than 30 personal bests during the competition.

Asia Cup 2025 cricket: India retain continental supremacy

India lifted their record-extending ninth Asia Cup title in the UAE in September with a seven-match unbeaten run.

Led by Suryakumar Yadav and with Abhishek Sharma in sensational form, India beat Pakistan in the final to secure a record-extending ninth continental title. Tilak Varma was the hero of the final with his unbeaten 69, rescuing India following a slow start while chasing 146.

Asia Cup 2025 hockey: India back on top

The Indian men's hockey team were crowned Asia Cup champions for the fourth time after they beat the Republic of Korea 4-1 in the final at the Rajgir Sports Complex in Bihar.

With the win, India ended their eight-year wait for the continental title and qualified for the FIH Hockey World Cup 2026, scheduled to be held in the Netherlands and Belgium. India's Abhishek Nain was named the Player of the Tournament.

Kho Kho World Cup 2025: India rule at home

The Kho Kho World Cup 2025 was held in New Delhi with India claiming the men's and women's titles after beating Nepal in both finals at the Indira Gandhi Indoor Stadium.

In the men's division, India outplayed Nepal by

a 54-36 scoreline in the summit clash, while the women's title decider finished 78-40 in the hosts' favour.

This was the inaugural edition of the world kho kho competition, backed by the Indian Olympic Association (IOA), and featured 20 men's and 19 women's teams.

Kho kho, along with other indigenous Indian sports like kabaddi and mallakhamb, was demonstrated on the sidelines of the Berlin 1936 Olympics.

Women's Kabaddi World Cup 2025: India crowned champions again

India beat Chinese Taipei 35-28 in the final to claim the Women's Kabaddi World Cup 2025 title in Dhaka, Bangladesh.

This was the Indian women's kabaddi team's second World Cup crown, having also won the inaugural edition hosted in Patna, Bihar, back in 2012. India beat the Islamic Republic of Iran in the final 13 years ago. Sanju Devi was adjudged the Most Valuable Player of the Women's Kabaddi World Cup 2025.

Koneru Humpy, Arjun Erigaisi Clinch Bronze at FIDE Championships in Doha



Indian Grandmaster Koneru Humpy won bronze at the 2025 FIDE Women's World Rapid Chess Championship in Doha on December 28, finishing with 8.5 points from 11 rounds and placing third on tie-breaks. Arjun Erigaisi also secured bronze in the Open section, marking a historic double podium for India.



Erigaisi went on to win another bronze at the FIDE World Blitz Chess Championship in Doha, delivering back-to-back podium finishes. Prime Minister Narendra Modi congratulated both players, praising their consistency and calling their achievements a proud moment for India and a sign of the country's rising dominance in global chess.

Microsoft, Cognizant and Intel Chiefs meet PM Modi in efforts to boost AI adoption in India

US-based global technology giants Microsoft, Cognizant, and Intel's Chief Executive Officers met with the Indian Prime Minister Narendra Modi on Tuesday, 9 December 2025, in efforts to boost the artificial intelligence (AI) adoption in the country.

"The youth of India will harness this opportunity to innovate and leverage the power of AI for a better planet," he said.

Modi's meeting with Cognizant

PM Modi also has a meeting with Cognizant's CEO Ravi Kumar and the company's Chairman and Managing Director S Rajesh Varrier, where they discussed the company's partnership with India in futuristic sectors.

"Had a wonderful meeting with Mr Ravi Kumar S and Mr Rajesh Varrier. India welcomes Cognizant's continued partnership in futuristic sectors. Our youth's focus on AI and skilling sets the tone for a vibrant collaboration ahead," said PM Modi in his post on X.

In the meeting, the company executives discussed boosting the AI adoption in India along with advancing education and skill development in the country to, in turn, boost India's AI capabilities and productivity.

"Our CEO also reaffirmed to the Prime Minister Cognizant's continued commitment to India and apprised him of our plans to expand into emerging cities to promote equitable growth and talent development," the company said in a post on X.

Intel and India's semiconductor vision

Prime Minister Narendra Modi, in his meeting with global tech giant Intel's Chief Executive Officer (CEO) Lip-Bu Tan, welcomed the US-based firm's commitment to the country's semiconductor journey.



"Glad to have met Mr Lip-Bu Tan. India welcomes Intel's commitment to our semiconductor journey. I am sure Intel will have a great experience working with our youth to build an innovation-driven future for technology," said Modi in his post on X.

Lip-Bu Tan, in his social media post on X, disclosed that the two talked about several topics related to technology, computing and the tremendous potential for India.

"I applaud the Prime Minister for putting in place a comprehensive semiconductor design and manufacturing policy and Intel is committed to support the India Semiconductor Mission," said Intel CEO in his recent post.

These meetings come amid India attracting major investment commitments from other US big tech giants. Earlier in October, Microsoft's tech rival Google unveiled its \$15 billion investment plan for a 1 gigawatt (GW) AI data centre in Visakhapatnam.
