Justice minister says legal reform key to sustainable investment

Qatar has said that clear legislation, an independent judiciary and efficient justice institutions are central to attracting sustainable investment, as it seeks to strengthen confidence in its legal and economic environment.

Speaking at the opening of the Doha Legal Forum 2026 yesterday, HE the Minister of Justice and Minister of State for Cabinet Affairs, Ibrahim bin Ali bin Issa al-Hassan al-Mohannadi, said the country recognised early on that long-term investment begins with a robust legal framework.

He said this approach formed the basis of the National Initiative for the Development of Justice Systems, launched in 2016, which aims to modernise Qatar's legal system while protecting rights, ensuring legal certainty and accelerating dispute resolution.

Addressing the two-day forum, held under the theme "Emerging Trends and Forward-Looking Insights", HE al-Mohannadi said Qatar was now reaping the benefits of that strategy through an integrated legal system that safeguards capital, preserves rights and supports sustainable partnerships.

He said reforms had included updated investment and company laws, improved dispute resolution mechanisms and the digital transformation of judicial services, helping to reduce procedures, improve efficiency and enhance legal certainty for both domestic and

foreign investors.

Al-Mohannadi said the forum was taking place at a critical moment, as the global economy undergoes deep economic and legislative changes that require countries to reinforce their legal systems not only to ensure justice, but also to provide stable and growth-friendly investment environments. "In today's world, investment seeks trust before opportunity," he said, adding that trust is built by law. Clear legislation, he noted, sends the strongest reassurance to investors, while the rule of law remains the true guarantee of sustainable investment and asset protection.

Al-Mohannadi described law as the "invisible infrastructure" of the economy, warning that economic growth without strong

legal foundations remains fragile and vulnerable. He said investors assess countries by their ability to protect opportunities, resolve disputes and enforce contracts.

He added that the Doha Legal Forum reflects Qatar's commitment to specialised legal dialogue, knowledge exchange and forward-looking discussions on legislation in areas such as the digital economy, cross-border trade, international arbitration and corporate governance.

Modern legislation, he said, cannot be developed in isolation, but through dialogue and partnership, and must be measured by its real-world impact on society, development and investment. Qatar, he added, is legislating not only for the present, but to safeguard future investment and generations. The minister said these efforts align with Qatar National Vision 2030 and the Third National Development Strategy 2024-2030, which place the rule of law, economic diversification and high-quality investment at the heart of sustainable development.

He also highlighted co-operation with the Qatar International Court and Dispute Resolution Center as a national model of institutional integration, expressing confidence that the forum's discussions and recommendations would strengthen legal security, support investment and reinforce the role of law as a bridge for co-operation, growth and prosperity. **(QNA)**

Forum stresses legal alignment with global digital, social transformations

The opening dialogue session of the Doha Legal Forum, organised by the Ministry of Justice in collaboration with the Qatar International Court and Dispute Resolution Centre (QICDRC) under the theme "Emerging Trends and Forward-Looking Insights", debated legislative policy in light of emerging trends and the significance of updating legislation and developing the legal system, in alignment with global digital, economic, and social transformations.

In his opening remarks before the panel, HE the Minister of Justice and Minister of State for Cabinet Affairs Ibrahim bin Ali bin Issa al-Hassan al-Mohannadi said explicit political will constitutes the foundation to help advance legislative policies and digital transformation in Qatar. He underscored that digital transformation is no longer an administrative option, but rather a strategic imperative to facilitate national transactions, foster judicial service efficiency, and ensure the easy and fast accessibility of individuals and institutions to justice.

The state-of-the-art legislative policies are intended to reinforce justice, ensure rights protection and the rule of law, with a sharp focus on elevating the

quality of legal and judicial services, streamlining procedures before litigants, and fostering the confidence of society and investors in the nation's legal system, the minister highlighted.

HE al-Mohannadi underlined that combined efforts among a variety of government agencies matter most when it comes to effectively enforcing legislative policies, preserving national resources, and ensuring the accomplishment of national development goals.

Legislation must be flexible to keep abreast of global socioeconomic and technological challenges, thereby boosting Qatar's competitiveness and achieving the sustainability of legal development, the minister stressed.

Al-Mohannadi elaborated that the global vicissitudes in the areas of the digital economy, artificial intelligence, and electronic financial services trigger the importance of constantly advancing legislation and aligning it with persistently evolving cutting-edge technologies to ensure rights protection and justice, and to significantly strike a balance between technological innovation and rule of law assurances. **(QNA)**

Legal forum explores future of energy sources

A keynote panel discussion within the Doha Legal Forum's deliberations, organised by the Ministry of Justice in collaboration with the Qatar International Court and Dispute Resolution Centre, debated the future of energy sources in light of global trends, with a particular emphasis on legal, investment, and regulatory challenges.

A contingent of experts weighed in during the panel and laid out an overall vision regarding the legal and regulatory challenges of future energy sources, along with the significance of legislations in supporting innovation, investment, and environmental protection.

They asserted that this matter has become pivotal on the regional and global stages.

Head of Atkin Chambers and former Chairman of the Bar of England and Wales, Chantal-Aimee Doerries, affirmed that the global pivot towards renewable energy is witnessing unprecedented dynamics, noting that innovation in sustainable technology broadens wide apertures but could ignite legal disputes about the non-accomplishment of project objectives.

Prof Khawar Qureshi, a lawyer at McNair International's offices, said Qatar has achieved a dynamic shift in legislations related to energy

since 2008, noting Qatar National Vision 2030 in fostering the gas industry as a prime source of clean energy and supporting the global transition from fossil fuels to the cleanest energy.

Dr Nihad Abdul Karim al-Husban, a judge at the Jordanian Court of Cassation, noted Jordan's transition from monopolising energy to competitive partnership. She highlighted that modern legislations aim to strike a balance between public interest and encouraging competition among domestic and foreign investors, with particular adherence to environmental sustainability goals. **(QNA)**

QICDRC chief stresses Qatar will consolidate system with advanced tech

Qatar is diligently and genuinely moving full steam ahead towards consolidating a modern corporate system that underpins leveraging cutting-edge technologies in managing services, Chief Executive Officer of the Qatar International Court and Dispute Resolution Centre (QICDRC) Faisal bin Rashid al-Sahouti **(pictured)** has underlined.

In his opening remarks at the Doha Legal Forum, al-Sahouti stressed that digital transformation has become an inevitable imperative, especially amid advancements in the digital economy, artificial intelligence, and electronic transactions that impose evolving legal challenges, prompting a profound corporate dialogue among judges and law enforcement men to put forward innovative legislative solutions. Throughout the past years, Qatar has witnessed a remarkable legislative renaissance in terms of issuing new laws and crucial amendments to the enforced legislation, in pursuit of keeping up with the nation's economic, social, and knowledge growth, he outlined.

These laws and amendments, al-Sahouti pointed out, strengthen the efficiency of corporate performance, streamline procedures, expedite transaction accomplishment, support the investment climate, deepen trust in the legal environment,



and enhance Qatar's position on international competitive indicators, with a particular emphasis on consolidating the principles of transparency, good governance, and the rule of law as a pillar for any development resurgence. Al-Sahouti elaborated that Qatar has forged ahead to advance its legal and judiciary system through updating procedural frameworks, as well as the issuance of the Enforcement Law as an inevitable imperative to expedite litigation procedures, activate enforcement mechanisms, and facilitate litigants' access to justice; alongside the promulgation of the rules and procedures applicable before QICDRC and the Regulatory Tribunal of the Qatar Financial Centre (QFC), with an expansion of digital transformation initiatives to enhance litigants' confidence, accelerate the adjudication of disputes, and improve the quality

of judicial rulings. This inaugural forum positions itself as a platform to develop legislation and keep abreast of digital transformations, which came by dint of an honoured initiative from the Ministry of Justice in tandem with QICDRC, as part of reinvigorating Qatar National Vision 2030 (QNV 2030) and the Ministry of Justice Strategy 2025-2030, al-Sahouti highlighted.

He noted that the forum sheds light on the salient legislation the nation has issued, particularly commercial legislation and its impact on promoting the investment climate, as well as confidence in Qatar's legal system.

This year's forum addresses a range of key legal matters, including legislative policy in light of emerging trends, alternative dispute resolution mechanisms, the legal regulation of the energy sector, financial services and financial technology, public-private partnership contracts, the role of the Free Zones Authority and Media City in fostering the investment climate, the legal regulation of the use of AI-powered technologies, the commercial bankruptcy regime, the extent to which legislation keeps pace with QNV 2030, and spotlighting the role of QFC in supporting investment flows, al-Sahouti noted. **(QNA)**

Key role of judicial mediation in focus

Academics and legal experts have affirmed the importance of judicial mediation as one of the most prominent and effective modern mechanisms for resolving civil and commercial disputes and achieving swift justice. They stressed the necessity of ensuring that expediting dispute resolution does not compromise the quality of judgments or the guarantees of judicial fairness. This came during a roundtable discussion on judicial mediation, organised by the Arab Center for Legal and Judicial Research – the scientific arm of the Council of Arab Ministers of Justice – in co-operation with the Center for Legal Studies at the Ministry of Justice, on the sidelines of the Doha Legal Forum. Participants in the roundtable emphasised that the world is witnessing rapid transformations in the social, legal, economic, and political spheres, amidst unprecedented developments in information and technology.

This necessitates that legal systems keep pace with these transformations by adopting modern policies and frameworks that enhance international co-operation and support alternative dispute resolution mechanisms, foremost among them judicial mediation.

They explained that these mechanisms contribute to easing the burden on the judiciary and provide disputing parties with greater scope for reaching agreements and more effective and sustainable solutions. They noted that keeping pace with these developments requires strengthening the principles of transparency and integrity, providing fair legal and procedural guarantees, and building a legal and cultural environment that supports the rule of law. Participants highlighted the legal framework for judicial mediation in the State of Qatar, pointing to Law No 20 of 2021 concerning mediation in the settlement of civil and commercial disputes. **(QNA)**

Doha forum ‘a platform to enhance economy-justice relationship’

The Doha Legal Forum is a high-stakes platform to debate issues that strengthen the relationship between economy and justice, as well as optimise the investment environment, Minister of Justice of Turkiye Yilmaz Tunc said. The minister highlighted that Turkiye's participation in this inaugural forum aims to share expertise with the sisterly and friendly nations, adding that the subjects laid out at this forum, such

as digitisation and technological advancements, are pivotal in all domains, particularly in the legal domain, to ensure the effectiveness of the judiciary and justice. Since 2007, and through the National Justice Project, Turkiye has been leveraging digitisation with cutting-edge technological potential, and is currently working to develop this system further by utilising artificial intelligence applications, Tunc noted, affirming

that these Turkish expertise and experiences have been weighed during the forum. When it comes to economic and investment matters, alternate means of conflict resolution, such as arbitration and mediation, matter most, the minister underlined, suggesting that since 2010, Turkiye has been applying the mediation system, filing almost 8mn cases to mediation and resolving almost 5mn cases

through settlement by mutual consent, thereby easing the burden on the judiciary and helping parties settle their disputes promptly and cost-effectively. Minister Tunc emphasised that arbitration is an important tool for conflict resolution without resorting to courts, noting the establishment of the Istanbul Arbitration Centre (ISTAC), alongside arbitration centres of the commerce chamber, offering investors the room to fairly

and effectively settle their disputes whether inside the judiciary or beyond. The investment improvement in Turkiye and constantly modernising laws within the judiciary strategy have largely contributed to attracting foreign capital, Tunc noted, recalling that stable legal security has been the fundamental factor behind the upsurge of investments and the number of foreign companies. **(QNA)**

Qatar, Albania sign public prosecution MoU

Experts discuss dispute resolution in Qatari law

A session held as part of the Doha Legal Forum, organised by the Ministry of Justice in co-operation with the Qatar International Court and Dispute Resolution Centre under the theme “Emerging Trends and Forward-Looking Insights” discussed alternative dispute resolution mechanisms in Qatari law.

The session was titled “Arbitration and Mediation: Toward Swift Justice for an Attractive Investment Environment”. The session brought together a number of experts and specialists in arbitration and mediation, who reviewed key legal developments and mechanisms for enhancing trust and transparency in the country's business and investment environment. They also highlighted the growing role of arbitration and mediation in accelerating dispute resolution and supporting legal stability.

Chief Executive Officer of Qatar International Court and Dispute Resolution Centre, Faisal Rashid al-Sahouti, emphasised that arbitration is one of the most important factors in attracting investment and reassuring investors. He noted that Qatar issued Law No 2 of 2017 on Arbitration, which is based on the UNCITRAL Model Law and is considered one of the most modern arbitration laws at the regional and global levels.

He explained that the law provides multiple and flexible options for parties, including recourse to



the Court of Appeal or the Qatar International Court. The court is distinguished by conducting its proceedings and issuing its judgments in English and by its reliance on the Anglo-Saxon legal system, in a manner suited to the nature of various disputes, particularly those involving international parties. Al-Sahouti added that the Qatar International Court offers a familiar judicial environment for foreign partners, which enhances confidence and encourages investment. He noted that figures from eight years of applying the Arbitration Law show a growing reliance on the competent court, and he expects further growth in this area.

He further stressed that the success of the arbitration system is not limited to legislation alone, but also depends on Qatar's strategic geographic location, its global transport network, and the institutional and knowledge legacy achieved after hosting the FIFA World Cup Qatar 2022. These factors, he said, enhance Qatar's international reputation in arbitration and dispute resolution. For his part, Jassim Saleh al-Kuwari, Assistant Undersecretary for State

Lawsuits Affairs at the Ministry of Justice, affirmed that the multilateral and bilateral investment treaties concluded by Qatar provide legal protection for foreign investors, including guarantees of fair compensation, protection against expropriation, and dispute settlement mechanisms through Qatari courts or international arbitration bodies such as ICSID.

Meanwhile, lawyer Jalal El Ahlab, partner in the Dispute Resolution Group at Bird & Bird in Paris, pointed to a decline in construction disputes in Qatar following the hosting of the FIFA World Cup Qatar 2022, noting that this decline reflects the maturity of the Qatari market after the completion of major projects.

Director of the Arbitration and Mediation Center at the World Intellectual Property Organisation (WIPO), Dr Ignacio de Castro, explained that intellectual property disputes increased by 70% in 2025, particularly in the fields of software, energy, advanced technologies, and artificial intelligence.

He noted that mediation has grown faster than arbitration, helping to resolve approximately 70% of disputes. **(QNA)**

Shura Council reviews legislative proposals, social policy reports

Shura Council held its regular weekly sitting yesterday in Doha, reviewing proposed legislation and government reports on key social issues, amid praise for growing institutional co-operation between the legislative and executive authorities.

The sitting, held at the Council's headquarters and chaired by HE the Speaker Hassan bin Abdullah al-Ghanem, opened with the approval of the agenda, read out by HE the Secretary-General Nayef bin Mohammed al-Mahmoud, and the minutes of the previous meeting.

The Council reviewed a draft law proposing amendments to certain provisions of Law No 24 of 2006 on fertilisers and soil conditioners within the Gulf Co-operation Council (GCC) framework.

The bill, referred by the government, was forwarded to the Committee on Health, General Services and the Environment for further study and reporting.

The Council also examined a government statement responding to a recommendation submitted by the Shura Council on providing services and benefits to senior citizens. The matter was referred to the Committee on Social Affairs, Labour and Housing for review and follow-up. In addition, the members were briefed on two government follow-up reports addressing the Council's earlier recommendations on rising divorce rates in Qatari society and the national framework for promoting values and moral conduct.

The Shura Council commended the government's response, saying the reports demonstrated a systematic and co-ordinated approach that reflected a high level of institutional integration between the two branches of authority. Members said such co-operation contributes to



strengthening social cohesion, supporting family stability and reinforcing the country's value system. Speaking during the session, HE al-Ghanem said the reports reflected an institutional partnership aimed at addressing societal challenges through unified national efforts. He said the approach supports sustainable solutions to family and social stability, while reinforcing ethical and moral foundations within society.

The Council also reviewed a report on the participation of Abdullah bin Nasser bin Turki al-Subaie, vice-president of the Parliamentary Assembly of the Mediterranean, in the body's 56th Bureau meeting, which was held virtually in December.

Following the sitting, Khalid bin Ahmed al-Obaidan, chair of the Committee on Education, Culture, Sports and Information, said the government's follow-up reports underscored a shared institutional approach

to addressing issues related to social values and ethics. He said the committee had discussed the role of educational and media institutions in reinforcing community values, adding that the government's efforts aligned with the Council's priorities.

Meanwhile, Shura Council member Khalid bin Abbas Kamal al-Emadi said the government's submission of implementation reports marked an important step in institutional co-operation. He noted that he had previously chaired a temporary committee studying the issue of rising divorce rates, adding that the follow-up reports demonstrated serious engagement with the Council's recommendations and their translation into practical policy measures. He said the collaboration between the Council and the government reflected a shared commitment to preserving family cohesion, strengthening social stability and supporting sustainable development in Qatar. **(QNA)**

BRIEF SCOPE:

Mesaieed Industrial City (MIC) is undergoing significant expansion in alignment with the planned strategic projects. In order to support the navigation of expected higher draft vessels, QatarEnergy is undertaking a major dredging campaign starting Q4 in 2026.

The scope of the project comprises dredging works at Mesaieed Port, including but not limited to the procurement of navigational lights, mobilization of a dredging fleet, dredging of the East Channel and Mesaieed Port Basin, disposal of dredged material to offshore locations, testing, commissioning of the navigational lights system. The scope also includes the development of CEMP (Construction Environment Management Plan), compliance with the conditions of Ministry of Environment and Climate Change (MECC) and liaison with other government authorities, as well as coordinating with various stakeholders.

The East Channel and Mesaieed Port Basin are required to be dredged to a depth of -15m CD, dredging through both hard and soft strata. The East Channel was dredged to remove high spots to achieve -13.5m CD in 2019, while the Mesaieed Port Basin depths vary with higher areas up to -11m CD. The project will require an adequate number of high-capacity cutter suction dredgers, as well as trailing hopper suction dredgers and barges for transportation to meet the project schedule. The estimated dredging volume is 7,000,000 cubic metres of material over an area of 500,000 square metres. All necessary marine infrastructure works, environmental protection measures, and compliance with regulatory requirements are included. The contractor shall be responsible for all associated works such as approval of vessels through the Ministry of Transport, Mesaieed Port approvals, the construction of temporary facilities, utilities, services, and the restoration of affected areas.

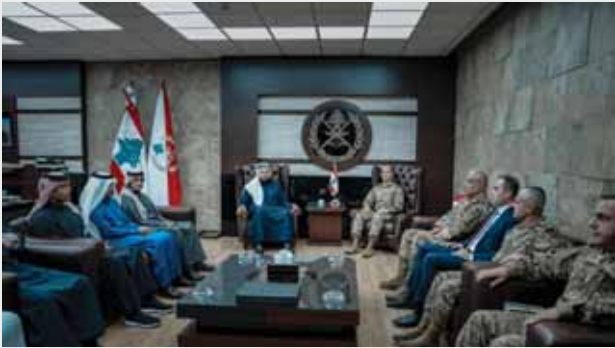

Alcatraz Interlocks, DESCO Host Technical Conference on ‘Safety by Design’



Alcatraz Interlocks, in collaboration with its authorized local partner Doha Engineering Services Company WLL (DESCO) successfully hosted a Technical Conference in Doha, Qatar, on 21 January 2026.

The event brought together professionals from the oil & gas, petrochemical, power, and industrial process sectors, with a strong focus on enhancing operational safety through engineered interlocking solutions under Alcatraz's core philosophy — Safety by Design.

The conference opened with a welcome address and presentation by Paul Ittoop, CEO of DESCO. The Alcatraz presentations were delivered by Craig Young, Managing Director of Alcatraz Interlocks; Jatin Aghera, APAC & Middle East Manager; and Chirag Nair, Commercial & Service Manager – APAC & Middle East.

The event served as a dedicated platform to exchange technical knowledge, share global best practices, and highlight how proven interlocking technologies can significantly reduce operational risks in complex industrial environments. With Qatar's energy and process industries continuing to prioritize safety, reliability, and regulatory compliance, the conference attracted strong interest from operators, engineers, and safety professionals.

The opening session emphasized the importance of strong local representation in delivering global process safety technologies to the Qatari market. As Alcatraz's representative in Doha, DESCO plays a key role in providing local engineering support, coordination, and customer engagement. This partnership ensures that Alcatraz's safety systems are supported throughout the project lifecycle—from early engineering and specification to installation, commissioning, and after-sales support.

The conference provided an overview



of Alcatraz Interlocks' global footprint and engineering capabilities. Founded in 1993 and headquartered in Rijen, the Netherlands, Alcatraz Interlocks has developed into a specialist provider of mechanical, electromechanical, and digital interlocking solutions. Today, Alcatraz is represented in more than 55 countries worldwide, supporting a wide range of industries including oil & gas, petrochemical, chemical, power, and infrastructure.

Alcatraz Interlocks operates as part of Indutrade AB, a Swedish technical trading and industrial group listed on the Stockholm Stock Exchange. Indutrade operates through more than 250 subsidiaries globally and reports annual revenues of approximately SEK 32.5 billion, exceeding €3 billion. This is particularly critical during maintenance, start-up, shutdown, and non-linear process operations, where deviations from procedures can lead to serious incidents.

The conference delivered a detailed overview of Alcatraz's valve interlocking solutions for both quarter-turn and multi-turn valves. Key technical features discussed included 316L stainless steel construction, electropolished surface finishes, fire-test certification to API 607, and compliance with international standards such as ISO 14119 for Machine Directive. These features make the systems well suited for harsh and demanding process environments commonly found in oil, gas, and chemical facilities.

In addition, key storage and control solutions were presented, including

operational key cabinets, key exchange boxes, and mechanically programmed sequence control units. These systems are essential for managing complex procedures such as pig launching and receiving, where multiple valves must be operated in strict, predefined sequences. Practical examples demonstrated how engineered interlocking eliminates incorrect sequencing by design, significantly reducing safety risks.

Machine guarding and access control solutions formed another important part of the agenda. Door, hatch, gate, and switchgear interlocks were presented as effective tools to integrate machine safety with process safety, ensuring that access to hazardous areas is only possible when equipment is in a proven safe condition. The flexibility to design bespoke mounting solutions was highlighted, allowing systems to be adapted to site-specific constraints without compromising compliance.

A major highlight of the conference was the presentation of ALCATRAZ PILOT, the company's Process Interlocking

Oversight Technology. PILOT combines traditional mechanical interlocking with digital oversight, offering electronic key management, keyless interlocks, and IIoT-enabled process monitoring. Real-time operator guidance, live process visualization in control rooms, and enhanced oversight of critical operations were presented as key benefits of this future-ready solution.

The conference also showcased Alcatraz's valve drive and remote operation solutions, including shaft drives, helix drives, and pneumatic drive systems. These solutions enable safe operation of valves located in inaccessible or hazardous areas, significantly reducing operator exposure while maintaining full interlocking integrity. Eco-Drive and Eco-Lock solutions were presented as practical tools to reduce manual strain and improve operational consistency.

The event concluded with breakout sessions, live product demonstrations, and open technical discussions, allowing participants to engage directly with the systems and explore applications specific to Qatar's industrial environment. Informal networking over dinner further strengthened collaboration between Alcatraz, DESCO, and local end users.

Overall, the Technical Conference reinforced Alcatraz Interlocks' commitment to advancing process safety in Qatar and the wider Middle East. Through strong local representation by DESCO and direct engagement from Alcatraz's regional and global teams, the event highlighted how engineered safety — by design — plays a vital role in protecting people, assets, and the environment.

This edition builds on ongoing collaborations between VCUarts Qatar and VCUarts Richmond, including the broader dialogue prompted by the jointly authored book *Living to Learn: Art & Education for the Common Good* which is edited by Noah Simblist.

Qatar takes part in ministerial roundtable at 3rd Global Labour Market Conference

Qatar took part yesterday in the ministerial roundtable session of the 3rd Global Labour Market Conference (GLMC), currently underway in Riyadh.

The two-day summit has drawn policymakers, business leaders and labour experts from across the world, with participation from over 120 countries.

HE the Minister of Labour Dr Ali bin Smaikh al-Marri leads Qatar's delegation at the meeting.

In his address to fellow ministers and senior officials, HE Dr al-Marri underscored the need to move swiftly from broad policy frameworks towards tangible implementation.

Against the backdrop of rapid economic and technological change, he emphasised the importance of transforming theoretical strategies into practical, operational solutions that effectively respond to evolving labour market dynamics.

Drawing on Qatar's experi-

ence, HE Dr al-Marri highlighted the value of aligning institutional reform with targeted capacity-building and partnership-driven approaches.

He noted that careful balancing between robust worker protections and market flexibility has been key to fostering a more resilient and adaptable labour market.

HE Dr al-Marri further argued that employment policy must extend beyond long-term planning.

It now requires, he said, institutional agility – with mechanisms for precise labour market monitoring, rapid policy adjustment and continuous alignment between skills development and actual market demand.

Accelerating the transition from jobseekers to meaningful employment opportunities, HE Dr al-Marri said, hinges on such responsive frameworks.

The minister also reiterated the pivotal role of the private sector, not merely as an employer but as a strategic collaborator in designing and delivering workforce so-



lutions.

At the international level, HE Dr al-Marri stressed that strengthening bilateral and multilateral co-operation is essential for aligning the global supply and demand of labour.

He added that enhanced co-operation in areas such as labour mobility, mutual recognition of skills, and knowledge exchange opens new pathways for work, deepens shared benefits and bolsters the flexibility of global labour markets in the face of worldwide shifts.

The ministerial roundtable addressed a broad spectrum of pressing issues affecting the global workforce.

In addition to the roundtable, HE Dr al-Marri attended the official opening of the 3rd GLMC, taking place on January 26-27.

GAC launches new AI service package

The package also features a Pre-Classification of the Harmonised System Code service, a self-service feature that enables users to request an expert opinion while supporting customs officers with smart suggestions, allowing final decisions to be issued with greater accuracy and in a shorter timeframe.

In addition, the package encompasses an Agentic AI service, which shifts systems from traditional command execution to intelligent, decision-making and autonomous action, as well as a Smart Virtual Assistant that provides instant, data-driven responses based on customs information, making access to information easier and more efficient.



The GAC marked International Customs Day under the theme *Customs Protects Society through Vigilance and Commitment*.

GAC Chairman Ahmed bin Abdullah al-Jamal said in a speech delivered during the ceremony that "Customs plays a pivotal role in facilitating trade, enhancing compliance with regulations and legislation, supporting market stability, strengthening stakeholder confidence, and creating a stable economic environment capable of responding to development requirements and global transformations".

Drugmakers turn to AI to speed trials, regulatory submissions

Artificial intelligence has yet to deliver on the most challenging aspect of drug development – finding new molecules that lead to major medical advances – but it is already streamlining less glamorous parts of the process.

AI is helping find participants and sites for clinical trials and drafting documents for regulators, shaving weeks off these labour-intensive processes, seven large drugmakers and six smaller biotech companies said at the recent JP Morgan Healthcare Conference.

It can take a decade and \$2bn to bring a new drug to market, pharmaceutical companies say. Many, including Eli Lilly, which has partnered with leading chipmaker Nvidia, are betting AI can also improve the success rate of new drugs.

Drug companies have announced a slew of deals for tools to unleash the promise of AI, seen as the biggest technological upheaval since the internet, much as other industries are doing.

Agentic AI – or AI that is autonomous requiring little human intervention – could increase clinical development productivity by about 35% to 45% over the next five years, consultancy McKinsey predicted last year.

Companies are utilising AI in multiple ways so it can focus on the big picture goal of successfully bringing new drugs to market.

Executives from global pharmaceutical companies AstraZeneca, Roche and Pfizer, as well as smaller biotechs like Spyre and Nuvalent, described tracking thousands of pages of documents for regulators, including clinical, safety and manufacturing records.

The documents must be compiled, cross-checked and kept consistent across geographies, often requiring the costly use of outside contractors, AstraZeneca chief financial officer Aradhana Sarin explained.

Jorge Conde, a general partner at venture capital firm Andreessen Horowitz, is investing in fixes to what he calls drug development’s “messy middle,” including putting \$4.3mn into startup Alleviate Health.

He described trial enrolment as a “leaky funnel” in which participants drop out along the way, and sees Alleviate using AI technology to help with patient outreach, education, screening and scheduling.

TD Cowen analyst Brendan Smith said the use of AI, including large language models like Microsoft Copilot, for administrative tasks has become fairly common in the pharmaceutical industry.

But it may take another one to three years before investors can measure how AI has begun speeding up drug development, he said. Quantifying savings is difficult, Smith said, as it depends on how and where the tools are deployed.

Swiss drugmaker Novartis turned to AI in 2023 when it was starting a 14,000-person, late-stage cardiovascular outcomes trial for its cholesterol drug Leqvio, chief medical officer Shreeram Aradhye said.

The typical four- to six-week site selection process became a two-hour meeting, as AI helped identify higher-performing sites and allowed Novartis to close participant enrolment with only 13 patients above its trial target, Aradhye said.

“AI becomes augmenting intelligence, not artificial intelligence,” he added.

A Novartis spokesperson said the time savings afforded by AI can add up to months over a drug-development programme.

British drugmaker GSK said it’s using a mix of digital and AI tools to reduce manual data collection and aggregation and trial enrolment, and aims to speed up all clinical trials by 15% this way.

That helped save about £8mn (\$10.87mn) in costs for late-stage studies of asthma drug Exdensus last year, according to a GSK spokesperson. The drug won US approval last month.

Danish antibody developer Genmab said it plans to deploy Anthropic’s Claude chatbot-powered agentic AI to support clinical development priorities.

Hisham Hamadeh, Genmab’s head of AI, said the goal is to automate post-trial work, including analysis of data and its transformation into graphs, tables, figures and clinical study reports.

German radiopharmaceuticals firm ITM said it has figured out how to use AI to convert long trial reports into US FDA template formats, potentially saving weeks of effort requiring several staff, but has yet to deploy it.

Amgen research chief Jay Bradner said AI is delivering on multiple fronts in the drug development and regulatory document preparation process.

“What everybody’s waiting for is the AI drug. When do I get the AI drug?” he said. “I actually think those molecules are in pipelines right now.” – Reuters

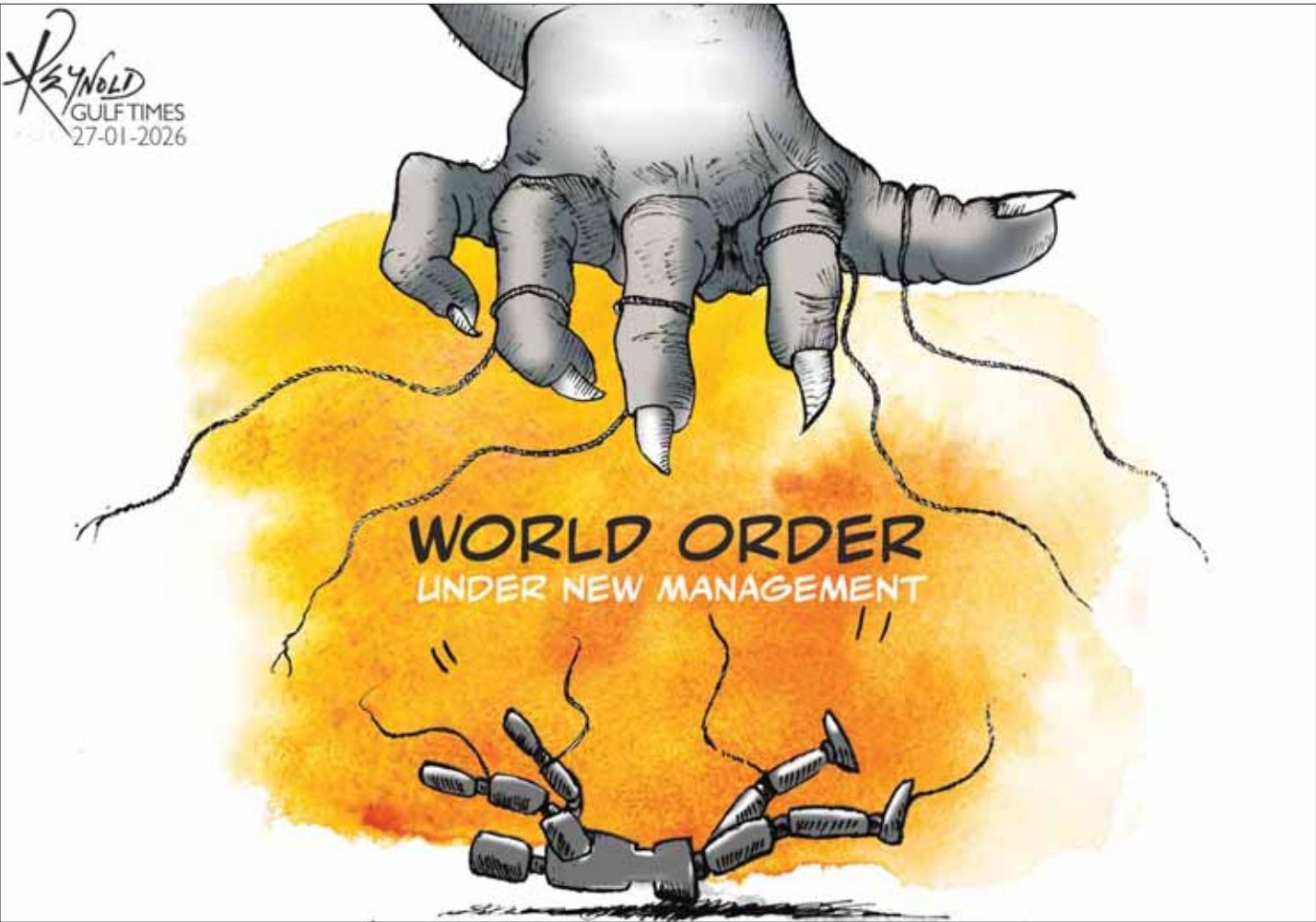

The data centre surge has a hidden source of carbon emissions

Data centres siphon huge amounts of energy to power artificial intelligence. But their environmental footprint starts to balloon even before the first server switches on due to the immense amount of carbon-intensive concrete needed to build them.

As the US data centre buildout surges, with construction beginning on multibillion-dollar facilities from Texas to Wisconsin, tech companies are becoming buyers of low-carbon concrete.

Through 2030, data centre expansion is expected to require 2mn metric tonnes of cement, the binding agent in concrete, according to environmental nonprofit RMI. If these facilities are constructed with traditional concrete, they could generate 1.9mn metric tonnes of CO2 emissions, according to Chandler Randol, a senior associate with the group’s cement and concrete team. That’s the equivalent of annual emissions from 415,000 gas-powered cars.

Concrete – as well as steel – is a significant portion of the emissions associated with building data centres, said Katherine Vaz Gomes, a decarbonisation engineer at Carbon Direct, a climate advisory firm.

“The boom in data centres is providing an opportunity to evaluate, address and move on the carbon impacts of concrete,” said Vaz Gomes. “As AI infrastructure explodes, data centre construction is accelerating and bringing concrete demand with it.”

Microsoft Corporation announced a deal with low-carbon concrete maker Sublime Systems last year, allowing the tech company to purchase up to 622,500 metric tonnes of cement over a period of six to nine years.

“As demand for AI and cloud services grows, we are advancing how we design, build, and operate our data centres and campuses. Decarbonising the built environment is a crucial element in this process,” Melanie Nakagawa, Microsoft’s chief sustainability officer, said.

In August, Amazon.com struck a similar deal with startup Brimstone, but didn’t disclose how much concrete it would purchase. To help support the industry, Amazon, along with Meta Platforms and Prologis signed a low-carbon concrete pact in September called the Sustainable Concrete Buyers Alliance. The group was brought together by RMI and the Centre for Green Market Activation, a non-profit focused

on decarbonising industries. Its aim is “sending clear demand signals to producers” that they’ll find buyers of their low-carbon products, a representative from RMI said.

Amazon has started using low-carbon concrete in data centres under construction in Virginia and Oregon, and the company also invests in startups with the “potential to help accelerate decarbonisation progress,” according to Chris Roe, the company’s director of worldwide carbon.

In addition to Brimstone, Amazon has also invested in CarbonCure, another startup that produces low-carbon cement. The tech company has also put in place carbon intensity standards for any concrete it uses that factor in production and transportation emissions, according to Roe.

The maturation of the green cement industry is going to require a lot of capital, said Christina Theodoridi, policy director for industry at Natural Resources Defence Council. The technology for low-carbon cement is there, but the industry hasn’t yet scaled to meet the enormous demand coming over the next several years. But the partnerships between large tech companies and startups are crucial.

“Having an offtake agreement with a large data centre is a very clear demand signal,” Theodoridi says. “That’s a really critical mechanism to scale up those technologies.”

Funding from big tech companies might not be enough, though. The green concrete industry was set to receive

roughly \$1.6bn in support from the Inflation Reduction Act. But President Donald Trump pulled the funding last year.

“That was going to breathe real momentum into the industry,” Theodoridi said. “The data centres present an opportunity for which we would have been much better prepared for had we continued those investments in heavy industry.”

The impacts of funding cuts are starting to ripple through the industry. In December, Sublime laid off 10% of its staff, citing a loss of \$87mn in government funding. It also said it was pausing construction on its factory in Holyoke, Massachusetts, which was scheduled to open as early as this year.

Data centre operations will put much more carbon in the atmosphere than their construction. Operational emissions, however, can be lowered over time as data centres become more efficient or rely more heavily on clean energy. But using green building materials is the only way to reduce what’s known as the embodied emissions associated with data centres.

And for tech companies to meet their climate goals, those emissions will have to be dealt with. “Quite a few of those large tech companies actually have quite aggressive and meaningful climate targets,” said Chris Magwood, a manager on RMI’s carbon pre-building team and embodied carbon team. “Internally, they obviously have identified that data centres and particularly the concrete use in those data centres is a key driver for them.” – Bloomberg

Sheikh Joaan also stressed the importance of forging long-term relationships with other organisations, particularly as the International Olympic Committee (IOC) operates within well-defined systems and frameworks.

Adhering to these frameworks and implementing them effectively, he said, would ensure that the OCA remains open to collaboration with all stakeholders, institutions, and companies in ways that advance both athletes’ interests and the broader Asian Olympic movement.

He emphasised that his leadership aim is to serve the 45 National Olympic Committees and to make supporting youth – both athletes and sports administrators – a top OCA priority. This, he explained, would include nurturing future talents to manage and sustain sports organisations effectively.

Sheikh Joaan further recognised Asian media institutions as essen-

tial partners in promoting the Olympic movement, noting that they play a vital role in sharing the inspiring stories of athletes and amplifying sport’s impact across the continent. He reaffirmed his openness to media feedback, saying that constructive dialogue would help improve communication strategies and public engagement.

“The Council exists to serve Asia and its National Olympic Committees, providing excellence that matches the dedication these committees display daily,” he stated. “I am not here to shine – the spotlight belongs to the athletes and the National Olympic Committees.”

Sheikh Joaan concluded by reflecting on Asia’s rich diversity, describing it not as a challenge but as an opportunity for growth, particularly through the region’s expanding emerging markets. What matters most, he added, is ensuring unity around a common vision and direction to advance together as one continent.

“As Qatar accelerates its national agenda around smart urbanisation, sustainability and next-generation infrastructure, Doha is increasingly being viewed not only as a destination for global innovation – but as a platform to export it,” said Park, who views buildings should no longer operate as passive consumers of energy, but as intelligent, productive assets – capable of optimising demand, generating power, and creating measurable energy outcomes across their lifecycle.

Qatar’s emergence as a base for EnergyX’s expansion reflects the company’s view that the country offers a rare combination: national momentum behind AI-driven transformation, strong national ambition, and a policy environment increasingly shaped by sustainability and long-term resilience.

As Qatar accelerated investment in AI, smart cities, sustainable districts and major infrastructure, Park saw an opportunity to scale EnergyX – with Qatar positioned as a key hub.

Beginning in 2024, EnergyX initiated the relocation of its global leadership and command functions to Qatar. By early 2025, Park and the company’s core leadership team had moved to Qatar, anchoring the company’s future scaling in the country.

Today, EnergyX describes its Qatar operations not as a regional outpost, but as a global hub – directing projects, research and development, and acquisition activity across Asia, Europe, the Middle East and North America.

For Park and Dandrieux, the strategy is not simply to expand a company footprint in the Gulf. It is to advance a wider proposition: that cities can be designed to be energy-optimised by default – and that buildings can become part of the energy solution rather than part of the problem.

“As the country continues to

build at scale, its ambition increasingly extends beyond adopting global innovation. It is positioning itself to shape what comes next – and to export it,” said Park.

EnergyX’s approach is to unify disciplines that have traditionally operated in silos: AI-powered computational energy intelligence, façade engineering and fabrication, and long-term operational optimisation. The goal is not simply to design efficient buildings, but to deliver performance outcomes from early-stage design through decades of use.

EnergyX claims to have delivered more than 2,000 buildings worldwide, supported by over 300 intellectual property assets, across asset classes ranging from high-rise commercial towers and large residential developments to industrial facilities and hyper-scale data centres.

Among its most prominent demonstrations is the EnergyX DY-Building, which recorded 129.6% energy self-sufficiency over a one-year period, based on 2025 certification and performance data published by the Korea Energy Agency, calculated on a net annual basis that includes grid exports.

The seven-storey DY-building is seen as a functioning showcase of integrated technologies of EnergyX. From design to operations, the building demonstrates a complete application of optimised, data-driven, AI or artificial intelligence-powered, hardware-integrated solutions.

“In Qatar, EnergyX is applying this model in alignment with national objectives, supporting a broader push to link sustainability with productivity, performance and long-term value,” he said.

During the Web Summit Qatar 2025, EnergyX had disclosed its plans to establish a major research and development centre in Qatar, committing to invest more than \$100m in the Gulf Co-operation Council region over the next five years.

Qatar Press Centre hosts caricature exhibition by Qatari artist

Qatar Press Centre has launched the art exhibition “Caricature: Vision, Message, and Art” by caricature artist Saad Abdulwahab al-Muhammadi, which will run until February 1.

The opening of the exhibition, held at Professor Abdullah bin Hussein al-Naama Hall, was attended by a select group of cultural and media figures, including Khalid bin Ahmed al-Obeidan, Member of the Shura Council and vice-chairman of the Board of Al Jasra Cultural and Social Club, besides Youssef al-Qassifi, head of the Lebanese Journalists Syndicate; Majed al-Jubbara, managing editor of *Arrayah* newspaper; Hassan al-Mohamadi, managing editor of *Al-Arab* newspaper; and Abdulaziz al-Kubaisi, deputy director of Qatar Centre for Photography, in addition to several journalists, media professionals, and caricature art enthusiasts. The scene reflected the growing interest in caricature as a shared space that brings together creativity and critical thinking.

This cultural event underscores the status of caricature as a powerful visual medium of expression,



capable of engaging with reality and condensing meaning, and as a bridge linking art with the journalistic message in a creative form that resonates closely with the public.

The artist welcomed the attendees, expressing his appreciation for the centre’s initiative in organising the exhibition and providing a platform that opens space for dialogue between the artist and the audience.

He stressed that caricature is not limited to satirical drawings, but rather a comprehensive media language with its own capacity to address public issues and con-

dense meaning through the simplest of lines. He noted that this art form works on ideas as much as on images and employs paradox and brevity as tools of influence.

Al-Muhammadi explained that the exhibition is an extension of the Centre’s approach to highlighting Qatari creative experiences within the journalistic field and shedding light on non-traditional tools of expression in the media landscape.

He reviewed the works featured in the exhibition, which represent different stages of his artistic journey and carry multiple symbols and messages. According to

him, caricature relies on “intelligent reduction,” enabling the image to serve simultaneously as a tool of critique and awareness, engaging the audience in a direct and impactful way.

He pointed out that the exhibition’s main idea is to present a selection of his most prominent caricatures that previously sparked positive debate and wide engagement among supporters and critics alike, due to their bold treatment of social and media issues open to discussion.

The exhibition features several new works, published and displayed for the first time, offering

visitors an opportunity to follow the evolution of the artist’s vision. He has brought together old and new works in a visual dialogue that reflects changes in reality and shifting questions.

Al-Muhammadi said the exhibited drawings capture the pulse of the street and the public’s aspirations regarding many local and global events and issues. He stressed that caricature draws its vitality from its closeness to people and its ability to capture everyday details, transforming them into scenes that condense the story and open the door to reflection.

The artist has a career that combines journalistic work with artistic practice. He began his professional career as a daily caricature artist in January 2006 and has participated in several art exhibitions, including a solo exhibition at the Artistic Creativity Centre in September 2005, an exhibition at Qatar University, and other exhibitions inside and outside the country.

He also won third prize from Al Kass Channel for Best Caricature in the Best Media Coverage competition during the Gulf Cup 21 in 2013, and published a caricature work titled “Red Lines.”

Mowasalat launches Robotaxi public trials at Old Doha Port

Mowasalat (Karwa) took a significant step towards autonomous mobility in Qatar with the public launch of its Robotaxi trials at Old Doha Port yesterday, allowing residents and visitors to experience self-driving transport in a real-world setting. The trial marked the first opportunity for the public to test the Robotaxi service, which is now accessible through the Karwa app in selected locations. Speaking at the launch, Mohammed Abu Khadija, executive director of Commercial Affairs at Mowasalat, described the initiative as a key milestone in Qatar's transport evolution. "This Robotaxi initiative is one of the projects we are working on under the guidance of the Ministry of Transportation's 2030 vision for sustainable and safe AI-driven technology," Abu Khadija said. "It is about preparing our workforce and integrating innovation into different means of transportation to build a smart,



integrated transport system in Qatar." Currently, 10 Robotaxis are operating at designated points of interest across West Bay, Central Doha, and Hamad International Airport. Abu Khadija explained that the vehicles are already embedded within Mowasalat's existing taxi and limousine network, allowing users to book them in the same way as conventional taxis, subject to availability. He stressed that safety remains the cornerstone of the project, noting that each Robotaxi is equipped with 11 cameras and four radars that continuously collect data, map roads and respond instantly to surrounding

conditions. "All these systems are live and designed to read every possible scenario on the road," he said. While the vehicles are autonomous, trained safety officers remain seated behind the wheel during this phase. "The driver is not actively driving," Abu Khadija explained. "He is there to ensure the comfort and safety of passengers, especially for those trying a Robotaxi for the first time." In the event of an emergency, he said the safety officer can immediately disengage the AI system and manually control the vehicle, moving it to a safe location. Abu Khadija noted that since testing began, there have been no recorded incidents. The public trial also served as a platform for engagement, enabling participants to ask questions, build confidence and better understand how autonomous technology works. The Robotaxi trial reflects Mowasalat's broader commitment to safer, smarter and more sustainable mobility, with public feedback playing a central role in shaping future phases of autonomous transport in Qatar.

QF's 'Heart to Heart' series to present 'The Arab Prince of Violin'

As part of its 'Heart to Heart' series, Qatar Foundation (QF) will host a musical evening titled 'The Arab Prince of Violin: 60 Years After Sammi Shawwa' on January 31.

The evening will be hosted by Kuwaiti musician and researcher Dr Ahmed al-Salhi, alongside musician, composer, researcher, and oud player Dr Mustafa Said, founder of the Asil Ensemble, with the participation of Bilal Bitar, a qanun player specialising in the authentic traditions of the Arabic maqam.

Taking place from 7pm-8pm at the Black Box Theatre in Multiqa, the event celebrates one of the most influential figures in Arab music, Sammi Shawwa. A musician whose impact continues to resonate with generations of music lovers, Shawwa mastered the many dialects of the Arabic maqam - from the Atlantic to the Gulf - and extended his mastery to maqam traditions from non-Arab musical cultures.

Free of illuminated screens, amplification, mobile phones, and other technology, to enhance authenticity and audience enjoyment, the evening will also have a workshop organised by QF's Herfah programme, held prior to the performance and titled 'Outdoor Structure Geometry'. In this workshop, participants will build geometric structures that deepen their understanding of the forms, spaces, and proportions used in Islamic art and architecture.

Following the musical performance, audiences will be invited to attend an interactive discussion session with the musicians, organised by QF's BilAraby initiative.

Dr al-Salhi is widely regarded as one of the leading figures in the authentic Arab maqam tradition. He has founded several musical programmes and initiatives, specialises in traditional Arab performance styles, and brings extensive experience in the history of music in the Arabian Gulf, recording history, and the craft of oud making.

Dr Said, from Cairo - winner of the Aga Khan Music Award (2019) and the Sheikh Zayed Book Award (2024) in the Arabic Manuscript Editing category - will bring his distinctive musical voice, shaped by both classical and contemporary Arab music traditions, to the performance.

The evening will also be enriched by Bitar, the Lebanese musician and winner of the Sammi Shawwa Award for Maqam Improvisation (2017). His performance is inspired by the authentic traditions of the Arabic maqam, and he continues to contribute to the preservation and presentation of Arab musical heritage through a style that blends authenticity with creativity.

This latest edition in the 'Heart to Heart' series follows a special performance last November by Iranian musician and composer Negar Bouban, which brought together Persian and Kurdish musical traditions drawn from her cultural roots.

'Heart to Heart' will continue its celebration of authentic musical maqam over the coming months. In March, the series will feature 'Maqamat of the Ottoman Court with Fikret Karakaya,' followed in April by 'A Journey Through Maqam with Mohammed Antar.'
