Doha Legal Forum ends with focus on future challenges

The first Doha Legal Forum wrapped up yesterday after two days of discussions on current legal challenges and ways to strengthen the rule of law at regional and international levels. The event was organised by the Ministry of Justice in co-operation with the Qatar International Court and Dispute Resolution Center, under the patronage of HE the Prime Minister and Minister of Foreign Affairs Sheikh Mohammed bin Abdulrahman bin Jassim al-Thani. It brought together senior officials, legal experts and academics from a wide range of countries. In his closing remarks, HE Undersecretary of the Ministry of Justice Saeed bin Abdullah

al-Suwaidi said the forum had laid a solid foundation for future editions and confirmed it would be held every two years. He described the gathering as a "rich legal experience" that showcased ambition, innovation and initiative, and provided a leading platform for dialogue, knowledge-sharing and debate on emerging legal issues. He noted that the forum hosted 19 panel sessions with 55 speakers, covering legislative reform, trade and investment, dispute resolution, energy regulation, public-private partnerships, cybersecurity, financial services regulation and the use of artificial intelligence. Al-Suwaidi added that the outcomes would be compiled into a set of recommendations, to be drafted by a dedicated committee, to help shape future legal frameworks in co-ordination with strategic partners. **Page 4**

Qatar to make art history with Art Basel debut

Qatar is set to make history next month as it becomes the first Middle Eastern nation to host Art Basel, the world's most prestigious contemporary art fair. The inaugural Art Basel Qatar, from February 5-7 at Msheireb Museums and M7 in Doha, marks a turning point for the region's cultural scene and underscores Qatar's rise as a global hub for artistic exchange and innovation.

Wael Shawky, artistic director of Art Basel Qatar, said the country's long-term investment in cultural

infrastructure and its growing community of collectors made it a "natural choice" for the fair's regional debut. "Qatar's comprehensive arts ecosystem - from education and institutions to public engagement - creates the right conditions for an art fair to thrive," he told *Gulf Times* in an exclusive interview.

"Qatar has invested seriously in cultural infrastructure over a long period of time, building a comprehensive arts ecosystem that supports artists through education, exchange, and sustained support. For Art Basel, this kind of long-term commitment matters," Wael Shawky, artistic director, Art Basel Qatar, told *Gulf Times* in an exclusive interview. **To Page 7**

Where travel meets tranquillity: Inside HIA's living oasis

Nature, design, serenity converge at airport's tropical garden

Airports are synonymous with urgency, defined by queues, boarding calls and tight connections that set the rhythm of travel. At Hamad International Airport (HIA), however, one space has been purposely designed to slow that pace.

The Orchard, a vast indoor tropical garden at the heart of the terminal, is redefining the passenger experience by weaving nature, innovation and sustainability into a setting built for constant movement.

"Walking into The Orchard at HIA was a total vibe shift. Entering this tropical garden before my flight felt like a literal sanctuary. With all the lush



greenery and natural light, you totally forget you're even in an airport," Fili-

pino traveller Zoey told *Gulf Times*.

She recalled spending nearly an hour

soaking in the calm energy and the soothing sounds of flowing water, while her one-year-old daughter explored the space.

"It's the ultimate spot to reset your brain before take-off. Honestly, every airport needs this level of biophilic healing," says Zoey.

Dinah, a frequent traveller herself, shares a similar experience, saying: "It is refreshing to see a garden inside the airport as it creates a relaxing atmosphere while waiting for a flight. It offers a pleasant space to read books, enjoy a cup of coffee, or have a quiet conversation with a friend."

Spanning 6,000sq m, The Orchard is filled with natural light, dense greenery and the gentle sounds of water, all proven indicators of relaxation. Since its unveiling in 2022, it has become a visual and emotional anchor within the airport.

More than 300 trees and over 25,000 plants and shrubs sourced from sustainable forests around the world populate the garden, with around 30 tree species and

90 varieties of plants carefully selected to thrive together in a single indoor environment. The tallest tree rises to 16 metres, highlighting the rainforest-like atmosphere.

For frequent travellers like Miriam from Kenya, the impact is immediate and lasting: "I always look forward to visiting the Orchard at HIA because of the tranquillity it offers both my mind and body."

"The moment one steps into the space, the usual rush and noise of an airport seem to fade away. Surrounded by lush greenery and the gentle presence of water, one hardly feels like they are in a transit hub at all."

Water plays a key role in shaping that experience. A 575sq m water feature includes a sustainable bio-pond that has evolved over time, from aquatic plants at launch to flowering water lilies and lotus flowers today.

Since opening, Orchard has seen multiple blooms, including the introduction of new orchid species, subtly renewing the environment for repeat visitors. **To Page 7**

CRA takes part in GCC telecom panel meeting in Bahrain

The Communications Regulatory Authority (CRA), representing Qatar, participated in the 48th meeting of the Technical Committee of the Telecommunications Technical Bureau at the General Secretariat of the Gulf Co-operation Council (GCC), held in Bahrain recently.

The meeting brought together representatives of telecommunications regulatory authorities and technical experts from GCC member states to discuss regional priorities related to wireless communications and radio spectrum management. The meeting serves as a key regional platform for co-ordination on technical and regulatory telecommunications matters, supporting alignment among GCC countries on spectrum management and wireless communication issues.

This co-ordination contributes to unified regional positions at Arab and international levels and strengthens collective engagement in global regulatory processes in response to rapid technological change. During the meeting, Qatar made several technical contributions

demonstrating active engagement in discussions. The Qatari delegation presented a consensus working paper on the 6GHz frequency band, addressing growing demand for wireless services and emphasising the importance of balanced and forward-looking spectrum allocation approaches that support innovation while ensuring long-term sustainability. Qatar also submitted a working paper focusing on applications installed on certain mobile devices, examining key regulatory and technical considerations, including impacts on network performance, consumer protection, and compliance with national regulatory frameworks. In addition, the delegation presented a working paper on harmful interference affecting positioning systems, outlining related technical challenges and potential mitigation solutions. The meeting further provided an opportunity for Qatar to highlight its hosting of the ITU Plenipotentiary Conference 2026, reaffirming the country's readiness to contribute to global decision-making in the field of information and communication technologies. **(QNA)**

NPC reviews strategy at Doha Data Forum

The National Planning Council (NPC), represented by the National Statistics Centre, organised the Doha Data Forum yesterday.

Participating in the forum were representatives of government agencies, the private sector, and civil society organisations, alongside a number of experts and decision-makers, to discuss the role of national data in supporting the development planning process in Qatar and to review key developments in the national data ecosystem.

The forum served as a national platform to highlight the achievements of 2025 within the National Data Programme, which saw the launch of several initiatives and national platforms, including the National Data and Statistics Strategy, the Qatar Data Trust Index, the QInsights Platform, and the revamped Qatar Open Data Platform. This was complemented by capacity-building programmes, including the Qatar Datathon, the Data Summer Camp, and a series of other initiatives aimed at promoting a data-driven culture.

Addressing the forum, Direc-

tor-General of the National Statistics Centre at NPC, Ahmed Hassan al-Obaidly, said the forum convenes at a profoundly critical time, marking an advanced executive phase Qatar has attained in implementing the Third National Development Strategy, placing high-quality data and statistics at the core of achieving its socioeconomic and development targets as key enablers of effective planning.

The ambition for the upcoming phase goes beyond data collection to maximising strategic value through improving data quality, broadening the use of administrative records, adopting advanced analytics, and leveraging artificial intelligence to enable more accurate policies, more flexible planning, and faster responses to change, al-Obaidly said.

The forum reviewed the directions of the National Data Programme for 2026, which include several upcoming national initiatives, notably the National Data Compliance Platform to monitor progress towards national objectives, alongside the continued development of the Central Data Bank Project as a pivotal initiative

providing high-quality data accessible to decision-makers.


The forum highlighted the commitment to data transparency, reflected in its specialised sessions that showcased the achievements of the National Data Programme in 2025 and outlined priorities for the next phase.

Discussions also addressed the state of data and artificial intelligence at both national and regional levels, emphasising the role of trusted, high-quality data in enabling the responsible use of advanced technologies.

The forum's panel discussions further focused on data governance, implementation challenges, and mechanisms to enhance co-ordination among government entities, ensuring the development of a more integrated and efficient national data ecosystem.

Concluding its deliberations, the forum underscored the importance of continuous collaboration among multiple state sectors, fostering a data culture, and accelerating the adoption of cutting-edge technologies, particularly AI and advanced data analytics. **(QNA)**

Forum discusses role of legislation in Qatar National Vision 2030



A panel discussion held on the second day of the Doha Legal Forum examined the theme "Qatar National Vision 2030: Future Prospects and Aligning Regulations to the Vision", along with new development projects in the country and prospects for foreign investment.

Participants stressed the importance of strengthening Qatar's position as an attractive destination for both domestic and foreign investment.

Assistant Secretary-General for Legislative Affairs at the General Secretariat of the Council of Ministers, Abdulaziz Mubarak al-Boainin, said investment-related legislation constitutes a core pillar in achieving economic diversification and boosting the national economy in line with Qatar National Vision 2030. He noted that the state is working to develop a competitive, multi-sector economy that ensures a high standard of living for current and future generations by encouraging innovation, supporting entrepreneurship, and developing priority sectors.

Al-Boainin highlighted that implementation of the Vision is being carried out through the Third National Development Strategy, which aims to achieve sustainable economic growth at an annual rate of 4%, accelerate economic diversification through specialised clusters, enhance fiscal and environmental sustainability, develop a productive workforce, strengthen innovation, improve quality of life, and upgrade government institutional performance

by 2030. He noted that economic legislation serves as the main driver of any economic transformation, as it provides the legal frameworks needed to attract capital and direct it towards targeted sectors by creating a competitive and investor-friendly environment through laws aligned with global developments. Among these is Law No 1 of 2019, which allows up to 100% foreign ownership in most sectors, alongside tax and customs incentives to steer investment towards priority sectors and accelerate their growth compared to the oil and gas sector.

He also underscored efforts to enhance investor confidence and legal certainty through clear dispute resolution mechanisms and protection of intellectual property rights, as well as the adoption of free zones and the Qatar Financial Centre as leading models for attracting companies and capital. These frameworks are supported by the Qatar International Court and clear regulatory mechanisms that provide a flexible and secure business environment.

Al-Boainin further emphasised the role of Law No 12 of 2020 on public-private partnerships in strengthening the private sector as a key driver of development through contractual frameworks that reduce the financial burden on the state and open new investment opportunities.

He noted that these laws have contributed to the growth of the digital economy and attracted global companies in data and artificial intelligence.

He added that involving the private sector in drafting economic legislation ensures the effectiveness and sustainability of laws by bridging the gap between legal texts and practical realities through the participation of practitioners in identifying real challenges.

This approach enhances ownership of legislation, accountability, and compliance, enables future-oriented and flexible legal frameworks, and improves legislative effectiveness through feedback from the private sector, providing investors with a predictable environment for long-term planning.

Al-Boainin also said Qatar has achieved significant advances in a number of international rankings and indicators in 2025 and 2026.

The country ranked among the world's top 10 in the 2025 Global Competitiveness Index issued by the International Institute for Management Development (IMD), placed 27th globally and second regionally in the Economic Freedom Index published by the Heritage Foundation, and was classified among the top 20 countries worldwide in digital competitiveness and innovation.

Qatar also ranked 48th globally in the Global Innovation Index (GII) and sixth worldwide in the use of information and communications technology, reflecting its transformation into a secure and attractive environment for investment and capital, with a high level of legal and digital security that supports sustainable economic growth and the objectives of Qatar National Vision 2030. **(QNA)**

Call to align legislation with global standards to boost investment

Academics and legal experts emphasised the importance of aligning national legislation with international standards and modern investment requirements to foster the competitiveness of the national economy, improve the business environment, and attract investments. In a roundtable discussion on enhancing the role of the legal profession in developing the legislative framework and improving the investment climate in Qatar, convened as part of the Doha Legal Forum, the panellists stressed the importance of preserving legislative identity and national sovereignty. Chairman of the Board of the Qatar Lawyers Association, lawyer Mubarak Abdullah al-Sulaiti, affirmed that the association plays an active role in developing the nation's legislation by providing guidance on draft laws and legislative proposals, particularly legislation related to judicial procedures, civil procedure, and family law. This is part of supporting what he described as the legislative reform movement in Qatar, in accordance with international legal standards and societal requirements. He explained that the association participates through specialised legal committees composed of a select group of lawyers, focusing on reviewing draft legislation and providing technical feedback to ensure alignment with rapid developments, and underscored the importance of involving relevant experts in drafting legislation to achieve effectiveness and fairness. Al-Sulaiti also highlighted the association's role in promoting awareness through organising conferences and workshops and providing specialised digital platforms, thereby contributing to raising professional standards in legal practice, training lawyers, and reinforcing confidence in the legal system. He emphasised that the judicial environment is one of the primary factors investors consider before making investment decisions, and that the speed of dispute resolution, integrity of the judiciary, clarity of procedures, and ease of profit repatriation are essential elements of an attractive investment environment, cautioning that procedural

complexity or restrictions on capital movement could hinder investment attraction. Al-Sulaiti further stressed the importance of developing a comprehensive dispute resolution system, noting that it should not be limited to arbitration alone, despite its importance, but should also strengthen amicable settlement and reconciliation mechanisms, which provide faster, more flexible, and cost-effective solutions. Dr Noura al-Sahlawi, senior lawyer and law professor at Qatar University, emphasised that aligning Qatari legislation with international standards and modern investment requirements remains one of the key challenges amid the economic and legislative transformations Qatar has undergone over the past two decades. She noted that this issue represents the core of the current legislative, economic, and institutional transformation. Dr al-Sahlawi pointed out that legislative alignment is a fundamental condition for the success of countries seeking integration into the global economy, without undermining legal sovereignty or legislative identity. She noted that the quality of laws, clarity of provisions, and speed of procedures are now decisive factors in boosting legal certainty and the attractiveness of the business environment. Dr al-Sahlawi highlighted Qatar's recent legislative progress, including updates to company laws, regulation of foreign investment, strengthening arbitration independence, and issuing legislation in technology, financial services, e-commerce, labour, taxation, and customs, alongside the development of specialised courts, most notably the Investment and Trade Court. She clarified that legislative alignment does not imply copying ready-made legal models, but rather adapting them to the national context, noting that investors seek legislative stability, clear procedures, and effective dispute resolution channels. Dr al-Sahlawi addressed the challenges posed by rapid technological advancements and modern business models, such as fintech, digital trade, and artificial intelligence, calling for a proactive legislative vision based on planning and flexible laws capable of keeping pace with these transformations. **(QNA)**

Qatar takes part in Arab panel meeting on nuclear weapons

In a speech during the event, Assistant Secretary-General and Head of the International Political Affairs Sector of the League of Arab States ambassador Khalid

bin Mohammed Manzalawi emphasised the importance of the Senior Arab Officials Committee. He noted that it is the sole technical body within the framework of the Arab League that addresses issues related to weapons of mass destruction, particularly nuclear weapons. He explained that since its establishment in the early 1990s, the committee has played a vital role in monitoring Israeli nuclear capabilities, as well as formulating unified Arab positions in international forums. Registration open for Qatari students at Qatar Science and Technology Schools

The Ministry of Education and Higher Education (MoEHE) has announced the opening of applications for Qatari students, both boys and girls, to enrol in Qatar Science and Technology Schools for the 2026-27 academic year, in conjunction with the inauguration of two new schools for boys and girls.

Applications will be accepted from now until February 20, through the Maaref Public Services Portal on the ministry's official website.

The schools are specialised government institutions offering high-quality education based on the integration of STEM (science, technology, engineering and mathematics), with curricula designed in line with the national curriculum framework and the Next Generation Science Standards (NGSS).

The new schools are the Qatar Science and Technology Preparatory Secondary

School for Boys in Al Sakhama, targeting Grade 7 with a capacity of 100 students, and the Qatar Science and Technology Secondary School for Girls in Rawdat Al Hamama, targeting Grade 9 with a capacity of up to 100 students.

Registration will also continue at the boys' school in Umm Al Seneem for Grades 7 and 9, with an intake capacity of 48 students per grade.

English will be the language of instruction for science subjects, while Arabic language, Islamic studies, and social studies will be taught in Arabic.

The admission process comprises several stages, beginning with application screening to ensure applicants have achieved a minimum of 80% in mathematics, science, and English, followed by specialised admission tests, including a mathematics test covering the previous two academic years, the English proficiency test (APTIS), the Cognitive Abili-

ties Test (CAT4), and an Arabic language skills test.

Applicants meeting the initial criteria will be invited, alongside their parents or guardians, to attend a personal interview to assess their personal characteristics and academic interests.

Qatar Science and Technology Schools provide an advanced educational environment that prepare students to obtain a specialised secondary school certificate accredited locally and internationally.

The MoEHE also provides free transportation services across all areas of the country, with school hours running from 7am-2.30pm from Sunday-Wednesday and until 1.40pm on Thursdays.

Final results for accepted students will be announced no later than the end of May 2026, based on the highest scores achieved and within each school's capacity.

Sheikh Thani honours winners of 3rd Arab Book Award

HE Sheikh Thani bin Hamad al-Thani, chairman of the Board of Directors of the Qatar Fund for Development (QFFD), honoured the winners of the 3rd Arab Book Award at an official ceremony yesterday.

The ceremony was organised

at the Grand Hyatt Hotel.

In this year's single-book category for linguistic and literary studies – focusing on literary and critical examinations of Arab heritage up to the end of the 10th century AH – Abdullah al-Rashid was awarded first place for his work *The Recording of Debauchery in the Arab Heritage: Presentation, Explanation, and Interpretation*. Second place went to Amer Abu

Qatar Museums announces final phase of its diverse exhibition programme

Qatar Museums (QM) has announced the final phase of a diverse programme of exhibitions set to conclude in February, as part of the Qatar Creates fall-winter 2025 season.

Spanning five decades of transformation, the exhibition underscores the museum's central position in Qatar's cultural landscape, highlighting its vital role in preserving national identity, advancing cultural diplomacy, and fostering global exchange.

It also showcases the museum's pioneering use of innovative tech-

niques and visual storytelling to present Qatar's history, featuring contemporary re-creations of beloved elements of the original site, such as the Earth Dome, alongside rare documents and photographs from the museum's early years.

In a related context, the immersive exhibition "Lehmesa: Return by Moonlight" explores the life cycle of the sea turtle known locally as "Lehmesa", with a particular focus on the Hawksbill turtle that returns to Qatar's shores each nesting season.

The exhibition addresses pressing environmental challenges, including habitat loss, pollution, and climate change, as well as the fragile marine ecosystems along Qatar's coasts.

"Lehmesa: Return by Moonlight" underscores Qatar's commitment to marine conservation and the protection of its natural heritage for future generations. – QNA

Behind the scenes, technology ensures the garden's long-term health.

A smart irrigation system uses sensors and algorithms to respond dynamically to soil and environmental conditions, improving plant health while sharply reducing water waste and energy consumption.

More than 350 fogging nozzles maintain humidity levels essential for a rainforest environment, while the HIA's in-house nursery propagates and nurtures plants, many of which are grown on site.

"The Orchard transforms a long and tiring journey into something more bearable, even quietly uplifting," Miriam said. "It creates a rare pause within a place defined by constant movement, allowing travellers to slow down, breathe and reset."

Sustainability underpins the entire concept and aligns with Qatar National Vision 2030.

Irrigated water is collected, recycled, and converted into Treated Sewage Effluent (TSE), which is then re-used for outdoor landscaping across the airport, reducing energy demand and the airport's carbon footprint.



Study examines experiences of Palestinian therapists in war

The perspective of Liberation Psychology was among the key themes debated on the third day of the 4th Palestine Annual Forum, during the third track of the seventh session on "Mental Health under Genocide and Settler Colonialism".

Einas Odeh Haj presented her paper *The Experience of Palestinian Psychotherapists inside the Green Line: The Perspective of Liberation Psychology*.

She is the founder and director of the Liberation Psychology Programme at Mada al-Carmel – the Arab Centre for Applied Social Research in Haifa, where she previously served as associate director.

A certified psychotherapist, she operates a private practice and holds a postgraduate diploma in psychotherapy, a master's degree in educational counselling, and professional accreditations from local and European institutions.

Her research focuses on structures of oppression and their impact on the mental health and psychosocial wellbeing of Palestinian individuals and communities.

In an interview with *Gulf Times*, Odeh Haj said that since the onset of Israel's war on Gaza, "violent and sustained attempts by the State of Israel to intimidate, persecute, and silence Palestinian citizens of Israel have intensified markedly", affecting workplaces, academic institutions, and the healthcare system, including mental health services.

Within this environment, she noted, Palestinian mental health professionals find themselves in an exceptionally complex professional, personal, and psychological position.

Odeh Haj stressed that Palestinian therapists have been constrained by Western-oriented frameworks that impose an Israeli narrative of trauma and

suffering, defined exclusively through Israeli society, marginalising Palestinian lived realities.

Her study traces the experiences of Palestinian therapists, examining their human, intellectual, and professional encounters with the war, the policies of silencing and restriction they face, and the psychological impact of these conditions on their political and professional identities.

It also explores the psychological and behavioural mechanisms therapists employ to cope with such pressures.

Odeh Haj explained that the study adopts a qualitative approach grounded in critical liberation psychology as its overarching conceptual framework.

This approach engages with the lived experiences of oppressed communities from both

psychosocial and political perspectives and seeks points of convergence between the therapeutic self and the collective Palestinian self.

On the impact of psychotherapists' work on patients, Odeh Haj said: "We can feel that our agency is contributing something."

"When we hold together, we enact a form of resistance against atomisation and silencing," she continued. "The impact of this collective agency is that psychotherapists themselves feel empowered – they are not alone or isolated."

"It gives a sociological dimension to psychological suffering by showing that everyone is experiencing similar conditions," she said.

"We emphasise that we are part of the Palestinian people, fragmented and dismembered into ashlaa – dismembered body parts," Odeh Haj stressed.

"This word should be internationalised, because our psyches are also dismembered," Odeh Haj stated. "When we hold together, we perform an act of resistance against this dismemberment, moving towards the reassembly of the whole Palestinian self."

Qatar to make art history with Art Basel debut

"Qatar has invested seriously in cultural infrastructure over a long period of time, building a comprehensive arts ecosystem that supports artists through education, exchange, and sustained support. For Art Basel, this kind of long-term commitment matters," Art Basel Qatar artistic director Wael Shawky told *Gulf Times*.

He said that it creates the right conditions for an art fair to function not only as a marketplace, but as part of a broader ecosystem – one that connects artists, institutions, collectors, and the public in a meaningful way.

"Equally important is the region's growing, internationally oriented collector base and strong tradition of patronage," he underlined. "These conditions make Qatar an ideal place to develop an Art Basel fair that is both globally connected and deeply rooted in its local context."

According to Shawky, Art Basel Qatar is distinct because it is curatorially driven and artist-centred.

"This is the first Art Basel fair to operate under such a strong thematic framework," he said. "The fair focuses on single-artist presentations rather than dense booth displays, which allows for deeper engagement with each practice."

Art Basel Qatar will debut as a concisely curated showcase cel-

ebrating Qatar's vibrant cultural landscape and the dynamic arts ecosystem of the Mena (Middle East and North Africa) region.

The inaugural edition of Art Basel Qatar will be held at M7, as well as at the Doha Design District in downtown Msheireb.

Shawky said that it is essential to place significant emphasis on artists from the region and the wider Global South, while remaining globally connected.

"Art Basel Qatar will strengthen connections between local artists and international galleries, between collectors and regional practices, and between institutions across borders," he stressed. "The fair will expand global demand for art from the Menasa (Middle East, North Africa and South Asia) region. For Qatar, it reinforces the country's position as a cultural hub where ideas, not just objects, circulate."

Shawky strongly feels that by establishing a flagship event in Qatar, new opportunities can be created for established collectors, emerging collecting communities and first-time art audiences.

"Beyond Qatar, the fair helps reposition the region not as an emerging market, but as a site of serious artistic and intellectual production. It also opens new pathways for artists from the Menasa region to engage with the global art ecosystem on their own terms," he continued.

"Art Basel Qatar will take place annually," Shawky said. "Unlike

traditional exhibitions, it is not only a showcase of artworks, but a platform that brings together galleries, artists, collectors, institutions, and the public within a shared framework, and the intent is to extend programming outside of the fair year-round. Each edition will evolve in response to its context."

One of the key highlights of Art Basel Qatar, according to Shawky, is the focused, single-artist presentations, which allow visitors to engage deeply with each artist's work.

Another is the Special Projects programme, which activates important public and heritage sites in Msheireb Downtown Doha.

"Art Basel Qatar is part of a larger process, one that supports artists, encourages thoughtful collecting, and invites the public to engage with art as a way of understanding the world around them. If the fair succeeds in creating curiosity, dialogue, and sustained interest, then it will have achieved something meaningful," he added.

QRCS deploys new medical, relief aid convoy to Syria

As part of Qatar's ongoing relief programme for the people of Syria, Qatar Red Crescent Society (QRCS) has deployed a new land aid convoy to Syria, in co-operation with the embassy of Qatar in Damascus and the Syrian Arab Red Crescent Society (SARCS).

The aid convoy comprised eight trucks, carrying a total of 34 tonnes of medical, food, and non-food aid, at a total cost of QR4.2mn. Earlier this month, it departed from QRCS warehouses in Doha and travelled overland through Saudi Arabia and Jordan, heading for Damascus, Syria.

SARCS will be responsible for receiving and distributing the aid shipment to those most in need, according to the plan.

The aid provided by QRCS included medical equipment and supplies to support Syrian health facilities (such as dental clinic equipment, panoramic X-ray machine, and medical beds), medical aids for persons with special needs (such as wheelchairs, walkers, and electric patient lift), and thousands of medical supplies needed for everyday activities at health facilities (such as wound dressings, band-aids, medical gloves, vital signs monitors, and other medical materials for treatment, nursing, and ICU).

Also, the convoy was loaded with more than 30,000 units of various essential medications, including antibiotics, pain killers, respiratory/topical medications, and maternal and child health care supplies.

There were large quantities of winterisation clothing and items, totalling more than 65,000 pieces for adults and children (male and female), along with essential food items, such as olive oil, and other necessities for living and shelter.

Moreover, service equipment was provided, including solar-powered refrigerators, coolers, and water and sanitation equipment, to help maintain essential services at the target locations and bolster health and safety measures.



This is one of a series of Qatari aid convoys provided for the people of Syria. QRCS had already deployed successive air and land aid convoys from Doha to Damascus.

These shipments included medical equipment and relief supplies, in co-operation with Sidra Medicine, the embassy of Qatar in Damascus, and SARCS, adopting a humanitarian approach aimed at enhancing the resilience of major institutions and alleviating the suffering of affected and displaced people in Syria.



MoPH conducts 800 inspection visits, collects 1,335 laboratory samples during QIFF 2026

The Ministry of Public Health (MoPH) intensified its monitoring efforts during the recently concluded Qatar International Food Festival (QIFF) 2026. This initiative formed part of MoPH's ongoing commitment to protecting public health and enhancing food safety at major events and large gatherings, in co-ordination with Qatar Tourism and the festival's organisers. The Food Safety Department teams carried out 800 inspection visits during the festival, during which 1,335 food product samples were collected and tested at MoPH's Food Safety Laboratories to verify their safety and compliance with requirements. Prior to the launch of the festival, MoPH developed a comprehensive regulatory plan that included assessing the level of compliance among local restaurants participating in the event. In addition, specialised training support was provided to international restaurants through the implementation of

an intensive two-day training programme ahead of the festival, aimed at raising awareness of food safety principles and the requirements for storage, preparation, and presentation. Wasan Abdullah al-Baker, director of the Food Safety Department at MoPH, stated: "These intensive regulatory efforts reflect the ministry's commitment to ensuring the highest standards of food safety during major events. This is achieved through a risk-based approach that integrates field inspections with awareness raising and pre-event training, thereby contributing to the protection of visitors' health and strengthening their confidence in the services provided in Qatar." A team of 14 inspectors from MoPH's Food Safety Department monitored food safety practices throughout the festival, including weekends and all operating hours. Inspection rounds were intensified during peak periods and times of high visitor turnout. The inspection teams

applied the provisions of the risk-based inspection checklist to ensure greater compliance with health requirements and to raise the level of safety of food served to visitors, particularly in light of the large public attendance at the festival. The inspection covered all points of sale at the festival site, amounting to 220 kiosks, including 46 international restaurants. In addition, daily morning follow ups were conducted at the central preparation units supplying the restaurants to ensure proper health practices were applied across all stages of preparation, including transportation. Upon reviewing the recorded violations, the Food Safety Department confirmed that most were low risk and did not pose a threat to public health as they were related to the temporary structures of the kiosks and the limited working spaces. These were addressed immediately through the required corrective measures.

Hosting major sports events 'has enabled young Qataris to realise their full potential'

Qatar plans to host more high-profile sports and football tournaments over the next five years, building on the success of the FIFA World Cup Qatar 2022, the FIFA Arab Cup, the AGCFF U-23 Gulf Cup, and other major events, according to Jassim al-Jassim, CEO of the Local Organising Committee for Football Events. Al-Jassim was speaking at the third edition of the Mutual Dialogue Summit during a session titled "From Hosting to Legacy: How Gulf Sports Shape a Youth-Led Future," moderated by Asrar al-Ansari, director of the Youth Department at the Co-operation Council for the

Arab States of the Gulf (Kuwait). He said the experience gained from hosting global tournaments, coupled with Qatar's advanced infrastructure, has positioned the country to stage major international sporting events. He noted that many young Qataris discovered and developed their capabilities through hands-on involvement in these tournaments, enabling them to assume senior organisational and management roles without external supervision. Al-Jassim stressed that Qatari professionals have earned FIFA's full confidence to organise events independently, without direct intervention. He added that Hamad International Airport, security agencies, administrative bodies, and other state institutions are

now fully equipped to manage large-scale international events, supported by effective contingency plans to address unforeseen challenges. He also highlighted

Qatar's growing reputation as a family-friendly, safe, and welcoming destination for women, noting that the country's sporting events consistently record high ticket sales.

While embracing modern technologies and global best practices, al-Jassim said Qatar has remained committed to showcasing its heritage and traditions. He cited Al Bayt Stadium's architecture and the Gulf bisht presented to Lionel Messi at the 2022 World Cup final as examples of this cultural emphasis. He further noted that Souq Waqif has emerged as one of the most popular destinations for visitors during international tournaments. This outcome was not deliberately planned, but one that reflects the enduring appeal of authentic Gulf heritage. Respect for national traditions, customs, and laws, he said, has remained central to all event-planning efforts. Among the most significant outcomes of the FIFA World Cup

Qatar 2022, al-Jassim added, was the importance of investing in local youth by training and engaging them in planning and organisational processes. This approach has paid off, with many trainees now holding senior management and supervisory positions and performing their roles with high efficiency. The third edition of the Mutual Dialogue Summit concluded on Monday. Organised by the QatarDebate Centre, the two-day event was held at Msheireb Museums in Doha and brought together more than 100 young men and women from GCC countries. It was held in strategic partnership with the Ministry of Sports and Youth, in co-operation with Msheireb Museums as the cultural partner.

GCC, VCM sign pact to accelerate carbon market growth



Qatar based, Global Carbon Council (GCC) and the Regional Voluntary Carbon Market Company (VCM), established by the Public Investment Fund and Saudi Tadawul Group, announced a strategic partnership to scale voluntary carbon markets through trusted standards and institutional-grade exchange infrastructure.

Under this strategic partnership, carbon credits certified by the Global Carbon Council are now traded on Saudi Arabia's VCM exchange platform.

This strategic partnership has already demonstrated strong market traction, with more than 600,000 tonnes of GCC-certified carbon credits traded within the first month of the integration on the exchange.

The early trading activity highlights growing regional demand for high-integrity, independently verified carbon credits and underscores VCM's role in enabling price discovery, liquidity, and transparent market access.

GCC is an international carbon crediting programme that issues tradable credits to registered projects based on verified, results-based greenhouse gas (GHG) emission reductions and removals.

In the Global South, GCC's Programme is the first international GHG and sustainable development programme fully accredited by the International Civil Aviation Organisation for Carbon Offsetting and Reduction Scheme for International Aviation, as well as

International Carbon Reduction and Offset Alliance, positioning the GCC Programme as a critical gateway for channelling high-integrity climate finance into emerging markets.

Credits certified by the GCC Programme can be used by governments and companies to meet and enhance climate ambitions, including supporting Nationally Determined Contributions and enabling the trade of Internationally Transferred Mitigation Outcomes.

The availability of GCC credits on VCM's platform expands access to globally recognised credits for buyers in Saudi Arabia and the wider region.

Dr Yousef Alhorri, founding chairman of GCC, said: "Partner-

ing with VCM enables GCC-certified projects to access a transparent, institutional marketplace and reach new sources of demand. The early trading volumes not only demonstrate how exchange-based platforms can accelerate climate finance and support national climate objectives but also reflect the strong standing and deep-rooted trust that the Global Carbon Council has developed as a leading global carbon market programme."

Fadi Saadeh, acting CEO and head of technology of VCM, said: "This strategic partnership with the Global Carbon Council reflects our efforts towards scaling voluntary carbon markets through credible standards and real market activity.

"The strong trading volumes seen in the first month since their inclusion demonstrate growing confidence in the Saudi carbon market and the role played by VCM's exchange in connecting high-quality supply with regional and global demand."

VCM launched Saudi Arabia's first voluntary carbon credit exchange platform in November 2024. The exchange is designed to support a transparent, scalable and increasingly liquid market by offering institutional-grade infrastructure, price and data discovery, open connectivity with global registries and multiple trading mechanisms including auctions and request-for-quote functionality.

Stricter regulations on cupping therapy services needed: CMC

Stricter rules for cupping therapy services should be introduced to ensure the safety and quality of services provided, the Central Municipal Council (CMC) has stressed.

CMC recently held the 48th meeting of its seventh term, chaired by HE Mohamed bin Ali al-Athba, CMC Chairman, during which a proposal to make the Industrial Area and an independent municipality into a full administrative unit was presented. The meeting discussed several items on its agenda, as part of the council's keenness to follow up on service-related and regulatory issues directly linked to the lives of residents and the quality of services provided.

The council started its proceedings by approving the minutes of the previous meeting and reviewing incoming correspondence, reflecting the continuity of institutional work and the council's follow-up on proposals and observations submitted within the scope of its mandate.

Accordingly, the council discussed the recommendations and report of its Services and Public Utilities Committee regarding stricter oversight of cupping therapy practitioners.



This discussion stemmed from the importance of regulating this activity and ensuring it is practised in accordance with approved health regulations to safeguard public safety and curb irregular practices that may pose a risk to public health.

The council issued its recommendations to both the Ministry of Municipality and the Ministry of Commerce and Industry.

The meeting also addressed the recommendations and report of the Services and Public Utilities Committee regarding a review of procedures for issuing licences for rest houses within residential neighbourhoods.

The views of the competent committee were reviewed regarding regulating this activity in a manner that balances residents' needs with maintaining the residential qualities of

neighbourhoods, while taking into account associated regulatory and environmental aspects. The council approved submitting the appropriate recommendations to both the Ministry of Municipality and Qatar Tourism.

Meanwhile, the council reviewed the briefing by the Services and Public Utilities Committee on responses to the regulation of kiosks within shopping malls, placing greater emphasis on the importance of a clear regulatory framework that ensures optimal use of commercial spaces and preserves the general appearance and internal organisation of such malls.

In addition, the meeting discussed several proposals to establish an independent municipality in the Industrial Area, aimed at regulating industrial activities, bringing them under unified management, and improving municipal services for industrial workshops and garages.

‘Water bankruptcy’:
Need for equitable
global access to water

Water is the ultimate renewable resource, but global water supplies are becoming less reliable amid dangerous floods, droughts and threats to agriculture.

A new era has begun of “global water bankruptcy,” with humans depleting freshwater systems to the point they can’t recover, according to a United Nations report last week.

Three-quarters of the world’s population — about 6.1bn people — now live in countries where freshwater supplies are insecure or critically insecure, according to the report, published by UN University’s Institute for Water, Environment and Health.

Around 4bn people experience severe water scarcity for at least one month each year, while drought impacts cost an estimated \$307bn annually.

The UN report defines water bankruptcy as a “persistent over-withdrawal from surface and groundwater relative to renewable inflows and safe levels of depletion” with “irreversible or prohibitively costly loss of water-related natural capital”.

This differs from water stress which reflects high-pressure situations that remain reversible or a water crisis, which is used to describe acute shocks that can be overcome. Drought and water scarcity are likely to drive migrations in parts of Sub-Saharan Africa, South Asia and Latin America, says the report.

Cities are experiencing more Day Zero events in which municipal water systems near collapse. An acute water shortage in Tehran recently led authorities to warn it may become necessary to evacuate parts of the city or even relocate the capital.

Climate change is shifting fresh water on a planetary scale and, on a smaller scale, those effects can be made worse by local actions. A hotter, drier planet experiences more water-evaporating droughts. That concentrates salts in the soil, as so do certain farming practices.

Around 4bn people experience severe water scarcity for at least one month each year, while drought impacts cost an estimated \$307bn annually, according to the UN

traded on the Wall Street. Apart from being a tradable contract, the futures launch also highlighted growing worries that the life-sustaining natural resource is becoming scarce across of the world.

Proponents of the market say that the futures contracts will function more like insurance. But the United Nations had warned in late 2020 that water futures risked an essential public good being treated like gold and oil, leaving the market vulnerable to speculative bubbles.

The Middle East and North Africa (Mena) region has the world’s scarcest supplies of water, and more than 60% of the people in Mena nations live under conditions of high or very high water stress, according to the World Bank.

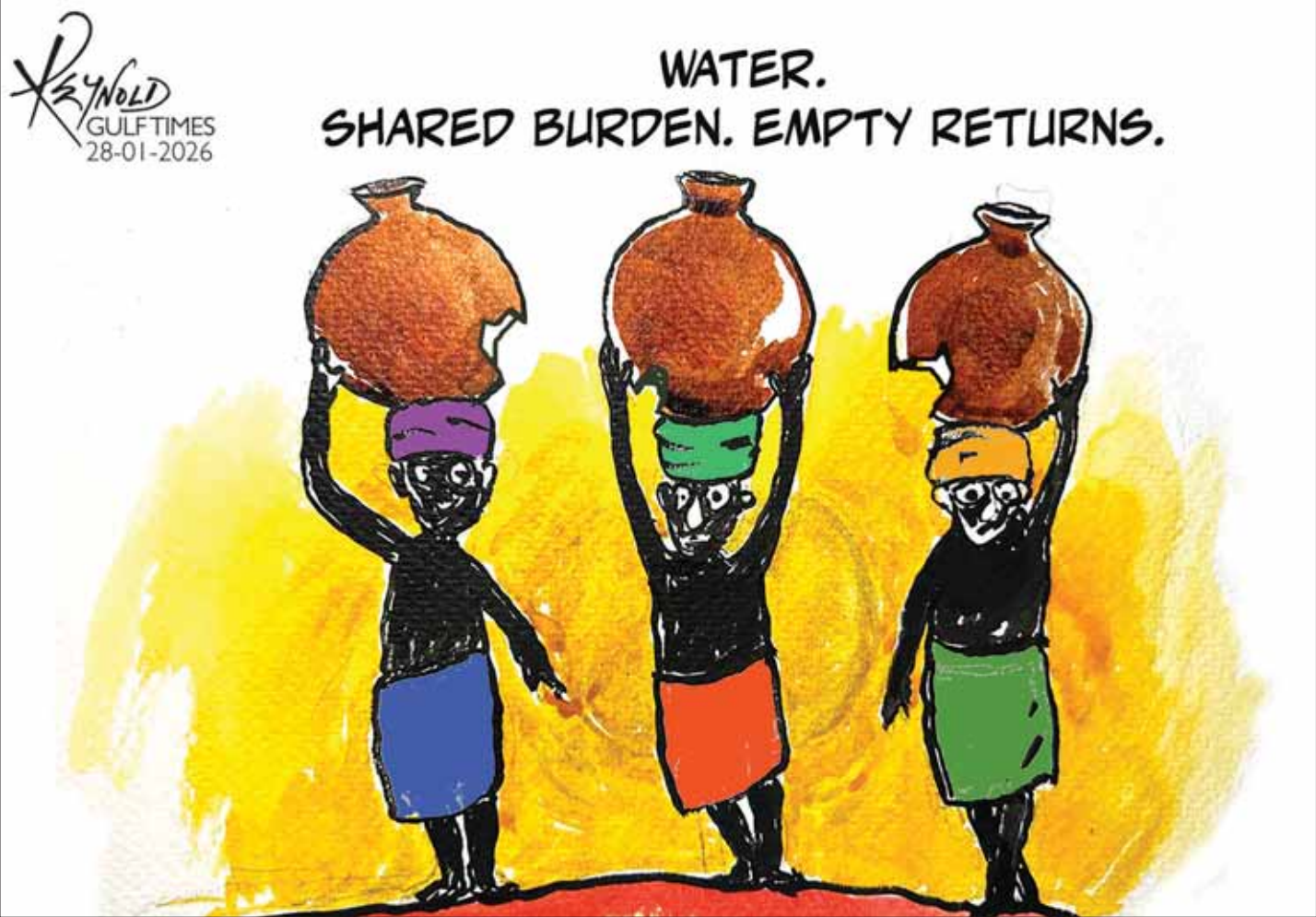
Higher GDP and population growth levels, as well as the increasingly hot climate, mean the Gulf countries need to spend heavily to meet their energy needs.

Water is becoming a significant geopolitical risk, as scarcity and unequal access to water contribute to rising political tensions when demand exceeds supply.

However, when access to water is managed equitably and transparently, it can become a powerful catalyst for socioeconomic growth, co-operation and peacebuilding, fostering cross-border collaboration and contributing to long-term stability.

The UN report calls for the recognition of water bankruptcy in policy debates, and for the creation of a global monitoring framework to track water resources, while governments should consider blocking projects that further degrade water supplies.

In July 2010, the UN General Assembly declared access to water and sanitation as a human right, with its sixth Sustainable Development Goal being access to clean water and sustainable sanitation for all by 2030.



Geopolitical analysis
on the rise for investors
as risks multiply

Demand for geopolitical analysis is rising, as asset managers and corporate investors seek guidance on the best way to price in risk from wars, territorial

sabre-rattling and global political risk. The need for such advice was highlighted last week when the US threatened various countries with tariffs unless a deal was reached over the US taking control over Greenland, causing a rollercoaster reaction in markets.

Other geopolitical events that have roiled markets include Russia’s 2022 invasion of Ukraine, US President Donald Trump’s 2025 call for broad tariffs and subsequent negotiations with individual countries, and this month’s US intervention in Venezuela.

For investors, geopolitical risk used to be overshadowed by factors including economic data points and central bank decisions. But since the Ukraine war, the demand for insight has been climbing steadily, said Mehil Marku, lead geopolitical analyst for PGIM Fixed Income.

“Before 2022, geopolitics wasn’t necessarily an important function in portfolio investment terms; it was a good thing to

have but not a ‘must have,” Marku said, adding the number of client calls had spiked. “It’s the interconnectedness of all the crises that feels really challenging to many.”

Investors and consultancy firms say the rising need for geopolitical advice and analysis has prompted them to either ramp up their own in-house capabilities, seek more independent analysis or increase the advice to give clients. Such analysis can include written reports, more tailored advice or developing scenario analyses.

“We have to develop a new muscle, almost,” Rishi Kapoor, vice-chairman and chief investment officer of Investcorp, the Middle East’s biggest alternative investment firm, told the Reuters Global Markets Forum on the sidelines of the World Economic Forum in Davos. “Earlier on, the geopolitical backdrop was something that we kind of took for granted and just assumed that it was a stable backdrop.”

Pandu Patria Sjahrir, CIO of Indonesia’s sovereign wealth fund Danantara, said his fund now did a lot of work on political leaders’ risk. “This year, maybe even more so than any other year, we’re focusing a lot more on geopolitical risks,” he said. “We think about worst case now in terms of underwriting. In fact, my base case is worst case.”

The second Trump

administration’s policies have helped catapult geopolitics to the top spot on the list of client priorities, from being “somewhere in the top 20” about a decade ago, said Marc Gilbert, head of the BCG Center for Geopolitics.

Everything is “faster, harder, more volatile” he said of US trade and foreign policy pronouncements. In the last 18 months, he has had 235 meetings with C-suite officers and corporate board members on these topics, which he said marked a dramatic increase.

Asked for comment on increasing demand for geopolitical analysis, White House spokesman Kush Desai said the president’s “shakeup of this broken status quo is finally putting America First” and that “trillions in investments pouring into the United States is proof” that investors believe it is the most dynamic global economy.

Banks have been dedicating resources to the theme. JPMorgan last year launched a dedicated Center for Geopolitics, while Lazard Asset Management and Goldman Sachs launched geopolitical advisory divisions in 2022 and 2023 respectively.

JPMorgan did not return requests for comment on the centre. Goldman and Lazard

did not respond to requests for comment.

Heightened awareness of global risk is increasing the need for specialist geopolitical analysis firms, said Matt Gertken, chief geopolitical analyst at investment consulting firm BCA, who said his company was growing, without giving specifics.

Consulting firm Signum Global Advisors has also seen increased demand, boosting its roster of partners by 25% last year as its client list grew, said Charles Myers, the firm’s chairman and founder.

There was particular interest from investors trying to understand what may result from the shifting power dynamics in Venezuela, said Myers, adding that he had 20 spots for an investor trip to the country on March 23, but 60 clients eager to participate, and was considering making the trip a full-fledged investor conference at a Caracas hotel.

Jens Larsen, London-based head of Eurasia Group’s geo-economics team, said competition to provide geopolitical insights was growing. “I’m still not sure that the supply of advice is keeping up with demand as the nature of the challenges becomes multi-faceted,” said Larsen.

US decision to strip migrant children of legal aid flayed

UN human rights experts yesterday denounced the US decision last year to cut legal aid for unaccompanied children in US immigration proceedings. The condemnation came days after UN High Commissioner for Human Rights Volker Turk urged the Trump administration to ensure its migration policies respect international law. "Denying children their rights to legal representation and forcing them to navigate complex immigration proceedings without legal counsel is a serious violation of the rights of children," said the independent experts, who are appointed by the UN Human Rights Council. - Reuters

US to conduct multi-day military exercise in Middle East

The US yesterday announced a major multi-day Air Force exercise in the Middle East, as Washington and Tehran face off. The announcement came a day after the US military said the Abraham Lincoln carrier strike group had arrived in the Middle East, dramatically boosting American firepower in the region. The exercise will "demonstrate the ability to deploy, disperse, and sustain combat airpower across" the Middle East, the US Air Force component of Central Command, which is responsible for American forces in the region, said in a statement. No date or exact location for the exercise were released. - Reuters

US sued over deadly missile strikes on alleged drug boats

Relatives of two Trinidadian men killed last year in a US military strike on a boat allegedly carrying drugs filed a wrongful death lawsuit yesterday against the US government. It is the first such case to be brought against the Trump administration over the three dozen missile strikes in the Caribbean and eastern Pacific, which have left at least 125 people dead since September. President Donald Trump alleged at the time that "six male narcoterrorists" were killed in a boat allegedly ferrying drugs from Venezuela to the US. Washington has yet to release any evidence supporting its claims. - AFP

French lawmakers pass bill on social media ban for under-15s

French lawmakers have passed a bill that would ban social media use by under-15s, a move championed by President Emmanuel Macron as a way to protect children from excessive screen time. The lower house, the National Assembly, adopted the text by a vote of 130 to 21 in a lengthy overnight session from Monday to Tuesday. It will now go to the Senate, France's upper house, ahead of becoming law. The legislation, which also provides for a ban on mobile phones in high schools, would make France the second country to take such a step following Australia's ban for under-16s in December. - Reuters

Trump weighs less aggressive approach in Minneapolis

Donald Trump's border czar, Tom Homan, yesterday met with Minnesota's governor ahead of talks with the mayor of Minneapolis, as the White House seeks to defuse the unrest that has gripped the city after the fatal shootings of two US citizens by federal agents.

The move to install Homan in charge of the operation in place of Border Patrol official Gregory Bovino, who sources said is leaving after having led most of Trump's crackdowns in Democratic-led cities, is part of a broader reset by the president to soften his administration's aggressive posture in Minneapolis. Some advisers are concerned that Saturday's killing of 37-year-old Alex Pretti by federal officers, which sparked national outrage, could derail Trump's immigration agenda.

Homan's job in Minneapolis is to "recalibrate tactics" and improve cooperation with state and local officials, a source with ties to the White House said.

"The goal is to scale back, eventually pull out," the source added.

A senior Trump administration official said Homan would move away from the broad, public neighbourhood sweeps that Bovino had conducted in Los Angeles, Chicago, Minneapolis and other cities and adopt a more traditional targeted approach.

In a statement, governor Tim Walz said he had outlined the state's priorities to Homan, including impartial investigations into the two shootings and reducing the 3,000-strong force of federal agents that has been deployed to the city. Homan and Walz agreed to "continue working toward those goals," the governor said.

Homan was also expected to sit down with Minneapolis mayor Jacob Frey, Trump said on social media.

The president spent the weekend huddling with senior advisers to reassess the administration's response to Pretti's death on Saturday, according to the same source and a White House official.

As in the aftermath of the fatal shooting of 37-year-old Renee Good earlier this month, some Trump administration officials initially responded by accusing Pretti of domestic terrorism, a claim belied by witness video verified by Reuters that showed he posed no threat.

The discussions included reducing the number of agents in Minnesota, recalibrating the mission to focus more narrowly on deportations and exploring greater co-ordination with state authorities. Trump also weighed whether immigration officers should be required to have body-worn cameras, as many police officers do, according to the White House official.

The killing of Pretti, an ICU nurse shot multiple times by Bor-

der Patrol agents on Saturday during daytime protests, has become a full-blown political crisis for Trump, with even some Republicans in Congress calling for investigations.

Coupled with the fatal shooting of Good, a mother-of-three, earlier this month by an Immigration and Customs Enforcement officer, Pretti's shooting sparked renewed anger over the aggressive tactics of the federal agents who have been roving the streets of Minneapolis for weeks.

Late on Monday, Minnesota's chief federal judge threatened to hold the acting head of US Immigration and Customs Enforcement, Todd Lyons, in contempt for his agency's failures to comply with court orders that some detainees receive bond hearings.

"The court's patience is at an end," US district judge Patrick Schiltz wrote in ordering Lyons to appear before him on Friday.

Public support for Trump's immigration enforcement tactics appeared to be waning both before and after the Pretti shooting, a Reuters/Ipsos poll showed. The issue has put Republicans on the defensive ahead of November's midterm elections, when the party's narrow congressional majorities are at stake.

The president held a two-hour meeting with Homeland Security Secretary Kristi Noem in the Oval Office on Monday evening after Noem asked to meet, a source briefed on the matter confirmed.

India, EU sign landmark trade agreement

India and the European Union (EU) yesterday announced the "mother of all deals", a huge trade pact to create a market of 2bn people, reached after two decades of negotiations.

EU chiefs and Prime Minister Narendra Modi hope the pact will help shield against challenges from the world's two leading economies, the US and China.

The agreement will cut or eliminate tariffs on almost 97% of European exports, saving up to 4bn euros (\$4.75bn) annually in duties, the 27-nation bloc said.

"A mother of all deals," Modi said yesterday in the capital New

Delhi, where he met with European Commission president Ursula von der Leyen and European Council president Antonio Costa.

"This deal will bring many opportunities for India's 1.4bn and many millions of people of the EU," Modi said, adding the agreement "represents about 25% of global GDP, and one-third of global trade".

The EU has eyed India - the world's most populous nation - as an important market for the future.

"Europe and India are making history today," von der Leyen said in a statement, a day after she and Costa were feted as guests of honour at India's Republic Day parade.

"We have created a free trade

zone of 2bn people, with both sides set to benefit."

EU officials said the deal was the most ambitious India had ever agreed, and European companies would benefit from so-called "first mover advantage".

Europe's key agricultural, automotive and service sectors stand to gain.

But sensitive agricultural sectors, such as beef, rice and sugar whose inclusion in an earlier deal struck with South American bloc Mercosur sparked farmers' anger in Europe, were left out of the agreement.

New Delhi sees the European bloc as an important source of much-needed technology and investment to rapidly upscale its infrastructure and create millions of new jobs.

Landslide leaves Sicilian town teetering on cliff edge

Homes in the Sicilian town of Niscemi have been left teetering on the edge of a cliff after a landslide that was triggered by a storm, Italy's civil protection chief said yesterday.

Niscemi, a town of about 25,000 in south-central Sicily, sits on a plateau that authorities say is gradually collapsing toward the plain below. More than 1,500 people have had to be evacuated. Buildings were overhanging the edge after large sections of the slope gave way. A car was left with its front end poking into the chasm.

"Let's be clear: there are homes on the edge of the landslide that are uninhabitable," the civil protection head Fabio Ciciliano told reporters in Niscemi, saying residents from the affected areas would be permanently relocated.

"Once the water has drained away and the moving section has stopped or slowed, a more accurate assessment will be made... The landslide is still active," he added.

On Monday, the Italian government of Prime Minister Giorgia Meloni declared a state of emergency for Sicily, Sardinia and Calabria, the three southern regions battered by the violent storm last week.

TikTok settles social media addiction lawsuit

Video sharing app TikTok has made an eleventh-hour deal to avoid a landmark US trial accusing it, along with Meta and YouTube, of addicting young people to social media, lawyers said yesterday.

The deal was made as jury selection was to begin in a Los Angeles court that could establish a legal precedent on whether social media companies deliberately designed their platforms to addict children.

The case being heard in the California state court is being called a "bellwether" proceeding because its outcome could set the tone for a tidal wave of similar litigation across the US.

The remaining defendants in the suit are Alphabet and Meta,

the tech titans behind YouTube and Instagram.

Meta co-founder and chief executive Mark Zuckerberg is slated to be called as a witness during the trial.

"The parties are pleased to have reached an amicable resolution of this dispute," the Social Media Victims Law Center said, noting that the terms of the settlement with TikTok are confidential.

The case focuses on allegations that a 19-year-old woman identified by the initials K.G.M. suffered severe mental harm because she was addicted to social media. After joining YouTube at age six, Instagram at 11, Snapchat at 13, and TikTok at 14, the Californian claims to have developed an addiction to the sites that contributed to her depression, anxiety, body image issues and that stoked suicidal thoughts.

School materials enter Gaza after being blocked for two years: Unicef

The UN children's agency yesterday said it had for the first time in two-and-a-half years been able to deliver school kits with learning materials into Gaza after they were previously blocked by Israeli authorities.

Thousands of kits, including pencils, exercise books and wooden cubes to play with, have now entered the enclave, Unicef said.

"We have now, in the last days, got in thousands of recreational kits, hundreds of school-in-a-carton kits. We're looking at getting 2,500 more school kits in, in the next week, because they've

been approved," Unicef spokesperson James Elder said.

"It's been a long two years for children and for organisations like Unicef to try and do that education without those materials"

A spokesperson for COGAT, the arm of the Israeli military that oversees aid flows into the Gaza Strip, confirmed it had recently allowed Unicef to bring in learning kits though not text books. A COGAT spokesperson said learning kits had been let in several times during the war, without saying how.

Children in Gaza have faced an unprecedented assault on the education system, as well as restrictions on the entry of some aid

materials, including school exercise books and pencils, meaning teachers had to make do with limited resources, while children tried to study at night in tents without lights, Elder said.

During the conflict some children missed out on education altogether, facing basic challenges like finding water, as well as widespread malnutrition, amid a major humanitarian crisis.

"It's been a long two years for children and for organisations like Unicef to try and do that education without those materials. It looks like we're finally seeing a real change," Elder stated.

Unicef is scaling up its education to support half of children of school age - around 336,000 - with learning support. Teaching will mainly

happen in tents, Elder said, due to widespread devastation of school buildings in the enclave during the war.

At least 97% of schools sustained some level of damage, according to the most recent satellite assessment by the UN in July.

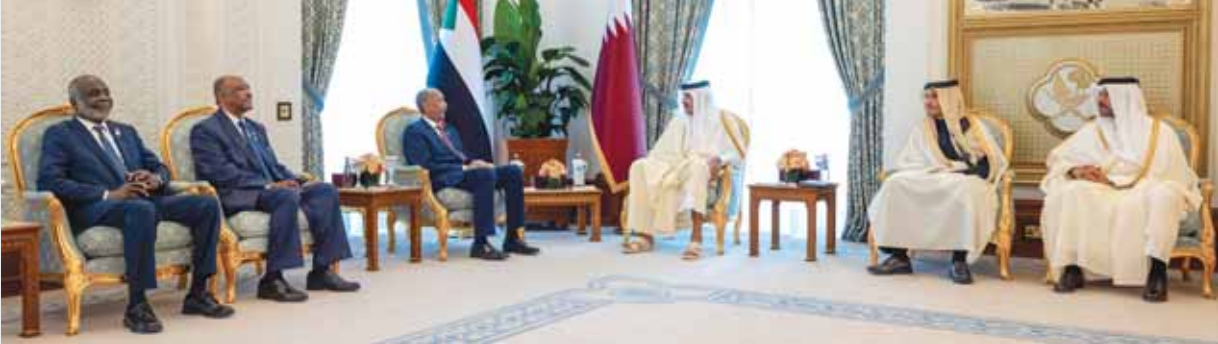
The bulk of the learning spaces supported by Unicef will be in central and southern areas of the enclave, as it remains difficult to operate in the north, parts of which were badly destroyed in the final months of the conflict, Elder said.

Israel's latest assault has killed 71,000 Palestinians, Gaza's health authorities say. More than 20,000 children were reported killed, including 110 since the October 10 ceasefire last year, Unicef said, citing official data.

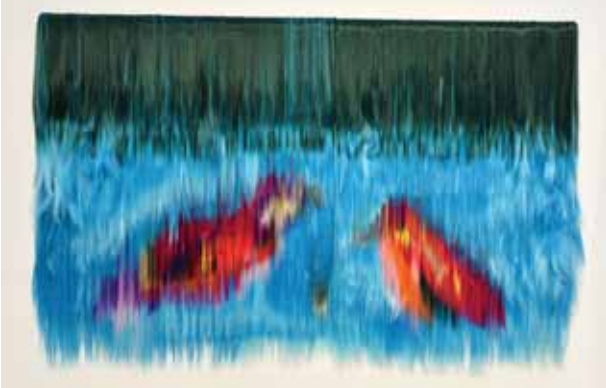

Katara Arts Centre (KAC) has been hosting the works of three contemporary artists, presenting art lovers and enthusiasts with remarkable pieces that reflect unique approaches blending modernity with tradition and heritage.

The exhibitions, running until February 28, are open daily to the public from 11am to 9pm.

The featured works include 25 portrait paintings by Qatari artist Khalid Bumatar, titled “(Faces 2)”; a collection of the works of Qatari artist Asma Sami, titled “What Remains Familiar”; and a collection of the works of Iranian-born artist Hilva Alizadeh, titled “Singing in the Hanging Gardens of Babylon”.

KAC founder and director Tariq al-Jaidah stressed the importance of these three art exhibitions as they represent three different schools.

For instance, he said, Bumatar is considered a naturalist and self-taught artist with a unique style that blends heritage with modern perspectives, while Sami is a practising artist committed to featuring local tradition, culture and everyday life, evolving them into new forms and compositions.

Those in charge of culture and arts in the country give great attention to promoting arts and artists, especially emerging Qatari artists, and offer them all the due support, in addition to encouraging them to be active participants locally, regionally and internationally.

However, al-Jaidah said that all artists are welcome in Qatar, and they are also offered the due support and encouragement to develop and display their work.

Bumatar said that he had always been drawing and creating new works but only started to take part in exhibitions after his early retirement.

He sees great potential in exploring the various angles of human faces and draws them from different perspectives with various unique and expressive postures.

All his portraits feature intrinsic element of the original Qatari heritage, culture and traditions with lively faces that give the viewers ample areas of interpretation.

Bumatar said that the arts and culture atmosphere and environment in Qatar have been very encouraging for artists and innovators, stressing that such a positive approach at both the popular and official levels encourages artists, Qataris, and others to further exercise their creativity and produce original and diverse works.

He added that this is his second solo exhibition, and that he is ready to collaborate with the relevant entities to participate in both local and international exhibitions.

The artist also said the artistic movement in Qatar has been witnessing an unprecedented boom, with multiple museums, galleries, display halls, and specialised arts events all year round.

True gift and talent, Bumatar added, would certainly prevail and produce authentic art in the age of modern technology, as such technology can be utilised to spread that creativity and reach a wider audience.

Sami meanwhile said that she focuses on various elements of local heritage and culture, using them as symbols to capture moments of nostalgia.

In this exhibition, she has 17 different paintings with such focus.

Alizadeh said that he is happy to display his works in Doha, adding that Doha is an excellent position to be a global hub for innovative arts and artists from around the world.

He noted that the overall artistic scene in Qatar is very encouraging and promising of greater potential.

Healing through leadership and art

From hospitals to canvases, Banan Soliman is reshaping wellbeing in Qatar, blending public health, art, and leadership to help people reconnect with themselves and thrive in uncertain times.

Soliman is not one to stay in a box. A public health leader and accomplished artist, she has spent over two decades moving seamlessly between government corridors and creative studios, guided by one question: “How can I make a real difference in people’s lives?”

Her role in Qatar’s health sector has seen her co-ordinate national operations during the coronavirus (Covid-19) pandemic and the FIFA World Cup 2022, ensuring hospitals and health systems were ready under immense pressure.

“Leadership is not about control or only managing systems,” she told *Gulf Times*. “It’s about having clarity under

pressure and helping teams stay focused when uncertainty is high.”

Soliman recalled the human side of these crises.

“During Covid-19, many teams were anxious about their safety, and it affected performance and even their immunity,” she recounted. “My role was to bring focus and empathy into the system. Leadership meant not only co-ordination and efficiency, but also protecting trust and psychological safety.”

“Even at peak demand, we stay committed to patient experience, because how people are treated is just as important as what systems deliver,” she added.

Alongside public service, Soliman has built a parallel life as an artist.

Her works, rooted in Arabic calligraphy and contemporary abstraction, have been exhibited worldwide and commissioned

by Formula 1 champions, FIFA athletes, and cultural icons.

Her calligraphy series, “Light Upon Light”, merges Qur’anic verses with contemporary design.

“Each artwork reminds people of their own inner strength and divine connection,” she said. “Art became the bridge between science and the spiritual dimension – it restores us, regulates the nervous system, and speaks to the soul.”

Her commitment to service extends into her creative practice.

In Germany, she curated charity exhibitions supporting Syrian children’s hospitals.

In Qatar, she organised fundraising art events for Palestine, with proceeds directed to the Red Crescent Society.

“Beauty gains meaning when it moves energy into action,” Soliman explained.

“Creating with intention feels lighter, more alive. And giving heals all sides – the artist, the buyer, and the cause being supported.”

She is now expanding her work in Qatar through retreats blending art, public health insights, and even kitesurfing.

“Thriving comes naturally when what you do matches who you are. It’s less about productivity, more about inner balance,” she said. “Qatar’s landscape, where desert meets sea, offers the perfect space to pause, realign, and remember who you are.”

For Soliman, success is measured not in titles or exhibitions, but in impact.

“Whether designing a policy, a building, or a painting, my goal is the same: to create environments where people feel supported to live with balance and flourish,” she told *Gulf Times*.

Buchbinder brings Beethoven’s piano concertos to life with QPO

The Qatar Philharmonic Orchestra (QPO) is set to welcome one of the towering figures of classical music, as legendary pianist Rudolf Buchbinder takes centrestage for a landmark Beethoven piano concerto cycle at Katara Cultural Village’s Opera House.

Renowned for his lifelong dedication to Beethoven’s music, Buchbinder brings decades of scholarship, performance experience and interpretative authority to this ambitious programme.

Widely regarded as one of the world’s foremost Beethoven interpreters, his return to the concert hall promises performances marked by intellectual depth, emotional clarity and formidable virtuosity.

The cycle opens tomorrow (January 29) at

8pm with Piano Concertos Nos. 2, 3 and 4, offering audiences a vivid journey through Beethoven’s artistic evolution.

Together, the three works trace the composer’s transformation from a brilliant young virtuoso working within classical traditions to a bold innovator reshaping the concerto form itself.

Piano Concerto No. 2 in B-flat major, despite its numbering, is Beethoven’s earliest concerto and reflects his classical roots, combining elegance with youthful energy.

The dramatic Concerto No. 3 in C minor marks a decisive shift, introducing a stormy intensity and signalling the emergence of Beethoven’s “heroic” style through its tense dialogue between soloist and orchestra.

Concerto No. 4, with its revolutionary open-

ing for solo piano, broke convention entirely, introducing a new psychological and narrative depth that would influence generations of composers.

Buchbinder concludes the Beethoven cycle on Saturday (January 31) at 7.30pm, with Piano Concertos Nos. 1 and 5.

The programme highlights Beethoven’s stylistic breadth, moving from the bright, festive brilliance of the First Concerto to the commanding grandeur of the Fifth, famously known as the “Emperor”.

Opening with a bold, improvisatory piano cadenza, the “Emperor” stands as a triumphant statement of heroic scale and ambition.

Together, the performances promise a rare and immersive celebration of Beethoven’s enduring genius.
